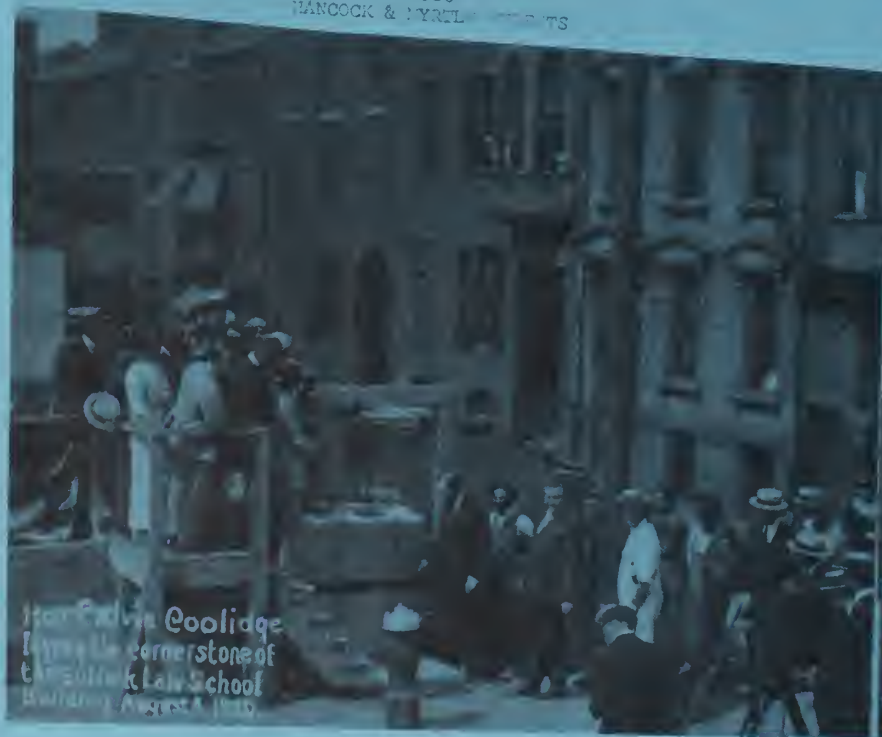

Buys Temple St. Building Planning Consultant Demolition Starts New University Acquisition

A cornerstone in the history of Suffolk University, plan for its future growth and development with the acquisition of adjacent property.

Purchased by the University after negotiations which began in May of this year were the 120 First Methodist Church and the Temple Housing from numbers 35-41 Temple Street. The First Methodist Church was the First Methodist Episcopal Society in Boston, Beacon Hill Community.

The University moved a step closer to occupancy of the Wright & Potter Building at 32 Derne Street with the December 29 passing of papers making Suffolk the owner of the property. Papers were signed in the President's Conference Room.

Present for the signing were Vice President and Treasurer Francis X. Flannery and Albert W. Rockwood, president of Wyman Trust, the owner of the property, Atty. William K. Mackey, counsel for Wyman Trust, and Kenneth A. Korb, counsel for the university.

Vice President Flannery expressed hope that the University might be able to occupy the building by the end of the year to begin renovations. Under terms of the agreement, the Wright & Potter printing firm holds an extended lease, and the university will not move into the five-story structure.

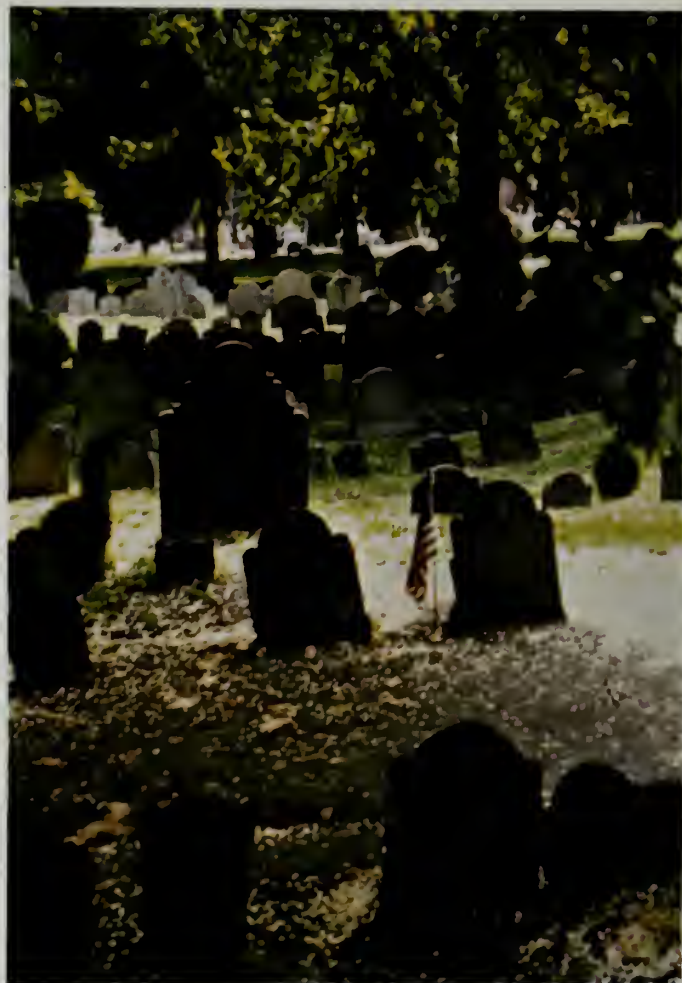

TRANSITION

Suffolk University, founded by Gleason Archer, began as a Law School in 1906 in Archer's Roxbury flat. The University grew out of the Law School, then in the Archer building, in 1936 with the establishment of the Journalism department and was chartered as an established institution in 1937 as a college of Liberal Arts, a graduate school of Law, a college of Journalism, and a college of Business Administration. By 1953 the university was fully accredited.



The Suffolk community has increased in size acquiring more buildings and many more students. We have climbed the Hill for one to four years coming from Boston, its suburbs, from within and from outside of Massachusetts. And perhaps at some point we've thought of hanging up the time spent here, where skipping class to play cards, to catch up on sleep, to study for a forthcoming quiz or just to satisfy that lethargic feeling would become a permanent absence instead of a sudden decision for one day. But for some reason we came back for more of the routine — the schedule of classes, that early cup of coffee to stimulate the desire to attend them, waiting in the cafe, the lounge or the library filling time before going to work, catching the crowded trains home or stamping a ticket for that discount at the parking garage and trying to beat the rush hour traffic. What was this common spirit and its purpose?

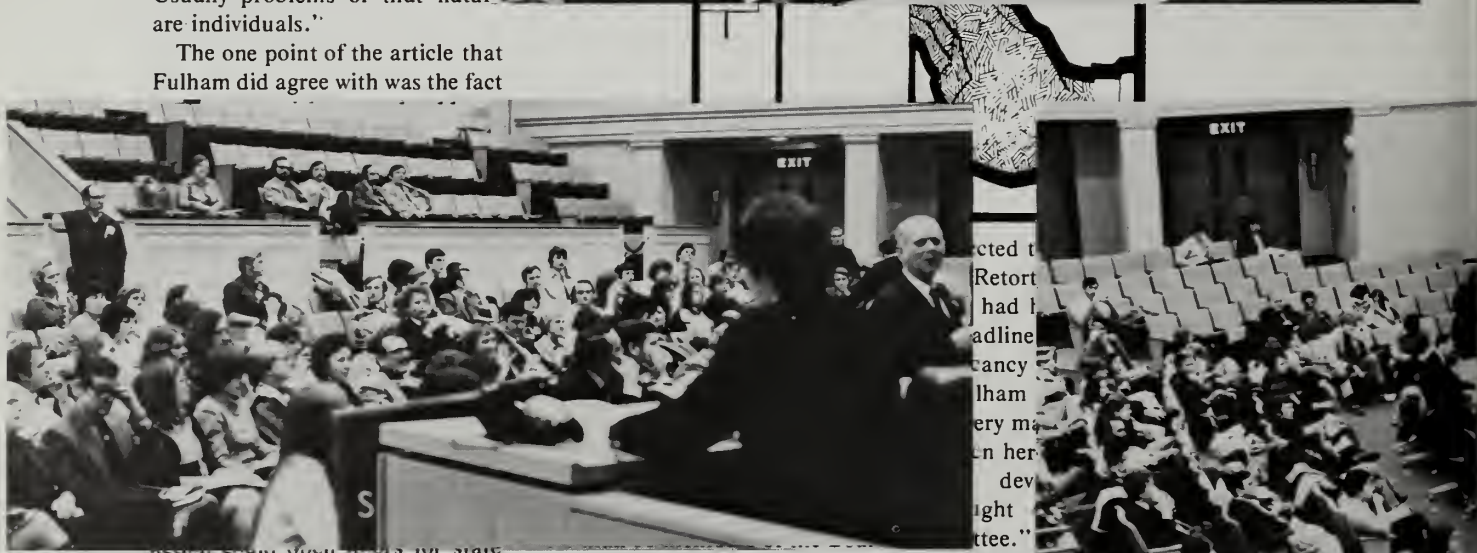
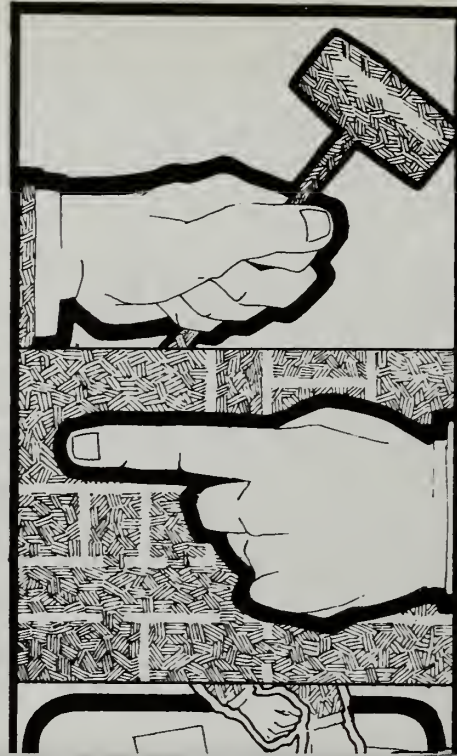
At the public hearing on House Bill 5421 the Trustee Bill many accusations were made against President Thomas Fulham and Vice President and Treasurer Francis X. Flannery. The charges ranged from voting themselves into their respective jobs to lying to students about the deadline for making nominations for the Board of Trustees.

When told about the allegations and asked if he would like to respond to them, Mr. Flannery said, "I don't think they are worthy of comment. Just that there were many inaccuracies in that story (the story concerning the hearing published in the early afternoon edition of the *Boston Globe* on Tuesday).

Flannery was just as unwilling to comment on what he thought the errors were saying," I wouldn't want to get into a battle with the likes of Mr. O'Donnell."

President Fulham was more willing to answer the allegation made against him and the rest of the Board, "As far as the charge of nepotism and cronyism, there is just no way to take that up. Usually problems of that nature are individuals."
