BY MAY OF BACKGROUND ON 01/12/90 SALVADORAN SOCIALIST LEADER HECTOR QUELI AND GUATEMALAN ATTORNEY GILDA FLORES WERE KIDNAPPED AT APPROXIMATELY 6:00 AM WHILE ENROUTE BY AUTOMOBILE TO THE AIRPORT IN GUATEMALA CITY, GUATEMALA. ON 01/12/90 BOTH WERE FOUND DEAD NEAR THE SALVADORAN BORDER IN JUTIAPA,

GUATEMALA 117 KILOMETERS FROM GUATEMALA CITY.

GUATEMALAN GOVERNMENT POLICE AUTHORITIES, UPON LEARNING OF THE KIDNAPPING, RESPONDED AND BEGAN AN INVESTIGATION IN THE VICINITY OF THE ABDUCTION. WITNESSES IN THE AREA ADVISE THAT THREE (3) UNKNOWN SUBJECTS, NOT FURTHER DESCRIBED, DRIVING A 4 DOOR BROWN COLORED AUTOHOBILE, NOT FURTHER DESCRIBED, PHYSICALLY ABDUCTED VICTIMS FROM GILDA FLORES! MERCEDES AND SHOVED BOTH INTO BROWN COLORED VEHICLE AND SPED OFF. NO WITNESSES DEVELOPED TO DATE CAN IDENTIFY ABDUCTORS AND NO LICENSE PLATE INFORMATION WAS OBTAINED. GILDA FLORES AUTOMOBILE WAS NOT CRIME SCENED. GUATEMALAN POLICE CONDUCTED A KIDNAPPING INVESTIGATION UNTIL BODIES LOCATED LATE ON 01/12/90.

ON 01/12/90 THE BODIES OF CAPTIONED VICTIMS WERE FOUND IN THE REAR OF A STOLEN TOYOTA PICKUP TRUCK. POLICE AUTHORITIES WERE CALLED TO THE SCENE OF THE CRIME AND CONDUCTED A CRIME SCENE SEARCH OF THE AREA AS WELL AS A NEIGHBORHOOD INVESTIGATION WHICH RESULTED IN NEGATIVE INFORMATION AS SAME PERTAINED TO SUBJECTS WHO LEFT THE PICKUP TRUCK AT THE SCENE. CASINGS FROM A .32 CALIBER BULLET WERE FOUND AND RETAINED AS EVIDENCE. THE BULLET CASINGS WERE NOT PRESERVED FOR FINGERPRINTS. CRIME SCENE WAS WELL VISITED BY PARAMEDICS, POLICE, AND ONLOOKERS. THE VEHICLE WAS NOT SEARCHED FOR HAIRS AND FIBERS AND WAS RELEASED TO THE DWNER.

THE TOYOTA PICKUP TRUCK WAS STOLEN AT GUNPOINT, FROM THE OWNER, DURING THE MORNING OF 01/12/90 IN GUATEMALA CITY, AFTER THE ABDUCTION OF CAPTIONED VICTIMS. THU DWNER OF THE PICKUP, A 60 YEAR OLD MAN, COULD DNLY DESCRIBE THE THIEF AS 30 TO 35 YEARS OF AGE, WITH A LOT OF HAIR, AND CARRYING A PISTOL. POLICE OFFICIALS DESCRIBED OWNER AS OLD AND SCARED AND STATED. THAT HE DOES NOT RECALL OTHER FACTS.

AUTOPIES PERFORMED ON VICTIMS INDICATE BOTH VICTIMS WERE INJECTED WITH AN UNKNOWN SUBSTANCE, IN THE VEIN LOCATED AT THE NAP OF THE INNER ARM. A BULLET WAS REMOVED FROM THE SKULL OF MECTOR OQUELI. NO BULLET WAS FOUND IN THE SKULL OF VICTIM GILDA FLORES. (BULLET HAS BEEN RETAINED AS EVIDENCE)

TO DATE, NO SUSPECTS HAVE BEEN IDENTIFIED AND SPECULATION IS

THAT RIGHT WING ELEMENTS (GUATEMALAN OR FOREIGN) WERE INVOLVED

IN CAPTIONED MATTER.

INITIALLY, THIS MATTER WAS NOT BEING TREATED AS SIGNIFICANT BY GUATEMALAN AUTHORITIES, HOWEVER BASED ON THE REACTION OF THE INTERNATIONAL COMMUNITY TO THE KILLING OF OQUELI, AND U.S. EMBASSY PRESSURE, THE PRESIDENT OF GUATEMALA HAS PUBLICLY DENOUNCED THE KILLING AND FORMED AN INVESTIGATIVE COMMITTEE COMPOSED OF THE INTERIOR MINISTER, THE DIRECTOR OF THE NATIONAL

POLICE, THE HEAD OF MILITARY INTELLIGENCE AND A HUMAN RIGHTS
REPRESENTATIVE. AS SET UP, ALL POLICE AND MILITARY INVESTIGATIVE
PERSONNEL ARE AT THE DISPOSAL OF THE COMMITTEE TO RUN OUT
LEADS AND/OR INVESTIGATE THIS MATTER AT THE DIRECTION OF THE
COMMITTEE. NO SPECIFIC INVESTIGATORS ARE ASSIGNED.

## ADMINISTRATIVE:

ON 01/29/90 DLAT MEXICO CITY ARRIVED IN GUATEMALA CITY AND MET WITH THE U.S. AMBASSADOR REGARDING THIS MATTER. U.S. AMBASSADOR AND POLITICAL COUNSELOR AS WELL AS ICITAP COORDINATOR BRIEFED DLAT ON CAPTIONED MATTER TO DATE. DLAT EXPLAINED FPC AS SAME PERTAINS TO TECHNICAL ASSISTANCE.

ON 01/29/90 DLAT AND ICITAP COORDINATOR MET WITH GUATEMALAN INTERIOR MINISTER CARLOS AGOSTO MORALES VILLATORO, AND DIRECTOR DF NATIONAL POLICE GIOVANNI VALERIO CARDENAS FOR THE PURPOSE OF DISCUSSING CAPTIONED MATTER (BOTH ARE MEMBERS OF BLUE RIBBON COMMITTEE DESCRIBED ABOVE).

CAPTIONED MATTER WAS REVIEWED IN GENERAL AND IN SOME CASES

SPECIFICALLY AS SAME PERTAINED TO EVIDENCE COLLECTED. DIRECTOR

OF NATIONAL POLICE WAS QUITE KNOWLEDGEABLE OF FACTS AND HAS

OFFERED TO MAKE AVAILABLE INVESTIGATIVE REPORT TO DATE, WHICH

INCLUDES CRIME SCENE PHOTOGRAPHS AUTOPSY RESULTS (VERY LIMITED),

AND INTERVIEWS CONDUCTED. VALERIO WILL ASK COURT IF EVIDENCE CAN BE RELEASED AND SENT TO FBI LABORATORY FOR EXAMINATION (BASED ON OFFER BY DLAT).

BASED ON BRIEFING GIVEN TO DLAT AND ICITAP COORDINATOR, THE INITIAL INVESTIGATION INCLUDED NEIGHBORHOOD INVESTIGATION AT THE SCENE OF THE ABDUCTION, AND A CRIME SCENE AT THE TIME OF THE DISCOVERY OF CAPTIONED VICTIMS ON 01/15/90, HOWEVER, EVIDENCE COLLECTED WAS NOT ADEQUATELY PROCESSED NOR THE SAME PRESERVED FOR FINGERPRINT EXAMINATION. IMPORTANCE OF HAIRS, FIBERS AND BLOOD SAMPLES AND THE PRESERVATION OF SAME WAS EXPLAINED, AS WAS THE IMPORTANCE OF EVIDENCE RETENTION IN THE FURTHERANCE OF IDENTIFYING SUSPECTS/SUBJECTS.

DLAT EXPLAINED FBI ROLE IN FPC MATTERS AND BOTH THE INTERIOR MINISTER AND THE DIRECTOR OF NATIONAL POLICE WERE APPRECIATIVE OF SAME. FROM AN INVESTIGATIVE STANDPOINT, IT WAS SUGGESTED THAT THE COMMITTEE CONSIDER OFFERING A REWARD FOR INFORMATION ON CAPTIONED MATTER. DTHER INVESTIGATIVE SUGGESTIONS WERE MADE AS WELL BASED ON THE LACK OF SPECIFICS OBTAINED FROM WITNESSES. DLAT WILL SECURE EVIDENCE AND TRANSPORT SAME TO FBIHO LABORATORY IF COURT AGREES TO RELEASE SAME FOR FORENSIC EXAMINATION.

IT IS NOTED THAT GUATEMALAN PRESIDENT HAS ALSO REQUESTED THAT VENEZUELA PROVIDE INVESTIGATIVE RESOURCES TO CAPTIONED MATTER (VENEZUELANS IN THE PAST, HAVE BEEN INVOLVED IN TRAINING OF

GUATEMALAN POLICE IN VARIOUS POLICE TECHNIQUES AND ARE WELL
THOUGHT OF AS INVESTIGATORS). TO DATE NO VENEZUELAN INVESTIGATORS
HAVE ARRIVED.

DLAT WILL MEET WITH GUATEMALAN FIELD INVESTIGATORS AND OTHER MEMBERS OF INVESTIGATIVE COMMITTEE ON 01/31/90 IN AN EFFORT TO DETERMINE FURTHER FACTS, AND POSSIBLY OTHER EVIDENCE IN CAPTIONED MATTER.

U.S. AMBASSADOR AND STAFF, WILL BE KEPT APPRAISED OF ANY AND ALL INFORMATION DEVELOPED IN THIS MATTER.
