DEAR CONGRESSMAN,

JOE, I AM ASKING YOU TO TAKE THIS ACTION BECAUSE, (QUOTE)STEPHEN WEMIEL AND SEVERAL SENATOR,S EASTLAND, WILLIAM ROTH(R.DEL.)AND SCOTT OF VIRGINIA SAID THE CONSTITUTIONAL OR LEGISLATIVE ACTION SHOULD FOCUS ON REMOVAL FROM THE FEDERAL COURT JURISDICTION FOR DESAGRAGATION.

THE CONSTITUTION GIVES THE CONGRESS VERY SPECIFIC POWERS FOR CONTROLLING THE FEDERALJUDICIARY. ONLY THE SUPREME COURTS WAS ESTABLISHED BY THE CONSTITUTION. ALL OTHER FEDERAL COURTS EXCEPT THE SUPREME COURT CAN BE ESTABLISHED OR ABOLISHED AT ANY TIME FOR THEY ARE LITERALLY CREATURERS OF CONGRESS. CONGRESS, IF IT WISHED, COULD BY A SIMPLE MAJORITY VOTE IN BOTH HOUSES WITHDRAW FROM FEDERAL DISTRICT COURTS AND FROM COURT,S OF APPEAL THIER POWERS TO HEAR CASES OR TO TRY AN ISSUE. ANY ISSUE WHATEVER.
