Meeting his wife, and having graduation in the Hatch Memorial Shell (only Suffolk University Class to do so).

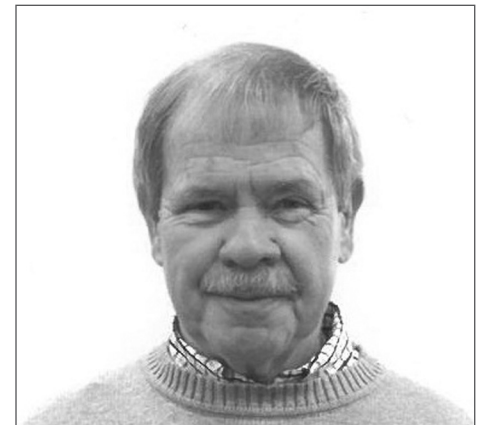
