STATEMENT BY THE SELECTMEN

We, the selectmen of the town of Farmington, herewith submit for your consideration the annual report for 1955.

Without pursuing the subject to any great length perhaps prior to the examination of this report it might be well to state the major aims and objectives of this board.

- To establish an even keel assessment and tax basis which will be fair and equitable to every property owner and thereby stabilize the economy of the community and the security of the home owner.
- To establish economical methods of transacting the town's business in order that the town might get equivalent service for every dollar expended.
- 3. To establish a well integrated forward looking road maintenance and building program which will cause every road within the town limits to receive major maintenance and repair at least once in every three year period.
- 4. To establish and implement a cooperative policy towards the industries presently conducting business in the community as well as those outside industries which might under this program be induced to locate in Farmington.

5. To establish a program to increase the local recreational facilities in cooperation with the splendid efforts of the private organizations of the town.

We feel that much progress has been made in the past year toward the successful completion of each of the above named objectives. It is of course manifest that much more can and will be done and improvements in our methods dictated by experience must be adopted in order to increase the value of what has been done as well as what is to be done in the future.

The board is very grateful for the unprecedented cooperation which we have received from the townspeople in the past year. We continue to invite your suggestions and your interest.

WARRANT

THE STATE OF NEW HAMPSHIRE

- To the inhabitants of the town of Farmington, qualified to vote in town affairs:
- You are hereby notitied to meet at the town hall in said Farmington on Tuesday, the 13th day of March next, at nine o'clock in the forenoon, to act on the following subjects:
- Article 1. To choose one selectman for three years, a town clerk, a town treasurer, two auditors, a trustee of the trust funds for three years, three budget committee members for three years and one budget committee member for one year, and all other necessary officers and agents for the ensuing year. You are also notified to meet at the said town hall at seven o'clock in the afternoon on the same date, to act on the following subjects:
- Article 2. To see what sum of money the town will vote to raise and appropriate to defray the expenses of general government as defined in the budget.
- Article 3. To see what sum of money the town will vote to raise and appropriate for the police department.
- Article 4. To see what sum of money the town will vote to raise and appropriate for fire protection.
- Article 5. To see if the town will vote to raise and appropriate the sum of \$400,00 for white pine blister rust control. The same to be expended in cooperation with the State Forestry and Recreation Department.
- Article 6. To see if the town will vote to raise and appropriate the sum of \$1,500.00 to be applied to the payments for services of a district nurse of said town, said funds to be disbursed through the Farmington Visiting Nurse Association, Inc.

- Article 7. To see what sum of money the town will vote to raise and appropriate for the health depart menf.
- Article 8. To see what sum of money the town will vote to raise and appropriate to vital statistics.
- Article 9. To see what sum of money the town will vote to raise and appropriate for summer and win ter maintenance of highways and bridges and for the general expense of the highway department.
- Article 10. To see if the town will vote to raise and appropriate the sum of \$822.05 in order to assure state aid in the amount of \$5,480.31 for the improvement of Class V highways.
- Article 11. To see if the town will vote to raise and appropriate the sum of \$2,000.00 for the Farming ton Public Library Association.
- Article 12. To see what sum of money the town will vote to raise and appropriate for old age assistance, town poor and soldiers' aid.
- Article 13. To see what sum of money the town will vote to raise and appropriate to Clarence L. Perkins Post No. 60, to be used for Memorial Day observance.
- Article 11. To see what sum of money the fown will vote to raise and appropriate for the care of parks and playgrounds.
- Article 15. To see what sum of money the town will yote to raise and appropriate for employees' retirement and social security.
- Article 16. To see if the town will vote to authorize the selectmen to hire such sums of money as may be necessary in anticipation of taxes.
- Article 17. (By request) To see if the fown will vote to raise and appropriate the sum of \$317.98 which is 1/100 of 1% of the assessed valuation of the town, to the Lakes Region Association for the purpose of publicizing and promoting the natural advantages and resources of the town, in cooperation with other towns in the Lakes Region.

- Article 18. To see if the town will vote to raise and and appropriate the sum of \$300.00 to be used in the construction of a new skating rink.
- Article 19. To see if the town will vote to raise and appropriate monies necessary in order to increase the annual salaries of the Board of Selectmen in the following amounts: Chairman—\$300.00; Members—\$200.00 each, and the annual salary of the town treasurer in the amount of \$50.00
- Article 20. To see what purpose or purposes the town will vote to appropriate the balance of the parking meter fund not otherwise earmarked, and the income over and above the maintenance expenses, in accordance with the provisions of Laws of 1947. Chapter 74, Section 2.
- Article 21. (By petition) To see if the town will vote to appropriate from the Capital Reserve Fund (Sewer Tax Reserve) the amount necessary in order to extend the present sewerage system on North Main Street from Winter Street to Warren Street.
- Article 22. To see if the town will vote to appropriate from the Capital Reserve Fund (Sewer Tax Reserve) the sum of \$300.00 for the purpose of purchasing sewer cleaning equipment to be used in the general maintenance of the sewerage system.
- Article 23. To see if the town will vote to raise and appropriate the sum of \$850.00 for the purpose of purchasing a new stage curtain and cyclorama for the town hall.
- Article 24. To see if the town will vote to authorize the selectmen to complete payment for the town roller, in the amount of \$3,480.00; and either purchase a 1 cubic yard new loader or a second hand shovel and a second hand loader, the total purchase price not to exceed \$11,000.00 in any event and to establish whether these amounts are to be borrowed by note or transferred from the Net Surplus account.
- Article 25. To see if the town will vote to authorize the selectmen to transfer from the Net Surplus

account an amount not to exceed \$3,000.00 for the purpose of making available monies to be expended in order to meet the assurances required by the federal government prior to the commencement of the Cocheco River Local Protection Project.

REPORT OF TAX REASSESSMENT COMMITTEE

At the annual meeting of the town of Parmington March 8, 1955, it was voted to empower the moderator to appoint a committee of five property owners "to investigate and study various methods used in the reassessment of towns with a view toward establishing an adequate and equitable method of property appraisal for tax purposes, said committee being charged to report their findings and recommendations at the next annual meeting."

In accordance with this vote, Moderator C. Aubrev King chose a committee consisting of the following members: George Roberts, Ronald Parrock, Francis R. Mooney, Edward Mros, Jr., and Eugene F. Nute.

Four meetings and an executive session were held by the committee. The first meeting was organizational and set a course of proposed action. The second meeting was with the selectmen of Farmington to ascertain present methods of assessmen. Philip Weymouth revealed that the selectmen use a "blotter book" containing a list of all taxable properties in town, the annual inventories, transfer cards from the Registry of Deeds and personal viewing of property as aids to determine valuations for residential and business property. Woodlands presently are valued at \$3.00 per acre.

They stated that there are approximately 1000 parcels of real estate in Farmington, of which 700 to 800 have buildings on them. In 1954 the selectmen made a determined effort to view each parcel with buildings and an agreed market value was assessed. At the request of the State Tax Commission this value was reduced by 50 per cent as the tax valuation of the property. Generally speaking, this view was an external inspection.

It was disclosed that 75 per cent of the taxpayers returned inventories to the selectmen, but because of the obsolete format of the inventories they did not reveal information of value other than stock and trade tax information.

A card file of taxable property as compiled from the blotter book is also in use by the selectmen.

The third meeting was with John Gilman, selectman of Milton, who discussed the reassessment made at Milton in 1950 and its effectiveness.

The reassessment was mainly done by one state appraiser with the help of the selectmen. It took about five months and cost \$1600.00. The appraiser established a card system using all the data obtained with one card for each individual piece of property and sent the card system to the town. It is revised and kept up to date yearly.

Total valuations of taxable property before the assessment were \$1,750,000, and after the assessment were \$2,500,000. The tax rate fell from \$55.00 per thousand to \$41.00 per thousand. Mr. Gilman thought the re-appraisal should be done every ten years as good business practice.

Lawton Chandler, chairman of the N. H. Tax Commission and Mr. Leduc, a state appraiser, attended the fourth meeting and described the state re-assessment procedure. Between 20 and 30 New Hampshire towns have been reassessed successfully with less than five per cent of complaints, which were considered and adjusted. The cost of reassessing is approximately \$4.00

per parcel of improved real estate which would cost Farmington approximately \$3200.00 to reassess its estimated 800 parcels.

At the conclusion of the meetings, a private appraisal company was contacted. Its methods were similiar to those used by the state. It estimated that the cost would not exceed \$9000.00 to re-assess Farmington.

FINDINGS:

The committee feels that the method of re-assessment as conducted by the N. H. Tax Comission is very effective and is least expensive of the methods studied, assuming that an outside agency had to be engaged to make a re-appraisal.

The committee feels that the selectmen, in 1954, have virtually made a re-assessment of the town in the course of their extremely thorough annual appraisal with the result that the appraisal values of real estate, with some possible few exceptions, are uniform and equitable and represent approximately 50 per cent of present market, values.

It feels that a re-assessment would not be of material help to the town at the present time in view of the vigorous action by the selectmen. The committee feels that information of considerable value could be obtained by revising the inventory blanks with a system of check squares to indicate the presence of bathrooms, central heating, insulation, type rooting, type siding and other pertinent information pertaining to residence and business property to help set an equitable assessment. Based on this information, the present card system could be expanded and kept timely for successive boards of selectmen.

It is believed they serve a good purpose in reminding local citizens of the danger from such fires and how they can help prevent them. The following is offered with the respectful request for publication in your town report.

BE A GOOD CITIZEN——COOPERATE

Smoking and debris burning caused more than 50 percent of the forest fires occuring in the state of New Hampshire in 1955—235 fires out of a total of 463 originated from these two sources. Lighted smoking material and matches thrown from moving vehicles along the highway or dropped by fishermen,

hunters, hikers, berry and flower pickers accounted for 26 percent; debris burning in the wrong place or at the wrong time by those who failed to heed all pleas for safety or refused to recognize the logical, sensible rules and regulations set up under legislative authority governing the use of fire in or near woodlands accounted for more than 24 percent. This is inexcusable.

Everything possible is being done officially to remedy the situation. Since 1909 there has been a statute on our law books which requires everyone to secure written permission from the local forest fire warden before starting a fire in or near woodlands or where fire can be communicated to woodlands, unless the ground is covered with snow. A never ending program of educational work is being carried on by your local warden and state officials to inform the general public both of the value and necessity of securing the required permit for such burning. Much progress has been made, but there are still many who fail or refuse to cooperate. The value of our permit system was definitely proven in this district during the 1955 calendar year. Local wardens issued 23 permits for debris burning fires. That's a lot of permits. The records show only 1 permit fire got out of control. This proves several things—while wardens were liberal in the issuance of fire permits, accomadating every applicant so far as possible, they were cautious, following closely directives outlining overall policy governing the issuance of burning permits and thoroughly instructing permit users. The latter, too, fully appreciating their responsibility in using their permits, governed themselves accordingly. Result? Much burning done legally and safe.

But what of the smokers? Despite all the efforts of those officially charged with the responsibility of preventing fires, too many were careless or thoughtless in disposing of smoking material and matches.

Why? It is difficult to say. Autos are now equipped with ash trays. Why not use them? The crushing out of a cigar, cigarette and the complete extinguishment of matches before being discarded is an easy chore.

If the costly habits of the careless and indifferent smoker and debris burner could be overcome, more than half of our annual forest fires would be eliminated. Will YOU do YOUR share to bring this about?

REMEMBER

- 1. Get a written permit from your local warden before starting your debris burning or camp fire. The law requires it.
- 2. Make certain they are dead out before leaving them.
- 3. Become a safe smoker by extinguishing smoking material and matches before discarding them.

HEALTH OFFICER'S REPORT

Foreword: The decrease of \$100. in budget appropriations for the Health Department was voted at the last town meeting. Since salaries are fixed and expenses fluctuate from year to year, the reduction affected travel and expense, incident thereto, of the health officer. Despite this economy-move, this official has made more than usual personal contribution in order that standards, built up over a period of eight years, might not be sacrificed. In this effort the health officer has received good support from town and state officials and, especially, from the public, which is the vital factor in the public health program anywhere.

The importance of trained and faithful public health administration, recognized and supported from the nation's top levels down through the smaller communities, does not appear to be shared locally, despite the fact that any grave emergency must be met and paid for.

The year which closed December 31, 1955 was an unusually demanding period, as the following statistics reflect. If we are to have new industry, taxrevenue resources and protect those we have and their employes; moreover, safeguard the operation of our schools, these factors of our community life either are insured or in jeopardy by the health environs which surround them.

In view of the apparent indifference to the importance of health work, it would be futile to out-

line a program for advancement of public health standards. However, your health officer does pledge such a program with all the implements his community provides.

My sincere thanks to all cooperating sources. Following are the statistics:

Miscellaneous complaints investigated, 315; hearings, 1; prosecutions, none; complaints outstanding, 1; polio, 3; scarlet fever, 2; miningitis, 1; mumps, 19; septis sore throat, 6; measles, 31; chicken pox, 33; occupational diseases, 5; scalp infections, 11; cancer, 2; tuberculosis, 2: pneumonia (all forms), 14: dog bite, 13: orders issued on sustained complaints, 9; permits and investigation of foster homes, 13; permits for boarding homes and/or convalescent, 1; disposal of unidentified dead animals, 47; water pollution (natural source), 1; improper food displays, 3; plumbing installations 3; welfare case sanitation, 5; barbershop inspections, 1; collection milk, water and food samples (open and packaged), 37; venereal diseases, 1. Six of the above cases of communicable diseases were by out of town physicians who treated Farmington patients. Due to reduction in budget appropriations for this department, no state-supervised meetings for instruction and training were attended; out of town conferences with officials, or hearings were not attended.
