A Model Town.

Ur among the White mountains there is a town, the metropolis of that section which is run on what in many respects is a model plan. The town is blessed with a number of wealthy citizens who are at the same time publicspirited, and politics and everything else has to take a back seat when anything for the advancement and prosperity of Littleton is at stake. They have a way there of holding a citizen's caucus just before town meeting and dividing up the offices between the two parties, selecting the men they think best fitted to administer the town's affairs. As for the articles in the warrant, they fix that up in about the same way The leaders of both parties get together, decide what they think will be for the town's interests and then go to town meeting and pull together for it. The result is apparent.

This year the same form was gone through with. The citizen's caucus nominated two Republicans and one Democrat on the board of selectmen and gave the Democrats the town clerk. When it came to town meeting, however another man was found to be in the field for selectman sgainst one of speech in which he urged this outside candidate to withdraw and thus let the citizen's caucus candidate go in without opposition, as they always had done, thus preserving harmony and maintaining this ideal system of elections. The shoe business is all right, of course, but with diversified industries the pinch would not be so strongly felt as it is when but one line of business runs a town.

The entire business will be moved to Farmington from Springfield and located in the old Waldron mill on Spring street, now occupied by Charles W. Jeaness.

In 1826 Kean was offered \$12,000 a year to go to America. In the prime of his popularity he received £200 for a week in Edinburgh, and apparently reached the highest point when Mr. Bunn wrote from the Theater Royal, Dublin, on Feb. 8, 1829, and offered him £50 a night to play in Dublin and Cork.-Liverpool Mercury.
