- Better training and counseling of health care staff working with people living with AIDS.
 - the risk for health care workers becoming infected at work is so slight that it would be "unethical" for them to refuse to care for people living with AIDS.

AIDS activists in the USA have hailed the final report to President Reagan from the Presidential Commission on the Human Immunodeficiency Virus epidemic. The report contained 583 recommendations.

Of particular interest to AIDS ACTION NOW!, the report included recommendations calling for 120 new full-time employees for research, 50 to work on the approval of new drugs/treatments, and 73 at the National Institute of Allergies and Infectious Diseases. It also stressed the important need for scientific researchers to work with community-based research initiatives.
