### GAY BROTHER MURDERED

As of this writing, details on the recent murder and assault of two patrons of the Other Side are still somewhat nebulous. The story from different credible sources is as follows. . .The two victims met shortly before the bar closed. They were approached by the six assailants and invited to a party with promises of "booze, some pot and a lot of fun." The eight men left the bar and drove around the areas of Forest Hills and Jamaica Plain.

The driver of the vehicle stopped near a rear entrance to the Arnold Arboretum at South and Bussey streets. The eight sat and conversed until one of the six yelled: "Now" and began their attack. Both victims were repeatedly beaten and struck with clubs, knives and an assortment of other weapons. The victims were then robbed of cash, wallets, jewelry and watches.

The six men dragged the two bodies to a sewer main at the edge of the Arboretum. The two men were then dropped through a 27-inch opening into the deepest section of the sewer. The cover to the sewer was replaced and the six fled.

The one conscious survivor waited until he was sure his attackers were gone before yelling for help. After an undetermined amount of time an unidentified motorist passing by heard him and stopped.

Police investigating the crime discovered several sticks covered with blood and have few details to go on. The survivor was only able to describe two of the assailants. One was about 21, with curly black hair. The other was 5'9", very skinny with long red hair over his shoulders. The car was described to be "a not too new but not too old, compact with a very clean interior."

The survivor of this heinous crime was admitted to the hospital with multiple contusions and has been listed in fair condition. The other victim was pronounced dead on arrival at the hospital. The medical examiner stated that the dead man inhaled a combination of mud and water and then suffocated after being thrown unconscious into the sewer.

If you have any information that might help the police in apprehending these killers of a

gay brother, you are asked to contact Det. Sgt. Daley of Homicide Division or Det. Sgt. Arnold White at Station 13 of the Boston Police Department.

**Ed. note: two suspects have been arrested in connection with the case.**

### A PLEA FROM HCCHS

The Homophile Community Health Service is in immediate danger of closing due to serious financial difficulties.

The non-profit agency, incorporated as Counseling Service, Inc., has served the gay community for three years. It has provided gays with low cost therapy, as well as providing a broad range of educational and social welfare programs. The staff -- composed of qualified professionals, paraprofessionals, and mostly volunteers -- has both a local and national reputation for the quality of its services.

It would be a major catastrophe for Boston area gays if these services (paid for almost entirely by our clients) had to be discontinued due to lack of funds.

One thousand dollars must be raised by the end of this week:

for rent, and for telephones used for client services and our phone counseling program. Other monies are needed to ensure continuance beyond this week.

### CSMH AUCTION

Saturday's auction festival to benefit the Charles St. Meetinghouse, the kickoff event in a \$25,000 fund raising drive to keep CSMH open, was financially disappointing for the church. With a goal of \$4,000 for this event, the net proceeds of \$651 (gross \$850) plus donations, only brought a total of slightly over \$1,000.

Rev. Gibson stated that the major difficulty was the lack of attendance, especially at the afternoon auction.

Due to the small turnout, many valuable items were auctioned off at ridiculously low prices - the most notable being a male nude painting by Frank Cooper valued at \$125 sold for \$4. Other exceptional bargains were a \$60 Mudflat pottery course for \$18, a Robert Lowell first edition for \$4, and a parakeet & cage for \$5, (which did not even cover the \$7 cost of the bird, which the auction organizers bought to go with the donated cage).

The highlight of the auction was the sale for \$125 of a solid mahogany desk donated by a Beacon Hill doctor. Sidelights were a kissing booth (sign reading: "We also make house calls.") and the sale of CSMH t-shirts.

Day long entertainment included, among other things: readings by a Pulitzer Prize Candidate, George Haden; Maruga, a Rock, Jazz band; Operatic Baritone Antonio Franco; classical guitarist Josef Groden; the Elm Seed Theater & Resonance, a jazz group.

The evening session was better attended, and therefore the bidding was more competitive.

Jack Powers, a member of the

CSMH board of Trustees, a financial Chairman, and head of the fund raising drive, felt that an important reason for the financial disappointment was the lack of support from the Beacon Hill community. This is intensified by comments made to him by influential Beacon Hill residents such as "No one will come to the church now that the fagoots have taken over", to extremes such as people are "hoping for a murder at the church to close it down." Yet Powers was encouraged by the work & support of church members, donors of articles and the Gay Community for their support. Gibson and Powers agreed that much was learned by this event concerning auctioneering and fund raising in general. With this experience, future auctions and rummage sales are being planned for the summer.

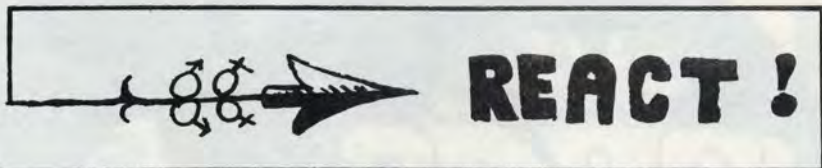

True, the moderator helped in shaping the bad portrayal made on MASS. REACTION, but we certainly presented him the opportunity. . .

**TO THE EDITOR:**

Last month's anti-obscenity ruling by the Supreme Court declared that obscenity is to be defined according to local standards. Predictably, purveyors of gay pornography are hit first and hardest. It seems that there are plenty of localities where the very idea of male/male or female/female sex is ample definition for obscenity.

However, there are some places - Beacon Hill, Fire Island, Provincetown, etc. - where local standards are substantially different. It would be very interesting to see the stores in these areas barred from selling such "obscenity" as PLAYBOY, ESQUIRE, FORTUNE, THE PILOT, and THE CHRISTIAN SCIENCE MONITOR. Of course, this sort of censorship would be no better than that which attacks gay pornography, but it might serve as the basis for a test case which would point out the fact that any censorship is a violation of human rights.

# THE HOSSENPFEPER ~column~

Last week the column dealt with movies, this week it's television; I just keep hitting until somebody listens.

I went to MASS. REACTION last week, with the purpose in mind of simply evaluating the program. Prior to air time the audience was informed that any question whatever could be asked; the presence of the sportscasters was apparently not to be construed as an attempt at pre-censorship, or direction of the questioning.

Throughout the first half, questions of all types were asked, and dealt with quite reasonably by the panel, including the propriety of hiring a queen as newscaster. Then, a specific complaint concerning coverage of the gay community was brought up and immediately put down by Chuck Scarborough, saying that two weeks earlier, virtually the entire program was gay-oriented. He then called for the next question.

Up to that point I was rather impressed with the show, but I could not countenance the obvious attempt to silence the gay contingent. This was the first question of the evening which did not receive a satisfactory answer and I could not let it pass unchallenged. My statement several minutes later that one program alone does not fulfill their obligation to us was dealt with in exactly the same way, Scarborough's response being, "Next question, please."

If Channel Seven no longer wants gay people on MASS. REACTION, they'd better give us an alternative. If they want to deal with different topics in different weeks, they would be wiser to announce so in advance, rather than merely load the panel and expect the questions to be directed thereby. If the ticket said "MASS. REACTION - Sports" I would have been happy to comply; since it didn't, they had no right to try to direct our queries.

## GAY RAPS CONTINUE

There are three weekly rap groups for gays now being held in the Boston area. The first, for women, is held by the Daughters of Bilitis Tuesday nights at 7:30PM at 419 Boylston Street, room 323. Ring the bell three times to get in the building.

The second group, which is for men only, is held Monday nights at 7:30PM upstairs from the Charles Street Meetinghouse, 70 Charles Street.

The third group, open to both men and women, is held also at 419 Boylston Street, but at room 509, ring the bell five times to get in. This rap is also Tuesday night at 7:30PM. It is sponsored by the Homophile Union of Boston and will be in their new rap lounge.

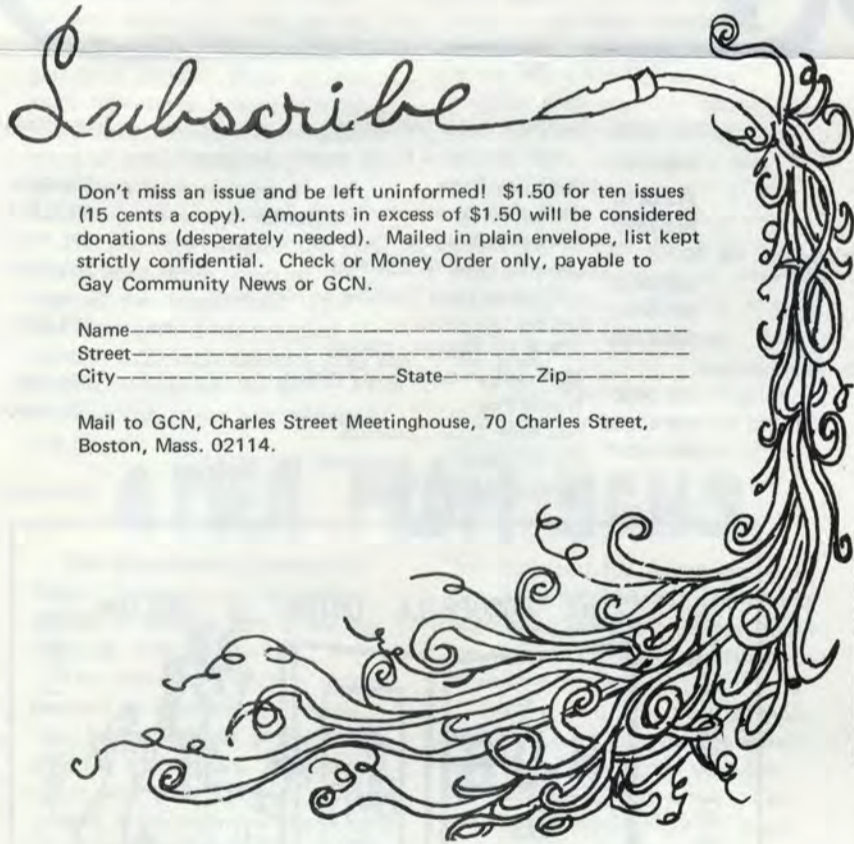

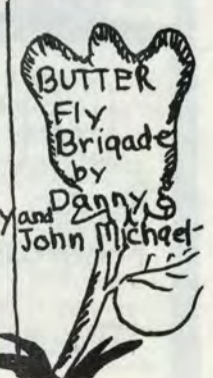
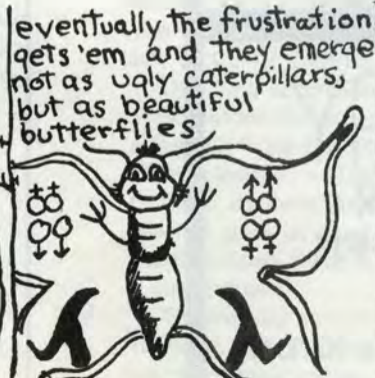
