Sciences to be largest building on campus

Design documentation has been completed for the new \$10.2 million sciences complex, which will be the largest building on the Cameron campus.

The two-story complex, 81,086 square feet, will be larger than either of the Shepler Towers.

It will be located northeast of the School of Business, where Cameron Hall was located. Cameron Hall and nearby South Hall were demolished to make room for the new building.

University officials (with architects of Urban Design Associates of Tulsa) completed the design during meetings on campus Oct. 28 and Oct. 29.

The next step will be preparation of construction contract documents with detailed specifications. University officials expect construction to begin in the spring of 1994. Officials hope the new building will be ready for occupancy by the fall term, 1996.

The sciences complex will house the physical science and biological sciences departments, eight classrooms including a 100-person lecture hall, 21 laboratory spaces including two faculty research

labs, and 24 faculty offices including the office of the dean of the School of Science, Mathematics, and Technology. The complex will also feature a computer-based tutorial lab. It will have a relatively small basement for utilities and storage.

Dr. Bob Vowell, dean of the School of Science, Mathematics, and Technology, said the new complex will feature first rate facilities comparable to those in any major university in the midwest. The complex will also provide research space for faculty members in their continuing quest for knowledge, he said.

"The new complex allows us to keep up with the current enrollment trend," Vowell said. CU enrollment in the sciences increased about 4.5 percent this year, more than in any other field.

An eight-person university committee worked with architects on development of the design. Another key member of the design team is Research Facilities Design, a San Diego firm which has designed more than 1,500 teaching and research labs.

Committee members visited similar

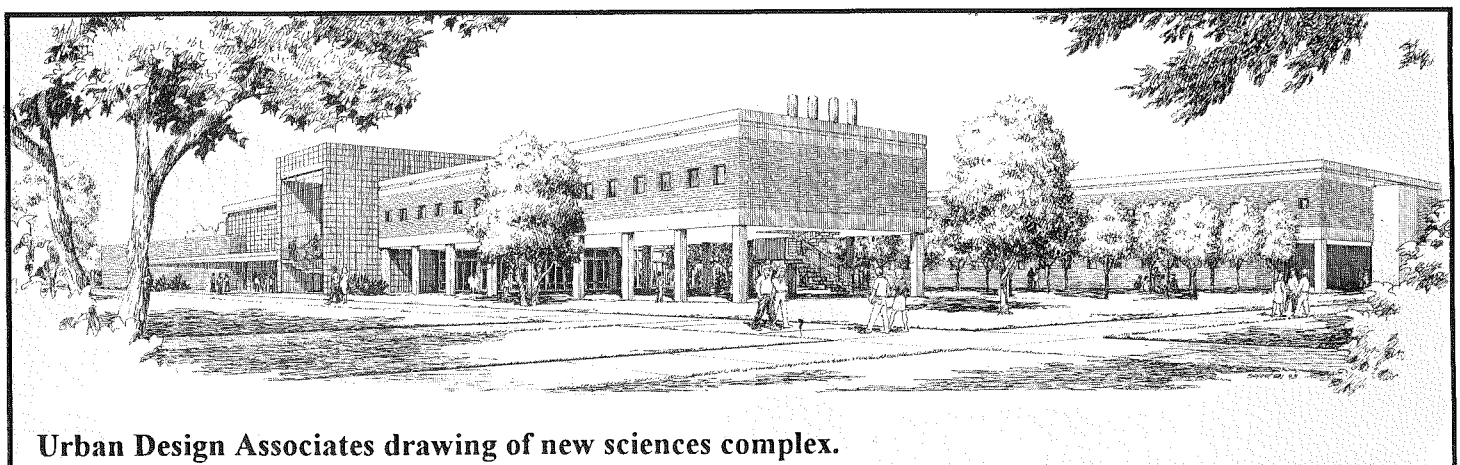
installations at the University of California at Irvine; Claremont Colleges, Claremont, Calif.; the University of California at San Diego; and Colorado College, Colorado Springs.

Committee members include President Don Davis; Dr. Terral McKellips, provost; Dr. Don Sullivan, vice president for development; Harold Robinson, director of physical facilities; Dr. Bob Vowell, dean of the School of Science, Mathematics, and Technology; Dr. Theodore Snider, chair of physical science; Dr. David Groves, chair of biological sciences; and Dr. Ira Hawk, professor of physical science.

Completion of the sciences complex design is the second of 12 university institutional goals listed for 1993-94 by President Don Davis.

Funding for construction will be from the statewide education capital bond issue voted by the people.

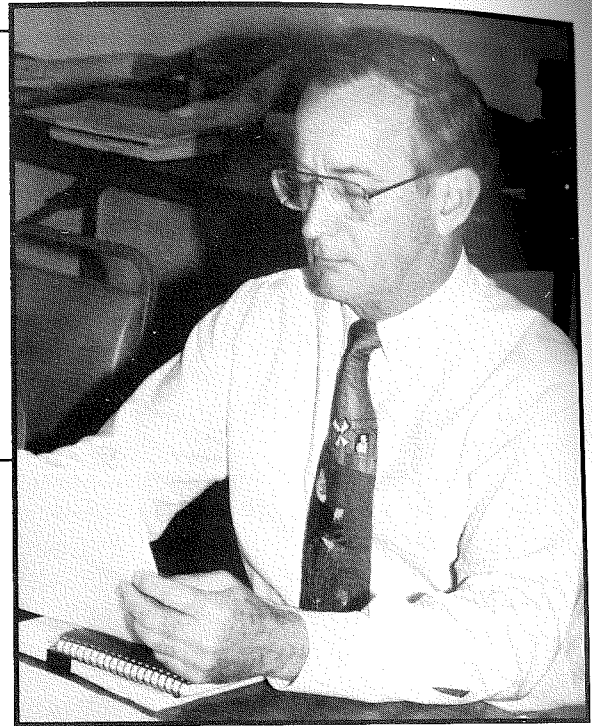
McCasland Foundation/Cache Road National Bank has pledged \$150,000 to assist in equipping the sciences complex.

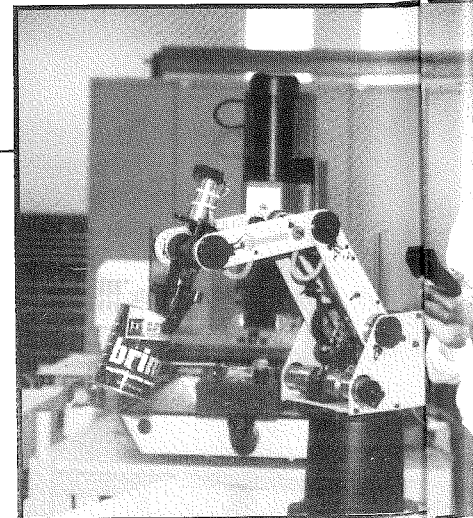


McMahon star

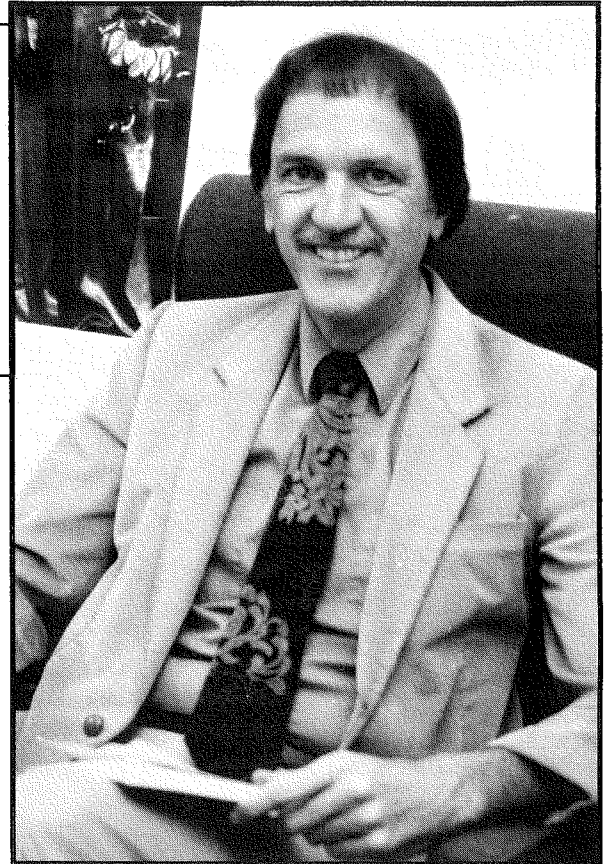
Space robots

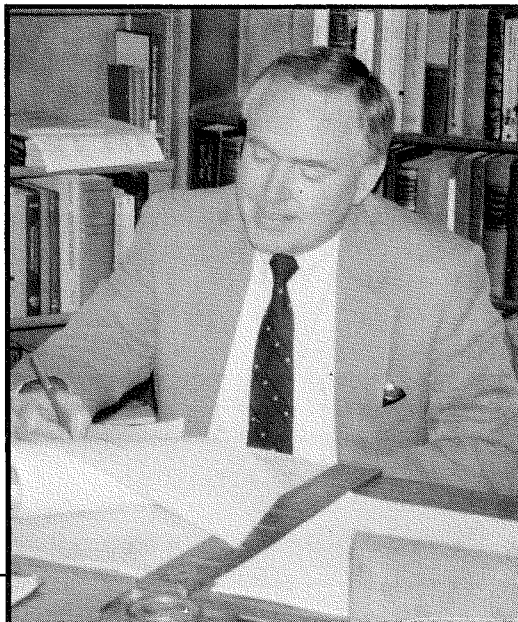
Smiley edits

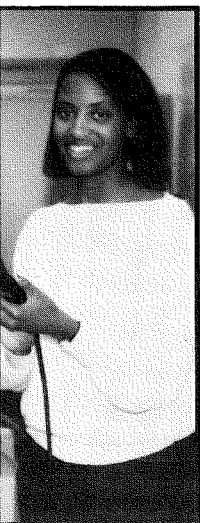
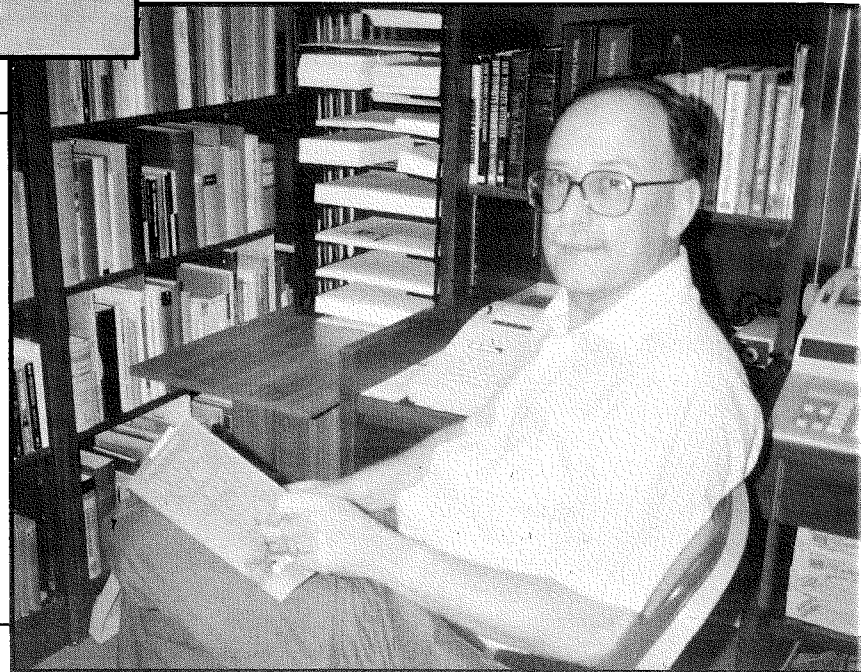
Stegmaier publishes

Commuter professor one of CU's best

"I try to treat my students the way I want to be treated. I think a sense of humor is important also. I try to be fair," said English professor Dr. Mary Allen.

Allen's classes are always the first to fill during enrollment even though the grades she gives are generally lower than the departmental norm.

In 1993 Allen received the Phi Kappa Phi honor society's Distinguished Faculty Award.

Each year Phi Kappa Phi presents this award to a faculty member who has achieved superior scholarship and promoted the intellectual life and academic prestige of Cameron.

Allen received the award after being nominated by assistant English professor Vivian Thomlinson. Thomlinson said in her letter of nomination:

"It is Dr. Allen's cheerful, loving, giving personality and her ability to explain English and make it 'do-able' to her wide audience of students that makes her the department's most indispensable professor."

Allen graduated from Duncan High School and received her bachelors degree at Wayland Baptist University in Plainview, Texas. She earned her masters at Oklahoma University, and her doctorate at Oklahoma State University.

Allen has taught at Cameron for 26 years. Before teaching at Cameron she taught for nine years in the public school system, four in Marlow and five in Duncan.

Allen still lives in Duncan and like many of Cameron's students she commutes every day. She has considered moving to Lawton, but never seriously.

"I grew up in Duncan. I still enjoy the small town atmosphere there. Sometimes the weather is not very cooperative, but the only time I could not get here was when we had a flood in the 1980s. I do put a lot of miles on cars though."

Her relationship with Duncan goes beyond that of a commuter. She is very involved with the branch campus in Duncan, where she was one of the first teachers.

"It was a brain child of Duncan and Cameron. Having the campus probably strengthens Cameron's representation and we have more students from Duncan than when I first came here."

Allen does more than just teach, she also serves on several committees, such as the scholarship and English department personnel committees.

She is also the supervisor of entry-level teachers of English.

"We have a committee that observes the first year teachers before they get their teaching certificate. I've had teachers in Healdton, Apache, Anadarko, Ringling, Duncan, Lawton, and other area towns. It helps me keep up with what is going on in the public schools."

Many of the teachers Allen has helped now consider her their

mentor.

Thomlinson said:

"I know several teachers in area public schools who credit Dr. Allen with inspiring them and providing an exemplary role model as a professional teacher. When she does a speaking engagement there is always a line of her former students--now teachers--waiting to greet her and reiterate just how important a role model she has been for them."

Allen attributes her 26 years of teaching to the people she works with.

"I've lasted as long as I have because of my great colleagues. I've also gotten a great deal of support from the administration. It is good to have great people to work with."

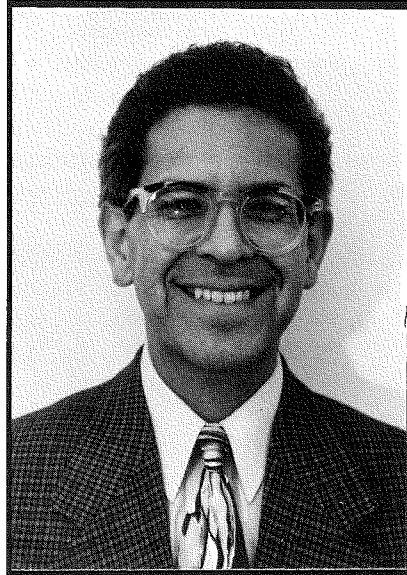

Festival II features stunning diversity

CU's year-long Festival II: A Celebration of Diversity, is well under way, with a stunning variety of projects, from lectures, concerts and art shows to new course offerings, quilting, a cookbook, and construction of a Unity Garden.

The year-long festival celebrates the diverse cultures that enrich America.

Dr. Ramon A. Gutierrez of the University of California, San Diego, will speak Feb. 14 at University Theater. An authority on Latin-American history and ethnicity, he is the author of "When Jesus Came the Corn Mothers Went Away: Marriage, Sexuality and Power in New Mexico, 1500-1846." The book was published in 1991 by Stanford University Press.



Gutierrez

Gutierrez, born in 1951 in Albuquerque, N.M., is a graduate of the University of New Mexico. He earned a Ph.D. in history at the University of Wisconsin, Madison. He is the second of three internationally recognized diversity experts appearing this school year at Cameron in the McCasland/Cache Road Bank lecture series.

The first was Dr. Henry Louis Gates Jr., African-American studies scholar from Harvard University. Gates spoke to a full house at University Theater Sept. 24.

The third McCasland lecturer will be Cornel West, premier African-American philosopher and director of the African-American Studies Program at Princeton University. West will deliver the keynote lecture at the Festival II academic conference in April 1994. A national call for papers has been issued. The conference, highlighting the year-long celebration, will explore diversity in history, the college classroom, the business environment, and the community.

The history honor society, Phi Alpha Theta, will host the Gutierrez free lecture and a reception in the art gallery.

Dr. Janet Spence, psychologist at the University of Texas in Austin, spoke Nov. 15 at Cameron regarding changing male and female roles. Her topic was "You've Come a Long Way Baby--But Where Are You Going From Here?"

Following are Festival II updates from coordinators Dr. David Carl and Dr. Sally Soelle:

Greenwood Art Exhibit ☼ Slated for display three weeks in January, "Greenwood: From Ruins to Renaissance," features 42 photos in 33 frames of the Greenwood African-American community of Tulsa. The display records the history of the community that at its peak was called the "Black Wall Street of America." In three days of race riots in June 1921, 35 blocks of Greenwood were demolished. The exhibit includes three videotapes.

Chinese Folk Art Exhibit ☼ This three-week exhibit is slated in February. "The Good Earth: Folk Art and Artifacts from the Chinese Countryside," includes 25 large paintings and 15 children's toys and clothing articles that represent daily life in rural China.

Ramon Gutierrez lecture ☼ The free lecture at 7:30 p.m. Feb. 14 in University Theater will be followed by a reception in the art gallery, hosted by Phi Alpha Theta, the history honor society.

Diversity Quilt ☼ The Festival II commemorative quilt will use the Festival II logo as its center, and will include 12-inch squares from individuals, clubs and other organizations. Jan. 17 is the deadline for completing squares. Louise Brown, vice president for student affairs, is coordinating the quilting.

Unity Garden ☼ Landscape specialist Hugh Payne has prepared plans and cost estimates for Unity Garden, tentatively to be located between Nance-Boyer and West Hall. The garden will be partially paid for from proceeds of a Festival II cookbook produced by Cameron employees. Cameron University Foundation, Inc., and private donors, are also contributing. The garden is to be a place of tranquil and quiet reflection, and a tangible and permanent reminder of Cameron's efforts to raise awareness of multiculturalism.

Curriculum Changes ☼ Cultural diversity course offerings will increase from 11 in the fall semester to 29 in the spring 1994 semester. New course offerings are the result of strictly voluntary efforts by faculty and students and will have a permanent impact at Cameron, said Dr. Terral McKellips, provost. New courses on African-American history, American Women, the American Indian, and intercultural communications are among those already approved as permanent by the state regents.

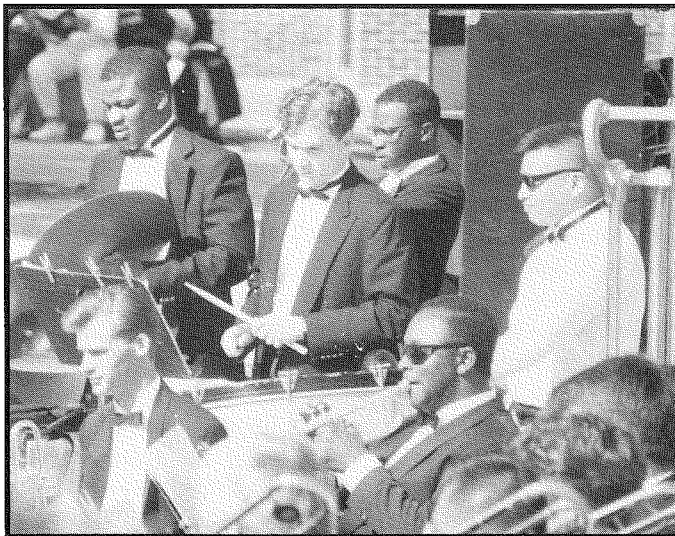
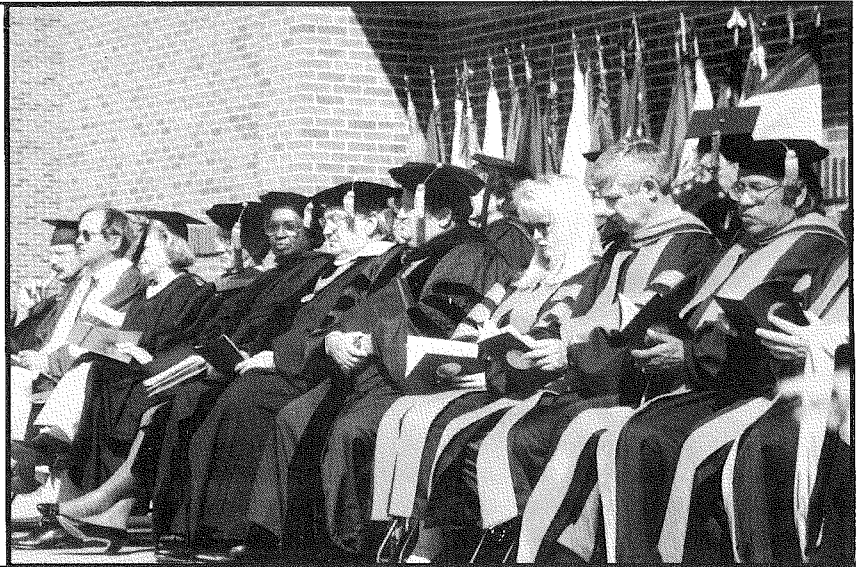

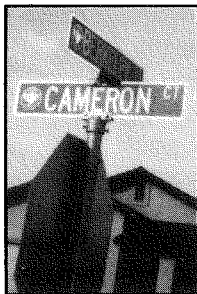
