University honors Bentley, Burgess, Kinzer

OU President Emeritus Paul Sharp stressed quality education at the annual Academic Convocation Oct. 7 as three leaders in higher education were honored with distinguished service awards.

Weather forced the faculty and honorees in academic regalia to rally in University Theater rather than the courtyard for the annual ritual renewing commitment to the goals and ideals of the university.

In higher education, there is no word more meaningful than quality, Sharp said. He added that the university's job is not to be a Utopia but to present a quality education to its students.

He listed three ways to improve quality:

1. Encourage renewed emphasis on effective teaching.
2. Renew preparation for citizenship and service to society.
3. Rediscover a sense of community on campus.

President Don Davis presented Cameron's highest honor, the Distinguished Service Award, to three individuals. They are Stephen F. Bentley, co-publisher of The Lawton Constitution; Bill W. Burgess Jr., attorney; and Dr. Joe M. Kinzer Jr., president of Northern Oklahoma College at Tonkawa.

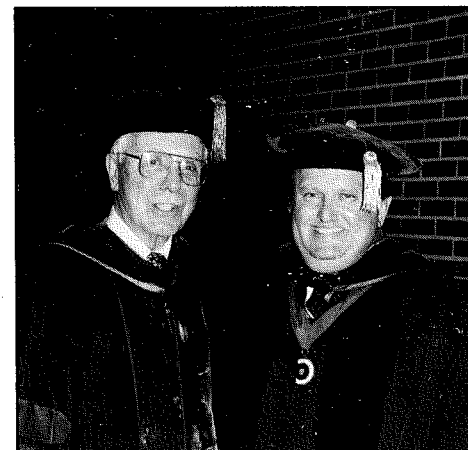
Bentley is the first Lawtonian ever to serve as a member of Cameron's governing board. He was appointed to the Board of

Regents for the University of Oklahoma and Cameron University by Gov. David Walters in 1993.

Bill W. Burgess Jr. is senior partner in Lawton's Burgess Law Firm and is CEO and chairman of Vortex, Inc. investment company. In 1993, the Cameron alumnus was

appointed to a nine-year term on the Oklahoma State Regents for Higher Education, the state-wide coordinating board which allocates funds to all Oklahoma colleges and universities and is responsible for program approval. He is one of the youngest to serve on that board.

Dr. Joe M. Kinzer Jr. has been president of Northern Oklahoma College at Tonkawa since 1990. He has also been business school dean at the University of Central Oklahoma in Edmond and was a member of the Cameron faculty. He grew up a few blocks from the Cameron campus and earned an associate degree at Cameron. He was a founding director and chair of the board of the Association of Collegiate Business Schools and Programs.

Electronics will revolutionize

Cameron Provost Dr. Terral McKellips in his call to convocation Oct. 7 equated the electronics revolution with the invention of reading and writing and the printing press, and said the effect of electronics will be even more profound.

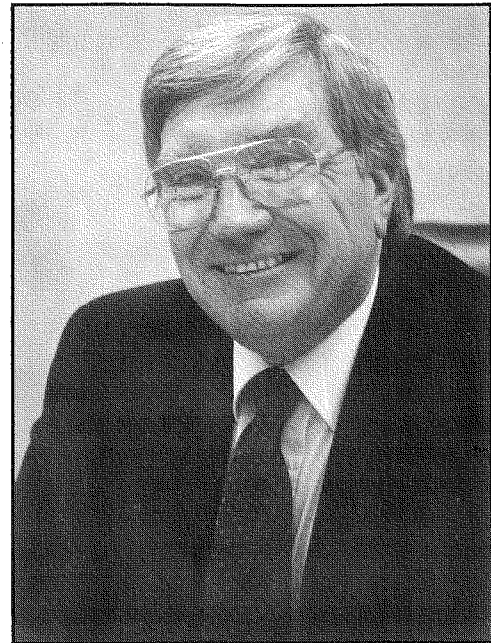
He said the information highway will radically alter forever the processes which support learning, research and knowledge preservation, and warned that the revolution will meet resistance.

He declared that Cameron University will make a new institutional commitment to explore every educational advantage of "this latest of the three greatest inventions of humankind."

Following are excerpts from his call to convocation:

...At the mid-point of this decade of excellence, we have begun to recognize that some of our fundamental assumptions with respect to the processes by which we conduct all of our academic pursuits must be seriously reconsidered. Through every period of recorded history, human knowledge has expanded. And throughout history, powerful societal institutions have acted to control the rate of such growth, sometimes to suppress or halt the rate and at other times to stimulate it.

Two momentous achievements stand out in the history of knowledge and stimulated exponential growth rates which all of the entrenched bureaucracies, religious, political and educational, were powerless to suppress. The invention of writing and reading was the first of those events and the invention of the printing press was the second. Those two inventions produced immeasurable benefits for all humankind. But initially there was resistance by all of the bureaucracies, including portions of the academy, to integration of those two magnificent inventions into their systems of information control and dissemination. Segments of the academy foresaw that the processes by which the academy fulfilled its mission would be forever radically altered and that such alteration would be accompanied by loss of control and

shifts of power. Even the academy's most thoughtful members expressed reservations.

On the invention of reading and writing, Socrates indicated his agreement with the position taken by Thamus, the king of Egypt, when he reproached Thoth, the Egyptian god who invented hieroglyphics with these words "This discovery of yours will create forgetfulness in the learners' souls, because they will not use their memories; they will trust to external written characters and not remember of themselves. The specific which you have discovered is an aid not to memory, but to reminiscence, and gives your disciples not truth, but only the semblance of truth, they will be hearers of many things and will have learned nothing; they will appear to be omniscient and will generally know nothing; they will be tiresome company, having the show of wisdom without the reality."

Now, as we near the 21st century, we are perfecting a third invention which is encroaching on our traditional processes and established systems and is sometimes resisted with warnings similar to that of Socrates.

I have absolutely no reservation in predicting that the total effect on individuals and all societal institutions from the invention and widespread implementation of the electronic storage, retrieval and transmission of information will be even more

profound than either of those first two inventions. And within the academy, the transformation which is being wrought by the information highway with its capacity to provide interactive access to all of the world's storehouses of knowledge and to facilitate exchange of information among people all over the world will radically alter forever the processes which support learning, research and knowledge preservation.

With this call to convocation, we publish a new



declaration of institutional commitment. We will explore every educational advantage which potentially can be extracted from this latest of the three greatest inventions of humankind. We commit the human and fiscal resources of the university to that effort and we will support every reasonable and sustainable undertaking which promises to capitalize on this advancement to increase the rate of dissemination of knowledge.

Cameron hurtles into information superhighway

Cameron University with more than 500 personal computers on campus, and with 300 accounts on the Hewlett-Packard 9000 (CU's gateway to Internet), is headed into the great information highway of the future.

OneNet, started in July 1993, is expected to expand quickly through the state. It is backed with \$14 million in capital bonds approved by voters in 1992. The OneNet "backbone network" will connect all state communications systems including schools, doctors, businesses and government offices. The OneNet expansion was adopted by a legislative advisory committee Nov. 4.

OneNet, the statewide "backbone network," will connect all the state's telecommunications systems.

State Rep. Danny Williams, D-Seminole, leader of the legislative advisory committee on state data processing and telecommunications, predicted:

"... We will have accessibility for every person in the state to the latest technology available in the information age."

The goal is to link the 1,850 public schools with libraries, health care centers, state agencies, universities, and many businesses, said Mike Erhart, manager of information systems at the State Regents for Higher Education.

The system will revolutionize education. High school students using personal computers will be able to take college courses without ever entering a college campus.

The system will have 33 work station "hub" sites, including one on the Cameron campus.

"OneNet allows us to connect to Internet," said Debbie Goode, Cameron director of computer services. Internet is the superhighway that leads to libraries and other endless worldwide information. It will bring global resources to the classroom. Currently, it

consists of 5,000 connected networks extending to all seven continents.

Cameron pays OneNet an annual fee to provide access to Internet, and there is no charge to the Cameron user. Computer Services will set up an account for faculty, staff, or currently enrolled students wanting to enter the superhighway.

In early 1995 Goode, Greg Duncan, academic computer lab manager, and Cheri Frazier, coordinator of Instructional Technology, will offer a course, a self-paced tutorial road map to the super information highway. The program was developed by an individual at the University of Alabama and consists of several lessons, all of which the user can study on his or her personal computer without ever seeing the instructor.

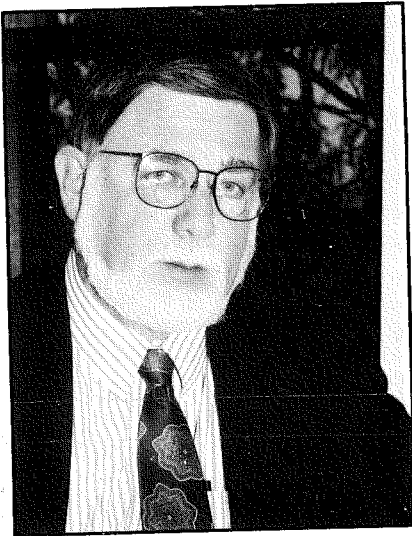
Goode predicted that many people will come to their Cameron computers at night in order to study the course.

The university is in the process of developing specifications for Fiber Optic cable to connect all campus buildings. The investment in Fiber Optic will cost many thousands of dollars, but will carry unlimited traffic to the superroad of the future.

Cameron's determination to drive the information superhighway is indicated in the 1994-95 university goals announced by President Don Davis. Ordinarily, the university establishes 10 major goals annually. For this academic year, the number expanded to 17. Coincidentally, seven of the 17 goals involve computers and telecommunication. These vary from installing a system to deliver telecommunications to the Duncan Higher Education Facility to upgrading the writing lab in the English department, and making general information available electronically to students, faculty, staff and alumni. This information would include the campus catalog, upcoming events and university publications.

Cardwell to direct Festival III year of science

Dr. Scherrey P. Cardwell has been appointed to the McCasland/Cache Road Bank Endowed Chair and will plan Cameron's Festival III scheduled for the academic year 1996-97. The theme for the academic symposium will be "Science and Technology: New Eden or Armageddon?"

Cardwell has been a member of the Cameron faculty 21 years. He holds the rank of professor and is the chair of the department of English.

Cardwell earned a B.A. from St. John's College and his M.A. and Ph.D. degrees from the University of

Arkansas.

Dr. Sally Soelle was the first recipient of the McCasland/Cache/Road Bank Chair and served as co-coordinator of the 1993-1994 Festival II: A Celebration of Diversity. Soelle helped organize the McCasland Lectures in the Humanities which brought three internationally known scholars of multiculturalism to the campus. She organized events and coordinated fund raising and promotion of Festival II.

The McCasland chair was approved in January 1994 and is one of six Cameron University endowed chairs. Each chair has a \$500,000 endowment. The McCasland Foundation in addition to endowing the chair has supported purchase of equipment for the new sciences complex at CU, has provided scholarships for Cameron students, and funded the McCasland lecture series.

The latest of the six Cameron endowed chairs is the Virginia Brewczynski chair presented by the Lawton Retail Merchants Association June 1, 1994. The other five chairs are the Independent Insurance Agents Endowed Chair, the Clarence E. Page Endowed Chair; the Dr. Joseph H. Mullin Chair in agriculture; the Mary Dixie Mullin Chair in the Sciences; and the McCasland/Cache Road National Bank Chair. Total value of the chairs is \$3 million.

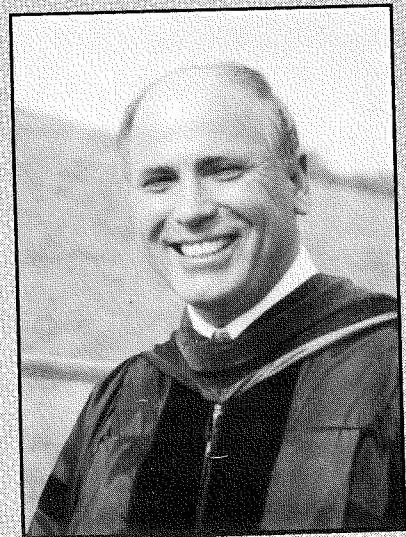
Jack Hickman Award established

The Jack L. Hickman Award has been established to honor the late sociology professor.

Dr. Hickman, 54, professor of sociology at Cameron University for 18 years, died Oct. 28, 1994 following a lengthy illness. The department of politics, sociology and criminal justice established the award, which will be administered through the Alpha Kappa Delta Sociology Honor Society for which he was the advisor for many years. Contributions to the award fund can be made to Alpha Kappa Delta in care of Dr. Karen Youngblood. The award will be presented annually at the School of Liberal Arts awards banquet.

Hickman was the first departmental chair of the department of sociology. Much of his work was focused on survey research in Southwest Oklahoma. He conducted surveys for United Way, the City of Lawton, and a major Lawton bank. He was president of Oklahoma Sociology Association for the past year.

Dr. Hickman was a veteran of the Army. He attended Brigham Young University and earned his Ph.D. from Utah State University in 1979. He was bishop of the Church of Jesus Christ of Latter-day Saints, 2nd Ward, Lawton.

Ag student receives highest FFA award

Brian Johnson of Gotebo, one of 103 majors in Cameron's flourishing agriculture department, has been awarded the Future Farmers of America highest honor, the American Star Farmer Award. One individual in the nation is awarded the honor each year.

Johnson, 21, a junior majoring in animal science, received the award for his accomplishments as an agricultural leader and producer. He owns 160 acres. He rents 100 acres, and he and his father also rent an additional 1,120 acres. He raises wheat, forage and cotton crops, sheep and cattle.

Johnson was previously named regional winner in both the Agricultural Electrification and the Diversified Livestock Proficiency Awards. In 1990, he was named a national winner in the Home and/or Farmstead Proficiency Award, and in 1991 he was named Star Farmer of Oklahoma.

Johnson recently developed a fullscale stocker cattle operation and built permanent receiving and shipping pens that enabled two men to do the work of four in less time.

CU agriculture department chair Dr. Al Bennett said the study of agriculture at the university is alive and thriving even though the training of secondary agriculture teachers is being phased out. That phaseout will be completed by August 1995.

Bennett said some people in non-university circles got the completely erroneous idea that all agriculture training was being phased out. Agriculture at Cameron offers a bachelor of science degree with five concentrations -- animal science, plant science, ornamental horticulture, agriculture mechanics, and agriculture business.

The training of secondary agriculture teachers, started in 1983, drew about 35 to 40 students annually. Sixty percent of these graduated, but only 10 percent wound up graduating in the

secondary agriculture specialty.

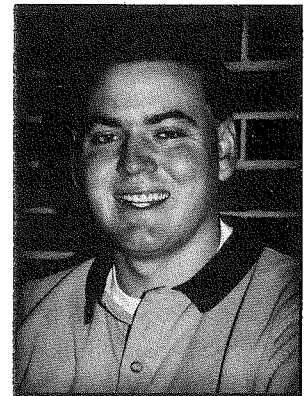
"We evaluated the program which had only 17 grads in five years, and recommended that it be phased out," Bennett said.

Agriculture has been strengthened with the \$500,000 Dr. Joseph H. Mullin Chair in Agriculture. A trust created by the late Joyce Elizabeth Hansen of Santa Monica, Calif. provided almost \$500,000 to the Cameron University Foundation, and two chairs were created, the ag chair and the Mary Dixie Mullin Chair in the Sciences. The Hansen gift was matched with funds from the state regents. The remainder of the gift will establish a scholarship program.

The Cameron ag program recently has sent graduates to graduate school; two to the environmental division at Fort Sill; eight to the huge DeKalb swine breeding operation; and others to state research facilities, the Federal Land Bank, Farmers Home Administration, and the Oklahoma State University Agronomy Department Research Center which is located south of Altus.

The program conducts an annual beef conference in cooperation with the OSU Extension Center and the Comanche County Cattlemen's Association, and conducts an interscholastics meet which draws 500 kids to the campus each April.

The program farms 80 acres on campus, west of 38th, leases pastures at Lake Ellsworth, raises cattle and sheep, and operates a greenhouse. It has six faculty members, including Bennett.

McMahon monument dedicated

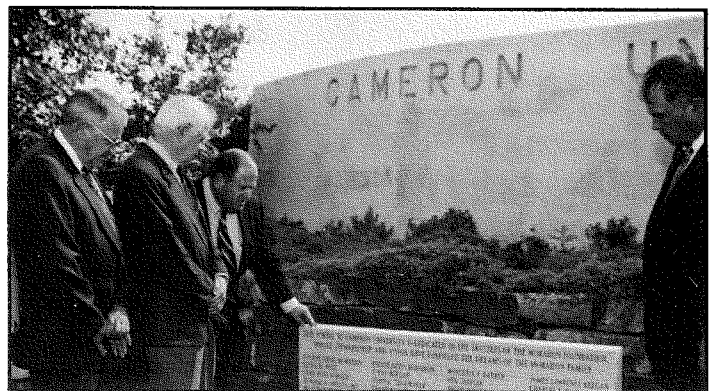
The McMahon Foundation monument at the Gore Boulevard/University Drive entrance to the campus was unveiled Sept. 13.

Unveiling the granite stone were Murray Gullatt, chairman of the University of Oklahoma/Cameron University Board of Regents; and CU President Don Davis.

The monument contains the names of past and present trustees of the foundation, and has space for future trustees.

The inscription on the monument reads, "This portal to Cameron University is dedicated to the trustees of the McMahon Foundation, whose stewardship and vision have fulfilled the dreams of the McMahon family."

A week after the monument dedication scores of McMahon scholars were honored at a Sept. 20 luncheon at Shepler Center. The McMahon Foundation provides more than \$100,000 each year for the appointment of McMahon Scholars and funding of the PLUS program. Dr. Charles Graybill, foundation board of directors chairman, and other directors attended.



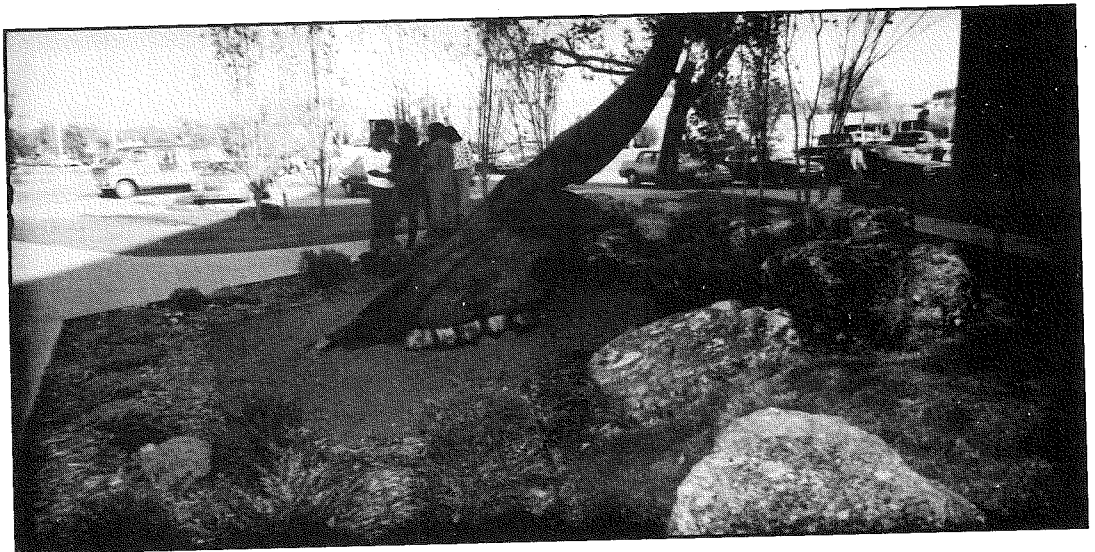

The Garden

The Jesse Davenport Unity Garden was finished in early fall as part of Cameron's Festival II - A Celebration of Diversity. Festival II was a year-long, campus-wide series of events focusing on the many cultures of Oklahoma. The concept of a unity garden was developed by Professor Rose Richardson, CU history and humanities instructor. Dr. Sally Soelle, co-ordinator with Dr. David Carl for the festival, said, "The garden was conceived as a quiet island for reflection and contemplation and also to serve as a tangible reminder of the Festival II study, and to enhance understanding and awareness of our complex diversity as a campus and community." Individuals and groups, including CU's classified staff, made gifts for the garden.

Jesse Davenport died Jan 14, 1994 at age 58. A staunch supporter of the university, he was a member of the Board of Directors of CU Foundation, Inc., the CU Alumni Association, and President's Partners. He was also the first baccalaureate degree recipient at CU.

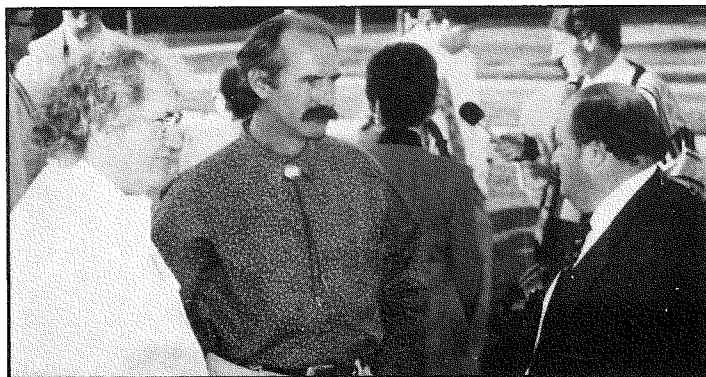

The Skull

Centerpiece of the garden is the metal sculpture of a bison skull, commissioned with \$5,000 donated by the Leslie Powell Foundation. The skull is the work of sculptor Joe Barrington of Throckmorton, Texas. Art department Professor Benson Warren won a Leslie Powell Foundation grant which funded both the artist's creation and a workshop for Cameron students during the fall of 1993. The bison skull depicts the significance of bison in the ancient ecosystems of the Great Plains, the dependence of native Americans on the bison, and the ties of Cameron and its students to these historic roots.

Jack Bryan, chair of the art department, said no preservational materials were added to the skull structure, and that the piece, like the great bison, will eventually disappear, oxidizing away over the next 100 to 200 years. "Those of us fortunate enough to observe this process will be reminded of the importance of recognizing and discussing with future generations the ideals that are vital to our culture," he said.
