CU graduates more than 700 students

More than 700 individuals from 39 states plus the District of Columbia and nine countries received diplomas at the 1991 Cameron University graduation ceremony.

Diplomas were presented at Cameron Stadium on a sunny Saturday morning, May 11. Approximately 7,000 attended.

Graduates include five from Puerto Rico, five from Korea, two each from Nigeria and Germany, and one each from Ethiopia, England, Okinawa and Honduras.

After Oklahoma, the states whose residents received most CU degrees this year are Texas, with 24, followed by New York with 11, California with 10, and Ohio and Missouri with nine each. Residents from Virginia earned eight degrees; residents from Illinois earned seven, and residents from Florida earned seven degrees.

A posthumous associate degree in nursing was accepted by Maj. Robert R. Wetzel of Fort Sill. His wife, Lisa Kay Wetzel, died April 14, 1990, only four weeks before completing the requirements for her degree.

Degree recipients included 42 masters

degree candidates. Of those, 33 received master of behavioral science degrees and nine received master of science in business degrees.

Carolyn Anne Thompson, Norman, member of the Oklahoma House of Representatives and chair of the education committee was the graduation speaker.

NCA milestone achieved

The North Central Association accreditation team will recommend continued accreditation for Cameron with no stipulations, focus visits, or required reports.

The team following its February visit further recommended that the next comprehensive evaluation be scheduled for the academic year 2000-2001.

After internal review by North Central, the recommendation will be considered for final action by the North Central Commission in August.

The visit culminated a three-year self-study headed by Dr. Terral McKellips

and participated in by almost 175 faculty, staff and students.

President Don Davis designated continued accreditation as number one of 10 goals for the university during the school year.

"I am absolutely elated with the findings and recommendations of the team," Davis said. "This is recognition by our peers from across the country that Cameron is a first rate institution in every way."

NCA team members said the university has made a successful transition to a fully accredited five-year institution.

Irene Powers Lawrence grows with Cameron

Her first night at Cameron was the second night Irene Powers, an only child, had ever been away from her mother. It was September of 1925.

Cameron was the most exciting place she'd ever been.

Sixty-six years have passed, and the campus still excites Irene Powers Lawrence.

"Cameron's progress has been amazing -- something that couldn't have been imagined when I started to school here," she said.

When she enrolled as a ninth grader in the Cameron State School of Agriculture, she was one of 60 girls who lived in Whitehurst Hall. The dormitory was a two story wooden structure with a basement, and was located near the present location of Burch Hall.

The basement housed the kitchen and dining area. Two cooks, with student assistants, provided meals for all students living on campus. There wasn't much variety in the cuisine. Toast and gravy was a breakfast staple, Irene Lawrence recalls.

Most of the students, like Irene, came from isolated rural areas that could not support a high school. Her family's farm is located four miles south of the present site of Goodyear, and she attended the one-room Pecan School.

Her parents, Clarence Lee Powers and Maud Annabell Frazier Powers, migrated from Grinnell, Iowa to Oklahoma and moved to the farm in July, 1909.

Board and room and one piano lesson per week at Cameron cost \$16.25 per month. In the spring of 1926 the girls moved to Reinwand Hall, a newly constructed brick building, located a little west of 28th street about one block east of

Whitehurst. Irene shared a "double" room with four girls.

Classes for all junior high and high school students were held in the administration building. Many students worked for board and room by feeding and watering the school chickens, gathering eggs, feeding and milking dairy cows, washing dishes, doing janitorial work, and assisting the dormitory matrons.

On Sunday evenings, members of the Lawton churches would transport students to their evening services.

"All of the students would attend. This was a wonderful service, as it enabled the students to acquire knowledge of the beliefs of the different churches," Lawrence said. "For the students who were unable to go to their homes for the weekend, it was a pleasant outing."

There were weekly assemblies, monthly meetings of two literary societies, picnics at Craterville Park, north of Cache, and visitation in the girls dorm on Friday, Saturday and Sunday evenings. Buses provided transportation to downtown on

weekends. In the fall of 1927, Cameron started its first year as a junior college, Lawrence recalled.

During the last three semesters of her junior college years, she worked in the registrar's office. She received payments, filed, and ran errands.

During the 1930-1931 school year she worked as assistant registrar, attended one class and edited *The Wichita 1931 yearbook*. She was also matron for Powell Cottage, which housed 12 girls, the overflow from the main dormitory.

She graduated from OSU in 1933 and started teaching high school subjects. She headed the business department at Lawton High School for six years.

In 1941, on the eve of World War II, she took a 30-day appointment at Fort Sill. She became a civilian personnel staffing specialist and retired in 1970 after 30 years of service.

Her husband, James R. Lawrence, also graduated from Cameron. Their romance blossomed in 1940 when he worked at Fort Sill and was sent to Irene to learn shorthand. They were married June 29, 1941.

He served in World War II and spent 21 months in Teheran, Iran, with the U.S. Military Mission. Later he became a Civil Service purchasing and contracting specialist at Fort Sill. He died April 13, 1979.

Irene Powers Lawrence is a director of Cameron University Foundation, Inc. and is also a member of President's Partners.

The first annual Irene Lawrence cash award was given last spring to Carol Claiborne as outstanding School of Business undergraduate student for "excellence in service and academic performance."

'78 alum mans radio in Alaska

Daniel L. Stephenson, D.O., 1978 graduate of Cameron, recently made good use of a Cameron sweatshirt. He wore the shirt for a week during minus 30 degree weather while manning a remote radio shack during a great Alaskan dog sled race.

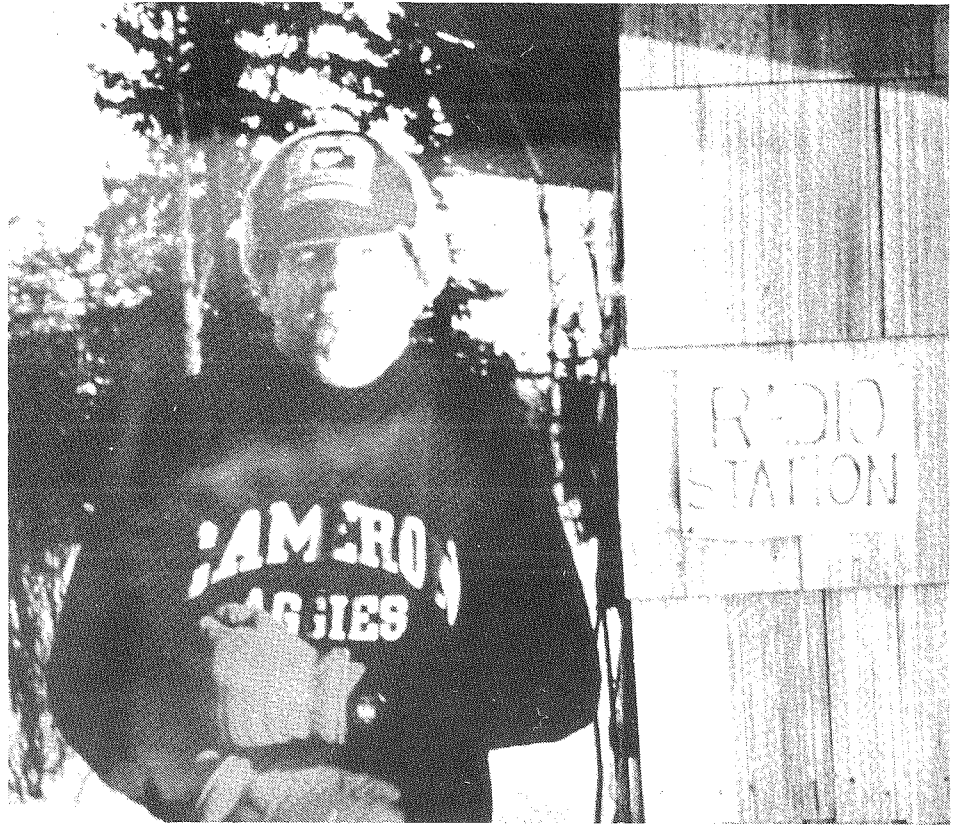
Stephenson writes:

"After graduation from Cameron I subsequently graduated from the Oklahoma College of Osteopathic Medicine and Surgery (1982). I have been in the service for post-graduate education. I have finished my payback period for these educational periods, and am soon to practice medicine in Sparta, Wis....the best years of my life were through your halls."

Stephenson now lives at 2683 Newby Road, North Pole, Alaska, 99705.

The great dogsled race commemorates an historical event in which mushers carrying the mail took it upon themselves to travel 1,100 miles carrying serum from Anchorage to Nome to halt an epidemic of diphtheria.

"Retracing the route of the original racers, mushers do it alone, without the help of relays," Stephenson writes. "Volunteers staff the race and over 1,800 people help at one point or another along the race. Veterinarians from all over the world participate. Dog handlers from all over the United States and Canada help the stations, and amateur radio operators carry their gear into remote outposts where they will establish the only communication linkage to the outside world."

The checkpoint manned by Stephenson is a cabin, some 110 miles east of Ophir. Behind the cabin is a sauna bathhouse, a small room just seven feet by eight feet in size. Inside there is a small stove that provides heat for the sauna. Outside is a little ledge for dripping oneself off and jumping into the snow. On the

outside wall of the building is a sign, "Radio Shack."

"It was there that I spent a week as the radio operator for Ophir, wearing a sweatshirt from the Cameron Aggies," Stephenson said. "It was minus 30 degrees when the picture was taken, a nice comfortable temperature for the interior of Alaska."

Oliver joins Cameron President's Partners

'41 alumni celebrate golden anniversary

W. Ray Murley and Ruby (McMurtrie) Murley, Cameron alumni of Blacksburg, Va., celebrated their 50th wedding anniversary July 12.

Both graduated with two-year degrees in June 1941. He majored in agriculture and she earned a degree in home economics. He was the outstanding graduate in agriculture for 1941.

After graduating, Murley served in the Navy for four years and then in the Marine Corps during World War II. Mrs. Murley worked in the defense plants. After the war, they attended Iowa State University, Ames, Iowa, where they both earned bachelors

degrees. He later received a masters and a Ph. D.

Murley was employed by Iowa State from 1948 to 1951, by North Carolina State University, Raleigh, N.C., from 1951 to 1965, and by Virginia Polytechnic Institute and State University, Blacksburg, Va., from 1965 to his retirement in 1980. He retired professor emeritus from the dairy science department.

Murley started a consultant service in 1980 and is still managing it as a dairy cattle nutritionist. Mrs. Murley taught chemistry at North Carolina State for several years. The Murleys have two daughters and a son.

Cameron summer enrollment increases

Cameron's summer enrollment increased 6 percent in full-time equivalency (FTE) hours over last summer. Dr. Teral McKellips, vice president of academic affairs, said it is Cameron's largest summer FTE enrollment and projected an even greater increase this fall.

As of June 18, the total FTE was 1,903, up 6 percent from June 19 last summer; graduate FTE 188, up 63 percent; and lower division FTE 1,154, up 7 percent.

The increase in full-time students means people who have options concerning where to attend school are choosing Cameron, McKellips said.

"When you look at part-time students, frequently you are looking at people who are placebound and may feel they don't have options other than Cameron," McKellips said. "But full-time students usually have a choice of where they go. I think the increase in FTE is an indication that Cameron has moved up on the list of choices."

McKellips said the university had projected an increase for this summer and next school year because of last year's

large freshman class, the largest ever (828 students), and small number of graduating seniors -- approximately 700.

"We had an unusually large enrollment of full-time freshman students last year," McKellips said. "We had a smaller graduating class this spring. When you add on a big freshmen class and take off a small senior class, you anticipate that enrollment is going to go up."

McKellips said that with higher education's stronger admission requirements and increasing tuition, students are looking for the best bargain they can find. He said he thinks students are finding Cameron to be a good bargain.

It will cost students \$6,000 to attend and live at the University of Oklahoma next year, McKellips said. Students can attend and live at Cameron for \$3,700.

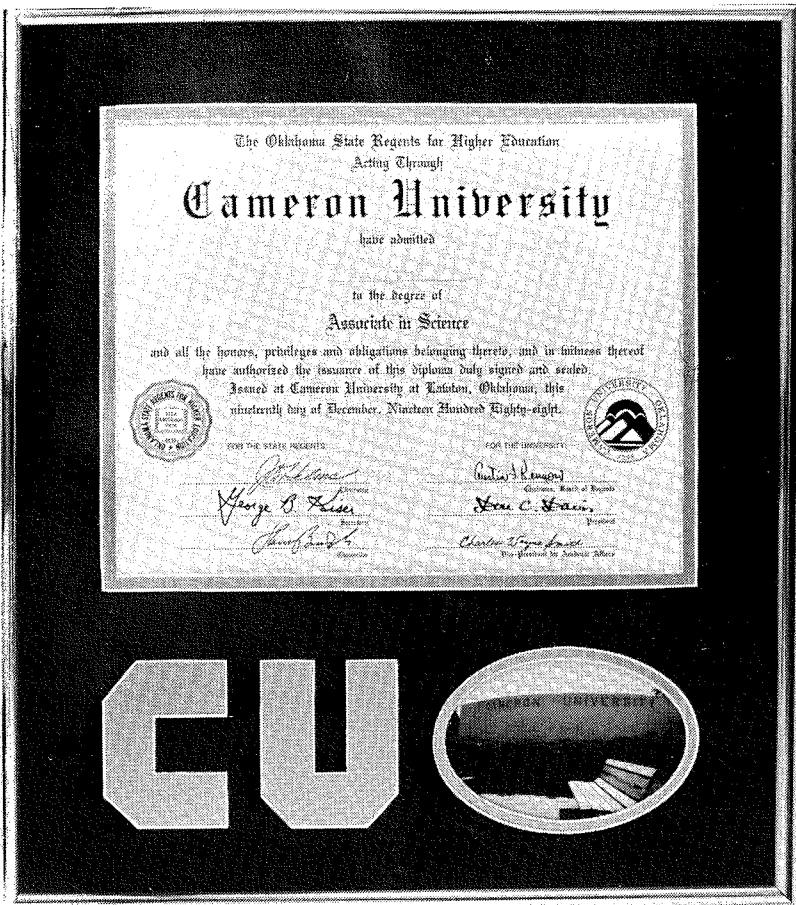
"Over the last several years Cameron has gained several recognitions that have placed it in a favorable light," McKellips said. "Students are realizing they can get a quality education and not expend the amount of funds you have to expend to go a long way from home to go to school."

McKellips said two indications -- the large freshman class last year and the increasing number of students in freshmen orientation clinics -- are the basis for the projected increase in enrollment this fall.

Enrollment figures on June 18, compared with June 19 last year, are:

Total students 2,815, compared with 2,789, an increase of 1 percent; **total undergraduate students** 2,478 compared with 2,623, a decrease of six percent; **total graduate students** 337 compared with 166, an increase of 103 percent; **lower hours** 8,653 compared with 8,113, an increase of 7 percent; **lower FTE** 1,154 compared with 1,082, an increase of 7 percent; **upper hours** 4,211 compared with 4,541, a decrease of 7 percent; **upper FTE** 561 compared with 605, a decrease of 7 percent; **graduate hours** 1,146 compared with 698, an increase of 64 percent; **graduate FTE** 188 compared with 115, an increase of 63 percent; **total hours** 14,010 compared with 13,352, an increase of 5 percent; and **total FTE** 1,903 compared with 1,802, an increase of 6 percent.

Cameron pool to be replaced

The new Cameron University swimming pool will be replaced at no cost to the university, President Don Davis announced at a press conference Friday, June 21.

The pool, inside the new \$3.2 million Cameron Fitness Center, was completed last December but developed cracks and leaks and has never been accepted by the university or used.

"The only way for the State of Oklahoma to get what it bargained for is removal of the pool and rebuilding according to specifications," Davis said.

A portion of the south wall of the building will have to be removed in order to take out the pool. Davis said the contrac-

tor, K.A. Industries of Broken Arrow, expects that the removal and reconstruction will take 90 days from the time it is started.

"We expect the work to start almost immediately," Davis said.

University officials, the architect and the contractor studied two structural options and three liner options to fix the pool. The liner options included Fiberglass, plastic, and stainless steel.

Davis said Ken Ewing, president of K.A. Industries, assured the university that the firm would do whatever the university wanted.

"The bottom line is that the pool was designed not to crack, and it was not built

in compliance with the design. All we want is a pool that has no cracks and holds water," Davis said.

The design called for a foot of aggregate rock plus three feet of select fill under the entire bottom of the pool. Tests showed that the present pool does not have fill in the specified amount.

Davis said the contractor, the architect, C.H. Guernsey, and the university have all worked in good faith to find a solution to the cracking. The contractor filled cracks with epoxy, which sealed the existing cracks, but new cracks developed almost immediately, Davis said.

"The cracks have been a nightmare for all concerned," Davis said.

Starters return for '91 volleyball season

The return of all six starters and the renewal of a Lone Star Conference postseason tournament highlight the 1991 Cameron volleyball season.

Second-year coach Kim Vinson is ready to make a run at the LSC title with a wealth of returning senior talent. Stacey Fogel, Amy Dreier, Gretchen Houston and Lisa Follett are all three-year starters. Fogel, a setter, was a second-team all-conference pick last season. Dreier, a middle blocker, earned LSC Player of the Week honors. Houston

should close out her career as CU's all-time leader in digs. Vinson's other returning starters are juniors Bette Calloway and Kim Riddle.

The Lone Star Conference coaches voted to return to a single round-robin league schedule with a postseason tournament, which will be hosted by Angelo State University. CU will compete in tournaments at Abilene Christian, St. Edwards (Texas), and defending NCAA Division II national champion West Texas State.

Gridders face comeback effort

The 1991 Aggies face the challenge of rebounding from a disappointing 2-8 record, including a 1-6 finish in the rugged Lone Star Conference.

But second-year coach Frank Crosson's 1990 nightmare could develop into the LSC's surprise squad this fall with 14 starters returning.

On offense, eight starters return to showcase a new "One-back Spread" formation. Junior running back Michael Ivory, who rushed for 349 yards last fall, hopes to return to the form that earned him the league's Freshman of the Year honors in 1989. Senior tight end Bryan Weems, who caught 16 passes for 220 yards last season, will be a third-year starter.

The loss of the entire defensive front line will burden CU's four returning backs and one linebacker. Senior safety Tommie Taylor, who earned honorable mention all-LSC honors last season, anchors that group, along with linebacker Che' Harris (68 tackles) and safety Jamal Chappell (63 tackles).

The Aggies 10 game schedule includes Lone Star powers Texas A&I (Oct. 5) and Angelo State (homecoming on Nov. 2). The non-conference portion of the schedule consists of old rivals Missouri Southern, Tarleton State (Texas) and East Central, and a first-ever meeting with Division I-AA Prairie View (Texas) A&M.

Student-athletes earn honors

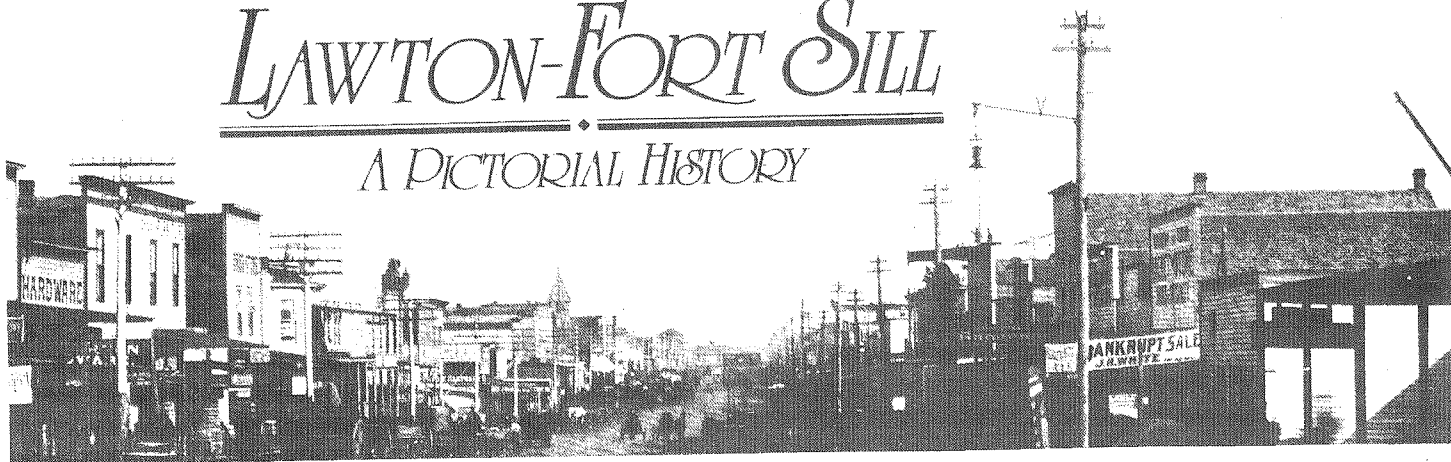

Unless stated otherwise, all courses are held on Saturdays from 8:30 a.m. to 4:30 p.m. and course fees are \$50.

Successful Resume Writing - Aug. 24. This seminar is designed to develop participant skills for writing resumes, cover letters, follow-up letters and job acceptance letters. Instructor: Dr. Jane Kerr.

Effective Job Interviewing Strategies - Sept. 7. A seminar designed for persons who are seeking a job with a focus on background information needed to answer the most frequently asked questions, appropriate image, body language and professional mannerisms for the interview situations. Instructor: Dr. Jane Kerr.

Whole Language: The What and How of It - Sept. 7. This seminar is designed to introduce the student to the whole language/integrated curriculum philosophy. Instructor: Dr. Kay W. Terry.
