Partners to help build child center

President's Partners will provide seed money to build a new home for the Cameron University Child Development Center, President Don Davis announced.

He discussed the new project during the third annual meeting of the Partners Jan. 17.

Money provided by the Partners will be used to design and help finance the construction of a state of the arts Child Development Center, he said.

Davis noted that the center provides a positive link between the university and the community. It trains future public school teachers and has an expanding mission to help teachers meet new HB 1017 requirements for teaching pre-school children.

Davis said to the Partners:

You have provided both financial and public moral support for Cameron's academic programs. Your assistance has founded new initiatives and provided boosts for existing programs. You have properly placed the emphasis on academics, which is Cameron's primary enterprise.

Previous projects funded by the Partners were the creation of an endowed professorship in faculty development, and support of the Business Research Center in the School of Business.

Davis introduced six new members of the Partners. They are Woody Oliver, Monica Moss McCasland, Milo and Jonanne Gordon, Dr. Jim and Linda Fahey, Dr. Donald and Midge Barnhorst, and Rocky Hudson of Southwestern Bell Telephone.

President's Partners now has 120 personal or corporate members. Each member pledges \$1,000 annually to the university. President's Partners is part of Cameron Foundation, Inc., chaired by Aulena Gibson.

The third annual meeting was a departure from the first two, which were banquets with guest speakers. The speaker at the first meeting was Hans Brisch, chancellor of the Oklahoma State Regents for Higher Education. The 1991 speaker was Allan W. Ostar, president of the American Association of State Colleges and Universities and father of the "interactive university" concept adopted by Cameron.

The 1992 meeting was "An Evening With Will Rogers," staged at University Theater with entertainment starring Gene McFall who has portrayed Will Rogers in 43 states. McFall's appearance was underwritten by Southwestern Bell Telephone.

The show was followed by a reception and a book signing by Joe Carter, director of the Will Rogers Memorial in Claremore. Carter autographed copies of his "Never Met a Man I Didn't Like: The

Life and Writings of Will Rogers." The festivity also featured displays of paintings of Will Rogers and the screening of excerpts from his movies.

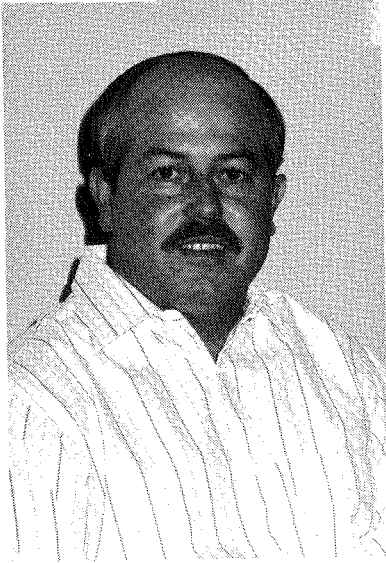
Cameron's Child Development Center, in its 19th year, is housed in an old brick residence and has inadequate instructional and play facilities, Davis said.

He said faculty and staff members in formulating a design for a new center will visit several other centers at other universities in the state.

Dr. Margie McMahan has been center director since its inception. It has one other permanent staff member, Charlotte Cranfill, lead teacher.

The primary purpose of the center is academic -- to provide experience for persons specializing in early childhood education. Student teachers and other teachers observe and receive critiques on their teaching of 4-year-olds attending the center. The center has operated mainly in fall and spring, but reinstated summer sessions since passage of HB 1017. The center has room for only the first 18 pre-schoolers on the waiting list each fall, and abides strictly to a first-on-the-list policy. The center is so popular it is booked with pre-schoolers several years ahead.

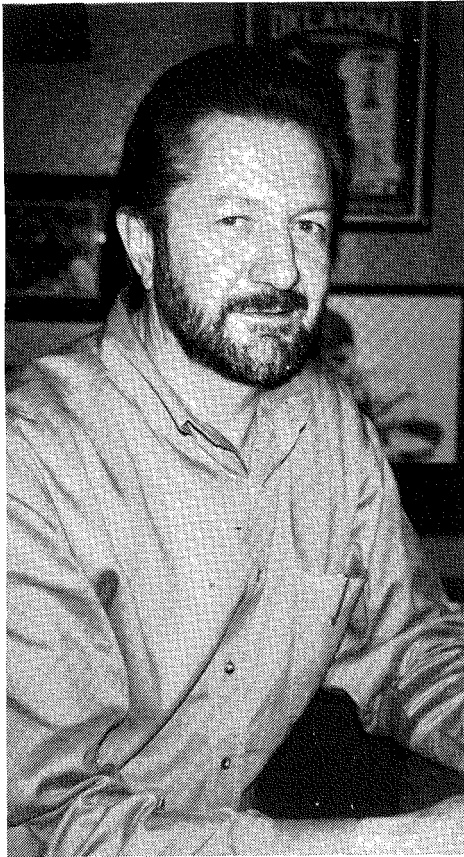

Mike reveals Sports Grille success secrets

Ninety percent of all new restaurants fail within two years. Not Mike's Sports Grille at 517 E. Gore in Lawton. Since its grand opening Nov. 9, 1989, it has become one of the most popular gathering places and eating establishments in the city.

The place is operated by Mike Underwood, who graduated from Cameron Junior College in 1967. What is the secret of his success?

"Consistent quality of food with good service and nice atmosphere," he says. You can order about anything you want. But eight or nine different chicken sandwiches are favorites with customers, and a salad centered with an eight-ounce grilled chicken breast is also a winner.

The service - to about 400 customers per week day and 600 on weekend days - is provided by 70 employees who wear sports grille logo golf shirts in summer, and logo sweat shirts in winter.

Mike's Sports Grille atmosphere includes international sports events on two 10 feet by 10 feet screens. Through two satellites, events that cannot be seen elsewhere come from around the world to the Lawton restaurant.

The atmosphere also includes college football jerseys of Thurman Thomas and Barry Sanders, donated by Head Coach Pat Jones of OSU; a dozen autographed OU footballs, dating back to 1975; an OSU autographed football from last year; and a basketball autographed by star Larry Bird.

Lawton's Randy Bass who achieved baseball stardom in Japan is donating a jersey, a baseball bat and other artifacts for a new shadow box display.

Mike's also features a dance floor and draws a club crowd at night during hours that are a slowdown period in other restaurants. After 9:30 p.m., food amounts to only 10 percent of the sales.

Mike has devised special events "nights" that draw crowds. Tuesday night features the musicians Phil Sampson and Lex Hazelwood and a gong show for amateur entertainers, with a \$50 prize to be best performer and \$50 to the worst.

Wednesday night is video horse racing night. Thursday night is "Bozo Bingo."

The grille uses a disc jockey and has been the site of a radio sports talk show.

Mike and his wife, Dorthy, have three children ages 7 to 11, but manage to keep the restaurant open seven days a week except for four days each year -- Christmas Eve, Christmas Day, Easter,

and the Fourth of July.

With so much going on so much of the time, the restaurant draws a variety of patrons varying from rabid football fans to connoisseurs of fine food and drink, to the young dancing crowd.

After graduating from Cameron Junior College, Mike Underwood attended the University of Oklahoma from 1968 to 1970. He took a commission in the Army, served in Vietnam and in 1971, returned to OU for four semesters but says he was not a "disciplined student" and he was looking for direction. In 1975 he opened Mad Dog Saloon on Cache Road in Lawton. He later remodeled it into a club, then into a restaurant.

On 1978, he ate at Butterfield's, a sprawling restaurant then operating in Oklahoma City. He thought Lawton would someday need such a place.

He patterned Mike's Sports Grille after the Varsity Sports Grill in Oklahoma City, which was patterned after a similar restaurant in Dallas.

"I didn't know anything about the restaurant business, except that it looked easy," Mike said. "It nearly killed me."

The owner of the Varsity helped him start Mike's Sports Grille.

"He started talking to me about concept. I didn't know what concept was. If I would have put in a place before I talked to him, it would have fallen on its nose."

He took great financial risk and went into major debt turning the Mad Dog Saloon into a restaurant. It has been 13 years since he ate at Butterfield's and his restaurant dream was born. Today, the dream is reality.

"We opened to a market that had been starved for a nice place, and we just got a hit," he said.

All - American O'Kelley returns as student, coach

All-American Thomas O'Kelley is back at Cameron as a student and part-time coach.

O'Kelley, who anchored the Cameron defense on the 1987 NAIA national championship team, returned to school this spring to get his teacher certification and to go into teaching and coaching.

Head football coach Frank Crosson said:

"He will be working part time with our defensive line. It is good to have somebody with his kind of experience."

O'Kelley is down from his playing weight of 280 pounds to 250 pounds. He has always been a giant, and not always a gentle one with opposing backfields.

In 1986, he registered 32 tackles and 38 assists in leading the Aggies to an NAIA runner-up season. During his senior season in 1987, he anchored the defense with 14 tackles and had 23 assists.

When he was in grade school, he was too big to play in the midget leagues, and he envied his big brother who was small and fast. In the sixth grade, his age group graduated out of the midget leagues, and he was allowed to play. After playing in high school at Burkburnett, Texas, he went to Rice University for a year before transferring to Cameron. He played three years for the Aggies, majored in health and physical education, and graduated in 1988.

He said trust made the 1987 team special. The feeling among the players was so strong that O'Kelley keeps regular contact with several including John Brandes of the Washington Redskins; Johnny Hollarn who is

assistant coach at Lawton Eisenhower, and Joe Watkins who manages a sporting goods store in Duncan.

"You didn't have to worry about covering everybody else, because you knew they could do the job," he said. "We believed in each other." He said the level of trust extended to the coaches.

"They might call a play and you might say, 'What did they call this for?' But they had been with us so long, you just knew they must have a reason for it."

O'Kelley said:

"One of my goals when I played was to give it all I had and I did, sometimes to the point they had to help me off the field after a game."

After graduation, he had a free agent tryout with the Washington Redskins. But his medical file was inches thick, and the pros don't take chances on unhealthy free agents, he said. He received inquiries from the Houston Oilers and San Diego, but declined.

O'Kelley and his wife, Lisa, have a 6-month old daughter, Brittany.

From April 19, 1989 to Jan. 10, 1992, O'Kelley worked with youngsters at the Lawton YMCA. Teaching children is rewarding, he said, especially when a child brings you a note written in crayon that says thank you.

"The funniest thing is teaching classes to little kids," O'Kelley said. "It's about doing something for kids, like having a kid who is real scared of the water and leaves two weeks later knowing how to swim. And they're not touching the floor because they're so happy."

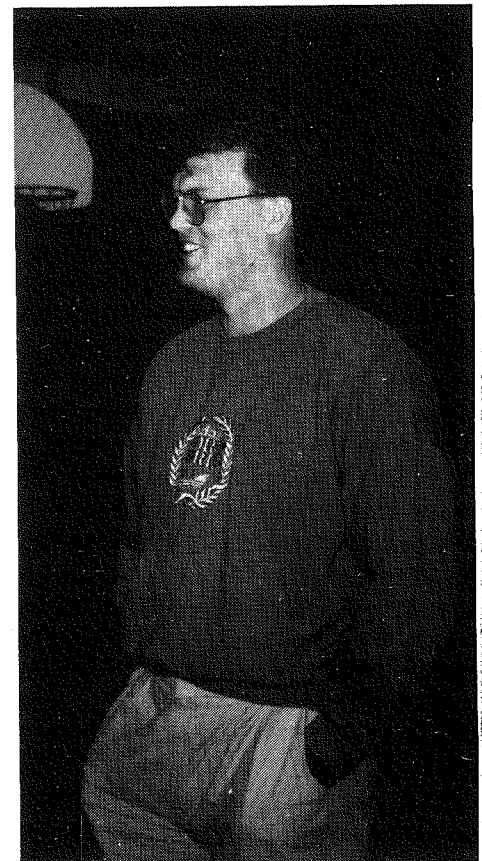
"We had a lot of kids who have no home life. They have a house to go to

and lay their head. And some don't even have that. The best part is being able to influence them and tell them that they are something." Having been a football player helps him relate.

"There are some tougher kids who, when they find out you were successful, are more apt to listen to you."

For the gentle giant, teacher certification and coaching is a logical next step from the Y.

The Cameron yearbook affectionately named him Teddy Bear. O'Kelley said he has no idea how the publication came up with the name. "It probably had something to do with my demeanor off the field," he said.
