## NEW DIRECTIONS IN ACADEMIC LEADERSHIP

### SULLIVAN APPOINTED PROVOST

Professor Gary Sullivan, who has been Director of Wagner's Theatre Program since 1987, and a member of our faculty for 20 years, has been named Wagner's chief academic officer. As Provost, he will oversee all academic areas including academic policy and planning, faculty committees, department chairs, student affairs and enrollment.

"Professor Sullivan is among our most distinguished and talented veteran professors and program heads," said President Norman Smith in announcing Sullivan's appointment. "Under his leadership, the theatre program has earned an impressive national reputation for excellence. In every way, Gary has overseen an academic program that is exemplary to our mission as a quality undergraduate teaching institution. His leadership of the College's academic life is welcomed with enthusiasm."

A part of the Wagner Community since 1975, the new Provost is pleased with the progress Wagner has made in recent years and sees a number of challenges in the years to come as the environment for higher education changes in this country. "Many colleges have become too insular and will ultimately fail because they will not hold themselves accountable for the services they provide," Professor Sullivan stated.

"I am proud that Wagner reaffirmed its liberal arts core curriculum a few years ago," he continued. "It is a curriculum that highlights the liberal arts and critical and analytical skills along with an ethical value tradition to prepare students for a lifetime of learning and careers. To insure that our 'Core' continues to prepare students for an ever changing world," he added, "Wagner will need to be constantly re-evaluating and fine-tuning the core curriculum."

Among the changes, Professor Sullivan perceives is dealing with issues of diversity, a global economy and world culture. "An essential factor in the 'small world' view," he said, "will be the continuing need to adapt to technology and for Wagner to be more proactive in its use of advanced technology."

"A Wagner education must also have a practical base that makes the theoretical classroom work more relevant," he added. "We have to

provide experiences beyond the classroom, be they with faculty through the faculty masters program or actual work experience by expanding internship opportunities and alumni networks, in addition to actual job placement."

Hiring new faculty is also an important challenge in the coming years, whether they are needed to replace retiring faculty or to meet the needs of an ever demanding student body. "Not only must faculty be outstanding in their fields, but they must fit into the Wagner community and contribute to the whole of a Wagner education."

"This is an exciting time to be



part of the academic leadership at Wagner College," concluded Professor Sullivan, "the College is growing, our budget is expanding and we are attracting some of the finest students and faculty in the nation."

## MEGERLE FAMILY MAKES A DIFFERENCE

Dr. George Megerle and his mother Dr. Martha Megerle were both honored this past spring by the College. At the 1994 Commencement exercises, Wagner presented Dr. George H. Megerle with an Honorary Doctor of Science degree.

A research scientist and past President and CEO of the Wella Corporation, Dr. Megerle has served as a Trustee of the College since 1988 and for the past several years has been a member of the Board of Trustees Executive Committee. During the past 6 years he has been among Wagner's most significant leaders and supporters.

Martha Megerle was honored at a luncheon in April hosted by President Norman Smith. The highlight of the luncheon was the unveiling of her portrait, along side that of Dr. Al Corbin '35 H'91, in Wagner's executive offices. Martha was also honored in 1989 with an Honorary Doctorate of Humane Letters.

The Megerle Family has for decades been one of Wagner's most eminent supporters, beginning with Dr. Eugen Megerle, the founder of The Wella Corporation, for whom the Science Building is named. In the 1940's Eugen Megerle and his wife Martha emigrated to the United States from Germany and adopted Staten Island as their new home. Through the Lutheran Church, they developed a lifelong interest in Wagner College.

Their interest has spanned the academic and cultural progress of Wagner including the sponsorship of the Wagner College Choir's European tours and Wagner's German programs. Their primary interest, however, has been the promotion of Wagner's science programs.

Martha Megerle along with George and his sister Eva, who is also a Wagner Trustee, continue the legacy of the Megerle name at Wagner with their leadership on the Board of Trustees and with the sponsorship of the Megerle Science Endowment, providing ongoing support for the Science Building and scholarships for deserving science majors.

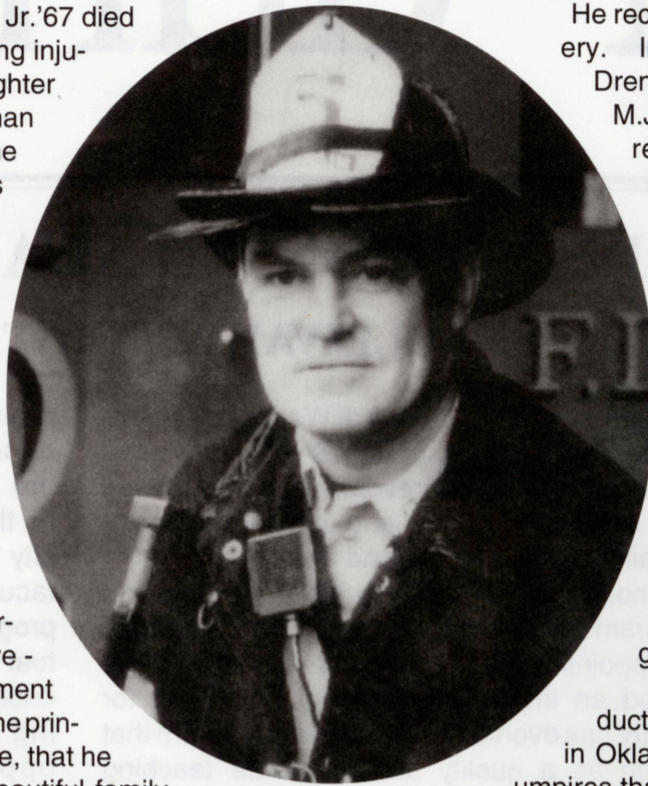
## COLLEGE LOSES IMPORTANT ALUMNUS CAPTAIN JOHN J. DRENNAN, JR. '67 (1945 - 1994)

Captain John J. Drennan, Jr. '67 died in May, 40 days after sustaining injuries in a fire. A decorated firefighter and modern day hero, Drennan touched the lives of everyone he met from colleagues to kids throughout the community and the City of New York.

"For 40 days, Drennan put up the fight of his life," said New York City Mayor Rudolph Guiliani at Drennan's funeral. "Some might believe that he lost; I believe that he won. None of us can determine how we're going to die, but we can determine how we're going to live. And John Drennan determined how he was going to live - strength, courage, commitment and character...And those are the principles, more than anything else, that he leaves as his legacy to his beautiful family and to the Fire Department of the City of New York."

Born in Eltingville, Staten Island, John Drennan came to Wagner College in 1963 and maintained a close association with the College ever since. He was a member of the 1964 undefeated football team and the Alpha Sigma Phi fraternity and graduated in 1967 with a degree in elementary education. After graduation, he taught school for a year, and joined the fire department during a teacher's strike.

Drennan was promoted to lieutenant in 1982 and became captain in 1989. In 1990, he was assigned to Ladder Co. No. 5 in Greenwich Village where he led a group of young and dedicated firefighters until this past Spring.



He received several awards for bravery. In 1976, and again in 1979, Drennan was presented with the M.J. Delehanty Medal. He also received the Meritorious Act Award in 1978.

In addition to his exemplary service to the Fire Department, Drennan coached the Tottenville football team for five years in the mid-seventies and then served as the assistant coach for Wagner's team. Drennan also officiated at local football and softball games and was often seen on campus as umpire for the Women's softball team's games.

Last year, he was inducted into the Softball Hall of Fame in Oklahoma City, one of only a few umpires that have received that honor.

In his spare time, Captain Drennan helped deliver food to senior citizens through his church, Eltingville Lutheran and tutored kids who needed help with reading at his wife, Vina's school.

Drennan is survived by his wife Alvina, who graduated from Wagner in 1966 and their four children, Jessica, Adrienne, Justine and John Joseph, III.

"A man's life is measured by his acts and deeds and what he leaves behind," said Fire Commissioner Howard Safir. "In days past, men would sit around campfires and sing songs of their heroes. In days to come, brave men will sit around kitchen tables and speak in reverent voices of the legend and legacy of Captain John Drennan and wish they could be just like him."

## EXECUTIVE MBA PROGRAM TRAINS BUSINESS LEADERS First Class Graduates

Eighteen months ago, fifteen mid-career executives and professionals, including several corporate vice presidents, financial officers, department heads, a doctor, a lawyer, and the C.E.O. of a mid-size not-for-profit organization, came together as the first class of *M.B.A. for Executives* at Wagner College.

Through *Wagner's M.B.A. for Executives* program, they traveled to Washington D.C. to study reform on health care, honed decision-making skills through in-depth analysis of the Challenger Space Shuttle disaster, ran a major corporation in a simulated exercise and functioned as management consultants for their own firms.

Unlike traditional executive M.B.A. programs where the emphasis is on number crunching, Wagner's program is designed to teach the management of an organization's most critical resource - its people.

Team building, communicating, motivating people and decision making skills are stressed throughout the curriculum. "Wagner's *M.B.A. for Executives* is a program that builds leaders," says Bob O'Brien '66, Managing Director of C.S. First Boston and Chair of the Board of Advisors for the executive M.B.A. program. "I am delighted to be to be a part of it and I am impressed by the quality and substance of this program."

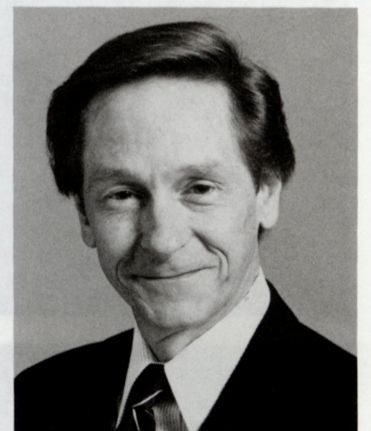
"It provides the technical fundamentals required of any M.B.A. and it utilizes leading-edge technologies in the classroom for critical decision making and management in the real world." O'Brien added.

Key to its success is the small size of classes which remain together for the duration of the program. "With fifteen members, we forged a close working relationship creating an environment where executives can learn from each other," said Dr. James Michael, director of the program. "The conclusion of the first class is bittersweet," he added. "While the work is hard, I am going to miss seeing these students every month."

The *M.B.A. for Executives* program at Wagner addresses the needs of professionals and mid-level managers with an accelerated schedule and course work that takes into account their professional experience. It is designed to provide participants with the behavioral-management skills necessary to advance within and effect change in their organizations.

"The work was intense at times, but all worth it," said John Rutigliano, National Director of Services for A-1 Courier Services, of the eighteen-month program that met every other week on Friday afternoons and all day Saturday. "I have a larger perspective of my corporation and my job and approach my work and problems more logistically and strategically."

## THOMAS G. MOLES '65 -

A man with two great passions, business and athletics

A high school football star, Tom Moles was pursued by prestigious universities with large football programs. He remembers being recruited for Wagner by Howard Braren '50 (former Director of Alumni Affairs) and selecting the school because Braren spoke not only about Wagner's strong football program but getting an education, a fact that impressed Moles' father.

Tom was a part of Wagner's football history as a member of the undefeated 1964 team that also included his long-time friend, Greg Knapp '66 and Dick Kotite '66 now head coach of the Philadelphia Eagles. He was also fortunate, he said, "to have played under two great coaches - Micky Sullivan and Bob Hicks."

His college education was interrupted by the Vietnam War and he finished the requirements for his degree after the war at night. While at Wagner, he majored in secondary education thinking he might be a coach.

Moles most remembers classes

in philosophy and religion with Dr. George Hackman and Dr. Thomas Kendris and how they broadened his perspective on life. A lively economics course with Dr. Charlie Kraemer piqued his interest in business and after returning from Vietnam, Wall Street lured him from the classroom where he has been for the past 25 years.

In 1983, he joined J. & W. Seligman & Co. and is now a Managing Director of the corporation. He also serves as President and Senior Portfolio Manager of two closed-end funds, Seligman Select Municipal and Seligman Quality Municipal Fund, and of the Seligman Tax-Exempt Funds, which include 19 separate portfolios. He is responsible for the management of over \$2 billion in tax-exempt securities.

Tom Moles became interested in Wagner through Greg Knapp, also on Wall Street as a Managing Director at Dillon Read, and joined Greg on Wagner's Board of Trustees in 1991. He became a member of the Executive Committee in 1993. "Wagner provided

for my education," said Moles. "It is gratifying, therefore, to be giving something back, particularly since the College is doing so well."

He sees Wagner moving in the right direction and is encouraged by its progress. "I am proud to be supporting Wagner's turnaround," said Tom. "Nothing is more important than educating children and Wagner is a place of which we can all be proud."

Moles is also particularly interested in Wagner's athletic programs, which is what got him through college. This year he is Honorary Chair of the Seahawk Golf Outing benefiting the Athletic Scholarship Fund. "Wagner's athletics under the direction of Walt Hameline are an asset to the College." Moles emphasized. "Walt is a great coach and a great person -- one of the best coaches I've ever met anywhere." he added.

When not working or attending a Wagner Board meeting, Tom can most often be found on the golf course. A



hard-working and disciplined man, Tom Moles' passion is golf. He lives in East Windsor, New Jersey with his wife Polly (nee Peck) also a Wagner graduate. Their two children, Anne and Thomas are away at College.

## HERB SUTTER '31 HONORED BY NIT

Herb Sutter, Wagner's long-time athletic director and most successful basketball coach, was inducted into the NIT Hall of Fame during the final round of the National Invitation Tournament's 57th program at Madison Square Garden on March 28th.

Sutter, whose time in the world of New York City college athletics extends over six decades, was involved at the start of the National Invitational Tournament in 1938 and was among the college athletic directors who assumed direction of the tournament from the New York Basketball Writers Association. Wagner is still one of the five sponsors of the NIT, along with NYU, Fordham, St. John's University and Manhattan College.

As proud as Sutter is of his years with the NIT, his real love has always been Wagner College. He came to Wagner's prep school in 1918, when his father and President of Wagner, Rev. Frederic Sutter, moved the College to Grymes Hill.

A star athlete during his college years, he graduated from Wagner in 1931 and returned in 1935 where he served as athletic director until he retired in 1974. Herb Sutter carried Wagner's sports programs from little more than pick-up teams to a position where it could play at the levels it does today. Sutter now lives in Maryland.

## ALUMNI EXCEED \$350,000 PLATEAU IN ANNUAL GIVING

We are pleased to report that during 1993-94, Wagner received more than \$350,000 in alumni support through the annual fund for the first time in its history. None of this would have been possible without the leadership and assistance of the 51 Class Agents led by the 1993-94 Annual Fund Chairman, Harry Volz '51. Wagner is grateful to this very special group of alumni for serving as liaisons between Wagner and their classmates promoting The President's Merit Scholarship Program which attracts academically gifted students to Wagner College.

Of the \$350,000, more than \$112,000 in President's Merit Scholarship support was raised, in pledges, through the Alumni Telefund. More than sixty students from fifteen student organizations around campus, alumni from the Staten Island area and Wagner faculty members came together for two weeks in October and two weeks in March to renew and increase alumni participation to the annual fund. 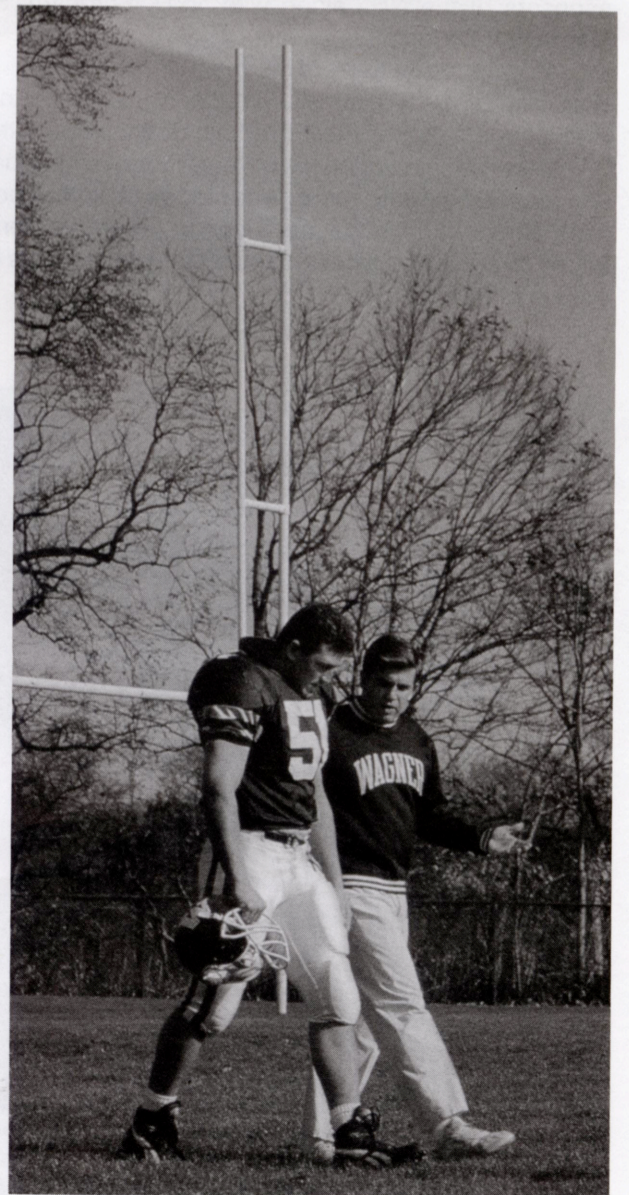
Gifts to the Friends of Wagner College Athletics will be used specifically to:

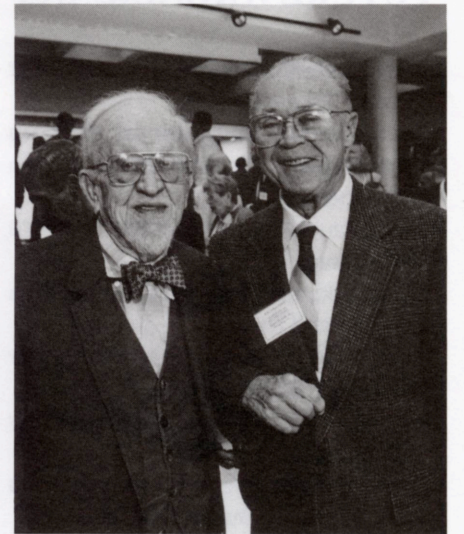

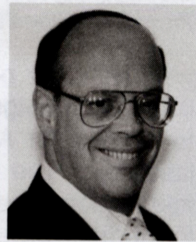

## OBITUARIES

**Dr. Johann C. F. Schulz**, a retired chemistry professor and long-time chairman of the chemistry department died this past March. Dr. Schulz taught at Wagner from 1950 to 1957 and then from 1960 to 1987.

Born in Gottingen, Germany, Dr. Schulz came to the United States in 1937. He received his bachelor's degree in chemistry from Mount Union College in Ohio and his doctorate from Syracuse University. Although he taught for brief periods at universities in this country and abroad, he spent the majority of his career at Wagner College.

He was a member of the American Association for the Advancement of Science, the New York Academy of Sciences, The American Institute of Chemists and the American Chemical Association.

Dr. Schulz was the 1976 recipient of the American Chemical Society's Certificate of Merit, awarded by the Society's New York section.

An inspiring force on campus, Dr. Schultz upheld high standards for his students. For over 30 years, he worked closely with students assisting them as they struggled with pressing questions in the sciences. He helped shape the careers of many Wagner graduates who later became physicians, researchers and scientists.

Following his retirement, he continued to teach chemistry part-time at James Madison University in Harrisonburg, Va., and tutored children and adults in chemistry and math.

**Dr. Dale Yarns**, professor of biology since the early 1970's at Wagner College passed away in August while visiting his family in Minnesota.

Born in Jackson, Minnesota, Dr. Yarns left to pursue his studies and then came to Staten Island to join the faculty at Wagner College. He received his undergraduate degree from the University of Minnesota. He did graduate work at the University of California and the University of South Dakota, earning his doctorate from the University of Maryland.

He did extensive research on Staten Island's wetlands, conducting studies of biodiversity at the former Brookfield landfill in Great Kills.

A member of the American Littoral Society's Baykeeper Water Monitoring Program, Dr. Yarns touched off a 1992 investigation into a sewage plant that was illegally dumping waste into Richmond Creek. He discovered the problem while doing research in the waterway. He also collected diatoms, a form of primitive plant found in local creeks.

Dr. Yarns is well remembered for his warmth and concern for his students and great enthusiasm and interest in his subject. He had the ability to take very dry and clinical material and bring life and humor to his courses.
