News notes on the hill . . .

. . . the summer sessions enrolled 1132 persons compared to 1136 the previous summer. Among the special programs, 54 students were in "Exploring Art in New York," 23 were in "Exploring Theatre in New York," 36 took part in an ecological survey in Putnam County and 20 persons were involved in an archeological "dig" on Staten Island.

. . . 113 freshmen took part in a pilot project of early orientation this summer that included advisement and familiarization with the campus and with the cultural and recreational opportunities of the metropolitan area.

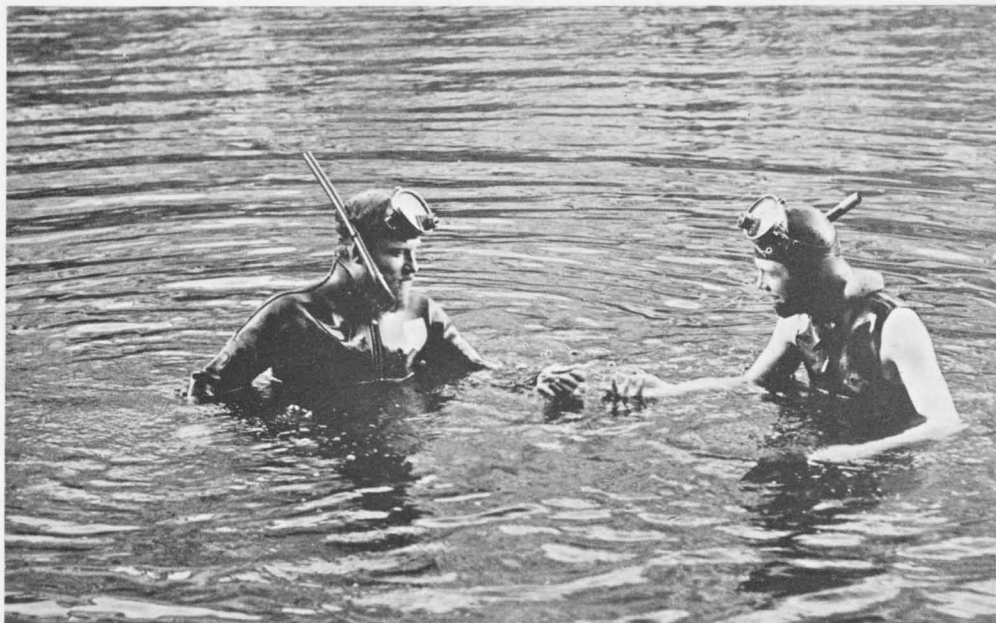
. . . there will be a 90th Anniversary celebration between January and June 1973, recognizing Wagner's 90 years of service in higher education . . . the largest graduating class in the history of the college, 637 students, received degrees at the 87th annual commencement June 4. There were 535 undergraduates and 102 graduate students.

More than 700 alumni responded to the first alumni-admissions program last spring, answering a letter that asked them to volunteer calls on prospective Wagner students. Harold Nelson '66 of the admissions office coordinated the drive and alumni received names of prospects who lived in their area, along with a fact sheet on the college.

Annual fund gets \$302,709

A final accounting in the 1971-1972 Wagner College Annual Fund shows that the drive reached \$302,709, \$27,000 over this year's goal, according to Donald Spiro, chairman of the annual fund committee. The \$302,709 came from 2073 donors in the nine categories of the fund.

In terms of donors, more than 1409 alumni responded with more than \$43,800. These figures represent an increase over last year of \$5800 with 46 more donors. Also showing an increase in both dollars and donors was support from foundations, this year reaching more than \$55,800 from 42 donations.

The college's "Friends" category recorded nearly \$150,000 and was the leading group. The figure represents

an increase over last year of about \$43,000. Included in the "Friends" category are 22 members of the Cunard Society, the leadership group of the campaign's efforts.

A comparison of totals shows that the recently-completed campaign showed an increase of \$75,722 over last year's totals. But 185 fewer donors responded to the appeal this year.

"Our theme for future campaigns should be to increase the participation in our efforts to create a dependable flow of dollars for Wagner," Spiro stressed. "Although we challenged ourselves to generate more than \$300,000 for the Fund, we witnessed a weakening of support particularly in the kind of interest we sought from the surrounding community."

Choir tours Austria, Germany

In early July choir members returned from their successful tour of Austria and Germany. The Rev. Walter Bock, director of church relations for Wagner and organizer of the tour, took careful notes while on the trip. A few excerpts follow.

June 5, 1972 dawned bright and sunny. In various parts of the City much remained to be packed, choir members were eating the last American style breakfast for a while and passports were being checked. Others were looking up words in phrase books which always seemed not to have the words one wanted.

Slowly, late afternoon, the choir members began to converge on the Lufthansa terminal at J.F.K. airport; forty-two students and four adults. President and Mrs. Arthur O. Davidson gave us a most gracious verbal send-off.

Arriving in Germany, we were faced with an air traffic control strike which delayed us. Finally we touched down in Munich and our bus and driver were waiting for us.

Due to twenty-five miles of detours on the road to Bregenz, we arrived in the middle of the afternoon. Dr. Gaspard Pinette and Mrs. Herma Karg had every-

thing organized and we were graciously received.

Bregenz is a beautiful city, and we took advantage of its attractions including a cable car ride, a boat trip to the Wasserberg as well as a great deal of walking to see the sights.

Our first concert in Europe was a joyous occasion with the church well filled and with an enthusiastic audience.

Leaving Bregenz, we drove to Munich where a representative of the German Ambassador to the Olympics took us on a tour of the Olympic grounds. After a tour they treated us to coffee and cake in the revolving restaurant on top of Olympic Tower. We sang two numbers for the Ambassador's representative and his party at the entrance to the tower. Both he, his staff, and the many people who stood around to listen were most appreciative.

In the following days we sang concerts in Ansbach and Fürth.

The 14th of June everyone got up for an early breakfast as we were to undertake the longest ride of the tour, from Fürth to West Berlin through East Germany. The formalities of going into the Zone only took about thirty minutes. Once in the Zone we had been told that we should eat along the way at one of their eating places. We stopped and asked two of the People's Police if this would be possible. In any Communist area the average person dare not make such decisions, so they called headquarters and we waited hungrily for the answer. After a long while, the answer came back in the negative. Not only could we not eat, but we were not to be allowed any rest stops in the Zone. In other words, we had just so many hours to get through this territory. If we went too fast we would be charged with speeding and if we went too slow we would be accused of stopping. Yet, for reasons of nature, it was imperative that we stop, and we did, in a wooded area. When the doors opened, the women went in one direction; the men in another. Our driver kept yelling to hurry because our stop was illegal.

We arrived in West Berlin about 4:30 p.m., having left Fürth at 8:30 a.m. Our concert was in the world famous "Kaiser Wilhelm Memorial Church" and was well attended with a number of our alumni present.

Leaving West Berlin, we went to Hannover where Bishop Hanns Lilje had graciously consented to be the honorary chairman of our concert. It was in his church, the "Marktkirche" where we sang to a large and appreciative audience. It was in this very same church that the Wagner College choir sang twenty years previously when they sang at the meeting for the Lutheran World Federation.

At Muenster we were the guests of the Madrigal Choir of that University. The first evening they presented a concert in our honor while the second evening we presented our concert, which was so well received that the choir had to sing four encores. As part of our visit we had a reception given us by the mayor

of Muenster in the "Hall of Peace" where the treaty of Westphalia was signed, ending the Thirty Years War. Also a reception was tendered us by the Rektor (president) of the University.

Leaving Muenster we proceeded to Bad Oeynhausen and Kassel, as well as Fritzlar, where we again sang to audiences that were most appreciative.

Our next stop was Bonn, seat of the Federal Republic of Germany. It was in Bonn that President and Mrs. Davidson joined us and remained with us for a number of days. In Bonn we had a tour of the city, and a reception by one of the executive officers of the city, at which time President Davidson expressed his thanks to the German Government and the German people for their kindness and gracious hospitality. Dr. Davidson also presented a Wagner College plaque. A press conference, which was mainly directed to the students, was held in the afternoon and the young people gave mature answers and were very honest and observant in their replies.

In Bonn we also visited a beautiful and famous monastery as well as a wine cellar. One of the highlights was a reception given us by Bishop Kunst, Ambassador of the Protestant Churches to the Bonn Government; he was a most gracious host.

Our concert in Bonn, held in the "Schloss Kirche" was well received and the Bishop, his staff, and all present were loud in their applause.

President and Mrs. Davidson rode with us to Darmstadt, where we were happy to meet and greet Mr. and Mrs. Eugen Megerle whose contributions helped make the tour possible. It was in Darmstadt that Mr. Megerle's firm "Wella" served us an excellent lunch, gave to all present samples of their products and catered our evening meal.

Leaving Darmstadt after a most successful concert we soon arrived in Stuttgart. While we were quartered in Stuttgart we had two concerts—one in

Schorndorf and the other in Degerloch. Mr. and Mrs. Megerle were present and both concerts were received with loud applause.

The day of our return flight soon arrived, and on the 5th of July we flew Stuttgart to Frankfort, and then to New York. A concert on the plane, at an altitude of 38,000 feet, was enthusiastically received.

Our arrival was a happy return, filled with experiences we will long remember.

Football '72 is "Year of the Big Challenge"

New foes, new faces, a new football conference and a new offensive alignment are just a few parts of the new 1972 Seahawks that will face up to the "Year of the Big Challenge."

Coach Bob Hicks is faced with rebuilding again after losing 22 seniors (15 of them starters) and with 26

sophomores donning the Green and White colors this season. "We're forced to use a lot of these boys before they are really ready," adds Hicks, "but they'll just have to learn under fire."

It doesn't help that the Wagner schedule is the toughest it has ever been. Perennial football power Hofstra University is back on the schedule and tough Drexel University returns after a seven-year absence. The University of Bridgeport, usually a pre-season scrimmage foe, is the other newcomer to the Wagner family.

The Seahawks will also compete against a few teams in the experimental Metropolitan Intercollegiate Football Conference during the 1972 and 1973 seasons and officially begin round-robin play in the conference in 1974. Among the teams scheduled to play are Hofstra, Upsala, C.W. Post, St. Peter's, Fordham, Kings Point and Montclair State.

The newest offensive fad in football—the wishbone offense—is making its debut on Grymes Hill this season. It's an exciting offense to watch and a challenge to the young Seahawks—one of many to come this season.

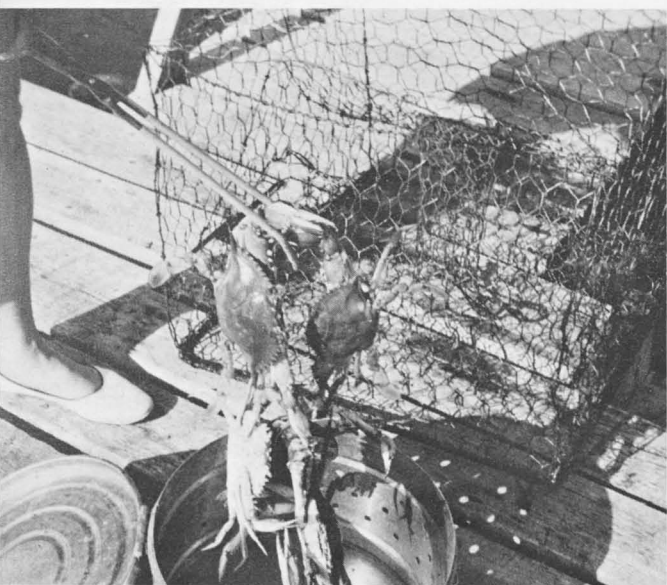

Virginia is

"Carry me back to old Virginie"—through Occoquan to Tappanhannock and across the Rappahannock River to Lancaster County, the home of *Verona Lee Van Pelt '49* and her husband Eugene "Van" (M.I.T. '22). As we sat on their porch we watched the crabbers checking their traps along the still salt water river (Chesapeake Bay is only 20 miles downstream).

One of the few rivers not yet polluted, the Rappahannock has many gifts to give; the view, the breeze, the wildlife and fauna, the boating and the crabs. Lee took us to their crabtraps where we found over a dozen hard-shell crabs.

Lee is an organizer, inventor, innovator, herbologist, horticulturist, ornithologist, registered nurse and all around hard-worker. Having initial training in merchandising, she learned the value of efficiency and product improvement. She carried this insight to her nursing career and developed equipment and methods that benefit patients and medical staff alike. Examples are the magnetic visual control system, the Regu-vak catheter, the disposable vaginal irrigation system, the disposable closed aseptic bag, and a limb holder that is comfortable for the patient but easily removed in emergencies.

"Methods research and development is terribly important. Too often it is overlooked or not stressed as an integral part of nursing."

Lee remembers her experience at Wagner's nursing school as "an excellent background in the sciences and the most valuable practical experience of working at Yonkers General."

We watched the sunset on Virginia's Rappahannock River as the hummingbirds fought over the feeders. The tide was coming in and soon the traps would be submerged and collecting the catch for tomorrow.

The next morning we drive West—through Millers Tavern, St. Stevens Church, across the Appomattox River onto the J.E.B. Stuart Highway to the Blue Ridge Parkway and Hillsville, Va., to meet *the Rev. Louis C. Suessmann '41* and his family who run an experimental ministry in a motel high in the Blue Ridge Mountains.

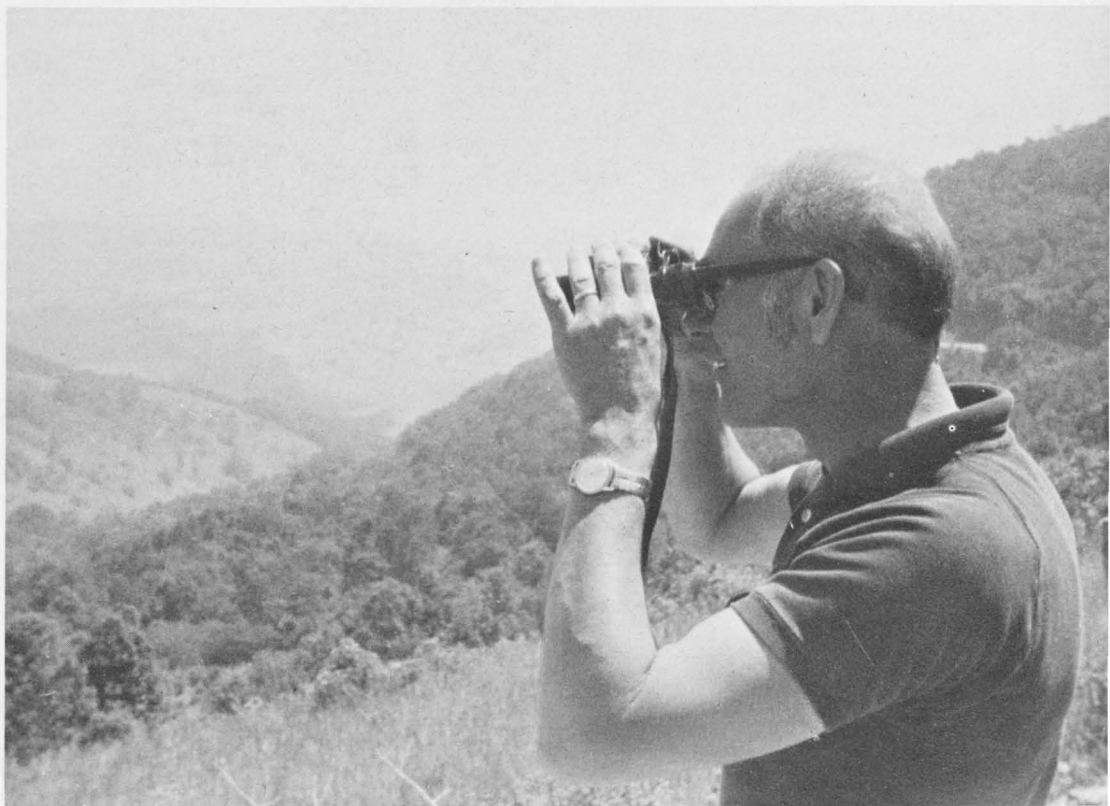
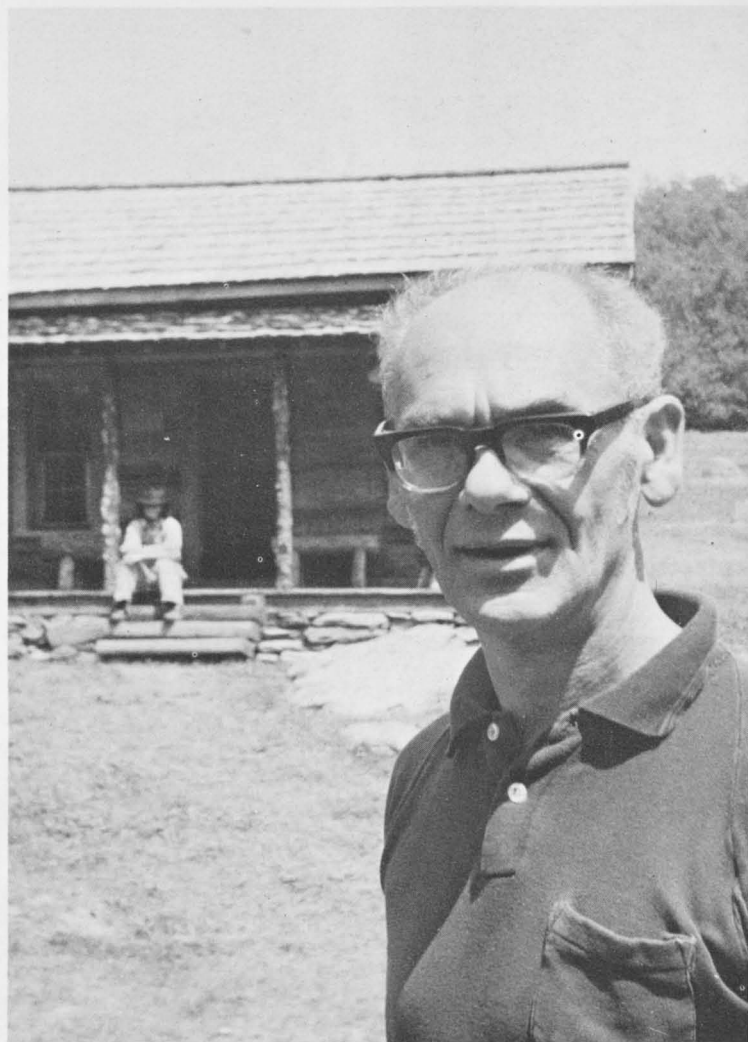
"I was born and raised in Oceanside, Long Island. The highest elevation I had ever seen was a parkway overpass. When I saw these mountains I knew I had to live here someday." Seventeen years ago the Suessmanns bought a 35-acre farm in Floyd County where they would come for vacations before they moved to Virginia. Three years ago they invested in the motel in Hillsville and called it "The Stable and The Inn". Both properties are part of a dream—a "Re-Creation" community and ministry that is increasingly but not exclusively involved with young people.

As we listen to the stories about their life of sharing and helping, we see that it is a ministry by the whole family. The needs expressed by others are met not only by the professional clergyman, but also by his wife, Jean and their teen-aged children, Steve, Ruth and Joy.* In their ministry they've been called on to do many things. Jean has helped bring a baby bull calf into the world and Joy has milked cows and done other farm chores for a neighbor.

"Mountain people work together. They share equipment and help one another at harvest time. This community spirit is very much a part of mountain living." Here was the Christian ethic in its simplest form—"Love thy neighbor". The mountains speak of it and the Suessmanns offer it at "The Stable and The Inn".

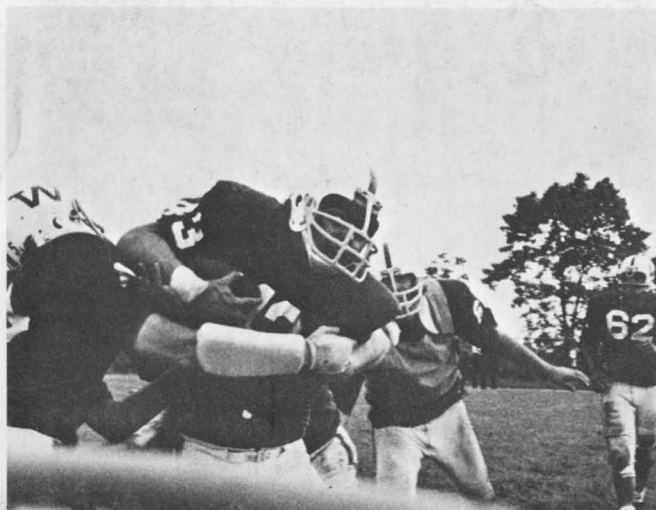
