Other Homecoming highlights included the traditional reunion buffet served in the main dining hall, and performances of "My Fair Lady" in the Main Hall theater.

Campus news

- Donald W. Spiro and his wife, Evelyn, both members of the Class of '49, have donated \$250,000 toward a state-of-the-art computer facility. Featuring IBM PS2 personal computers, the system will be equipped for word processing, financial spread sheet analysis, data base management and research methods. It could be linked to a mainframe computer in the future. Targeted for a spring completion, the facility will be located in two classrooms in the Communications Center. "My wife and I hope this (gift) will give other graduates the incentive to donate," said Spiro, who is chairman of Oppenheimer Management Corp. and a member of Wagner's Board of Trustees.
- Plans are under way for the annual Scholarship Sail through New York Harbor on July 4th. The five-hour boat ride will include dinner and entertainment, and a bird's-eye view of the fireworks show. Proceeds will benefit the Alumni Association's scholarship fund. Kevin Sheehy '67 M'70 is chairing the event.
- The Alumni Association recently donated \$1,000 to the Department of Speech and Theater. The money will help refurbish equipment in the Main Hall theater.
- Funds for furniture in the Towers dormitory parents lounge has been donated through the efforts of the executive committee of the Alumni Association.
- Students are enjoying three newly refurbished arts spaces on campus this year. Kade Gallery in the Student Union now features a glass wall so exhibits can be viewed 24 hours a day. Two classrooms on the second floor of Main Hall have been remodeled into a dance studio. And in Campus Hall (formerly the New Administration Building), the old cafeteria has been converted into an elegant performance space for concerts.

Dean of admissions seeks help from alums

Last fall, the Wagner College Admissions Office began new recruitment initiatives in some areas of Virginia, Maryland and Pennsylvania. In addition, prospective students with higher academic potential are being given more attention through our efforts.

Another goal of the Admissions Office is to revive the alumni role in recruitment. Some years ago, Wagner alumni were much more active. There are three programs which have strong promise for alumni involvement:

- 1. telephoning prospective students in local alumni areas
- 2. assisting with college nights and college days in local high schools
- 3. area receptions for prospective students and parents

Telephoning students has been a standard alumni contact program for many colleges. Some of the well-known colleges have also been very successful utilizing alumni in covering college programs at local high schools.

The Admissions Office would like to develop a group of alumni who would come back to Wagner College for a training workshop and attend some college programs with our admissions counselors.

If 15 to 20 alumni could eventually cover 3 or 4 high school programs in their areas, we would be able to cover 60 to 80 additional programs each year.

Area receptions will probably take a couple of years to develop.
