The Minutes for meeting held February 12th were read & confirmed

The pastor reported that the work of fixing the new Heating Apparatus was completed at a cost of £42. 17. 6.

Inidental work had cost £2. 10. 0 making a total of £45. 8. 4

Towards this he had received from the Ladies Sewing Meeting £30; gifts from our own friends £6. 5. 6, from friends of other Churches £8. 5. 0. Sale of Scrap 2/- and the collections for Sunday March 18th had realised £1. 1. 0 making a total of £45. 13. 6

It was agreed that the fund should be kept open and that the balance of 5/- should be carried forward towards the cost of placing new pews in the space

from which now left where the old stone had been removed.

It was agreed that an estimate should be obtained as to the cost of the new pews.

The question of insuring the heating apparatus ^{was raised}, but the pastor reported that he had received a letter from the Congregational Insurance ~~see~~ Co Ltd stating that the premium was 30/- which covered up to £500.

It was agreed that unless a smaller liability could be covered by a smaller premium the matter should be left. The Pastor promised to write the Company to this effect.

The Treasurer, Mr John Alderson, reported that he had received a letter from Rev T H Trelstad County Secretary pointing out that as the Pastor had passed the "List B" Examinations he was

entitled to an increase of £15 to his
stipend bring it up to the minimum
of £175. The County ~~was~~^{was} willing to
increase the grant from £55 to £60 if
the church could raise the other
necessary £10.

The matter was discussed in the
absence of the Pastor and it was
decided that the church should try to
raise the necessary extra £10 for one
year.

It was agreed to invite Messrs. C. Alderson (Harker House) & J. Melcalfe (West Stonesdale) to represent us at the Dales Conference to be held at Ravensdale in May.

Mr. Mee brought before the meeting two proposals, suggested by the Leeds Monk District of the County Union. (a) a scheme whereby the ministers of Richmond & Keld, with lay assistance, should share in the oversight of the church at Reeth, including

a day's visitation per week by each minister. This to be a six months' experiment during the summer. Keld Church to receive £5 per annum in acknowledgement of loss of ministerial service, & the minister £15 per year, exclusive expenses.
(b) a proposal to form the Swaledale churches into a voluntary group for purposes of fellowship, endeavouring to provide as many opportunities as possible of sharing each other's life problems, without in any way infringing the complete self-government of each. After an opening prayer the minutes of the last meeting were read and adopted.

The Secretary's Report of his year's work was then read, after which the Treasurer's Statement was made. We were deeply thankful to end the year quite clear of deficit, with a small balance of £1.2.0 on the right side.

The two reports were accepted for submission to the County Union. All the officials of the church were accorded a vote of thanks for their services during the year.

The pastor reported that arrangements were already made for the June Anniversary, & banquets of the Revs. Parker Davies, Gunter Stanford were put forward with a view to the Harvest Festival. Mr. Mee promised to make the most convenient arrangement possible with these speakers in mind.

Thanks.

It was agreed to write thanking the organists for their services during the past year.

Church Meetings.

Mr. Mee brought up the subject of church meetings. He felt that they ought to be held more regularly, because besides the annual meeting, when matters of routine business crowded other days out, the only other meetings were of an emergency character.

Opportunity ought to be provided of discussing higher matters, of deepening the spiritual life of the members, & of considering every aspect of God's work among us.

It was therefore resolved, on the motion of Messrs. S. F. Scott & J. Alderson, that there be six monthly meetings from October to March, held normally on the Thursday after the 1st Sunday in January, & one summer meeting, to be held at a suitable opportunity according to the state of the season's activities.

Renovation Fund.

Mrs. J. Metcalfe reported that she now had £ 5. 10. 7., which had been contributed to the Renovation Fund. It was moved by Mr. Scott, seconded by Mrs. Mee, & passed, that the even money be placed in the Post Office Savings Bank.

Sale of Work.

In spite of the present wellbeing of our finances, it was agreed that for several reasons it was imperative to hold a Sale of Work in the autumn. Accordingly it was decided to ask the Ladies Sewing Party to meet with a view to organising a sale of work.

Half-Yearly Bulletin.

The half-yearly bulletin of the Yorks. Union was read, & it was decided to arrange for the use of the Lenten Lecture, "The Story of Yorkshire Congregationalism".

Attention was drawn to the fact that 1939 would bring our 150th. anniversary, & it was felt that this occasion should be marked by special celebrations.

Either the 2nd. or 4th. weekend in June of that year was to be chosen, & Dr. Sidney Berry was to be asked, amongst others, to take part.

Christmas Concert.

It was resolved that we should endeavour to provide our own programme this year.

February Concert.

After discussion, it was agreed to ask the Low Row Institute Party to give a concert in February.

Reference was made to the lack of space near the communion rails, particularly on the occasion of a funeral, & the members declared themselves agreeable to such alteration as was found to be best, subject to the approval of the local trustees.

Then followed the Secretary's Report, which was accepted, as also the financial statement. Gratitude was again expressed that the books had been balanced again on the right side. It was reported that the Renovation Fund now stands at £6.13.9.

Appreciation was expressed of the services of the Secretary & Treasurer.

Passing to the election of officers, all officers & delegates were reappointed as last year, as also the School Managers.

It was agreed that we should apply for the same grant, viz. - £55.

Dales Conference.

It was agreed that we were prepared to entertain the Dales Conference in 1959, provided that it was made clear that some visitors would have to walk as far as 2 miles to their lodging.

Special Preachers.

Mr. Mee was empowered to make the best arrangements he could for the Sunday School Anniversary & the Harvest Festival.

Stewards in Summer.

It was decided that in summer time the deacons should act as stewards at all services, to show visitors to their seats, welcome them, & make them feel 'at home'. A rota was to be prepared, & notice given any steward not able to keep his appointment must provide his own substitute.

Church Reopening.

It was agreed that a very cordial invitation be given to Mr. J. Waggett to perform the reopening of the door on May 14th. The warmest appreciation was felt of his untiring service in connection with the renovations.

Mr. Mee reported that our invitation to the Dales Conference had been accepted, & that the date had been fixed from June 12th. to 14th. Home Missions Sunday. Mr. Mee reported that it had not been found possible to arrange an exchange of pulpits in the interest of Yorkshire Home Missions.

Rules Governing the Use of Keld Congregational Churchyard, authorised by a meeting of Church members & seatholders, held on 17th April 1960.

(Being the old rules amended where necessary).

- 1 The graveyard shall be under the control of the Pastor & Officers of the Church, to whom applications for burial must be made, & fees paid.
- 2 Grave space is free to all church members, seatholders, & subscribers to the weekly envelope system, also to unmarried members of their families. (These persons are hereinafter referred to briefly as

'adherents'). Non-adherents may use the ground on payment of a fee as shown in Rule 7.

3. The graves are normally to be used in rotation, as numbered in the plan, but clients may select a grave on payment of a selection fee, or may reserve one during his (or her) lifetime by a somewhat larger payment as indicated in Rule 7. The short lengths at the top (nos 118 to 125) are set apart for infants.

4. Where practicable, new graves must be opened to a depth of not less than 6 feet: two bodies may be buried in one grave, but in no case shall a body be buried at a less depth than 3 feet below the top of the coffin from the surface.

5. In no circumstances whatever may a grave be opened, or a burial effected, without permission of the Pastor or Officers of the Church.

6. The recognised charge for digging a

new grave shall be 25/- but a charge of 30/- may be allowed in special circumstances, if the pastor & office bearers approve. 20/- shall be charged for reopening a grave.

7. The fees payable to the Church shall be as follow:- Adherents (as defined in Rule 2) shall have free use of grave space, but shall pay 7/6 for the privilege of choosing a site. Non-adherents shall pay 15/- for a grave, and an additional 10/- if they select its position.

A further charge of 5/- will be made in every case where a grave is reserved before being required.

8. The Minister shall exercise his own discretion in charging a burial fee, but it is understood that his fee shall not exceed 5/-.

9. These Rules shall be posted in the Church Porch, & shall come into operation on 1st July, 1940.
