HISTORY OF THE COLLEGE

fficially founded in 1877, Philander Smith College is the result of the first attempt west of the Mississippi River to make education available to freedmen (former African-American slaves). The forerunner of the College was Walden Seminary, named in honor of Dr. J. M. Walden, one of the originators and the first Corresponding Secretary of the Freedmen's Aid Society. In 1882, Dr. G. W. Gray, President of Little Rock University, the institution for the Arkansas Annual Conference, met Mrs. Adeline Smith, widow of Mr. Philander Smith of Oak Park, Illinois, while soliciting funds. The late Mr. Philander Smith had been a liberal donor to Asiatic Missions and had developed an interest in the work of the church in the South. In making her gift to Dr. Gray, Mrs. Smith designated \$10,500 for Walden Seminary. The trustees accepted the gift and gave it special recognition by changing the name of the struggling Walden Seminary to Philander Smith College. A new site for the school had already been purchased at Eleventh and Izard Streets. The gift made by Mrs. Smith was a significant contribution toward the construction of Budlong Hall, the first brick building on the new site.

Philander Smith College, which has a rich Christian heritage and acknowledges a definite obligation to The United Methodist Church, was also chartered as a four-year college on March 3, 1883. The first Baccalaureate Degree was conferred in 1888. The Presidents of Philander Smith College are recorded as follows: The first President was the Reverend Thomas Mason, who resigned in 1896. He was succeeded by Reverend James Monroe Cox, Professor of Ancient Languages. Dr. Cox, who retired in

1924, was succeeded by the Reverend George Collins Taylor, a graduate of the College. Dr. Taylor served as President from 1924 to 1936. In May 1936, Dr. Marquis LaFayette Harris succeeded Dr. Taylor. Harris, who greatly enhanced the College, was succeeded by Dr. Roosevelt David Crockett, a graduate of the College, on June 1, 1961. Dr. E.T. Dixon, Jr. took office on January 1, 1965 as Philander's Sixth President. Succeeding Dixon was Dr. Walter R. Hazzard, who took office as the Seventh President of the College on July 1, 1969. Succeeding Hazzard was Dr. Grant S. Shockley who took office on January 1, 1980 as the Eighth President of Philander Smith College. Dr. Shockley was succeeded by Dr. Hazo W. Carter, Jr., who was elected unanimously by the Board of Trustees and took office August 20, 1983. When Dr. Carter resigned the presidency in August 1987, he was succeed by Dr. Myer L. Titus, a 1954 graduate of the College. Dr. Titus retired as President on June 30, 1998. Elected by the Board of Trustees in February 1998 as the Eleventh and first female President of Philander Smith College was Dr. Trudie Kibbe Reed. In 2004, Dr. Julius Scott succeeded Dr. Reed as Interim President. In 2004, the Board announced the selection of Dr. Walter M. Kimbrough as the Twelfth President of the College. In May 2012, Dr. Kimbrough resigned from the presidency. On July 1, 2012, Dr. Johnny M. Moore, a 1989 graduate, became the Thirteenth President of the College. Following the resignation of Dr. Moore in February 2014, Dr. Lloyd Hervey, a 1968 alumnus of Philander Smith College, was named Interim President. Succeeding Dr. Hervey was Dr. Roderick L. Smothers, Sr., the Fourteenth President of the College, who took office on January 1, 2015.

MISSION OF THE COLLEGE

hilander Smith College is a small, privately supported and historically Black, four-year liberal arts institution related to the Board of Higher Education and Ministry of the United Methodist Church. The College currently offers four degrees, including the Bachelor of Arts, the Bachelor of Science, the Bachelor of Business Administration, and the Bachelor of Social Work. The College's mission is: "To graduate

academically accomplished students, grounded as advocates for social justice, determined to change the world for the better." Philander Smith College, the only United Negro College Fund (UNCF)-member institution in Arkansas, strives to provide a quality college education for all regardless of race, religion, sex, national origin or ethnic background.

hillip L. Pointer, Sr. is the Senior Pastor of the St. Mark Baptist Church in Little Rock, AR. There he resides with his wife Keya and their three children: Gabriela, Phillip, Jr., and Elijah. Some twenty years ago, Pastor Pointer recognized and accepted his call to preach and teach the Word of God. During his tenure there, Pastor Pointer transitioned the traditional congregation to a progressive place of worship. He cultivated a style that was Bible-based and Holy Spirit-guided yet retained the essential historical elements of Baptist polity and beliefs.

Pastor Pointer earned a Master of Divinity Degree with honors from The Samuel Dewitt Proctor School of Theology at Virginia Union University in Richmond, Virginia, and a Doctor of Ministry from United Theological Seminary in Dayton, OH. Pastor Pointer is the fourth generation in his family to serve as a Baptist pastor. He is firmly devoted to his family and seeks to model a commitment to family first. Pastor Pointer has a strong passion for leadership development and personal discipleship. He also has a great desire to empower people to both live as God intends and to serve God to their highest capacity. He seeks to accomplish this through meaningful worship, clear teaching, and providing consistent and loving pastoral care.

Where the white gleam of our bright star is cast.


God of our weary years,

THE HONORABLE LINDA CHESTERFIELD



enator Linda Pondexter Chesterfield is serving her second term in the Arkansas Senate where she represents Arkansas Senate District 30.

Regionally and nationally, Senator Chesterfield works with legislators as a member of the National Conference of State Legislatures (NCSL) and the Southern Legislative Conference (SLC).

Senator Chesterfield came to the Senate with a wealth of legislative experience. She was elected to the Arkansas House of Representatives in 2002 to serve House District 36, where she served three consecutive terms. While in the House of Representatives, she served as Chair of Aging, Children and Youth, Legislative and Military Affairs; as Chair of Desegregation Litigation; and as Chair of the K-12, Vocational - Technical School Institutions Subcommittee of Education. Formerly, she served as the President of the Arkansas Democratic Black Caucus and has held the post of Treasurer. In 2013, the Arkansas


Municipal League honored Chesterfield with the Distinguished Legislator Award for her exemplary service benefiting cities and towns of Arkansas.

Civically, she has been active in many local, state and national organizations and has held various leadership positions, including past President of the Little Rock School Board and the Pulaski County Association of Classroom Teachers, and past two-term President of the Arkansas Education Association. She is the only Arkansan to have been elected to the nine-member Executive Committee of the National Education Association. Professionally, Senator Chesterfield is a retired educator with over 30 years of classroom experience. A native of Hope, Arkansas, Senator Chesterfield was the first African-American to graduate from Hendrix College. She and her husband, Emry, own a consulting firm, Pondexter Chesterfield Consulting. The Chesterfields reside in Little Rock and attend First Baptist Church.

He has been inducted as a Member of the esteemed M.L. Harris Society at Philander Smith College as a result of his many generous financial gifts to the College.

He has served as a confidant and special advisor to the President of Philander Smith College, Dr. Roderick L. Smothers, Sr. Dr. Williams is fully committed to students and their success, and he is recognized as a "Champion for Students."

ary Louise Williams has been a community leader and advocate in the Little Rock
Community for many decades, as well as a strong, vocal advocate for Philander Smith College. She has also served the Little Rock Community as a Justice of the Peace and, along with Sonny Walker, integrated the Little Rock Classroom Teachers Association in 1967. Her service as a Member of Alpha Kappa Alpha Sorority, Inc. is one of the hallmarks of her achievements and has enhanced her service to Little Rock, Arkansas and the South Central Region. She was educated at Lincoln University in Jefferson City, Missouri, where she received her B.A. in Music. She holds two Master's Degrees—one in Education and the other in Administration from the University of Arkansas at Fayetteville.

Her career in education was cemented by her 30 years as a Music Teacher. She also spent 16 years as an Assistant Principal, and four years as a High School Summer School Principal. She served as the Chairwoman for the National Education Classroom Teachers and as President and a Board Member of the Little Rock Classroom Teachers Association, as well as Chairwoman of the Arkansas Teachers Association Choral Division. She has also served as the President of the Little Rock Classroom Teachers Association and the Little Rock Principals Roundtable.

Her contributions to the community have also included service in government and politics. She has served on the National Association Board of County Officials; the National Association of County Officials Art and Culture Commission; as Chairwoman of the Pulaski County Election Commission; and as Chairwoman of the Pulaski County Democratic County Committee.

Mary Louise Williams was the eleventh President of Beta Pi Omega Chapter of Alpha Kappa Alpha Sorority, Inc. She also served as the thirteenth South Central Regional Director of Alpha Kappa Alpha Sorority, Inc. During her tenure as Regional Director, Williams chartered seventeen chapters.



COMMENCEMENT AND REGALIA

COMMENCEMENT

he term "Commencement" derives from a practice in the Medieval University where it was customary for a candidate for an academic degree to present a public lecture or disputation to the faculty and other scholars gathered to hear it. If the disputation was successfully defended and accepted, the candidate was "Admitted" to the degree "with all the rights, privileges and responsibilities thereunto appertaining." This first public lecture or disputation was originally called an "Inception." It signified the beginning or "Commencement" of the scholar's academic career in the degree to which he/she had been admitted. The ceremony surrounding this inception or "graduation" has subsequently come to be called Commencement.

HONOR CORDS

he Honor Cords are used to recognize students' achievements during commencement, and they identify those students who have the right to wear the cords. At Philander, the green, white & gold cord represents Summa Cum Laude which is with Highest Distinction (3.75 - 4.0 GPA); the gold & white cord represents Magna Cum Laude, which is with High Distinction (3.5 - 3.7499 GPA); the white cord represents Cum Laude which is with Distinction (3.0 – 3.49 GPA); and the old gold cord represents Distinction in Field of Study. Various other colors are used to identify members of the Honors Society, fraternities, sororities, and others.

ACADEMIC REGALIA

he distinctive dress associated with academic processions and convocations dates from the Middle Ages when long-sleeved, hooded gowns were necessary for warmth in the unheated stone colleges. Most of the scholars were clerics in holy orders, and they wore cloaks to which were attached hoods that could be pulled up to cover their tonsured heads. Over the centuries, much diversity occurred in academic costumes. To bring some order to this diversity in 1894 in the United States, the Intercollegiate Commission met in New York and agreed on a code of academic dress which has become the standard for most colleges and universities. According to this code, both the styling and color of the regalia have significance. The design of the gown indicates the degree. The bachelor's gown is simple, with a full sleeve. The master's gown is much like the bachelor's except for the long sleeves, which hang loose. The doctor's gown is fuller and more elaborate. It has velvet edging and three velvet stripes on the full, gathered sleeves. Usually, the color of the gown is black. Hoods, which are worn over the gowns, are similar for all degrees although differing slightly in length. The candidates for the Bachelor's Degree usually do not wear the hood. The hood has a velvet edging, which indicates the area of the degree. The inside or lining of the hood is satin in the colors of the college or university granting the degree. A partial list of the degree colors to be found on the edge of the hood or the trimming on the doctor's gown is given below. The usual cap, proper for all degrees, is the black mortarboard, although some colleges use the beret to represent the doctorate. Tassels, usually black, are worn over the left front quarter of the cap for a degree holder and on the right for a candidate for a degree. Holders of the doctorate may wear tassels of gold thread. Holders may also wear tassels in the colors of the college or university granting the degree.
