#### Supreme Court Rejects Gay Marriage Appeals From 5 States

WASHINGTON (AP) — The Supreme Court turned away appeals Monday from five states seeking to prohibit samesex marriages, paving the way for an immediate expansion of gay and lesbian unions.



The justices on Monday did not comment in rejecting appeals from Indiana, Oklahoma, Utah, Virginia and Wisconsin. No other state cases were currently pending with the high court, but the justices stopped short of resolving for now the question of same-sex marriage nationwide.

The court's order immediately ends delays on marriage in those states. Couples in six other states — Colorado, Kansas, North Carolina, South Carolina, West Virginia and Wyoming — should be able to get married in short order. Those states would be bound by the same appellate rulings that were put on hold pending the Supreme Court's review.

That would make same-sex marriage legal in 30 states (soon to be 35) and the District of Columbia.

Experts and advocates on both sides of the issue believed the justices would step in and decide gay marriage cases this term.

The justices have an obligation to settle an issue of such national importance, not abdicate that responsibility to lower court judges, the advocates said. Opting out of hearing the cases leaves those lower court rulings in place.

Two other appeals courts, in Cincinnati and San Francisco, could issue decisions any time in same-sex marriage cases. Judges in the Cincinnati-based 6th Circuit who are weighing pro-gay marriage rulings in Kentucky, Michigan, Ohio and Tennessee, appeared more likely to rule in favor of state

bans than did the 9th Circuit judges in San Francisco, who are considering Idaho and Nevada restrictions on marriage.

It takes just four of the nine justices to vote to hear a case, but it takes a majority of at least five for an eventual ruling. Monday's opaque order did not indicate how the justices voted on whether to hear the appeals.

#### Judge Strikes Down Alaska's Same-Sex Marriage Ban

The nation's oldest voter-approved amendment banning same-sex nuptials has fallen. On Sunday afternoon, a federal judge struck down Alaska's 1998 amendment defining marriage as an institution between one man and one woman.

"[A]ny relationship between Alaska's same-sex marriage laws and the government interests asserted by Defendants is either nonexistent or purely speculative," wrote U.S. District Judge Timothy M. Burgess, a President George W. Bush appointee, in his 25-page ruling.



Alaska's was the first ban of its kind, soon replicated in state legislatures across the country, and now the latest casualty in an unprecedented wave of pro-marriage equality rulings, set off by the Supreme Court's decision last year to invalidate the federal Defense of Marriage Act (DOMA.) Less than a week ago, the high court again made a bold move on behalf of same-sex couples hoping to wed, this time by declining to review any of

the seven marriage equality cases before it, and passing up the opportunity to hand down another landmark ruling.

On Monday, the justices refused to hear challenges against same-sex marriage bans in Indiana, Oklahoma, Utah, Virginia and Wisconsin – all of which saw their bans fall in both federal district and appeals courts. The move immediately legalized marriage equality in those five states, and doomed bans in six others that make up the 4th, 7th, and 10th Circuits. A day later, another federal appeals court – the 9th Circuit – struck down same-sex marriage bans in Idaho and Nevada, essentially making bans in three other states bound to that appellate ruling impossible to defend. Those states include Montana, Arizona and Alaska

Once the full effects of the past week's court actions are fully realized, there will be 35 states, plus the District of Columbia, where gay and lesbian couples can legally wed. A week ago, that number was 19. It may take time, however, for some of those states to legalize marriage equality, as several elected officials have vowed to continue defending their bans.

"As Alaska's governor, I have a duty to defend and uphold the law and the Alaska Constitution," said the state's Republican Gov. Sean Parnell, Sarah Palin's successor, in a statement. "Although the district court today may have been bound by the recent Ninth Circuit panel opinion, the status of that opinion and the law in general in this area is in flux. I will defend our constitution."

#### Melissa Klein, Anti-Gay Baker, Cries At Values Voter Summit Over Business Closing



am, Ore., refused service to a lesbian couple looking for a wedding cake. The subsequent fallout included national media attention and a state investigation for anti-gay discrimination, which may be supported by the Kleins' agreeing to bake cakes for an "ex-gay" group.

The couple is now reportedly fighting a \$150,000 lawsuit from the state, a reality that made Klein break into tears while discussing her passion for the process of baking wedding cakes during the Values Voter Summit.

"For me personally, when I would sit down with them, I just would want to know everything about her wedding," an emotional Klein told the audience. "I'd want to know about the flowers, her dress, the centerpieces, her colors, the way her hair is going to be. I would even want to talk about 'where are you going on your honeymoon?""

Following outrage over the business's anti-gay actions, Sweet Cakes By Melissa eventually chose to shut down their store-front rather than serve gay clients but the bakery is currently operating out of a home kitchen and is still taking orders online.

#### These Mormons Hope To Make Church More Welcoming Of Gays And Lesbians

SALT LAKE CITY (AP) — Court decisions this week paving the way for same-sex marriage to become legal in dozens of states, including Mormon strongholds like Utah, Idaho and



Nevada, have emboldened a growing group of Latter-day Saints who are pushing the conservative church to become more accepting of gay members.

The church's stance toward gays has softened considerably since it was one of the leading forces behind California's ban on gay marriage in 2008, but high-ranking leaders have reiterated time and again the faith's opposition to same-sex unions.

Some Mormons hope to change that, or at least work to make congregations more welcoming places for gays and lesbians.

Erika Munson, co-founder of a group that is neutral on gay marriage but is trying to work within church doctrine and policy to make congregations more accepting of gays, said she worries about losing younger Mormons because of the church's stance. One of her five children, an adult son, has chosen to not to practice Mormonism, in part because of the way LGBT people are treated at churches.

"People under 30 all know somebody who has come out. They are not the other, they are not scary. They understand that they are just like them," said Munson, whose group Mormons Building Bridges stays neutral on gay marriage because they want to work within church doctrine. "So, that's really hard to reconcile with a Christian church where we follow the teachings of Jesus."

On Monday — after the U.S. Supreme Court unexpectedly rejected appeals by Utah and four other states trying to protect their same-sex marriage bans — The Church of Jesus Christ of Latter-day Saints said in a statement that the decision will have no effect on church doctrine or practices, while acknowledging that "as far as the civil law is concerned, the courts have spoken."

Still, church leaders are not ready to accept gay unions. Dallin H. Oaks, one of the church's highest-ranking leaders, told a worldwide audience last week at a Mormon conference in Salt Lake City that legalizing same-sex marriage is among the world values threatening Mormon beliefs.

Yet he also urged members to be gracious toward those who believe differently in what many gay advocates in the church saw as the latest example of the softer tone leaders are taking.

The majority of Mormons will stand behind church teachings on the topic, said Scott Gordon, president of a volunteer organ-

ization that supports the church.

That doesn't mean they are bigots or hatemongers, though, as they are sometimes labeled, he said.

The reality is that most Mormons have gay relatives or friends they love, but they also agree with the religion's opposition to gay marriage rooted in a deeply-held belief that families are the center of life and for eternity, and that a family led by a man and a woman is best for children, he said.

"Marriage is not just about love. Yes, love is a large component of it, but marriage is about having families and raising children and doing those things that will help the children grow into adulthood," said Gordon, of FairMormon. "The fundamental teachings of the church are never going to change on this. We'll just adapt and move on."

The history of the church suggests Mormons could alter their views, although no one is expecting doctrinal change anytime soon.

Mormons believe in ongoing revelations from God, which has led to fundamental changes. In 1978, Mormon church leaders lifted the ban on blacks in the priesthood. In 1890, the church president at the time received a revelation to end the practice of

polygamous marriages that were part of the first 60 years of the church.

"They have change built into their cosmos," said Sarah Barringer Gordon, a history professor at the University of Pennsylvania. "Churches exist in societies as well and that can't help but effect how they think."

Spencer W. Clark said his beliefs began shifting when he became friends with gay and lesbian classmates in high school and college, and he eventually became the leader of a group of faithful Mormons that supports gay marriage.

He, Munson and others hope that same-sex couples will become visible, active members of their communities, allowing more Mormons to get to know and appreciate families led by gay and lesbian couples. Even if Latter-day Saints don't accept gay marriage right away, that could help break down barriers, Clark said.

"This helps people be more comfortable with it because it's no longer the big, scary unknown," said Clark, executive director of Mormons for Equality, who lives in Washington D.C. with his wife and three children. "They'll find out this isn't the doomsday scenario."

#### Russian LGBT Advocates Detained During Moscow Protest

Russian police on Sunday detained eight people who staged a National Coming Out Day protest in Moscow.

Nikolai Baev, one of those who was detained, told the Washington Blade on Monday that local authorities had authorized the protest. Dima Svetliy, who was also taken into custody, noted organizers had secured the necessary permits. "The rally was peaceful for the first half an hour," said Baev.



Baev told the Blade that policemen arrived and "claimed the action was not legal." He said protest organizers decided to take down their poster and flags, but the police nevertheless detained them and the handful of protesters. "Police officers asked the organizer to get into the (police) car," Svetliy told the Blade. "We understood that we were now screwed."

Baev said many of the policemen who detained them were wearing civilian clothing. "They were criminal policemen, who watched the rally and waited for the moment to detain the participants," he said. "This is a common practice in Putin's country; a lot of police agents watch all rallies in Moscow."

Pictures the Blade obtained from Baev show authorities detaining protesters and placing them into police cars. "Policemen started to drag people on the ground to police cars," said Baev.

Baev told the Blade he and the other protesters were brought to a local police station and accused of disobeying the officers. He said they released him and the other advocates three hours later. The protest took place against the backdrop of ongoing criticism of the Kremlin's LGBT rights record.

President Vladimir Putin in 2013 signed into law a bill that bans so-called gay propaganda to minors. Russian advocates with whom the Blade has spoken since the statute took effect maintain anti-LGBT discrimination and violence in the country has increased. Russian authorities over the last year have arrested dozens of LGBT rights advocates during protests and other gatherings. Police in Moscow and St. Petersburg in February detained more than a dozen activists who held pro-LGBT demonstrations on the eve of the opening ceremony of the 2014 Winter Olympics that took place in the Black Sea resort city of Sochi.

Authorities during the games arrested transgender former Ital-

ian Parliamentarian Vladimir Luxuria after she protested the Kremlin's LGBT rights record. Moscow police in May detained several advocates during two pro-LGBT protests. The Kremlin late last month withdrew from an American student exchange program after it said a gay couple convinced a Russian teenager to seek asylum in the U.S.

#### Nigerian Archbishop Flips from 'Jail the Gays' to 'Set Gays Free'

The Vatican, who has said gay people may have 'gifts and qualities' to offer the Catholic Church, may have already changed one bigoted view.

Nigerian Archbishop Ignatius Kaigama has flipped his position on the country's anti-gay laws that punishes ho-



mosexuality, gay clubs and societies with up to 14 years in jail. 12 states in Nigeria that enforce Shari'a law punishes gay sex with death.

When it was signed into law, Kaigama described it as 'courageous' and 'a right step in the right direction'.

But now, he has said the Nigerian church will defend any LGBTI person who is being harassed, punished or jailed for just being who they are.

'We are not supporting the criminalization of people with different sexual orientations,' he said, according to The Tablet.

We would defend any person with homosexual orientation who is being harassed, who is being imprisoned, who is being punished.' He added: 'The Government may want to punish them — we don't. In fact we will tell the Government to stop punishing those with different orientations.' Kaigama said he now only supports the part of the law that expressly bans same-sex marriage.



#### This Man's Cat was Killed Because He is Gay '

Andrew Davies, chief executive of the Swansea Bay Unity Project, said he discovered his dead black tomcat after it was dumped outside his home. His pet, who he named Jose, had been found forced fed with paracetamol tablets.



Davies has said this is just one of the many hate crimes he has witnessed in Wales. And while gay marriage may be a reality, it doesn't mean there are some who wish 'homos were banned from the area'.

'I didn't know at the time that paracetamol was so toxic to cats but my sister said it had been mentioned on Alan Titchmarsh's show the week earlier. Whoever did this may have picked up the idea from that,' he says in a new Welsh Government video.

'I then got a card saying sorry for the loss of your cat, but with a smiley face drawn on it.'

Davies says he gets numerous complaints on a daily basis from members of the LGBTI community in the Swansea Bay area, saying hate crime is a very real thing.

'It all started when I founded the Unity Project and people discovered I was gay,' he said. 'Notes were slipped under my door, saying "homos" weren't welcome in the area and that people were fearing for the safety of their children. 'Then I received a letter saying people had noticed a steady increase of "weird" people visiting my home and that this had to stop.

'The weird people being referred to were my friends and staff. It was alarming to think somebody was watching my home.'

The video was released by police forces in Wales who wish to raise awareness of hate crimes as part of the national Hate Crime Awareness Week.

116 hate crimes were reported in Swansea from just the start of April to the end of August this year alone.

#### How Being Gay 'Decimated' This Man's Life Savings

In February 2012, Paul, who is 59 years old and asked that his real name be withheld out of fear that using it



would further damage his career, got an attractive and lucrative offer from an outdoor sporting-goods company for a job in product development and sourcing, a field he has been in for about 30 years. Paul is an avid hiker and kayaker, and the move would allow him to focus on a part of the retail industry that he enjoyed and excelled at.

There was just one hitch. The job meant that he, his husband Peter and their teenage son James, who also asked that their real names be withheld, would have to leave Massachusetts and move to a small town in Nebraska, a state that does not recognize same-sex marriage and has no laws that restrict employers from firing an employee just because he is gay.

Paul did not hide his sexual orientation in the interviewing process. "The first thing they said was, they wanted to meet my wife because we'd be living in a very small community." Paul recalled. "I said, 'Well, I don't think that living in a small community is a problem. In fact, our family would like to live in a small community. And by the way, I don't have a wife, I have a husband.""

The recruiter was not troubled by this revelation, Paul said. He told Paul that "we are a very affirming company."

Paul, Peter and James visited the town and all three liked it. They bought a house in the country on 32 acres of land, where they grew a large garden and raised chickens. "We thought it was going to be a beautiful life," Paul said.

The problems began soon after they moved in. First, the company denied health insurance to Peter after initially promising to take care of him. Then there were the homophobic jokes in meetings -- and the company's indifference to Paul's complaints. Someone began sending Paul anonymous emails at his company address, daring him to step out into the parking lot. Finally, the company decided to do something about it. His boss called Paul into his office and fired him.

"Within 10 days, people started to contact me from within the company, telling me that I was let go because of being gay, and that once they knew that I had come out in the building, it was all over for me," Paul said. "We haven't recovered."

Paul's story is not unique. According to the report -- released this week by the Movement Advancement Project, a Denver think tank with a focus on LGBT issues -- LGBT families in states without supportive laws face greater financial hardships and have less money than comparable families in more supportive states.

As the report acknowledges, gays everywhere earn less than their straight counterparts, but the gap is far greater in states like Nebraska than in places like Massachusetts. Specifically, the report found that in states where same-sex marriage is banned, same-sex couples with children have \$8,912 less in household income than married opposite-sex couples. In states that allow same-sex marriage, that difference in household income is only \$689.

The report outlines three major ways that LGBT people can suffer financial blows in states that don't support gay rights. Without marriage equality, couples often pay more for health insurance, taxes and legal assistance, and yet they may still find themselves without adequate protection should a crisis occur. Without protection from discrimination on the job, or when seeking housing or medical help, LGBT people can struggle to find work, and may earn less money and have higher housing and medical costs than their non-LGBT peers. And in the absence of anti-bullying laws or a broad culture of support, LGBT students may struggle in school and fail to achieve their full potential in the workplace.

Paul and his family say they had trouble on all three fronts. Before they moved to the Midwest, they spent about \$1,400 ensuring that their legal papers, which they kept in a safe in the living room, were in order. But that turned out to be a minor expense compared to what the family would incur in Nebraska. All told, they estimate they lost about \$124,000, or about 70 percent of their liquid savings, on their investment in the move. They had to sell their farmhouse quickly, at a steep loss. They had abandoned Peter's antique and art shop in town. After months of searching for a new job and living off his life savings, Paul finally found work again — but he had to accept a 50 percent pay cut.

In some ways, the social losses were even tougher to bear. The church rejected the family's attempts to join. Colleagues at the sporting goods company made snide jokes about what gays did on camping trips. Paul mentioned an incident where one of his son's football teammates announced in front of the other players that James had two dads. Paul recalled what his son said then: "Yeah, I have two dads, that's common in Massachusetts." "Well. it's not common here," the teammate replied.

One day, after losing his job, Paul heard from the company's lawyer, who asked him the same question that his boss had already raised. "'What did you think was going to happen in this community?" Paul recalls the lawyer saying. "'We're a Republican town, we're a conservative town and we're a Christian town."

"I told them I will never forgive them for this." said Paul.

Unable to sell their house, Paul moved on to Pennsylvania while his husband and son stayed behind. Nine months later, they were finally able to sell the house and Peter's business, and today the family is living together in Pennsylvania, where same-sex marriage was legalized this May.

Paul is working at another retail company now, and his husband is settling their new house and beginning to apply to jobs.

Although they haven't recovered from their losses, Paul said, "we are determined to figure out a way to save our way back."

#### Chelsea Manning Sues Federal Government for Hormone Therapy

Wikileaks source Chelsea Manning filed a lawsuit in federal court against Secretary of Defense Chuck Hagel and the Pentagon Tuesday, demanding access to hormone therapy more than a year after her first request for such treatment.

The military's ongoing delay in providing such gender-affirming treatment has prompted the rapid deteriora-



tion of Manning's mental health, reports the Huffington Post.

Her lawsuit, filed Tuesday, seeks a preliminary injunction that would allow her to begin hormone treatment while the case is litigated, which could possibly last several years. Manning's legal team had previously indicated that they would file a lawsuit on her behalf if the Army continued to drag its feet on providing basic health care to Manning while she is in custody.

"It has now been more than four years since I was first diagnosed with gender dysphoria, a condition that I have struggled with my entire life," Manning stated in the filing. "I do not believe I will be able to survive another year or two — let alone twenty to thirty years — without treatment."

Manning is currently serving a 35-year sentence in an all-male facility at the U.S. Disciplinary Barracks at Fort Leavenworth,

Kansas, for leaking government documents relating to the wars in Iraq and Afghanistan to the website WikiLeaks in 2010.

The former Army intelligence officer publicly came out as transgender last August after she was sentenced. She has since been diagnosed by a number of military doctors with gender dysphoria, an incongruence between one's assigned gender and the one with which they identify. Hormone replacement therapy is one of a number of recommended courses of treatment for gender dysphoria, as outlined by the World Professional Association for Transgender Health's Standards of Care, and as supported by the American Medical Association.

In August, it was revealed that despite reports that Sec. Hagel had approved Manning's request to begin hormone therapy, she hadn't received any such treatment. One of Manning's attorneys, American Civil Liberties Union lawyer Chase Strangio, has been in frequent contact with Manning, and says she has been in "escalating distress" the longer the military has refused her hormone therapy, according to Huff Post.

"She, for a long time, retained the hope that they would do the right thing," Strangio said. "Since then she's been very desperate for relief for a very serious condition which is not being taken seriously."

David Coombs, who represented Manning in her court-martial trial, is reportedly involved in the new federal lawsuit, as well. Coombs had previously indicated the possibility of filing an Eighth Amendment lawsuit if the military continued to deny his client the treatment, which he argues is "cruel and unusual punishment."

However, the Army has been resistant to providing that treatment, pointing to a military regulation that determines any transition-related treatment, or even a diagnosis of gender dysphoria, as grounds for discharge and evidence of a "mental illness."

But in Manning's case, she cannot be discharged from the Army while she is serving out her sentence. This leaves the military with limited options: deny her treatment in a military prison and face the current lawsuit, or treat her in a military facility and set a new precedent.

The Army has declined to comment on the ongoing litigation.

#### Life Beyond Therapy

Please consider the following question: "Do we see ourselves as people with aspirations of patience and empathy towards our brothers and sisters or - instead – as consumers who are entitled to the best stuff this world has to offer, so we'd better get out there and get as much of it as we can?" I



know I've set it up as an either/or proposition here, but bear with me. Whether you're a Buddhist monk or a reality show star, isn't happiness your goal? And, if so, how do you get happiness? Can you buy it? If so, where do you get it and how much will it cost? If you can't buy it, what are your alternatives?

Many of us happiness-seekers have big problems with delayed gratification, especially those of us raised in more recent times where advertising shouts at us, "Get it now, don't wait, only an idiot would be patient." It feels like we're leaving our hearts and minds behind as we focus instead on accumulating as much cool stuff as we can. That L'Oreal commercial "Because I'm worth it" sums it all up. As an advertising slogan, it's awfully good. It messes with our heads because ... of course we're worth it. We're worth whatever we want. Don't we deserve whatever we want? This kind of thinking can suck anyone into a whirlpool of spending, temporary satisfaction, and - ultimately - depression that leads to more spending and eventual debt. Debt does not equal happiness, can we agree on that?

We all want to be happy and being a good consumer looks like an easy path to get there. Really good advertising – and there's a lot of it around these days – tries to manipulate our emotions. As a result, it's no surprise that so many of us feel we're not living up to our (earning/achieving/sexual) potential and are cosmic losers. This doesn't mean we can't enjoy nice things. But, it's wise not to make them the most important thing in your life. If you have money and beautiful objects, great! But if you don't, can you be okay with that too? Or will it suck you down into depression?

Let's ratchet up the consumerism dial and ask another question: are we people or are we brands? I recently read how a young gay man had decided to turn himself into a brand so he could become wealthy and popular. This is not the way to happiness. If it worked, Paris Hilton would be up there with the Dalai Lama and Mother Teresa. This young writer stated that, "typically younger gay males 17-21, use skills they've yet to learn in marketing 101, and turn themselves into a product, complete with brand recognition...branding one's self (sic) is the new way to claim a piece of fame in our local bar and club scene". This could be amusing if it were playful, but it's pretty damned sad to me. Do we want a piece of fame so badly that we're willing to commodify ourselves to get it? So much for having personality, intelligence and social skills. Am I just an old fart who wonders why integrity, honesty and patience don't matter anymore? Maybe so.

Being a big-time consumer and turning yourself into a brand may get you some good stuff, but it usually brings anxiety and depression, NOT happiness. Author Patricia Pearson, in her terrific book, A Brief History of Anxiety (Yours and Mine, found that 28.8% of Americans will suffer anxiety in their lifetime – the highest level in the world - and that \$4.2 Billion is spent annually, in the USA alone, on treating anxiety. I posit that there is a relationship between the crazy anxiety epidemic in this country and the out-of-control consumerism that so many of us get sucked into. As a therapist, I typically see several people a month who have racked up huge debt as a result of the "I'm worth it" school of thought. Believe me, they don't come to me because they're happy...they come to me because they want to find a way out of the low self-worth that comes from thinking you're nothing but your brand, your house, your clothes or your stuff.

As someone who has a comfortable home, nice car and enjoys clothes, music and eating out, I am not recommending that you give up the basic comforts you've worked so hard for. What I AM putting out for your consideration, however, is the idea that you cannot buy happiness, you can only buy things, and the happiness that comes from things is temporary. Even if you become as popular a "brand" as Pepsi, Madonna or L'Oreal, happiness, peace of mind, friendship and a wonderful lover do not come with the package. Those joys typically come to us another way: through patience, humility, honesty, kindness and empathy to others.

- 1/8 tsp. ground black pepper
- 1/8 tsp. garlic powder
- 1/4 cup grated Parmesan cheese

#### Methods/steps


