Recently seven men were arrested in Omaha and Lincoln on charges involving child pornography and sexual assault on children. More arrests may occur.

laws in the state of Nebraska are perfectly clear. You don't have sexual relations with persons under 16 years old. A new law recently passed by the Legislature that went into effect in September also makes it unlawful to have in your possession sexually explicit materials depicting children under 16 years old. It is also unlawful to distribute, sell. or make sexually explicit films or material.

The Omaha and Lincoln police as well as the FBI recently conducted a lengthy investigation involving individuals engaged in these unlawful activities. The most notable of the arrests involved Jerry High who has been charged with first degree sexual assault on a child and generating child pornography. High was the previous owner of a Lincoln gay bar called Molleno's, which had not been open very long. However, the fact that a gay businessman has been arrested for exploitation of children has tarnished the gay community to a small degree. This is all homophobes need who already boast that gays are child molesters who spread AIDS.

The New Voice supports the efforts of the police to arrest and convict individuals who use and abuse children.



Out & About in Omaha

I get out and about less and less as the protective covering of the trees and shrubbery has fallen to the ground and the phobia about AIDS blossoms all around me. I see the bar scene in Omaha changing as there is less cruising, more fear of being open and, per chance, making contact with the "wrong type."

We have been warned against casual sex with unknown partners, and there are so many who do not know or practice the art of conversation or making friends. I realize that this is difficult with the music blasting you off the dance floor, but it seems that it must be done. It is not easy to ask a stranger if they believe in safe sex when you don't even know their name. A recent report in The Wall Street Journal (October 24) shows a strong correlation between the use of drugs (IV, pot, poppers, speed and so forth) and the development of AIDS. Since most drugs other than poppers, and boose is either against the law or prescribed by doctors, we don't normally know a person's drug intake on a first meeting. It is just another reason to get to know a person before bedding them.

On October 20, I attended a "Safe Sex" Seminar at The Max. I learned something there: We have been told of the warning signs, but did you know that when they refer to night sweats, they mean sweating to the point of needing to change bed clothes on a nightly basis over an extended period, and that elevated temperature refers to a continual reading of 101 degrees for a period of more than a week. That puts a different setting on my panic button. The seminar was interesting in that three people brushed the subject of Safe Sex and seemed to hedge on the graphic descrip-

Lincoln Group Seeks Community Center

A gay/lesbian community center in Nebraska? That is almost unthinkable. But the Third Culture in Lincoln is thinking big and is hopeful that a house can be purchased near 29th and R to serve the community. The property would provide space for housing, group and individual counseling, office space, and a group meeting area.

To help fund the project,

which requires an initial investment of \$4,000, Lambda, Inc. was created. Lambda, Inc. is a for-profit real estate and leasing corporation whose stock sales would be used to buy properties of interest to the gay and lesbian community. Union College Gives Lesbian Ultimatum

Union College [my alma mater] is at it again. Recently, through a series of events, the administration discovered a student's Lesbian identity. Becky [not her real name] was given an "alternative" concerning her sexuality: she would have to go through a 'homosexual rehabilitation' program designed to cure homosexuality, or she would be expelled, in which case she would receive no credit for the courses she was taking. At the same time, she was pressured to confess her sexuality to her parents (which she did), and when/if she chose to stay at Union College, the issue would be discussed at the Deans' Council. While Becky was trying

to decide what to do, she was called in to see the Women's Dean, who wanted to know the names of other female students she'd had sex with and the names of other Lesbian students on campus. (Can you imagine?!)

Becky spent several days away from Union trying to evaluate other alternatives. Her friends gave her a lot of support and a place to stay during that time. Even so, Becky suffered a great deal of anguish and finally decided to go home. It is not known what she faces there.

This kind of thing has happened before at Union College, but I

Terry Taylor Receives Life Sentence

On December 21, 1984, a tragedy occurred that has affected the lives of many people, including those in the gay community. Ben DeBeats, Jr. was brutally murdered. DeBeats' body suffered 51 stab wounds and was found in the trunk of his car. Soon after the discovery of his body, DeBeats' former lover, Terry Taylor, was sought and apprehended by Lincoln police. Initially he was charged with manslaughter, but the charge was changed to first degree murder. Approximately three months ago in an apparent plea bargain, charges were once again changed -- to second degree murder. At that time a pre-sentence investigation was initiated to help the judge determine sentencing. On November 27, Lancaster County Dis-trict Judge Jeffre Cheuvront sentenced Taylor, 22, to a life sentence after 5 90-minute hearing was conducted.

The human toll is immense and the scars will be felt for many years. Never has the gay community of Lincoln witnessed such a tragedy since the murder-suicide of two male lovers in the late 1970s. Many people knew of, or saw, Terry Taylor and Ben DeBeats, Jr. In the bars or gay social sphere of Lincoln. Those who knew Terry were shocked and bewildered because it was felt that he was incapable of any kind of violence. He was known as a friendly, non-aggressive individual. Taylor's father, John Taylor of Broken

Arrow, Oklahoma, and his grandfather, Dr. Bowen E. Taylor, testified that Terry was quiet, caring, and hardworking.

The DeBeats family has suffer-

ed a great amount of grief.
Mrs. DeBeats said her son had
confided in her that he was
homosexual, and she and her
nusband had accepted that.
Ben, 18 years old, had received a grant before his death
and he had planned to study interior design at the University of Nebraska - Lincoln.
Sarlier testimony had revealed
that Ben met Taylor in the
summer of 1964 and the two
eventually became lovers. They
moved into an apartment at
610 S. 17th on September 1,
1964.

Taylor expressed regret and remorse before the sentencing. Terry stated, "I loved Ben very much. I cared for him. All I ever wanted was to be with him. Things changed, It created a situation that neither one of us was experienced in handling. It led to arguments once in a while. If one of us had the guts of leaving that night this would never have happened. I take full responsibility. At times I wish I could take his place. I realize there is pain and anger against me. I can't exanger against me. I can't ex-press how sorry I am about everything. I don't ask their forgiveness (DeBeats' family). I know how they feel. I know I have hurt my family. It is hard for them to deal with it all and me to deal with it all. I hope that sometime I can be forgiven, at least by my family. I love them very much. I realize that I will spend a lot of time. There is nothing anyone can do. I loved him very much. I'm

State Health Department Minimizes AIDS Problem

The Nebraska State Health
Department in recent announcements has minimized the serious
problem of AIDS as well as
shown irresponsible conduct in
their reporting. On November
25 the Department suddenly
announced three more cases of
AIDS, bringing to seven the
total number of cases in 1985.
It has been known since late
1984 that statistics were
underestimated and not reported
correctly. Why, suddenly, did
three cases get reported in one
day?

The State Health Department reported that the first case of AIDS in Nebraska was reported in 1983. Two cases were reported in 1984 and seven have been detected so far this year. All 10 cases reported involved males between the ages of 28 and 69, with an average age of 38.7 years. Nine of the cases occurred in the state's metropolitan areas. Eight of the men were homosexual or bisexual and the remaining two cases resulted from blood transfusions. The Department reported that no trans-fusion-related AIDS cases have been reported in Nebraska since blood banks began screening

donated blood for the AIDS-related virus this spring.

The State Health Department also minimized the problem by stating that Nabraska remains a low incidence state. The State Health Department director, Dr. Gregg Wright, stated that AIDS was a severe public health problem but he did not say what the department was doing as far as education and research. It is apparent that the Health Department is doing too little, too late. The word epidemic was never used in the press release but has been used nationally by public health officials.

It was also reported recently that Lancaster County had its first case of AIDS. Earlier the State Health Department stated an unwillingness to release county-wide statistics, apparently fearing that persons in smaller counties would react hysterically.

Lastly, the Department asked individuals in high risk groups to take steps to lower their risk but did not outline what these steps were.

Nebraska Wesleyan S.A.S. Support Protection of Gays

On Monday, November 18, 1985, the Student Affairs Senate (SAS) at Nebraska Wesleyan University, in a move to reflect their concern, passed, nearly unanimously, Senate File 9-85R. The primary portion of this bill states:

 This Senate shall not discriminate in any way against any minority group which organizes itself for the purpose of discussing circumstances of and consequences faced by that group because of that group's or its members' sex, race, creed, ethnic origin, sexual orientation, national origin, or handicap.

It also contains an important statement in item 4 when it says:

A) No group meeting as a minority for purposes of discussion of that minority's concerns, if that group is a minor-

ity group because of its members' sex, race, creed, ethnic origin, sexual orientation, or national origin, shall be defined as or categorized with groups formed by, of, or for persons with abnormal behaviors or physical, mental, or emotional ailments or disabilities by this Senate or any of its committees. All members of the campus community are urged to avoid such definitions and categorizations.

At the time of this writing, it was not certain whether the President of Nebraska Wesleyan University, Dr. John White, would sign this bill. Any bill passed by the SAS must be signed by the President. Should he not sign it, the SAS may then appeal it to the Board of Governors. It is this writer's opinion that Dr. White will sign this legislation, because it is only binding upon the Student Affairs Senate and is not in conflict with existing Administrative guidelines.

Congratulations to the Senators

at Nebraska Wesleyen University for the evidence of their concern that all persons be guaranteed their rights with "all humans of sacred worth" ("Administrative Guidelines for Gay and Lesbian Support Group," 1984). As one alum said, "Great' Sounds like Nebraska Wesleyan University is moving into the twentieth century!"

In addition to this legislative action by the SAS, the Nebraska Wesleyan Student Group continues to be alive and well. This group has also reflected its compassion and ability in reaching out to other suffering people. Recently members of this group reached out to a women in need and ministered to her. I would like to publicly thank those who helped—for their willingness to reach out to another person of worth.

Continue to watch us. We at Nebraska Weslevan University may not be as vocal as others, but we are working!

Gay Couples—Holidays


Have you ever wondered what other couples do for the holidays? Thanksgiving and Christmas are considered family holidays. This can bring up issues about our own families and holiday rituals. It can also be a time of feeling alone and depressed. The holiday rituals that we experienced as children linger with us as adults. It is important to respect and remember those traditions.

Rituals are behaviors that we repeat over and over again. They incorporate behaviors that are meaningful to each individual and possibly communicate meaning to other people. A Christmas ritual might be you and your partner having oyster stew together on Christmas eve and making a toast to each other. This might be followed by sitting in front of the fireplace and opening special presents from each other. It has meaning, because the two of you are doing it

together, and it incorporates the warm feelings you had as children when your families had oyster stew. It is a special time that the two of you set aside and do not allow other people to interrupt. When you think of Christmas later in the year you might conjure up the feelings you had with each other in front of the fireplace. The more you repeat this ritual, the more it has meaning.

The holiday rituals we experienced as children were neat, but we did not have much to do with creating them. Gay couples do not think much about creating rituals, but it is important to do just that, especially at this time of the year. Rituals that you repeat each year help bond the two of you to each other. There are no formal rituals for gay couples, like there are for straight couples. This may be an advantage, because the rituals you create with your partner will have far more meaning than the ones created by tradition.

It is helpful to look at the rituals What about your families? Many of you had as a kid and incorporate some of those into your adult ritu-als. Violence Against Wimmin —Part 2

(The following to Part 2 of a two-part editorial aubmitted by H. Moore and the counselors of the Rape-Spouse Abuse Crisis Center. Part i was published In the November issue.)

The recent opinion in State v. Hunt vacating the sentencing of Robert Hunt, Jr. communicates to the women of Nebraska a whole set of misogynist messages through the application of the law. Understand from the out-set, the imposition of the death penalty is not the focus. We must set that aside because many women among us feel that the death penalty is applied in a discriminatory pattern nationwide (as are murder charges). Instead, we must challenge the messages included in the formal opinion of State v. Hunt and reiterated in public by Chief Justice Krivosha at the University of Nebraska, Lincoln on September 12, 1985.

The majority of the Court denied that aggravating circumstances were involved in the death of Beverly Ramspott. They argue that the murder was not committed to conceal the commission of a crime, but was an act of "sexual gratification." They further assert that "There is no evidence that acts were performed for the satisfaction

of inflicting either mental or physical pain or that pain existed for any prolonged period of time." Many details of the case have been presented in public media, and Krivosha has stated publicly that Mike Royko and other critics have not read the opinion or have misrepresented the legal "hair splitting" that occurs in this case.

The above quotes -- from the Nebraska reports-and the general media coverage of this Issue send the following messages to us:

That any rapist who kills or renders unconscious a victim first, and then rapes that victim, has established a "not especially helmous, atroclous or cruel enough" scene for the crime of murder.

That sexual assault is sexual gratification. By drawing a parallel between these two acts, the motivation for sexual assault is obscurredthat motivation being domination, power and the degradation of women. By using the term "sexual gratification" the justices imply that a reciprocal relationship exists between the victim and the assailant. This is patently

In Krivosha's public comments, he states that ". . .
the reason for the slaying was sexual gratification." This equates murder with sexual gratification—another dangerous idea to reinforce in our paternalistic society.

4. That the unconscious state of the victim somehow mitigates the acts surrounding a murder. The use of the victim's unconscious state as a "mitigating circumstance" is not accepted in Nebraska as an excuse for sexual assault (e.g. if the victim is drunk, not competent or conscious), why then should it he a mitigating circumstance for murder?

More to the point, we have no proof of Janet Ramspott's unconaclous state throughout the sexual assaults and murder. The only evidence we have is the lack of water in the victim's lungs, which places her death at any time before she was held under water by her murderer. Note that the court depended upon the convicted murderer's testimony for the time of her death though he noted that he felt a pulse after sexually assaulting her, and then tried to drown her) and for the time of her loss of consciousness (within one minute of entering her housel. The burden of proof should be upon the defendant to prove that his victim was not conscious up to and until he dragged her to the bathtub. She may well have been conscious during each of his assaults against her; bound and gagged, she could hardly struggle in any way that would give physical evidence of her not suffering. Janet Ramspott cannot speak to the especially heinous, strocious and cruel acts carried out against her, but we can and must.

Judicial and community energy should be put into challenging the vague statute created by State v. Stewart. Arguing against the "especially heinous" victimization of Janet Ramspott increases the burden against all women victims of sexual assault. As elected officials, the State Supreme Court Justices must attend to the community standards of all Nebraskans. Our agreement or disagreement with the death penalty per se cannot be used to stifle our outrage at the opinions expressed by a majority of the court. The Supreme Court engaged in legal denial of a victim's "experience" of a painful death and sexual assault, which led them to unproveable and dangerous conclusions.

The week of October 5-11 was a statuwide focus on Violence Against Women Awareness. Women in Lincoln organized a series of educational and political activities concerned with sexual assault and violence on the job, in the legal system, in schools. and in the lives of women of color. The justices of the courts were sent a copy of this editorial and invited to attend a Community Symposium on Vic-Lence Against Women. None attended. Each of us must decide where and how we will work for women victims of vialence-in our courts, at the voting polls, at our centers and crisis lines or in our own personal recoveries.





Nebraskans Attend National Affirmation Meeting and inclusive

More than 60 people from at least 17 states, including 4 from Nebraska, participated in celebrating Affirmation: United Methodists for Lesbian and Gay Concerns' 10th birthday held this past September 20-22 at Wheadon United Methodist Church in Evanston, filinois.

The work of the weekend included regional organizing with an emphasis upon more grass-roots activities. Nebraska is only one of several local groups to have organized in recent months. In addition, the Reconciling Congregation Program now includes 15 local congregations who have chosen to be intentionally supportive

and inclusive of lesbians and gay men. Inquiries about the Reconciling Congregation Frogram continue to be received from all over the country.

The national meeting next turned its attention to the AIDS epidemic. While the population most affected is the gay male community, AIDS is a danger to all people -regardless of gender, race, class or sexual orientation. Affirmation is working on a more detailed statement to be released after its Coordinating Committee meeting in February of 1986. Work began for selecting a new Coordinating Committee to take office in the spring of 1986. Pledges in the amount of \$10,000 were raised to underwrite Affirmation's work.

Living with Dignity in Omaha

Lesbian and gay persons are full members in Christ's mystical body, whole persons God made in a self image. This is a basic tenet of DIGNITY International, a lay organization of Roman Catholics which has more than 90 chapters across the U.S. and Canada with other affiliates throughout the world. The organization was founded in 1969 by an Augustinian priest working with gay and lesbian Catholics at San Diego, CA.

DIGNITY has four areas of concern in its Statement of Position and Purpose. Foremost is spiritual development where the organization strives to help its members attain Christian maturity through various means, notably Eucharistic celebration.

Another concern is educating the gay and lesbian community in the realization of selfworth. Social involvement, to demonstrate to both the gay/lesbian community and the community at large that gay and lesbian persons truly are children of God and do contribute to a community of love, is another part of DIGNITY's concern. group also aims to work with other homophile groups for the cause of justice in the gay community and to promote a sense of solidarity, and aims to work with other religious and secular groups to help them understand gays and lesbians and to recognize present injustices.

Finally, DIGNITY strives to arrange social and recreational activities in an atmosphere where friendships can develop and mature and where the gay's/leabian's sense of acceptance and dignity may be strengthened.

DIGNITY/Omaha just recently became a "chapter in formation" --something of a "mission" under tutelage of the DIGNITY regional office at Chicago. The Omaha chapter's aim is to grow and take an active part in the Christian and specifically Roman Catholic community, providing a place for encouraging Catholics to retain their faith in God and ties with the Church.

The Mass arranged by DIGNITY/ Omaha is the second Sunday of each month at 7 pm at St. John's Church on the Creighton University campus. The "Celebration Room," a smaller chapel at the north end of the church's lower level, provides a setting especially conducive to prayerfulness and sharing. DIGNITY/Omaha is affiliated only with DIGNITY International and



A Choice

With the unslaught of news about AIDS patients and victims, I have become oppressed by the frustration of how to channel my energies to best help the gay community. I have learned to engage in safe sex, and promoted it in various ways. I have read extensively about people with AIDS from Rock Hudson to porno stars to infants. I have supported various fund raisers for AIDS research. I have read a book on spiritual gifts to help recognize my gifts that might be helpful at this time, as well as Elizabeth Kubler-Ross's book On Death and Dying.

My faith in my God has been helpful to me as I know that I do have eternal life, and that I am neither condemned to hell or to have AIDS because of my sexuality. I have looked for and found fellowship with other believers. I know the principles of Christian Love which are set forth in the scriptures, and I attempt to incorporate these into all of my inter-personal relationships.

Having recently read On Death and Dying, I am overwhelmed by the common thread of despair in the various case studies. None were done with a gay person with AIDS. The studies did reflect the loneliness during dying by people with strong genetic family ties.

I recall the Biblical account of Jesus as He prayed alone in the Garden when He knew that He was to die, and His anger at His disciples as they slept through His hour of despair. However death comes to me, I choose to have people around me that share my Christian philosophy of Love.

I will still have my hours in the garden when I must face death alone, but I will also have times such as the Last Supper when friends gather in communal love.

We cannot choose our genetic family; however, we can choose our friends. If you hold to the Christian concept of Love, and have not become a part of a congregation (Church family), I urge you to do so. You don't have to have AIDS to need people, and becoming a part of a church will not guarantee that you will not get AIDS. People who know their need for people are the smartest people in the world. Scripture records in the story of creation God's first revelation, "It is not good for man to be alone."

Film Depicts M.C.C.

The Universal Fellowship of Metropolitan Community Churches has prepared a documentary which is available on video tape. I have had the privilege of viewing this film twice. Both times, I was moved at the concern expressed by those in leadership positions within the Universal Fellowship of Metropolitan Community Churches (UFMCC).

This film is primarily about the history of UFMCC, but also reflects a portion of our history as Gay men and Lesbians. It was begun in the late 60's prior to Stonewall and was incorporated in 1970 as the International Universal Fellowship of Metropolitan Community Churches. Primarily a religious organization, the UFMCC is also a political force to be dealt with.

There are over 200 churches world-wide, in ten countries with approximately 30,000 members. The UFMCC was the first Christian denomination to be organized around sexual orientation. The sexual orientation of members is not the main focus of UFMCC. The message is that God's love is for

everyone. About 20% of the members are not Gay.

This film was especially moving to me, because it caused me to remember some things I had forgotten. It tells of those churches which were mysteriously destroyed by fire, of those that have been vandalized, and those that have been destroyed. But more importantly, it brought back to my memory that there have been lives lost in these acts of violence against a group attempting to bring God's love to a suffering community.

M.C.C. of Omaha has a copy of this film which it will be showing at various functions within the community. MCC Omaha and UFMCC are attempting to raise funds necessary to show this film on television. Your contributions toward this end. or your inquiries concerning this film may be directed to:





How to Choose Condoms

There are many Kinds of condoms --latex, sheep gut, lubricated, unlubricated, long, short, wide, narrow, thick, thin, smooth, ribbed, ruffled, mushroom topped, receptacle tipped, round-ended, clear, opaque and brightly colored--they also have different tastes and smells. The main thing to remember when choosing the right condom for you is to EXPERIMENT!

Try out lots of different kinds using safer sexual activities such as maturbation, and intercourse between the thighs. Be sure to BREAK SOME while you practice so you know how much stress you can reasonably put on rubbers and what it feels like when one breaks.

* LATEX OR SHEEP GUTS?

Some users prefer condoms made from the appendix of sheep-often called "natural" condoms. However, latex is more durable and provides better protection. Both rubber and sheep intestines are highly impermiable, but the animal fiber condoms have walls of unequal thickness and thus tend to leak or break more easily. They should be used with those occasional people who are allergic to rubber, or who have such an aversion to latex that it's sheep guts or nothing.

* LUBRICATED OR UNLUBRICATED

There is evidence lubricated condoms do not break as easily as unlubricated ones. Lubricated rubbers also give that moist natural sexual feeling next to the skin that is missing in the dry, powdered ones. And because they are a little more slippery, lubricated condoms provide greater sensation to the wearer.

Rubbers are lubricated with gels or silicone based products. These are injected into the condom package just before sealing it. Gels tend to coat the rubbers unevenly inside the package, while silicone products (because of their molecular properties) lubricate all parts of the condom equally. This means there is less goo when you open the package and that the rubber is less likely to break from grabbin on dry spots during use.

* DIFFERENT SIZES

Most large manufacturers make at least two condom sizes--Class I: (7.1" x 4.2") and Class II (6.4" x 3.6"). Some manufacturers also make narrower condoms as well. These are usually advertised as "snugger for extra sensitivity." And for those who are "hung humongous," there are a few condoms which are longer and wider than the above sizes. So when picking a brand SHOP AROUND and remember, rubber ST R E T C H E S to fit many sizes!

A point you may wish to consider about condon size is that rubbers which fit snugly at the bottom create a slight tourniquet effect on the superficial veins. This makes a harder erection and increases the power of the orgasm--much like a cock ring works. If you like this effect, GO FOR IT! The researchers say it's safe fun --if not, pick a rubber which does not slip too much.
