

### ATTITUDES!

I realize that I have an attitude problem. I have failed to sympathize with gays/lesbians that want to talk about Gay Rights. For so long I have heard about civil rights from the blacks- to the point that they seemed to want privileges above other peoples just because they were black.

Now I find myself a part of a social minority. However, I have never been refused housing or evicted because of my life style (I have known gays that were evicted because a part of their lifestyle was to have property damaging parties).

I have never had problems in employment (as a High School English teacher - I taught English). I have never been denied visiting privileges with a lover in an ICU. I have never had a last will and testament contested. I've never been sued for "pal-a-money" for failure to disclose a medical condition.

I have experienced bankruptcy and divorce. A large portion of the pain of these encounters with the legal system was caused by my ignorance. I may never encounter any of the problems that gay rights are involved in, but then I never thought I would be involved in bankruptcy and divorce. I will undoubtedly not become an expert on any of these rights until they are denied to me, but I hope I will always be open to learn what is being done in the area of gay rights and supportive of those that fight for these rights in the courts and in the legislative bodies. My right to be gay only extends to the point where it infringes upon someone else's right- but the reverse is true too. I have the right to be gay and to pursue happiness as earnestly as any heterosexual or moral majority or anyone else.

My attitude is changing in this area. There is hope even for me.

### The Big Lip Sync Contest is Underway

The Big Lips are coming! The Big Lips are coming! Don't beware. Its only the first gay/lesbian lip sync contest held in Nebraska. But its no small affair. The New Voice staff is working hard and heavy to make this one of the biggest and best events yet.

The competition will begin at The Boardwalk on February 2. Other preliminaries will be held at Stars Restaurant on February 23, and Cherchez la femme on March 2. The top five performers in each of the preliminaries will advance to the finals which will be held on March 23 at The Max. All the shows will be held on Sunday evenings beginning at 9pm.

The contest is open only to amateurs. All contestants must be 21 years of age or older. Contestants can enter only one competition either in Omaha or Lincoln. Persons may enter as an individual and may also enter in a group category.

Each performance is limited to a maximum of 5 minutes. Props may be used but must be approved by the Lip Sync Committee and the bar/restaurant where the competition is held.

An entry fee of \$5.00 must accompany each application. All applications must be sent to The New Voice, P.O. Box 80819, Lincoln 68501. Applications must be received no later than one week before each show.

The December meeting of representatives from the Omaha Gay/Lesbian Bars and Organizations was held at the Run Bar. Represented were The Run, The Stage Door, River City Mixed Chorus, Dignity, MCC Omaha, The New Voice and The P.A.G.E.

The P.A.G.E. was acknowledged as having been well received as a useful tool in planning individual social calendars. Improvements are planned to make The P.A.G.E. more attractive.

The employees of The Run informed us that some 40 people shared a pot-luck meal at the bar on Thanksgiving. They were hoping to have another communal meal Christmas and New Years.

Dignity representative discussed the possibility of an ecumenical Eastern service with MCC Omaha and other Christian groups recently formed in Omaha. Easter comes early this year.

# Nebraska A.I.D.S. Project Announces Plans

The Nebraska AIDS Project held training for 28 volunteers over two consecutive weekends in November, and the Nebraska AIDS Project Information and Referral Line went into operation on December 1, 1985. The opening of the line represents the accomplishment of over 40 volunteers who have played a part in training, as well as more than 85 donors who have contributed to the project. In the face of an epidemic such as this, it is very gratifying for me to see the generosity and involvement of so many Nebraskans in this effort. The line is open from 6 p.m. to 11 p.m. daily at (402) 342-4233.

The steering committee continues to work at setting a course for NAP to follow in the months to come. Long range plans for 1986 and beyond are currently under discussion, and now is an ideal time for interested persons to become involved in the governing committees of NAP. Current plans are to hold a fundraiser aimed at the Omaha community in early February, and the steering committee hopes to be able to expand the phone service to a statewide toll-free line sometime in calendar year 1986.

Announcement of the opening of the information and referral line is taking place in a tiered process; initial announcement has been made in gay publications, on posters in gay establishments, and in letters to health and human service providers. Later phases of this process will involve advertisements in the general media in Omaha and Lincoln, and later in the general media throughout the state.

## Hark! The River City Mixed Chorus Sings

Omaha's River City Mixed Chorus, under the direction of John Zeigler, presented holiday concerts on December 15 and December 22...and both audiences loved them!

Sunday, December 15, The Max was the location of the concert, which was a benefit for the Nebraska AIDS Project. An estimated 100 people were present on this, the anniversary of the Chorus's very first concert. And since this year's Chorus had nearly 30 voices, compared to 8 last year, a lot more Christmas cheer filled The Max!

The program consisted of three sections. Section one contained the opening anthem, Brothers, Sing On!, followed by the "Morning Hymn" from The Sound of Music. Then, as accompanist Dale M's fingers flew over the piano

keys, the Chorus, with soloists D. Eric and Alan W. presented a Mozart cantata. To close the first section were selections from Irving Berlin's Holiday Inn.

The second section was Benjamin Britten's A Ceremony of Carols, featuring a large portion of the Chorus accompanied by Guest Artist Mary W., Principal Harpist of the Omaha Symphony. Solos were sung by Toni P., Ann S., Jerry K., and Phil O.,

The final choral section began with several traditional vocal Christmas pieces, followed by a quartet of Jonathan M., Jerry K., Alan R., and Tony A., playing recorders. Then, O Holy Night featured solos by Jerry K., Howard S., and Jonathan M. Mary W. treated the audience to a performance of Greensleeves, and the section concluded with the favorite, Winter Wonderland. The concert ended with a sing-along, where the entire audience got into the act!

The entire presentation was repeated for the general public, Sunday, December 22, at Lowe Avenue Presbyterian Church in Omaha. This was the Chorus's first major publicly-promoted concert.



In the Old Testament, the son of Isaac that most of us remember is not Esau but rather, it is Jacob. Esau sold his birthright to Jacob for some pottage, and as a result, history emphasizes the greatness of Jacob, rather than the weakness of Esau, his brother.

have encountered many self-proclaimed Christians and yet, when faced with a health crisis or death, they express to me their powerlessness in dealing with their own weaknesses.

Most of us have been guilty of selling our birthright to someone else. When we make statements such as: "I am the way that I am because of my family situation growing up," or, "Being gay or lesbian, and being a Christian are incompatible with the teachings of God and of the church," we have already sold our birthright.

Harry Truman had a plaque on his desk when he was President that read, "The buck stops here." It is my belief that we in the ministry and in the Church as being the People of God, need to emphasize the goodness of our humanity and celebrate our individuality, instead of apologizing for ourselves or blaming our lot in life on someone or something else.

I am amazed at the number of people that know about my sexual/affectional preference and yet some of these same people cannot understand why I am even entering the ministry in the first place.

I too have been guilty in the past of not naming and claiming my birthright. My sexuality has enhanced my life as a person and as a future minister, but, on the other hand, sexuality is not my whole life either. There is an importance difference here.

numerous articles on the subject in the August and September issues. "Safe Sex" have become the buzz words. But I think an important issue has largely been ignored here.

AIDS is a mostly sexually transmitted disease, and gay men in particular are dying from it. But a lot more children die each year from child abuse, a crime committed against them. Both issues are behavioral issues. A child surely is not born into a family knowing the risks of being the child of an abusive parent (even if he did, there is nothing he can do about it). A gay male, on the other hand, goes into a sexual encounter knowing full well, hopefully by now, the risk of contracting AIDS. Yet bathhouses are still open all over the country, and gay men still engage in anonymous tricks and one-night stands.

Can we say, then, that one is in fact the helpless victim and the other the conscious victim? The adult who abuses a child is responsible; the gay man who contracts AIDS, and the pick-up who gave it to him, are EQUALLY responsible.

I am a lesbian. How does all of this affect me? At first, I didn't think it did at all because lesbians have the least incidence of any sexually transmitted diseases, including and especially AIDS. But AIDS does affect us in a non-direct way. Social Hitlers like Paul Cameron, Jerry Falwell, and Jesse Helms are using AIDS as the reason why ALL homosexuals should be quarantined, thus "legitimizing" their hatred and prejudice against all of us. That makes me angry! Angry that my gay brothers are still screwing around. Not only are they promiscuous but moreso than heterosexual men. How many of them have to die from AIDS before they finally see the light???

Fidelity and commitment are not heterosexual mores; they are sound HUMAN sexual goals. Gay men are the only minority that I know of that actively and even boastfully contribute to the destructive stereotypical beliefs of the majority. In the meantime, however, lesbians and non-promiscuous gay men don't deserve the persecution that

LESPEAKS--Response to Sexism vs Gay Manhood

The evils of sexism (including slurs on gay manhood) do not need repeating, nor do those who seek to remedy them need defending. The real issue behind the Great Censorship Debate is voluntary self-discipline in the matter of good taste and sensitivity to invasion of personal space by the media. These things are individually defined--but when enough individuals set together to protest, issues need to be resolved. In my humble opinion, that is what has happened in the matter of The New Voice policy to not accept advertisements which affront the good taste of the feminist population.

Whenever self-discipline is exercised, we "open the door to censorship which could become more of a problem than a help." When I undertake a diet, I risk anorexia if I am a person who tends to behave compulsively --on the other hand, if I want to lose 25 pounds, I'd better diet, because other means of losing are unhealthy. If I want to be a champion, I submit myself to a coach who spells out the rigid standards of performance which will be seen by the discerning eye of judges. I limit (censor) activity which will diminish the stature of that performance. I limit (censor) the use of alcohol to protect the acuity of my mind and the reflexes of my body. I limit (censor) the time I sleep/wake so that I may get sufficient rest, etc.

Voluntary censorship of beliefs, ideas, and behaviors may lead to a restriction and narrowing of focus in a championship performance--and this kind of specialization is as necessary in quality media as it is in Olympic participation. Seldom does this result in "dangerous" or "discriminatory" practices--and when it does, protest makes it an obvious target for amendment if that is needed. Anti-drinkers DO express concern (objection) to bar ads. Alcoholics Anonymous does not print (voluntarily censors) bar ads in the "Grapevine." The New Voice is not into voluntary censorship of bar ads because in the gay/lesbian community, bars are an important part of the social/recreational life, and drinking is an accepted behavior. It not only can, but needs to voluntarily censor sexism because it is socially unhealthy and repressive of heterosexuals and homosexuals alike. Anti-church folks would indeed be offended by "You're going to hell in a handbasket!" ads or moral diatribes of any kind. Bigotry is an affront to all who respect humankind.

We do not refuse to go on diets, submit to coaching, or deny the pain of masochistic behavior at the gay/lesbian community level--we understand that freedom of the press permits (even demands) voluntary censorship of material which contradicts the broad purposes, needs and values of our community. Where purposes, values, and needs within the community are contradictory, then standards need to be set, maintained and judiciously balanced against the risk of inappropriateness. The gay/lesbian community is vulnerable to criticism and under constant scrutiny from both within and without. If the men of our community desire the participation of the women and the support of the larger society, they need to be aware of and sympathetic to the need for voluntary censorship in our common magazine.

If persons who pay to place, or hope to see, pornography and sexist viewpoints are denied that privilege, they have a right to defend themselves and their desires to do so --but they also have the obligation to listen and consider well, the purposes, values, and needs of others and the reasons for engaging in voluntary censorship.
