

COMMENDS JUDGE CHANG ON HAWAII DECISION

Dear Editor

I wish to commend Judge Kevin Chang of the Hawaiian Circuit Court for his heroic decision overruling the ban on same sex marriages. The court initially recognized legalized homosexual marriages in Baehr-vs-The State of Hawaii. This is a historic occasion for every gay American in our democracy. It represents a step in the right direction for the gay rights from religious bigotry upon a stigmatized minority. It advances the principle of equal rights for every American citizen, regardless of their sexual orientation.

I hail the Hawaiian court which has merely substantiated what the gay rights activists have been saying for quite sometime. No, you can't discriminate against other Americans based on sexual orientation. And religion cannot be used as any right to exercise that discrimination to deny the same equal marriage rights to other American citizens, regardless of religious conviction under the Constitution.

Needless to say, the issue of same sex marriage is purely a social and civil issue which demands a political resolve through the judicial process. This has been uniquely accomplished through the judicial proceedings of the Hawaiian courts. Clearly, the Hawaiian court is undoubtedly within its jurisprudence and has made its decision, let it stand forever! The separation of church and state is a valid argument although vehemently opposed by the so-called majority religious and Conservative Right.

Religion should not be exercised as a right under this democracy to willfully deny to other Americans all the same or like equal rights or privileges so enjoyed by a majority of Americans. This on the other hand is religious intolerance at its worst. Our forefathers fought a Revolutionary War to throw off such religious tyranny centuries before, no matter what its disguise today.

It is now imperative for the U.S. Supreme Court eventually to strike down and overturn as unconstitutional the merits of the so-called Defense of Marriage Act, on grounds of sexual discrimination. Furthermore, enacted as a desperate measure to counteract the judicial and historic proceedings in Hawaii. And to placate, in the religious mind, "Thou shalt now allow a homosexual to marry his her beloved spouse," even on grounds of love, monogamy and commitment. In my view DOMA was enacted by a Republican-dominated Congress immersed in hatreds and paranoia perpetuated upon the gay population. Little do they realize it is God alone who will judge both gay and straight on Judgment Day. That they should now spew out their judgmental animosity upon the gay citizenry.

The ethical and moral argument here is established in the premise, or for that matter, can religion be exercised by a ruling majority to reinstate the institution of slavery, if it so chooses? Or to invalidate women's right to vote merely on grounds of a majority vote? In any case, would the conservative/religious Right directly responsible for DOMA, now deny those liberties to black Americans and women simply by a ruling majority in the Congress? No, I think not, or America would then have another civil war on its hands.

In any event, the argument for gay rights before the judicial system will remain a hard-core plausible and valid argument. For justice and liberties sacred to every American, regardless of sexual orientation. Provided that the courts hold unflinchingly to the legal and ethical ramifications of the gay marriage issue. Above all, the gay citizens of our land merely seek to advance the American principles inherent in life and equality by which all citizens are entitled under the ideals of the Constitution. History then will record the final outcome of this country and their leaders

I impress upon the High Court to follow in the example of granting the exercise of free marriage privileges to gay American couples. In the greatest cases of jurisprudence which has enabled our land to be free and great, in spite of our faults and differences as Americans. In the judicial deliberation resolving prayers in school, the abolishment of slavery, voting and equal rights for women, the real of Prohibition, a right of flag-burning based on the right of free expression, and tolerance to allow neo-Nazis to march in the streets of our land protected under the right of peaceful assembly.

Therefore, if the gay rights struggle falters based on gay marriages, and DOMA is not struck down, it will be due to the mability of the conservative and religious Right majority in the country to overcome their homophobia based on religious intolerance.

My fellow Americans, this is what has made our democracy survive, let us not see it destroyed by unjustly denying the issue of gay rights. It works for every American regardless of their many ethnic origins, persuasions, and at this glorious movement the franchisement of equal marriage for gay couples advanced on sexual orientation. This indeed is a glorious hour for gay rights bestowed upon them the Hawaiian judiciary members, who stand firm to the principles of our

sacred Constitution. God bless, America!

GOVERNOR WELD SAYS HAWAIIAN MARRIAGES WILL HOLD UP IN BAY STATE

Gov. William F. Weld of Boston declared Wednesday that if a Hawaiian law recognizing gay marriages is upheld by that state's supreme court, Massachusetts will be forced to recognize those bonds as legal and to endow the newlyweds with "all the benefits and burdens of marriage."

Weld's remarks came as a Hawaiian judge Wednesday stayed his order of Tuesday allowing gay marriages, pending an appeal of the ruling to

the state's supreme court.

Weld said he views the federal Defense of Marriage Act, which was recently passed by Congress and is designed to allow states to ignore gay marriages sanctioned by other states, as clearly unconstitutional."

Weld said that his primary obligation as governor is not to adhere to the will of Congress but to the words of the US Constitution. And he believes the Constitution requires Massachusetts and other states to recognize the legal legitimacy of gay couples who might eventually marry in Hawaii and travel or move to Massachusetts.

'My position as a matter of law ... as the chief

executive officer of a state is that (gay) couples would be entitled to all the benefits and burdens of marriage," Weld said when asked about the Hawaiian case. "That's the Constitution. It's the

Weld acknowledged there was a limit on what he would promote in Massachusetts. While he argued the state should recognize gay marriages performed elsewhere, he pointedly did not endorse a new state law legalizing gay unions in Massachusetts.

"I'm not sure public opinion is ready for that, quite frankly," Weld said If the Hawaiian supreme court upholds the nght of gays to marry, some constitutional scholars say that other states would eventually have to recognize the legality of Hawaiian marriage contracts in their jurisdictions and that the Defense of Marriage Act may overstep the federal government's bounds in such matters.

Eventually, issues involving the legality of gay marriage, and perhaps the Defense of Marriage Act itself, are expected to make their way to the

US Supreme Court, which would interpret any constitutional concerns.

Weld's comments triggered quick and harsh reaction from several groups opposing gay

'Gov. Weld is being intellectually dishonest, and he knows better," scoffed Matt Damels, president of the Massachusetts Family Institute, a

conservative group.

'Massachusetts does not have to recognize those marriages. What Weld is saying is that he wants to, but the Defense of Marriage Act specifically says other states cannot be forced to change their laws," Daniels continued. "And gay marriages are not allowed in Massachusetts.

Other traditionalists agreed with Daniels, arguing that federal law supersedes the Hawaiian ruling that could legitimize gay unions in that

Opponents of gay marriage argue that the federal law, passed by Congress and signed by President Clinton this year, gives each state the power to ignore gay marriages performed and

recognized in other states.

Eventually one or the other law would have to be struck down, but it doesn't automatically mean the Hawaiian statute stands," argued state Sen. Robert Antonioni, a Democrat. "And aside from overturning the expressed will of the elected representatives of the people, I'm not sure that the US Supreme Court wants to take such a significant and perhaps unprecedented leap in reengineering social policy.

Meanwhile, local gay rights groups hailed Weld's comments and legal analysis Wednesday.

They noted that in the past when Massachusetts banned interracial marriages, it still recognized such unions legalized in other states

"Rhode Island allows first cousins to get married, but Massachusetts does not," noted Mary Bonauto, a lawyer with the Gay and Lesbian Defenders. "Yet when those Rhode Island couples come here, their marriages are recognized as

legitimate

Weld, who as governor has championed gay rights, offered another parallel. "We recognize Reno divorces here in Massachusetts even though they are a lot quicker than divorces that in this and other states," he said. "I think the problem would be the other way. For example, if you were on a cross-country train trip and whether you were married or not depended upon what state you were crossing at the moment.

However, opponents argue that a legally sanctioned marriage is different. "The passage of the Defense of Marriage Act reflects the fact the Congress and the American people understand the difference between tolerance and endorsement of the gay lifestyle," Daniels said. "We currently tolerate homosexual unions in this country. But with the Hawaiian case, what homosexuals are asking is for us to endorse them."

NAVRATILOVA MARKS FIRST ANNIVERSARY OF VISA RAINBOW **CARD WITH \$100,000 IN** CHARITABLE CONTRIBUTIONS

This collection will be a compilation of true.


first-person stories by women from around the country, describing the first time they met their long-term partner.



Hotel accommodations will be dispersed on a first-come, first-served basis. Those who wait will pay even more if forced to stay outside of the city (which will require additional motorcoach transfers to from the city center). The most important consideration now for both participants and spectators is confirmation of housing and other travel needs. The city will be full to overflowing, and those who wait to make arrangements will have the least-favorable accommodations, pay more and may even be too late to participate!



Swinging into immediate action, I fired off a burning epistle to the local administrator about rights and free speech and representation of all the community. It was eloquent, if I do say so.

You'd have been proud

But I'm getting ahead of myself.

For those of you who are not Internet literate,

let me immediately caution you that I am not a member of a secret sect working diligently for the emancipation of Martina Navratilova. (Although if I can be of *any * assistance in any way to Ms. Wimbledon's pursuit of happiness, I certainly encourage her to write me personally at any time. Or call. (Collect.)

You see, I am a computer nerd. Something I

never deny if anyone asks me directly.

My county library, funded by my state legislature, gives me cruise control on the Infobahn for nothing. (Well, if you don't count the couple of grand for the hardware and software, and all the productive hours lost because I'm "on-line" instead of doing paid labor.) It's easy. Accessible

VICTORY FUND CANDIDATES TRIUMPH - - TOPPED BY FIRST **OPENLY GAY CANDIDATE ELECTED** TO STATEWIDE OFFICE

Twenty-two of the Gay and Lesbian Victory Fund's 32 openly gay candidates have won their races. Among the winners, Victory Fund candidate Ed Flanagan has made history as the first openly gay person elected to a statewide office. Consistent with their tradition of fairness and tolerance, the people of Vermont elected Ed by a 10-point margin. "Every gay man and lesbian should feel tremendous pride in what Ed Flanagan has accomplished for us," says Victory Fund Deputy Director Kathleen DeBold. Thanks to this courageous man, our community has finally broken through the lavender ceiling which has kept qualified openly gay and Jesbian candidates from winning stateside office. The 22 Victory Fund winners are:

This has been a record-breaking year for openly gay candidates. The Victory Fund entered this election with five wins from earlier this year, bringing the 1996 win total to a record-breaking 27 (the previous highest win total was 14 wins in 1994). Our early winners are

DeBold notes that this unprecedented success rate for openly gay candidates is especially significant in light of the continuing rightwing backlash against the gains our community has made in the past few years. "Each of our candidates won two races," she says, "One against their opponents; the other against the distorted image of gay men and lesbians foisted on the public by our enemies. These election results send a clear message that the extremist viewpoints that lead to hate campaigns and gaybaiting are out of step with mainstream America. Our openly gay candidates won because their personal and community values are consistent with those of the average American family - values like hard work, responsibility, and respect for others.

SUMMARY OF ELECTION VICTORIES FOR THE TAY

AND LESBIAN COMMUNITY We broke through the "Lavender Ceiling" and elected the first

openly gay official to statewide office. We added openly gay representatives to the state legislatures in Nevada, Connecticut, Montana, Rhode Island, Washington, Illinois, and

Maine. Twenty-three openly gay and lesbian officials serve in 15 states -Every openly gay/lesbian incumbent on the ballot won reelection. U.S. Representative-District of Columbia, Sabrina Sojourner is the only openly lesbian African-American in elective office.

Sebastian Patti garnered more than 1,100,000 votes in his race - the highest total of any openly gay elected official in history

Since the Victory Fund was founded in May of 1991, our members have contributed almost \$1.4 million to openly gay and lesbian candidates.

NATIONAL NEWS

JUDGE RULES SAME-SEX MARRIAGE OKAY IN HAWAII: BUT DON'T PACK YOUR BAGS YET

A circuit judge in Hawaii says the state has not given any compelling reason to deny marriage licenses to gay and lesbian couples. After issuing his long-awaited ruling, Judge Kevin Chang ordered the state to begin issuing the licenses to couples who apply for them.

However, he almost immediately put his order on hold while the state could appeal. The issue may not be resolved for a year, maybe longer.

In any event, the decision was considered a victory for those who have been fighting to end this form of discrimination. The case involved three couples who sued for the right to marry. Kerry Lobel, executive director of the National Gay and Lesbian Task Force said, "This decision is one small but crucial step forward in a long march toward civil equality for lesbian, gay, bisexual and transgendered people. We see the same rights and responsibilities of marriage that heterosexual people enjoy. Marriage is an important personal choice and a basic human right. Whether gay people decide to get married or not, it should be our choice."

Partners Task Force for Gay and Lesbian Couples, also applauded the decision. Demian, co-director, said "The government has no business interfering with two consenting adults who wish to legally marry. Thankfully, the court disregarded popular prejudice and honored the state's Constitutional prohibition of sex discrimination."

Reaction from opponents of same-sex marriage was, at times, predictable. Conservative groups called it a stap in the face of traditional marriage between a man and a wife. Nebraska Attorney General Don Stenberg went further. He was quoted in the Omaha World-Herald as saying, "There is some danger that Nebraska hornosexual couples could travel to Hawaii in the next few days or so and then come back to Nebraska and claim Nebraska is legally required to recognize that marriage." It's safe to assume that his office could explain the attorney general's feeling regarding the "danger" of marriage. His number is 402-471-2682 for anyone wishing to know

The issue of same-sex marriage is certainly unresolved. The Hawaii decision is being appealed. In September, Congress and President Clinton approved the Defense of Marriage Act, which allows each state to decide if marriages licensed in other states would be honored. The DOMA will also likely face court challenges.

SOUTH AFRICA CONSTITUTION ADDS SEXUAL ORIENTATION

After suffering for years under a system known as Apartheid, the South African people have approved a new constitution — one that includes sexual orientation protection. A Constitutional Court gave final approval to the historic document that is considered one of the more t liberal constitutions in the world. It promises to lay a foundation for human dignity and equality for all. It specifically bans discrimination on the grounds of race, gender or sexual orientation.

JURY AWARDS \$10M TO VICTIM OF BASHING

A Wayne County, Michigan jury awarded a Detroit man \$10-million against a security firm, after learning that a guard stood idly by and watched while a man was repeatedly harassed and then shot six times because, "they didn't like the way be wore his hair." The incident happened January 27, 1994 when Sean McBride; now a paraplegic, returned home from work. After arriving at his apartment, he was met by three

men in the lobby who shouted anti-gay sturs and profanities. A guard working for Pinkerton's Security and Investigation, Inc. took no action even as the harassment escalated more than a half hour.

Carol McNeilage, McBride's attorney, said of the jury's verdict, "Society has finally realized that homosexuals are entitled to full respect and dignity."

Normally, I tend to look at these types of books as a self-fulfilling prophesy ("I'm in my dormant period now, please don't ask me anything difficult."), but this book takes you through all the steps gay men take from their first inking of awareness, to becoming a happy member of the gay community. Using interviews and case studies (along with their own experiences), the authors help to shut up all those "nay-sayers" who think gay men just suddenly wake up one day with a perfect fashion-sense and knowing all the lyrics to Chorus Line. All in all, it's a great read.

Another "great read" is Stuck Rubber Baby by Howard Cruse (Paradox Press, a sub-division of DC comics, the home of Superman and etc.) Cruse is the creator of the comic strip Wendel, which used to run in The Advocate. In this graphic novel, he presents the compelling tale of a young man growing up gay in the deep south during the years of the civil riots in the sixties. Cruse is a master at creating three-dimensional characters, and uses the backdrop of the struggle

against desegregation as a parallel of the Gay and Lesbian equal rights battles of today. So the next time you wander by a comic book store, stop in and check it out



ICON ANNOUNCES RESTRUCTURING OF BOARD OF GOVERNORS

ICON Membership to Elect Community Representatives to Board

The Imperial Court of Nebraska has undergone major restructuring during the last year. One year ago the Imperial Court began offering memberships to the public. These memberships entitle the member to discounts on the picnics, a subscription to the ICON Newsletter. invitations to "member only" cocktail parties, and entries in free members only raffles and giveaways. In addition, membership in ICON gives the member the right to vote for Emperor and Empress of the Imperial Court.

Beginning with the election of Emperor and Empress 17 which will be held in June 1997, only current, active members of the Imperial Court will be allowed to vote for Emperor and Empress. All voting will be done by mail-in ballots which will be mailed directly to the member's home. Ballots must be returned by mail and must be received by a deadline which will be set by the

Board of Governors

In addition, beginning with the campaign for Emperor and Empress 17, only members may run for Emperor or Empress. The time for accepting applications and the campaign time have both been extended. Applications for Emperor and Empress will be available in local bars and businesses by January 1, 1997. Candidates will be approved and campaigning will begin by March 1, 1997. Campaigning will end and ballots will be mailed by the middle of June and the winners announced at Coronation 17, which will be held at Paxton Manor over the July 4th weekend

Community Representatives Added to **Board of Governors**

As a result of further restructuring the Board of Governors will now be composed of past Emperors, Empresses, and Prince and Princess Royales and 4 "community representatives" elected by the ICON membership. Persons interested in being on the Board of Governors must meet the following criteria:

1) Be a current member of ICON

Have attained the legal drinking age as determined by the State of Nebraska

3) Shall not have any felony warrants or

charges pending against them.

4) Shall not have any outstanding insufficient fund checks with any organization or establishment

5) All members of the Board of Governors must sign an agreement to adhere to the Code of Conduct as set forth by the Board and must agree to abide by the regulations set forth regarding attendance, participation, and properties as set forth in the current By-Laws of the Imperial Court All members are subject to removal for just cause.

The specific revisions to the By-Laws are:

4. Community Representatives: Four seats on the Board of Governors shall be reserved for representatives of the community. These Community Representatives shall be elected for 2 year terms by the membership of ICON through a secret ballot.

1. Applications must be submitted by a date determined by the Board of Governors. (SET AS MARCH 1)

All applicants must meet the general

requirements as set forth in Article V, Section 1. In addition, a Community Representative may not have served as Emperor, Empress, Prince Royale or Princess Royale of the Imperial

Court of Nebraska.

3. During the period between the date set for applications to be accepted and the Board Meeting immediately prior to the mailing of ballots for Emperor and Empress, the applicant must attend 75% of all meetings of the Board of Governors and must attend 75% of all ICON shows, events, and functions. If Memorial Day falls during this period, all applicants must attend and assist with the Memorial Day Picnic. 4. All applicants will serve on at least one committee to be assigned by the Board of Governors. The applicant will attend at least 75% of all meetings of any committee to which the applicant is assigned.

5. The applicant is responsible for notifying the Secretary or an Executive Board member of their presence at any meeting, show, event, or

function.

2. Community Representatives:

Community Representatives will be elected by a yes'no vote of the membership by secret ballot, which will be mailed at the same time as the ballots for Emperor and Empress. The Secretary will verify that applicants have met all requirements for consideration for the Board of Governors. Only after the Board of Governors has received venfication from the Secretary will the applicants' names be placed on the ballot. The candidates receiving the highest percentage of "yes" votes will be declared the winners. To be elected a candidate must receive 'yes" votes from at least 51% of those voting In the event of a tie, the final selection will be made by the Board of Governors. The ballots for Community Representatives shall be counted at the same time and in the same manner as those for Emperor and Empress. announcement of the successful candidates for Community Representative will be made as a part of Coronation and the new Community Representatives presented to the membership.

3. Community Representatives:

Each Community Representative will be seated at the first Board meeting following Coronation and will serve with all rights and privileges for a two year term.

4. Number of Terms: Board members may be re-elected to an unlimited number of terms.

Note: Special Requirement for the Initial Election of Community Representatives: The first year 4 Community Representatives would be elected - two to two year terms and two to one year terms. The highest vote getters would be seated for two years, the next highest vote getters would be seated for one year.

STONEWALL II DECLARATION

We, the Stonewall Community of St. Louis, having been deprived of our traditional June celebration of the Stonewall freedom riots for three years in a row, hereby declare that henceforth, the last weekend in June, culminating on Stonewall Sunday, will be the permanent official date in St. Louis for celebrating the historic beginnings of our fight to live freely and openly. We ask all in St. Louis and throughout the world to come together on the same day each year to create a worldwide bond of solidarity and celebration.

After a quarter century of celebrating Stonewall on various dates in June, we believe it is time for our brothers and sisters throughout the world to unit on a single day for this global celebration of our struggle for love and freedom. We also propose the beginning of a new tradition, that our community's bars around the world flash their lights at midnight on June 28th each year to commemorate the police attack that sparked those three nights of resistance, using the same signal that was used that night in 1969 to warn the Stonewall Inn's patrons of a police raid.

We believe the Stonewall Community includes gays, lesbians, bisexuals, transgendered, and straight friends; all of whom were surely present on the streets of Greenwich Village in New York City during those three nights of resistance from June 28-30, 1969. In the spirit of their fight for personal freedom, we have therefore chosen the name of "Stonewall Community" to include all of these groups.

To all of the excuses and rationalizations that have been used to justify moving our Pride celebration outside of June, we respond as follows: If America can celebrate on the 4th of July, then it is not too hot to celebrate our own independence day in the heat of June. Those wishing to travel to other cities for a bigger celebration are welcome to do so, but the majority of the community should not be deprived of their traditional June celebration to accommodate any small group. And yes, history and tradition do matter, that is why every other culture's celebrations are tied to specific dates. We urge all who read this declaration and believe in our vision of a universal day of celebration to spread the word and work within their own communities to make it a reality.

THE GAY AGENDA: TALKING BACK TO THE FUNDAMENTALISTS

by Jack Nichols

While fundamentalists are not alone in objecting to homosexuality, their attacks on gays and lesbians over the years have been particularly brutal and malicious, strategically defining homosexuality in terms of sex acts alone, refusing to acknowledge affection or love.

You've got to put good levels of protein, good levels of unrefined complex carbohydrates, lots of fresh fruits and vegetables, and moderate amounts of only the good kinds of fats in your body every day, and you have to wash all that down with lots of good healthy liquids. That's the way you give your body the building blocks it needs to keep up the immense battle against HIV. And always make sure the food you cat and the water you drink is safe!

Commandment #3: Do Everything Necessary to Help Your Body Digest Food and Use It

Properly.

Even if you're eating the right things, it won't do you any good if you don't have good digestion and the ability to use the nutrients. Many people need to improve how their bodies handle food by supplementing the hydrochloric acid, pancreatic enzymes, vegetable enzymes, acidophilus, biotin, L-carnitine, and L-glutamine.

Commandment #4: Supplement Your Good Diet with the Nutrients that Will Help You Have Slower Disease Progression and a Lot Fewer Symptoms Along the Way, Including

Optimal Levels of Antioxidants.

Remember John James, the highly respected editor of AIDS Treatment News, reviewing on of the important nutrient studies, summarized his review by saying that research has shown that supplying the right level of nutrients in the body may be associated with greater reduced progression of HIV disease and better improvements in long-term survival than any anti-HIV drug tested to date. And, in addition, nutrients can reduce or eliminate or contribute to eliminating many symptoms such as fatigue, skin problems, neuropathy, digestive problems, memory or other mental problems, wasting, and others.

Commandment #5: Protect the Body in Every Way Possible from the Damage that Infections Cause and Give the Body what it Needs to Repair Itself When the Damage Does Occur.

First, use the best available treatments, then supply the particular nutrients that the body can use to repair itself. In particular, repair the intestines with zinc, beta-carotene, vitamin B6, vitamin E, bioflavinoids, vitamin C, and, especially, L-glutamine. If necessary, use does of up to 30-40 grams of L-glutamine per day until repair is effected, followed by lower doses for maintenance. You can't absorb nutrients or drugs if you don't keep your intestines healthy.

Commandment #6: Do Prophylaxis, Where Appropriate, and Add to Your Pharmaceutical Prophylactic Regimen the Nutrients and Natural Therapeutics that Help to Protect You from Infection, and That Help You to Fight Them when You Get Them.

Important nutrients for protection from infections: L-glutamine (intestinal, lung, and cervicovaginal infections), acidophilus (Candida overgrowth and other intestinal infections), garlic and oregano extract (Candida overgrowth), folic acid (anal or cervical cancer), and a good level of nutrients in general. Remember: Your body's response to any infectious agent or abnormal cell

is absolutely dependent on the nutrients needed for competent immune response. Thomas McKeown, M.D. says "deficiency of almost any of the essential nutrients may have a marked effect on the manner in which the host responds to an infectious agent. The same infection may be mild or even unapparent in a well-nourished host, but virulent and sometimes fatal in one that is malnourished."

Commandment #7: Take the Best Available Antivirals in the Best Possible Combinations and, While You Do It, Protect Your Body from Their Side Effects.

We finally have antiviral approaches that are worth doing — combination antiviral therapy with the best possible antivirals — and the viral load test to help determine when they're needed. The more you can use antivirals to suppress the viral load and let the body regain its immune function, the better off you are and the longer you'll be able to fight off infections. You must have good nutritional status for the body to use drugs effectively. Also, some matrients may help protect you from the side effects of certain drugs. For AZT B1, B3, B6, B12, E, magnesium, zinc. For bone-marrow suppressive drugs, in general recombinant human growth hormone, anabolic steroids. For liver-toxic drugs, alpha-lipoic acid, NAC, vitamin C, carnitine.

NAC, vitamin C, carnitine. Commandment #8: Handle the Hormone Problem of this Disease.

For both men and women, maintaining testosterone and using, where appropriate, anabolic steroids and/or recombinant human growth hormone may help prevent the loss of the lean tissue that keeps you alive, while helping you look better, function better, and feel better. Women may also need female hormone replacement.

Commandment #9: Exercise

Just do it. You need to build up the muscles

with progressive resistance exercise like weight training. That's what gives you a body with plenty of the lean tissue that you need for survival. Commandment # 10: Program the Mind Toward Healing.

The power of the mind to boost the body toward healing is amazing. And the power of bope is one of the best tools you can have for long-term survival. Bob Publicover, incredibly long-term (two decades and counting) survivor. "Never give up, never give up, never give up."

DON'T ASK, DON'T TELL NO GOOD

Servicemembers Legal Defense Network is concerned about the rising number of investigation seen where servicemembers who are suspected of being gay are accused of sexually harassing another servicemember of the same gender in an attempt to circumvent the military's "Don't Ask, Don't Tell" rules prohibiting witch hunts and investigations simply to determine sexual orientation.

The suspicion can arise with innocent intentions. For example, if a servicemember asks another of the same sex to go to see a movie together, the suggestion could be misinterpreted as a sexual overture.

Commanders frequently rush to believe the accuser where same gender sexual harassment has been alleged.

Even though it's unfair, servicemembers are urged to err on the side of caution. If at all possible, do not put yourself in a situation or make remarks that can easily be misinterpreted. Gay and lesbian servicemembers should scrupulously follow fraternization guidelines:

Avoid socializing with subordinates, especially in situations involving alcohol consumption. SLDN provides free, confidential


The Steering Committee will select members of the initial Board from these eighteen. As part of the process, the committee may ask the finalists to meet with them in a social setting.

WOMEN'S TREATMENT CENTER OPENS

Nebraska's first gender competent primary substance abuse treatment program for women open at St. Monica's in Lincoln

Program planning and start-up costs for the program to date have been provided by the Cooper Foundation, the Lincoln Foundation, the Rogers Foundation, James and Ann Rawley, First Bank, The Gallup Organization.

and Duncan Aviation.

The program provides gender competent treatment for women who are chemically dependent or with co-existing substance abuse and mental health issues. It operates 9 am to 3 pm, Monday through Friday in Lincoln. Child care and transportation assistance are provided. Program components include individualized treatment plan, individual counseling, daily group therapy, mental health screening and assessments, and health screenings.

Weekly topic groups include parenting, relapse prevention, general health, grief and same, relationships and assertiveness, and mental health. Daily psych-ed groups cover 30 topics over a six week period, and address issues such as domestic violence, forgiveness and guilt, spirituality, holistic health, sexual violence, stress management, socialization of women, body image, self-esteem, sexuality, and the physiological effects of substance abuse on women. Family care is included in the program. Fees are negotiated on a sliding scale based on each client's income/ability to pay. Insurance and Medicaid are accepted.

Recent scientific research across the country has verified that substance abuse treatment is most effective for women when it is "gender competent." that is, when it is specifically designed to meet the needs of women. Until now, there have been no gender competent programs for women anywhere

in the state of Nebraska.

The are several major issues that affect substance abusing women

more, or differently, than men.

Substance abusing women often have sole or primary responsibility for children, and little support system that could provide assistance such as a break from parenting or child care during treatment.

Pregnant women are affecting the health of their babies by abusing substances, but often don't admit to health practitioners that they are abusing drugs or alcohol for fear of prosecution for child abuse or loss of custody.

 Women alcoholics and addicts are often surviving on incomes below the poverty level with no transportation or health insurance.

 Studies have verified our experience that as many as 95% of substance abusing women are victims of domestic or sexual abuse, either now or in their childhood. Women don't feel free to discuss their abuse in mixed gender settings, so this major relapse issue is often not addressed at all.

For over 30 years, St. Monica's has provided gender competent residential and relapse prevention programs for women. These programs facilitate a woman's return to the community, and provide gender competent secondary treatment, after she has completed a traditional four to six week

primary substance abuse treatment program.

Planning of this important program involved focus group meetings with over 100 community professionals in the field of substance abuse, mental and behavioral health counselors, representatives from schools and local women's organizations, and alumni of St. Monica's. Many other agencies, organizations, and individuals have agreed to collaborate with us on this project by presenting educational sessions on issues such as domestic and sexual violence, relapse prevention, health, relationships, a and money management. CLINTON/GORE GAY AND LESBIAN OUTREACH GAINS MOMENTUM IN NEBRASKA

For the first time in Nebraska history, a gay and lesbian coalition was part of a Presidential campaign. The Clinton/Gore Gay and Lesbian Outreach, an extension of the Washington, D.C.-based Outreach office, shared office space with the Democratic coordinated campaign office in Omaha. With its efforts directed primarily at gay and lesbian voters in the Omaha area, the coalition urged voter registration and spread the "Get Out The Vote" message to this sector of the public. "We made hundred of telephone calls to the gay and lesbian community, as well as other voters concerned about progress," said Mark Allen, Nebraska State Chair for the Clinton/Gore Gay and Lesbian Outreach. "It was a grassroots effort in the truest sense of the word."

Working with the Rainbow Political Action Committee (PAC)*, the group also coordinated a mass mailing to about 1,000 voters. "This was history in the making for Nebraska," he said. "And, it's only the beginning. We're determined

to impact future elections.

The coalition also distributed promotional material at the Democratic Party's election night rally and canvassed establishments frequented by Omaha's gay and lesbian community. It plans to work closely with the Washington, D.C.-based organization, as well as sister coalitions throughout the country.

The Clinton/Gore ticket garnered the group's support because of the Clinton Administration's emphasis on non-discrimination issues, HIV/AIDS funding, and gay and lesbian political

appointees: "He's done more for the gay and lesbian community than all former Presidents collectively," said Allen. "Just to hear him say the word gay' at the Democratic Convention was heartening and a validation of our important role

in the political process."

*The Rainbow PAC is a group of metro-Omahans concerned about lesbian, gay, bisexual and transgender issues, as well as other progressive causes. Following this year's election, the Rainbow PAC will monitor political actions of those in office and keep records for future elections. Candidates' endorsements will be based on voting records and support for progressive issues. NAP SPONSORS WOMEN'S OUTREACH

Across the United States, HIV And AIDS surveillance date have pointed to women of childbearing age as an emerging high-risk group for HIV disease. Historically, Nebraska women have comprised only about 9 percent of AIDS cases reported to the Nebraska Department of Health (NDOH) since 1983. However, according to the newly implemented HIV surveillance data released by NDOH, women are accounting for 21 percent of newly diagnosed HIV infections in Nebraska.

Addressing the needs of women who may be at risk for HIV is a complex task requiring that intervention providers look at a variety issues the women face in American society. Sexual Assault, domestic violence, poverty, substance abuse, children and family, and many other issues may come into play in the lives of women at risk for HIV and other life-threatening health problems. A group of female professionals, headed by NAP volunteer Kelly Boury, have formed a group called W.A.R., or Women-at-Risk, to begin addressing HIV prevention and harm-reduction education for women in Metro-Omaha.

According to Boury, W.A.R.'s primary goal is "to empower women to reduce their risk for HIV infection by providing education, support, referrals, and access to risk-reduction information and devices." W.A.R.'s services and activities will be housed in the NAP Outreach Center at 1723 Leavenworth. Beginning in January, woman-to-woman HIV testing and counseling will be conducted the first and third Saturday of each month from 1.00 p.m. until 4:00 p.m. at the Outreach Center. In the near future, W.A.R. hopes to make available female condoms, finger cots, latex dams, bleach kits, and other riskreduction supplies to help women regardless of their sexual orientation, take charge of managing their risk. Audrey Espinoza, testing coordinator for NAP, is working closely with W.A.R. volunteers to devise ways of reaching women in minority communities who may not be getting the help they need because of cultural or linguistic barriers.

In addition to W.A.R., other outreach activities are on the drawing boards at NAP for 1997. The Leavenworth Outreach Center will also house activities designed to reach the gay community, sex workers, and other populations at risk. MARRIAGE! CFEP PREPARES FOR UNICAMERAL SESSION

With the continuing legal battles in Hawaii for recognition of same-sex marriages, many states on the mainland have taken it upon themselves to implement legislation denying recognition of same-sex marriages performed in other states. Nebraska's Attorney General Don Stenberg urged the unicameral to do the same last Spring with no success. It is expected that a bill will be introduced in the unicameral during the 1997 session. Therefore, it is tantamount that gays, lesbians, bisexuals and transgendered individuals across the state need to lobby their senators to ensure that they know how we feel. With a unified effort, we stand a better chance of preventing the passage of such a bill.

Citizens for Equal Protection will be organizing to educate senators in the unicameral and try to work with those members who have been identified as progressive towards gay and lesbian issues. With the assistance of the Rainbow Political Action Committee, CFEP has a listing of senators whom we expect to be supportive in this endeavor of blocking a vote negative to same-sex marriages in Nebraska.

Another legislative issue that CFEP is investigating is inclusion of sexual orientation protection in the state's employment non-discrimination policy. Senator Erme Chambers of Omaha sponsored this bill last year which failed. Attempts are expected to be pursued again this year.

At the CFEP meeting on Thursday, January 9, 1997 at 7:00 P.M. we have tentatively scheduled a professional AIDS lobbyist from Lincoln to speak at our meeting. It is a crucial time for the G/L/B/T community of Nebraska. We need every able-bodied individual to help us with letter writing campaigns, phone calls, and personal visits with senators to prevent our rights from being impinged. CFEP meets at the First Unitarian Church at 31st and Harney. If you have any further questions or would like to volunteer, please come to our meeting or call the phone line at (402) 398-3027.

Jim told Jerry, "I'm not looking for a one night stand." Jim and Jerry have long seen a need for a couples group in Omaha. "We enjoy spending time with other couples. We're not bar people. Until we got involved in MCC we didn't know anyone else." Jerry says, "We're looking for deep friendships. People we can lean on when we need friends, like when I was in the hospital and Jim had to sit there alone, with no one to turn to." The two want to see River City Couples become more visible to counter negative images of promiscuity that pervade people's minds. "We need to be out in the public as a group. We CAN change public opinion. We can be role models for change."

Chuck and John met 1.5 years ago. At first, Chuck never thought anything would come of the relationship, and John kept wondering "how long before we go our separate ways?" After dating for about a month, they realized their relationship was growing deeper. Chuck says, "I sat him down and we talked about what we wanted. We agreed on three things. First, we agreed we were looking for someone to be faithful. We both wanted someone who loved us, whom we loved. And we both were looking for someone who was a Christian." Realizing the "met each other's standards," they moved in together. Fifteen years has proved them right Chuck and John became interested in the concept of the River City Couples because they felt couples "need a place to go, an alternative to the bars. We just want a place to make friends."

WHAT IS **GAY RODEO?** PART 2

Heartland Regional Rodeo, sponsored by HGRA, is scheduled for weekend of June 27-29 1997, in Fremont, NE. Besides the rodeo performances on Saturday and Sunday, HGRA is also planning activities for Friday and Saturday nights. More on that in a later article. HGRA hopes that Heartland Regional Rodeo becomes a successful fund-raising endeavor and weekend of first class entertainment for our community.

There are a total of thirteen events in gay rodeo, divided into four categories: Rough Stock events, Roping events, Horse events, and Camp events. There are four Rough Stock events: Chute Dogging, Steer Riding, Bronc Riding, and Bull Riding. The rules are similar for the three riding events. Last month's article described Chute Dogging and Steer Riding. This article describes Bronc Riding and Bull Riding.

ROUGH STOCK EVENTS, PART 2

Bareback Bronc Riding

The contestant must remain on a bucking horse for 6 seconds with only a rigging to hold on to; there is no saddle. Times starts when the gate opens and the horse leaves the chute. A horn sounds 6 seconds later to signify time end. The contestant's boot heels or spurs must be touching the horse in front of its shoulders at the time the horse's front feet hits the ground on the first move out of the chute. The contestant my ride with one or two hands, but a two-handed ride scores lower. Two judges score the ride and each judge awards up to 25 points for the animal and up to 25 points for the rider for a total possible score of 100. Highest score wins. Men and women complete separately.

Bull Riding

This is the most dangerous event in a rodeo, and one of the most popular. Besides bucking, a bull may also spin, which adds to the difficulty of the ride. The contestant starts off sitting on the bull in the bucking chute. The gate opens, and time starts when the bull leaves the chute. Time ends 6 seconds later, and a horn sounds to signify time end. The contestant rides with one hand free and must remain on the bull for the entire 6 seconds. The contestant is disqualified for touching anything with the free hand, including the animal, the contestant's hat, equipment, etc. Two judges score the ride and each judge awards up to 25 points for the animal and up to 25 points for the rider for a total possible score of 100. Highest score wins. Men and women compete



LESBIAN WITH AIDS SPEAKS OUT

When I came out of the closet as a lesbian 15 years ago, there were smiling faces, warm hugs and new friendships to guide me as I moved with excitement into the uncharted future. I was out and free to live my life and celebrate my sexuality

In the past few years, I've learned that there are many kinds of closets which are just as dark and lonely as they were 15 years ago. When HIV struck, I found myself in the closet once again, all alone with my secret. Somehow I didn't think that those hugs and smiles would be there when I came out this time. I wondered if I should share my status with family and friends, or just remain silent in an effort to protect the ones I loved from the anguish I was experiencing around my new HIV diagnosis

For years I had been a caregiver - part of the support system for several of my brothers with HIV/AIDS. I visited the housebound and sat with the lonely. I helped prepare meals, provided transportation to appointments, walked in the AIDS walks, participated in memorials, vigils, and marches - always thinking of these "others affected by this disease and wanting to be a part of a solution that would end the suffering and alienation of these men I'd grown to love so much. At the time, in spite of what I'd heard, I thought that HIV/AIDS was somehow just "a man's disease i in ten years, I'd only met one woman with HIV, and I think I considered her disease "an accident of sorts.i.

I never realized that in my efforts to provide support and hope for these PWA's I cared about, that I was laying a foundation for my own future: the day when I found out that I was one of "them" - no longer only affected, but also infected by HIV

That day my mind was flooded with questions, and my emotions fell out of control. What would I tell my family? How would I tell the lover I'd recently separated from? And how would I ever explain this to the community of lesbians I was a part of? Shame and fear quickly set in. I knew that HfV was an equal opportunity virus that doesn't discriminate. But quickly I learned there was an unspoken discrimination — a "rule" that even I subscribed to, that stated that if I were any kind of respectable lesbian, i this wouldn't have happened to me

But it did, and there I was — 28 years old, working, playing, loving and living my version of the "American Dream." I was growing and maturing and seeing my ministry in UFMCC getting more defined and more effective. Would this news change everything for me? Would any part of my life ever be the same again?

I tried to shoulder the news, silently at first, living in a kind of self-imposed exile. It only lasted for a couple of weeks. Abut in that time I felt alone, abandoned by God and victimized by circumstances. The promising future that I had looked toward was now looming ahead, frightening and uncertain

In my growing desperation, I sought help from an MCC pastor. She was a lesbran, my friend, and I knew that circumstances in her own family had brought her face to face with the challenges of HIV, especially as it affects women. She laughed, cried, and prayed with me as I shared my struggle with her. She gave me support and encouragement as I sought out medical care and began working through the maze of services for PWA's. She reminded me that although I may have felt abandoned by God, God never let go of me - that I was still in God's care, and that God still had plans to use me.

For the first year or two, however, I did hide out in the shadows of my HIV closet. I was still afraid that I would be judged, and that no one would be there to support me. But there came a time when I couldn't carry the burden alone anymore, and a night when I laid it down and things began to change for me.

It was an evening in May at our Northwest District Conference in Boise, Idaho when I realized that I couldn't keep lighting this buttle by myself. The two men who had been my primary HIV support had passed away in the preceding weeks, and I was feeling very alone and afraid. Rather suddenly I lost that composure that always seemed to carry me through, and tears of grief, fear, and struggle poured out of me.

As I began to cry, I wondered if the tears would ever stop falling.

Sizanne McKeag was visiting our district conference with her partner Marsha Stevens of BALM Ministries, sharing the Word through testimony and song. I didn't know Suzanne, but she ministered to me so effectively that she helped me find some much needed peace and relief. She also helped me shape the future of my ministry by demonstrating so beautifully what it really means to minister and care for someone. She didn't just pay lip service. She touched me. She met me in my grief and isolation, and helped me to see that I wasn't alone. As we shared, the tears of anguish were somehow transformed to a healing wash. I vowed to myself that I would never return to the shadows of that closet again. I held my head high, and with my newfound freedom and support in MCC. identified myself as a lesbian living with HIV I started living

It wasn't too long after that district conference that my health declined, and I was diagnosed with AIDS. I was retired from my secular job. At first, I felt useless, and I headed to the security of my recliner to live out the rest of my days! But within a few weeks, was reminded that God still wasn't finished with me yet, and I found myself working with BALM Ministries. I now handle the bookings for Marsha's and Suzanne's ministry and often travel with them to MCC's all over the U.S. where I get to share my experiences and hope with others.

In my travels, I've visited a lot of churches, made a lot of friends, and found more prayer partners and support than I could have ever imagined. I've also met many people - men, women, and children - living with HIV. And my heart aches so much for the ones who go on living in fear of rejection, carrying the burden of HIV alone. There is so much love and support to be found in our Fellowship, and I try to be a part of that support network because I want to give back to this community of believers who have given so much to me

I can't imagine what the last year would have been like without my family in MCC's and independent churches all across this country. In the last six months, I have been hospitalized eleven times with PCP or complications of other opportunistic infections Hive with. At times, my declining health has seemed overwhelming, but at no time in the last few months have I ever really felt alone. I spent Thanksgiving and Christmas in the hospital with my biological family 2,000 miles away, and yet my holidays were still rich and full.

As I travel and talk to people about living with HIV, I try to remind everyone that HIV is not just my problem. We are all in this together. I talk about my search for answers when I was first diagnosed. In my search, I found strength and encouragement as I read about the miracles in the New Testament and how Jesus is the same yesterday, today and forever.î (Hebrews 13:8). I believe the Word and therefore know that God must still be in the miracleworking business!

I found hope in the story of the woman with the issue of blood found in Matthew, Chapter 9. Chad been sick for years and no one could find a cure, and it seemed that there was no hope for her. But she'd heard of Jesus. And she reached out, past her fears and the judgments of the day to touch the edge of His garment. He looked at her and said, "Your faith has made you whole! She was healed.

It was on one of those faith-lacking days that my mother reminded me of the story of another miracle found in that same chapter of Matthew - a story about a paralytic. No matter how much the man wanted to get to Jesus, or how much faith he had, he couldn't get there on his own. But his friends picked up his bed and took him to Jesus. They carried him to the roof, tore back the tiles, and lowered him into the presence of Jesus. Scripture tells us that Jesus saw their faith. f and the man was healed!

I started to see at that point that on those days when I just don't feel like I have the faith to carry me through, my friends and family, like the friends of the paralytic, take up my cause and carry my name to the feet of the Great Physician who is the source of my

Today, my life is very exciting and richer than I could have ever dreamed. I have six months worth of cards, letters, phone calls and well wishes from my sisters and brothers in this Fellowship. I need to respond to them — and at the rate I'm going, I'd better pray for a very long life, or I'll never get to them all! But I think that's a challenge I can live with!

When I found out that I was HIV positive, it seemed that my life was over, and life as I knew it, was. But as I've grown, and as my disease has progressed, I really have been blessed with "new eye" that see most days as beautiful, no matter what the weather is like. I found love and compassion for other people that I never knew existed. And although I deal with the reality of the struggles that come with living with AIDS, with the help of my caregivers and friends, most of whom are in MCC, I've begun to celebrate my life instead of worrying about my death

As I am writing this article, I am sitting in a treatment room at the clinic that treats me for HIV/AIDS, enjoying that first cup of morning coffee and friendly chat with Lauri, my caregiver, and the clinic staff. We're sharing thoughts and feelings, dreams and future plans. Today, we have some pretty important decisions to make like,

what should we do for lunch?

I'm really not the least bit concerned about what other people think of me and the fact that I have AIDS. I have the support and love that I need to face anything. My concern today is much bigger, as I ponder the origin of these three units of blood I'm receiving in this transfusion. Who were these donors? What are they like? Could they possibly have been a gay brother or a lesbian sister — or is it possible that they were flaming beterosexuals, or even Republicans? The possibilities seem endless and laughter fills the room as I share my concerns with the nursing staff.

I remember a time when I sat in this very room feeling like I'd been dealt a death sentence. Since then I've learned that it was just

another obstacle in this road we trudge called "life i

I try to make the most of every moment and I find that life is good! There is still love, laughter, and play. Even after an AIDS

diagnosis, there is life!

There is a saying that I've taken to heart — "T is the first day of the rest of your life!" And it is! Each new day brings with it hope. I look toward the days ahead anticipating a bright future. And I am strengthened as I face that future as a willing participant and no longer fear it as a victim!
