The End Game Is Here for Marriage Equality

This is it – the end game in the longstanding campaign to win the freedom to marry for same-sex couples nationwide is upon us. The U.S. Supreme Court has just announced it will hear freedom-to-marry cases in all four states in the Sixth Circuit- Ohio, Kentucky, Tennessee and Michigan. We're thrilled to be co-counsel in the Kentucky and Ohio cases.



With today's SCOTUS announcement we are entering what we hope will be the last phase of a journey towards greater dignity and equality for lesbian, gay, and bisexual people that started decades ago and has accelerated at a truly astounding rate over the last year and a half. A win before the high court would be a watershed moment for the LGBT rights movement.

It's clear from a few simple facts that the country is ready for the freedom to marry nationwide:

36 states now allow same-sex couples to marry
71 percent of the U.S. population lives in a freedom-to-marry state
59 percent of Americans support marriage equality
Adding the remaining 29 percent of the population to the marriage column, while momentous for LGBT equality, would not impose sweeping new change on the country. If South Carolina, Utah, Florida, and Oklahoma are all marriage states, then surely Texas and South Dakota can handle it, too.

It's also evident why marriage is so important. Marriage makes clear that both the state and society value and protect a relationship. Same-sex couples have been making the commitment at the heart of marriage for decades, but they have been treated as legal strangers by state after state and told that their relationships are less worthy.

Plus, showing the country all the same-sex couples who want to marry – and who do marry – has helped people understand that gay people's relationships are built around love, often are long-term, and increasingly involve raising children who thrive. All of those realities, which gay people find unremarkable, help the rest of America overcome the anti-gay stereotypes that they grew up with.

Finally, it's clear how we've gotten to this moment of such promise – through decades of concerted effort by LGBT people and allies all across America. The ACLU is proud to have been part of getting us here. We brought the first lawsuit in the country seeking the freedom to marry for same-sex couples in 1970. Over the years since then, we have worked in courts, legislatures, and in ballot campaigns to win marriage equality all across the country. We represented Edie Windsor in her landmark case taking down the core of the Defense of Marriage Act in 2013 and have filed 17 marriage cases since then, covering every region of the country.

What's not clear – yet – is just how the end game, well, ends. We'll know that come summer, but we do already know several things: That if we win, the country can handle it. That if we lose, we will still change the remaining anti-gay laws by going back to the ballot. And that we can never stop working to change the culture in America so that it understands and embraces LGBT people in all of our wonderful diversity.

Marriage will help us do that, so we welcome the end game – bring it!

9th US Circuit Court of Appeals Declines to Hear Appeal of Nevada's Gay Marriage Case

An anti-gay marriage organization was dealt a significant blow in its battle against LGBTI couples in Nevada.

According to the Associated Press, last week the 9th US Circuit Court of Appeals declined to hear a case overturning the state's ban on same-sex marriage.

Late last year, the Coalition for the Protection of Marriage petitioned the entire court to hear its appeal.

In early 2014 October, the Silver State's prohibition against marriage equality was overturned by a three-judge panel.

Last week's decision also applies to Idaho, a neighboring state.

Brian Sandoval, Nevada's governor, believes marriage should be between a man and woman.

However, the Republican is opposed to the Coalition's legal maneuvers.

The group can appeal to the Supreme Court, the country's highest court. As of today, 14 January, there was no information if an appeal has ben filed.

According to the AP, this week Las Vegas passed the 1,000 same-sex marriage certificates mark.

Colin Farrell to Call on Ireland to Vote for Same-Sex Marriage in TV Interview

Hollywood actor Colin Farrell is slated to persuade his country to support same-sex marriage by discussing the issue in a TV interview with Claire Byrne to be aired on Monday night, reports Goss.ie.

Ireland is set to decide whether it will recognize same-sex marriage in a referendum to be held in early May.

The actor, who stars in the upcoming second season of HBO's True Detective series, said last year that it's 'insane' his gay brother couldn't wed his husband Steven Mannion in Ireland. The pair married in Canada six years ago.



'What Colin wanted to do, really, was to quell the fears that some people have about marriage equality ruining the idea of traditional marriage,' Eamon was quoted as saying in a report.

'He wanted to say that marriage was about love and he wanted to hold up my own marriage as an example of how the world hasn't stopped turning since we got married six years ago.'

Colin, who wrote an open letter last year urging Irish people to vote for gay marriage equality, said, 'The forthcoming referendum is so personal to me. It's about inclusion. It's about fairness.'

'It's about giving our lesbian and gay brother and sisters back a right that should never have been stolen from them in the first place.'

Liam Neeson Says America Has 'Too Many F**king Guns'

Liam Neeson voiced his issues with gun ownership in America during a conversation about the recent shooting at the Charlie Hebdo offices in Paris.



"First off, my thoughts and prayers and my heart are with the deceased, and certainly with all of France, yesterday. I've got a lot of dear friends in Paris," Neeson said during an interview in Dubai this week. "There's too many fucking guns out there. Especially in America. I think the population is like, 320 million? There's over 300 million guns. Privately owned, in America. I think it's a fucking disgrace. Every week now we're picking up a newspaper and seeing, 'Yet another few kids have been killed in schools.'"

Neeson went on to deny that movies featuring firearms, such as his own "Taken" series, encourage people to buy guns, saying: "I grew up watching cowboy movies, loved doing that [gun gesture] with my fingers. 'Bang, bang, you're dead!' I didn't end up a killer. I think that's something the power of cinema can be."

According to estimates, there are between 270 million and 310

million guns in the U.S., the Pew Research Center has noted. With a population of about 300 million, that's one for every man, woman and child. In a 2013 Pew survey, 37 percent of Americans said someone in their household owned a gun.

The 62-year-old star, who was born in Ireland, echoed similar sentiments about gun control during a September interview with the Independent.

"I am totally for gun control in the U.S.," he said. "The population of America is roughly 300 million and there are 300 million guns in this country, which is terrifying."

Pope Francis: 'Family is Threatened by Gay Marriage'

Pope Francis has claimed the family is being threatened by gay marriage.

Speaking in the Philippines, the leader of the Catholic Church criticized what he called the 'ideological colonization of the family' - language that many have taken to mean the marriage of same-sex couples.



'The family is threatened by growing efforts on the part of some to redefine the very institution of marriage, by relativism, by the culture of the ephemeral, by a lack of openness to life,' Francis said.

A Vatican spokesperson has confirmed the pope was referring, at least in part, to same-sex marriage.

The pope was speaking to more than 1,000 families in downtown Manila.

During the trip, he also voiced his support for a ban on contraception and said if you insult faith, you can expect to get consequences - in reference to the Charlie Hebdo killings in Paris.

Federal Judge Orders Michigan To Recognize 300 Same-Sex Marriages

Three hundred Michigan same-sex couples have a "fundamental right" for their marriages to be legal, a federal judge ruled after the state refused to recognize the unions.

U.S. District Judge Mark Goldsmith on Thursday ruled in favor of the plaintiffs, eight same-sex couples, in *Caspar v. Snyder*, saying Michigan's refusal to validate their marriages was unconstitutional.

Those 16 individuals and about 600 more were married in March when Michigan's gay marriage ban was struck down. For one day, several county clerks were able to issue licenses to same-sex couples and perform wedding ceremonies before an appeals court stayed the ruling.

"The same-sex couples who married in Michigan during the brief period when such marriages were authorized acquired a status that state officials may not ignore absent some compelling interest -- a constitutional hurdle that the defense does not even attempt to surmount," Goldsmith wrote in his decision. "In these circumstances, what the state has joined together, it may not put asunder."

Michigan Attorney General Bill Schuette previously argued that the reversal on the gay marriage ruling "nullifies the district court's decision completely, and it is as if the legal premise upon which Plaintiffs' marriages are based never existed."

The fate of gay marriage in Michigan for all other couples is still unclear, however. The U.S. Court of Appeals for the 6th Circuit upheld Michigan's ban in November. Now, LGBT advocates as well as supporters of the gay marriage ban are waiting on the U.S. Supreme Court, which is expected to announce soon whether it will hear Michigan's case.

Pastor Preaches Against 'Erotic Liberty' of Gays at Georgia House

A baptist minister invited to give a devotional at the opening of the Georgia House of Representatives on Wednesday (14 January) took the opportunity to rant against gay rights, which he called 'erotic liberty.'

Bryant Wright, pastor of Johnson Ferry Baptist Church and former president of the Southern Baptist convention, reminded legislators that their role was to protect citizens against the 'evil,' in this case gay marriage.



'It is just one example of what our culture is going to increasingly see as an issue of erotic liberty versus religious liberty,' he said.

'We're liable to see this with our military chaplains in the years ahead if they in good conscience believe they cannot perform same-sex weddings and could be kicked out of the military.'

He urged lawmakers to remember that religious freedom was a 'foundational aspect' of the Constitution, 'even though a majority of your constituencies have embraced erotic liberty over religious liberty.'

Simone Bell, one of three openly gay state legislators, re-

sponded to him on Facebook.

'Told him he is a disgrace to the clergy, the Word and the state of Georgia,' she wrote.

'That he squandered his opportunity to bring a message of love to people who have sacrificed to serve the state. That his religious freedom is not being trampled upon, but that he is trampling upon mine and 300,000 + more Georgian's religious freedom to be who God created us to be.

'He responded that we clearly have a difference of opinion. I told him we have a difference of HUMANITY.'

A Colorado Baker is Being Investigated for Refusing to Make an Anti-Gay Cake

A Colorado baker has been slapped with a religious discrimination complaint for refusing to decorate one of their cakes with a homophobic message for a customer.

Azucar Bakery in Denver is known for being a business that is welcoming of LGBTI people and has made wedding cakes for same-sex couples in the past but also make cakes with religious themes so staff were not suspicious when a customer came in to ask if they would make a cake in the shape of a Bible for him.

Staff described the man to Out Front Online as an 'older, professional looking' man, and they say they took him through some photos on an iPad of other Bible cakes they had made before.

But once he'd found a cake he liked he took a piece of paper from his pocket and showed it to the bakery's employees, saying he wanted those words decorated on the cake.

'He wanted us to write ... really radical stuff against gays,' Azucar Bakery pastry chef Lindsay Jones said.

Her boss Marjorie Silva also recalled what the note said, adding that she could have not brought herself to write those words on a cake her business sold.

'He wouldn't allow me to make a copy of the message, but it was really hateful,' Silva said.

'I remember the words detestable, disgrace, homosexuality, and sinners ... I told him that I would bake the cake in the shape of a Bible. Then I told him I'd sell him a [decorating] bag with the right tip and the right icing so he could write those things himself.'

In response the man told Silva that she would be needing to talk to a lawyer and then left.

A few hours later the man came back into the store to ask if Silva had sought legal advice and to demand that she decorate the cake per his instructions and she again offered to sell him a

cake and the means to decorate it himself.

Silva told Out Front Online that she asked the man to leave as he was causing a scene but he returned again later that day, at which point she got her brother involved.



Silva said the man said 'You will hear from me' when he left.

The man then filed a complaint against the bakery with Colorado's Department of Regulatory Agencies (DORA) which asked the bakery to respond.

'I would like to make it clear that we never refused service,' reads a statement to DORA from Silva in response to the complaint, 'We only refused to write and draw what we felt was discriminatory against gays.'

'In the same manner we would not ... make a discriminatory cake against Christians, we will not make one that discriminates against gays.'

Silva fears her bakery has been targeted because she spoke to the media in support of a gay couple who sued another Colorado baker that refused to bake them a wedding cake.

DORA will make a decision in the case 30 days after the bakery provides a final response to the complaint.

'CSI' Star Gary Sinise Pulls Out Of Summit For Anti-Gay Group

"Forrest Gump" actor and "CSI: NY" star Gary Sinise has pulled out of appearing at a summit for an anti-gay Catholic group.

Sinise was set to speak at a summit in Naples, Florida, later this month for Legatus, a Catholic group with a mission to "study, live and spread the Catholic faith in our business, professional and personal lives," according to their website. The group has promoted anti-gay ideology, including calling same-sex attraction a "disorder" and promoting "gay cure" therapies, Good As You reported.

On Monday, Sinise announced he would not be appearing at the event. The actor, whose Gary Sinise Foundation creates programs and raises money for United States veterans, said in a statement on his WhoSay account that his mission is to be "unifying."

For me, faith has been a catalyst for my mission to honor the men and women who serve in our nation's military. When I accepted the invitation to speak at the Legatus conference about Veterans issues and share my story, I was unaware of the controversy surrounding some of the participants, and their views on personal matters. I don't want my mission—which is designed to be unifying—to be disrupted by these, or any controversies, and therefore have decided to withdraw. Along with Sinise, Fox News anchor Bret Baier also pulled out, citing the the group's controversial stances.

"Bret Baier has withdrawn his participation as a speaker at the upcoming Legatus Summit due to the controversy surrounding some editorial stances in the organization's magazine," a Fox News spokesperson told AdWeek. "Bret accepted the invitation to speak about his book, his faith, and his son's congenital heart disease. He was unaware of these articles or the controversy surrounding them."

New York's Cardinal Dolan and Louisiana Governor Bobby Jindal are still both scheduled to speak, according to the group's website.

Legatus did not immediately respond to a request for comment.

In Touch Magazine Photoshops Bruce Jenner as a Woman

Olympic Gold Medalist turned reality show star Bruce Jenner was photoshopped to look like a woman on the cover of the current issue of In Touch magazine.

Even his ex-wife, Keeping Up With the Kardashians matriarch Kris Jenner, thinks the magazine went too far.

According to TMZ, Kris Jenner is telling friends: 'The cover is shocking ... Bruce has never said he's going down the road to change his sex, but the cover reads that way. It's just mean to do whether or not it's true.'

Since his split from Kris Jenner, the 1976 Olympian's appearance has changed. He's grown his hair quite long, had a procedure to have his Adam's Apple 'shaved' down and has been photographed wearing bright fingernail polish.

Jenner has never commented on speculation that he is transitioning from male to female.

'Until someone self identifies, they are just who they are and how they choose to present is how they feel,' says the Los Angeles LGBT Center's Sharon Brown who transitioned in 1989.

'My journey has taught me that until someone self identifies,

regardless of how they are presenting, it might not mean anything other than he enjoys wearing lipstick,' she tells Gay Star News.

Brown adds that it is not uncommon, however, for someone to 'test the waters of acceptance by putting out feelers.'

'Along the way, they do try and let people know in their own way that this is something they are thinking about before they decide to go and come out,' she said.

Sigmund Goes To Palm Springs

For many of us LGBT San Diegans, this is the perfect time to go to Palm Springs: it's not too hot and just far enough away to feel like we've had an adventure.

I was thinking recently of what it would be like if Sigmund Freud – the famous psychoanalyst – were alive today and joined me for a weekend in Palm Springs.

Sigmund and I would sit by the pool at an LGBT-friendly resort, margaritas in hand, watching the boys and girls go by. Here's what he might say:

"You see that guy over there, the one who's so cautious about his sunscreen and afraid to get wet. He what I call the Too-GoodBoy... and that shy young woman who's hesitant to take a chance and talk to the cute woman next to her? She's the Too-GoodGirl. These people have overdeveloped superegos. The superego is the voice of caution and worry about future problems or dangers. It says, "You better not do that, you'll be sorry." Superego-focused people overvalue safety and undervalue a sense of adventure: they avoid risk, at all cost."

I have worked with many clients like this. For example, take Mr. A. He tries so hard to do the right thing, eat right, volunteer for a worthy cause, etc. However, Mr. A hardly ever lets himself go. He's locked into perpetual Good Boy mode. If he keeps this up, eventually he's likely to get so sick of being so good that he'll drink too much, score some crystal meth and let some guy (or 2 or 3) have unsafe sex with him. Then he'll come into my office and ask me, "How did I let that happen?" He ignored his inner Bad Boy for so long that it came out with a vengeance.

Another drink and Sigmund turns to another poolside group:

"Look at that group: see the ringleader? She's not afraid to be loud, bold and blunt. Across the pool is that handsome guy who's having too much fun and doesn't know when to stop. These people are the BadBoys/Girls; they're totally id-driven. The id is the instinctual, primitive part of us that wants to eat when we want to, sleep when we want to, have sex when we want to and won't compromise or wait for anything."

A client I'll call "The Supremely Charming Ms. Z" is a good example of the perpetual Bad Girl. She almost always finds a way to get what she wants. She's the woman who's done it all, had it all, and is bored to death. She's living the Id-driven life, and it's not making her happy. She's often disgusted with herself and with her friends/lovers for letting her get away with so much. But she'll come in for therapy and tell me, "I don't know



why I feel so depressed, I have everything I could want".

Are we doomed to live life in these two extremes? Fortunately, no.

Freud says, "I didn't want the id and the superego to battle it out alone, so I created the concept of the ego. When you go too far in either direction, your ego warns you: "Stop bouncing back and forth between extremes and find your balance.""

At this point, Mr. Freud (now on his third margarita) explains that some men and women have figured out how to be both Good and Bad. These wise folks can be outrageously sexy, goofy and loud and then pull back and be considerate, thoughtful and kind. They can have wild, uninhibited (safe) sex with some hot girl/guy they met last night and then go to church the next morning.

If you'd like this to be you, consider these questions. I suggest you write down your answers:

1. Think about a time when you were way too "good" for your own good.
2. Now think about a time when you were "bad" – even if it was only for a short while.
3. How can you balance the good boy/girl and bad boy/girl sides of yourself?

Put your answers aside and come back to them 3 days' later. Then, let your answers help you tap into both your "good" and "bad" sides, so you can have a balanced life with lots of sexy, spontaneous fun and quiet, grounded wisdom

You can have it all! Enjoy the process!

The Hungry Homo

Hashbrown Casserole

One of the most appetizing aspects of breakfast casseroles is that they can actually be prepped the night before. Then all you have to do is wake and bake. Give new meaning to rise and shine!

Ingredients:

- 1 lb. breakfast sausage
- 3 cups croutons
- 2 cups cheddar cheese, shredded and divided
- 10 large eggs
- 2 cups milk
- 1 tsp. dry mustard
- 1 tsp. salt
- 1 (10 3/4 oz.) can cream of potato soup
- 1/2 cup milk
- 30 oz. Ore-Ida country-style hash browns

Steps:

- Spray a 9 X 13 pan with non-stick cooking spray.
 - Cook sausage until browned, stirring to crumble; drain well.
 - Place croutons in the pan and sprinkle sausage over croutons.
 - Top with 1 cup of the cheese.
 - Beat together eggs, milk, mustard and salt and pour over the top of the cheese.
 - Cover with foil and refrigerate overnight.
 - Preheat the oven to 350 degrees.
 - Mix potato soup with milk and pour over the top of the casserole.
 - Cover with the hash browns and bake for 1 hour.
 - Top with the remaining 1 cup cheese and bake for an additional 5 minutes or until cheese is melted. Cut into squares and serve.
- Makes 8 servings

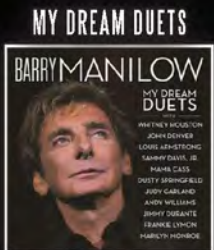
