

What a double-edged sword life is for a gay parent—with both joy and pain. I have a very unique lifestyle because I am a member of a minority within a minority. Depending on the definition used, I am either a male homosexual or bisexual, who is lovingly and consciously committed to a marriage with my wife (who is also my best friend). I am also the proud father of two beautiful boys, ages 7 and 1.

Because I did not want to put any possible offspring through a similarly tormented childhood and sexually confusing early adulthood that I had


experienced, I decided that I did not want children, But, due to imperfect birth control methods I became a gay parent. Now I am determined that my sons will have the best childhood my wife and I can provide.

The joys of parenting have been for me: receiving the unconditional love a child gives his/her providers, knowing there will always be someone somewhere who is a part of myself, watching the many facets of my sons' development, and listening to the wondrous storytelling of everyday events or fantasies. In essence, to experience your own child's growth and development is like look-

ing into a mirror that reflects an image of your own childhood.

My major fear as a gay parent is that my sexuality (which society as a whole considers unacceptable) will somehow affect their sexuality. My fear is that my otherwise straight son may possibly in rebellion think of himself as gay or being gay, think of himself as straight. There is also the fear that they will discover my dual sexuality in an inappropriate way or time.

I feel the best way to combat my fears and maximize the joys of being a parent is to give the most honest and open, loving care to my sons that is possible. I have also resolved not to live my life in a closet anymore, but to provide my aons with as many honest answers and as much information about my sexuality, my loving marriage to their mother, and my gay lover as they are capable of handling. With this approach, I believe I will be giving my sons the best childhood possible, and I will be helping them to develop their own sexualities whether they be gay or straight.

A Married Gay Father

Gay Couples - Parents

"I wish you weren't gay, Dad,"
This was part of a discussion
that my son and I had several
weeks ago. I was not sure at
the time whether he was wishing
that I weren't gay, or that I
weren't different.

I told him I understood that he probably did not want a dad who was different from other kids' dads. Part of the reason for the discussion was that he had told someone I was gay and had gotten an adverse reaction. He decided that it was not something that you tell everyone, that you keep it under your hat, so to speak.

Well, what does a gay parent do? Surely, there must be easy answers someplace. The pain my son experienced was real and difficult to watch. I was not sure at times how to help him, other than to tell him I loved him and that I understood. He is now in the closet about my being gay, except for family and some other folks.

This article is more personal than the past ones because the issue is very important to me. I have a partner also who has a child. We are both parents and stepparents. Our relationships with the children are pretty good most of the time. It has
taken years to develop them,
however. Stepparenting takes
a lot of work. In my work with
stepparents and in the reading
I have done, it is estimated
that stepparenting relationships take about seven years
to develop. I believe that!
Trust is an important issue in
any relationship, but it appears
to be even more of an Issue
with children.

Another issue is the loyalty children have to their natural parents. I do not know now many times I have heard in my office and at home, "You are not my dad and you can't tell me what to do." That statement hits at the core of the loyalty children feel and their sense of who is in authority and who is not. Because of this loyalty, I believe that the stepparent needs to start out more as a friend than as a parent. If a friendship can develop first, the actual parenting and disciplining is easier later. Trying to tell a partner's kid what to do usually does not go over very well, especially if the child is over four or five years old.

Visa, Master Card and American Express Welcome. I don't think that I can deal with all of the issues of being a gay parent and stepparent in this short article. I believe that as a gay parent, I can use ail the help I can get. It has been important to me to talk to other gay parents and stepparents, and it may be that you will need to do the same. It seems to me that we have to be extremely creative in dealing with the issues surrounding ourselves and our children.

I keep hoping that my son will have an easier time as the world becomes less homophobic, but that may not come in his lifetime. Probably the most frustrating question I get from straight folks I know is, "You don't want your son to grow up to be gay, do you?" I don't know how to answer that question. I am usually at a loss for words, and I simply ignore it.

I would say that it takes a lot of courage to be a gay parent and to live your life as an open gay person, but it may be that our children are the ones with the most courage in the long run. Take care and happy parenting.

There is one international organization for gay parents--it is the Gay Fathers Coalition International. It is not just for men, however, and recently, the chapters elected their first woman to the national board. They have an international conference once a year in the summer time.

Parenting - An Interview

(The following interview was taken from a phone conversation with a gay male parent who is 14 years old, has custody of his 9-year-old, and lives with another gay parent. All names have been changed.)

IN YOUR EXPERIENCE, WHAT WAS YOUR SEXUAL DIRECTION UNTIL YOUR MARRIAGE?

I can look back now and see the things that were there that made me decide I was indeed gay. There was no great change, it was a matter of understanding the definition and importance, I didn't know the significance of all the little signs at the time, I assumed I was feeling what everybody else was feeling.

50 YOU DIDN'T REALIZE THAT MAR-RIAGE WASN'T RIGHT FOR YOU. . . IT WASN'T A MATTER OF COVERING UP ANYTHING? Right.

HOW LONG WERE YOU MARRIED? About six years. WHEN WAS YOUR GIRL BORN? Not quite a year after we were married. That was important, we both wanted a kid.

HOW FAR WERE YOU INTO MARRIAGE WHEN YOU REALIZED THERE MIGHT BE A PROBLEM? It surfaced about our third year. It really happened when a lot more became available, in los Angeles. I'm not just talking about gay life but people were more "loose" there.

UNDER WHAT CIRCUMSTANCES DID
YOU SPLIT AND WHAT SORT OF RE-LATIONSHIP DO YOU HAVE WITH YOUR
WIFE NOW!
It has run the gamut. At first,
it was quite amicable. We did
get along and we could still
talk. The problem was I was
more interested in ending the
relationship than she was. It
has since then run all kinds
of feelings. Right now, things
are pretty much ambiguous.
She's in California, and that

helps. We rarely talk, just about when Mary (their daughter) goes back to visit. I don't know whether things will get hot again.

IN TERMS OF MARY AND THE DIVORCE EDUCATE ME ON HOW YOU GOT CUS-TODY.

It was a fluke. At first we had joint custory. That's rather ambiguous. At that time Beth (his wife) was living in Omaha and we visited a lot. Then Beth moved, and we didn't change anything. Mary stayed with her and visits were less frequent. Then Beth visited and asked me to keep Mary so she could move to California. I had Mary about three days and Beth came back, took Mary with her, left town with her. That's when there were suits and countersuits, all the dirty stuff.

YOU SAID ALL THE DIRTY STUFF. DID HOMOSEXUALITY COME OUT? It never came out in court. I am sure the opposition lawyer mentioned it to the judge because of the speed he acted on a couple of things. That's unethical at best. But we never came to a point in the actual court proceedings it was mentioned. It did come up in a deposition taking.

GO ON.

We had one hearing. Mary had been awarded to me because Beth left the state. Then we had another hearing which was a big flasco. We spent hours getting nothing done. The whole pro-ceeding ground to a halt. We settled out of court. By this time Beth was going back to California. She would have cuatody, Mary would come back here for Christmas and summer. The pretty basic arrangement. By the time that was actually arranged, it was summertime, so Beth left Mary with me for the summer. Beth left, got remar-ried, got a job in California. One year ago, Mary went to California for school. She decided she didn't want to live in California with mom, she wanted to live in Nebraska with dad. Berh called up last Christmas and asked if I want to change the arrangement. The lawyers

drafted the arrangement and basically flip-flopped it. I ended up with custody. But the gay thing never really entered into it, except when Beth got really angry.

SO YOU'VE NEVER REALLY SPENT THAT MUCH ENERGY, SAY IN COURT, FIGHTING ABOUT THE GAY ISSUE?

No. In fact, it would have been a good test case because, frankly, I'm in a pretty normal type situation. John and I have been together for awhile and neither of us is weird. Besides, Beth earlier agreed summers and long weekends were okay; it would have been hard for her to change that. But just from the deposition information, they were ready to use the gay issue.

WHAT DOES MARY KNOW ABOUT YOUR SEXUALITY?

I sometimes wonder. Any questions she asks get answered. She knows things are different here. It doewn't take much for a kid to realize she's living with two men instead of a man and woman. We're very open about affection. She's accepted that. I don't know if she's aware of any more. She knows it's more than two men who are just friends.

YOU DON'T THINK SHE'S UNCOM-FORTABLE?


There doesn't seem to be a problem. I guesa I'll have to hedge. - .whe sleeps over at the neighbor's house but there's not the reciprocation. I do wonder why the neighbor kid doesn't come over. ..not as much as Mary goes over there.

DO YOU THINK YOUR SITUATION IS SO MATTER OF FACT. EVERY DAY. THAT MARY MIGHT DISCUSS IT WITH OTHERS WITHOUT EVEN THINKING? I think she's gotten enough negative information, especially during the trial, that she's probably hesitant about using a word like gay. I'm not sure exactly what the rest of the neighborhood thinks. They know we're here. But it's a three bedroom place and they probably think just about whatever they want to. As far as I've seen, nothing appears as

though any of the neighbors were ostracizing her in any way.

AS MARY GETS OLDER, DO YOU THINK MORE MIGHT DEVELOP: KIDS TEASING AND SO ON?

Sure, but that can happen for every reason imaginable. I don't know exactly how to handle that. It will be honest. We'll have to talk about how one can be discreet without being two-faced.

I THINK PEOPLE LIKE MARY WILL ULTIMATELY CHANGE THE WORLD BECAUSE OF HER UNIQUE SITUATION.

She's seen a number of gay people going out together.

WHAT DOES MARY THINK OF JOHN AS7

We've never given him a title. I don't know if she thinks of John as compared to her mother's second husband. But we've never tried to put any name on that.

IN TERMS OF RAISING MARY, HAS YOUR BEING GAY CHANGED ANY-THING! FOR INSTANCE, WE TEND TO BE LESS BIGOTED ABOUT OTHER GROUPS BECAUSE OF THE WAY WE OURSELVES ARE SOMETIMES TREATED.

I'd say that's something I can appreciate. I think I can tolerate a bit better than other people.

DO YOU EVER THINK ABOUT THE FACT THAT YOU'RE BLESSD WITH SOME-THING MANY GAY PEOPLE WON'T EVER HAVE: A CHILD'

I'm very aware of that. I think a lot of our gay friends appreciate kids and relate, play and talk to them. But among at least some gay people there's a problem: a lot aren't comfortable with kids. It does put us in a minority, It does put some restrictions on gay parents, but it would do that to anybody. Kids are a blessing

IS IT A PROBLEM THAT MARY IS GROWING UP WITHOUT A FEMALE ROLE MODEL?

She has an open enough relationship with her mother that a lot of these things can be taken care of there. There are other people in my family. I think it'll be something I'll have to be aware of. I hope she'll develop relationships as she needs to with female relatives, teachers and so on.

WHAT MAPPENS IF MARY SOMEDAY WERE TO TELL YOU SHE IS GAY HERSELF!

I don't know what kind of difference it would make. I suppose we'd be a little more capable of handling the problem. Along with that thought, I would hope if something were to come up in school, if one of the kids or teachers were rumored to be gay, Mary would feel informed enough to speak intelligently about it. I would hope she could shed some light for others.

ANY OTHER THOUGHTS?

Communication with other gay parents is important and probably will be more so as the kids get older. We did go to a national conference for gay fathers and it was enlightening. The organization is called Gay Fathers Coalition International I would like to see something happen (in Omaha). It would be important for the kids, too. Gay parenting is an issue you can benefit from by discussion with other people. Just because people may not have custody or may even be denied visitation is not a reason to stay away from such a group.

in love with a beautiful lady, with the certain knowledge in the depths of my soul that my sexual preferences were being denied. During that outward display of manhood, two sons were born, both of whom I love very much.

After six or so years of pleasing society, reality began to knock at my door. I knew that I had to give this charade up if I were ever going to be my-self and totally happy. This knocking became a pounding after almost eight years. But, there was a price to pay: two very wonderful sons. It was with great reservation because of my sons that I finally ended the marriage and began facing my being gay. Facing it was much less of a task than I had anticipated. Losing my sons had to be the worst heartache that I had ever experienced. It took over six months before the crying in my sleep ceased. I finally began accepting their absence but never lost my love for them.

Some problems have occurred with their mother over the last seven years but I vowed to stay on good terms with her in order to always see the boys. I have seen them every summer. They visit for at least a month each year and occasionally I

have them at Christmas. You see, they live almost seven hundred miles away.

Out of that seven years has come a little sadness but also a little hope. My oldest son and his stepfather had severe problems dealing with each other. He's almost fourteen and through a common agreement between him, his mother and me I now have legal custody of him for at least one year. It was to be his decision at the end of the year whether he would remain with me or return to live with his mom. I have since learned that both sons were being physically abused and am now seeking full custody of both my sons.

I have complete faith that with the help of God, my sons will be with me permanently. I am sorry that my sons have had to experience the pain of abuse, but maybe I'll have the opportunity to ease a little of that pain with their father's love. I know the next few months will be an uphill battle in the courts but I know that with God on my side and the continuing support of my wonderful partner of almost seven years I will win.


Teresa Trull and Barbara Higbie will perform at UNL Trull's powerful vocal fir

Coalition Hosts Legal Expert

Rhonda R. Rivera, an attorney specializing in sexual orientation law, will be the keynote speaker at the annual meeting of the Coalition for Gay and Lesbian Civil Rights on Sunday, October 20. She will also present two workshops in the afternoon, one on child custody issues and one on Legal Life Decisions (how to write wills, real estate contracts, etc.)

Rivers will also speak in Omaha on Saturday, October 19 at 1:00 in the Dodge Room, 3rd Floor, Milo Bail Student Center, UNO, 60th and Dodge. Also several UN-L organizations will co-sponser her appearance in Lincoln on Monday, October 21.

The Coalition is working with Rivers and the NCLU to arrange a workshop for attorneys on representing gay and lesbian clients, to be held Monday, October 21.

Rivera is associate dean of the Ohio State University College of Law and one of the leading American authorities on lesbian/gay legal issues. Sandy

Documentary Film to be Shown in Lincoln

The award-winning documentary film, Before Stonewall--The Making of a Lesbian and Cay Community, will be shown at the Coalition's annual meeting in Lincoln on October 20. The following is an excerpt from a review by George De Stefano (The Nation, July 6, 1985):

"Inspired by John D'Emilio's important book, Sexual Politics, Sexual Communities, Before Stonewall hews to the historical materialism and time frame of its model, sometimes expanding and in a few cases attenuating the source material. The filmmakers have constructed their account of a community's evolution from archival footage, Hollywood film clips, home mov-

les and interviews with the men and women who lived gay life in the decades before Stonewall. Enlightening and entertaining, full of iconoclastic humor and a feisty, committed spirit, Before Stonewall embodies that elusive something known as gay sensibility. Before Stonewall makes a convincing case that the gay and lesbian community will survive, even flourish, because it is deeply embedded in the fabric of American life, born of profound social change and of a heroic, tenacious freedom struggle."

Nebraska Aids Project Announces Plans

The Nebraska AIDS Project (formerly, the Omaha AIDS Project) will be opening a telephone line for information about AIDS and referrals for persons with AIDS or associated illnesses.

The phone line will be operated by volunteers from the community who will be trained by area psychotherapists. Volunteers will be required to attend training sessions stretching over the weekends of Nov. 16 s Nov 17 and Nov. 21 s 24. Subjects to be covered in the training include interpersonal relationships, peer counseling skills, AIDS medical information and community resources (e.g., housing, general assistance, and medical resources).

Protection of Gays Debated by ASUN

Last spring the student senate at the University of Nebraska-Lincoln passed a resolution which would have banned discrimination on several grounds by ASUN. This action was vetoed by Student Body President Gerard Keating because it included sexual orientation as a protected class, and also because of some overbroad language in the statute itself.

A few weeks ago the student Senate again took up the issue. After the vote was over, sexual prientation was still not included in the list of protected classes, though other minorities are now protected from discrimination by ASUN. The measure had again been approved narrowly by the Students but was vetoedby Student Body President Gerard Keating. Following the vote I spoke with one of the senators, Jerry Roemer, who had been the origination sponsor of the bid to include sexual orientation and its primary supporter on the senate floor.

Roemer, a junior from Hooper, Nebraska, and an agriculture major who hopes to go into agricultural law, told me that he was exposed to minorities when he worked at Camp Easter Seal, a camp for handicapped children. He

said that that experience taught him that people who are "different" are still people. He also said that many of his fellow senators initially expressed apprehension about including blacks, to a large degree because many of them have had no experience with blacks. He believes that sexual orientation didn't pass for the same reason-senators who have had no personal contact with gay people have nothing to go on except stereotypes.

Roemer also said that there was a difficulty convincing some people that discrimination does in fact exist on UNL Campus. Prior to the passage of the bill last spring there was no provision against any sort of discrimination, and consequently nobody had any way of documenting whether minorities were being discriminated against or not.

There were no black senators at this time, and no openly gay senators, though approximately one-third of the senate is female. Jerry Roemer said that sexual orientation was deleted for emotional reasons: "There was an emotional bandwagon, particularly about what the folks back home would think." During the senate debate one female senator said that she had polled her classmates and only found one who opposed the addition of sexual orientation. Roemer, who chaired the committee that drafted the bill, said that

he was "shocked" to learn that there was no bill already in place to protect minorities. He also said that he was surprised at the number of senators who originally voted to include sexual orientation last spring but who changed their votes when it came to an override of the Keating veto.

Jerry Roemer said that there were few senators on either side who were really comfortable dealing with this issue. He again pointed out that few senators have had opportunity to deal with gay people as people and suggested that it was good that the bill was discussed because if nothing else it made people aware that this is an issue.

During the discussion one opponent of the measure, Jim Rogers, told the senate that being gay was like having a taste for okra—it is an acquired taste and people who wish to discriminate based on a liking for okra have the right to do so. Roemer found that argument "strange."

There has been discussion on possibly putting the issue on the ballot for the student body as a whole to decide under the co-spensorship of the Gay/Lesbian Student Group, the Womens' Resource Center and Young Democrats. At press time it was not known if that route would be taken or not.

Personal Profiles – Vincent A. Percy

Many words describe Vincent A. Percy that include Illusionist, entertainer, dancer, and star. Who is this charasmatic figure who has personified enthusiasm, creativity, and excitement? His show name is "Velvet" and

he recently won the prestigious title of Miss Gay Nebraska.

I recently interviewed Vince at The Max where he works as a bartender and at his home where I viewed a large collection of show costumes, props, and accessories. I also previewed his attire that was being put together for the Miss Gay America pageant. I was quite impressed by his wide range of talents and personable nature.

His involvements with female 11lusion started when he was a male dancer for his former lover "Satin". In 1981 he put on his first female face as merely a joke, prompted by friends who wanted to try drag on people who never tried it before. His name evolved when he was introduced as "Satin's" sister at his first stage appearance. His first serious show was held at the Hollywood at the end of 1981 and the song, "You Should Hear How She Talks About You", by Melissa Manchester was an instant hit. It wasn't long before Velvet was doing more shows and he remembers putting on benefit productions for the Metropolitan Community Church.

His first involvement with the Imperial Court came when he was asked by Empress Toadie to be Princess Royale. In 1984 he won the title of Empress IV and was very active in fundraising and community involvements with the Imperial Court.

Vince describes himself as an entertainer who Is able to walk off the stage and put his character back in the closet. "I want to be a man. Not a man who runs around in drag", exclaimed Vince.

He sees female illusion as a true art as it takes a great deal of time and work. He sees innovation as very important to keep the audiences attention and interest. Vince stressed the importance of new songs, new ideas and new moves. He uses imagination and creativity in his stage props, outfits, and dance productions. Such innovation was seen at the Miss Gay Nebraska pageant when "Velvet" was carried on stage in a African fishing net secured by an 11 foot bamboo pole. Two men carried him to the stage.

He performed to the song, "Beast in Me", by Bonnie Pointer. He is always looking for unusual items and Vince has searched in friends houses, garage sales, and antique shops. He sometimes draws ideas down on paper and his friend Beth can design the outfit or come up with new ideas. Vince describes Beth as remarkable and says she is a perfectionist at whatever she does.

He was totally shocked and surprised when he won the crown of Miss Gay Nebraska. He was especially proud to be the first performer in Nebraska state history to win two major titles in a row.

Vince stands 6'1" tail, has brown hair and brown eyes and 1's 24 years old. He is very large and tall compared to other illusion—lsts and this adds problems which he has to work around.

Vince has gone a long ways in a very short time. He sees new challenges in the future and may enter other contests such as Miss Gay Midwest.
