

## **The Laramie Project**

The Creighton University Sexual Orientation Issues Taskforce is producing "The Laramie Project" which is based on the brutal slaying of Matthew Shepard.

In October 1998 a twenty-one year old student at the University of Wyoming was kidnapped, severely beaten, and left to die, tied to a fence in the middle of the prairie outside Laramie Wyoming. His bloody, bruised, and battered body was not discovered until the next day, and he died several days later in an area hospital.

His name was Matthew Shepard, and he was the victim of this assault because he was gay. The authors of The Laramie Project made six trips to Laramie over the course of a year and a half in the aftermath of the beating and during the trial of the two young men accused of killing Shepard. They conducted more than 200 interviews with the people of the town. Some people interviewed were directly connected to the case, and others were citizens of Laramie, and the breadth of the reactions to the crime is fascinating.

The authors of the play have constructed a deeply moving theatrical experience from these interviews and their own experiences. The Laramie Project is a breathtaking theatrical collage that explores the depths to which humanity can sink, and the heights of compassion we are also capable of.

The Laramie Project will be performed on Thursday, March 25th, at 7 PM in the Skutt Student Center Ballroom. There will be a suggested \$2 donation at the door and proceeds will benefit The Matthew Shepard Foundation, a non profit organization. The foundation carries out Matthew's legacy by supporting educational projects, activities, and documentaries that raise awareness of the issues involving discrimination and diversity.

Its primary goal is to educate and inform the public on acceptance and civil rights regardless of sex, national origin, color, ethnicity, religion, disability or sexual orientation. The Foundation is also committed to educate the public on hate crimes and the need for proper legislation. Other areas of Foundation interest lie in the arena of human rights and dignity.

I use to spend my time seeking out to argue with people who thought my orientation was wrong. I would almost develop a hated of these people. Thinking they did not like me for who I am. I later became at peace with issue and realized that there are some people that just are not there yet, but if I am in their face I would be more of a burden than a help for the cause.

There are those that are not kind to you, but we should be kind to them anyway. It goes with the old saying, you can catch more flies with honey than vinegar. People will come around, but not if you are screaming in their face. This does not mean you cannot be assertive. I am saving do not be aggressive or passive. I stand firm in what I believe and willing to share others, but not at the expense of losing people.

I have had conversations in church with people who thought our "lifestyles" are utterly sinful. In which I would tell them I would disagree and say I was born this way. I have felt this way since as long as I can remember. I wanted to take offense to it and then I realize they just do not know better.

As a gay Christian I am reminded that there is the part when Jesus is on the cross and says "Father forgive them, for they know not what they do."

If we become intolerant of people that are intolerant of us, we are just reversing the discrimination. We have to try to love our enemies. If we are intolerant of intolerance we become hypocrites. Let us not make the same mistake of those who say we are making wrong choices with who we love.

### In Defense of Biblical Marriage

The Presidential Prayer Team is currently urging us to: "Pray for the President as he seeks wisdom on how to legally codify the definition of marriage. Pray that it will be according to Biblical principles. With any forces insisting on variant definitions of marriage, pray that God's Word and His standards will be honored by our government." This is true.

Any good religious person believes prayer should be balanced by action. So here, in support of the Prayer Team's admirable goals, is a proposed Constitutional Amendment codifying marriage entirely on biblical principles:

- A. Marriage in the United States shall consist of a union between one man and one or more women. (Gen 29:17-28; II Sam 3:2-5)
- B. Marriage shall not impede a man's right to take concubines in addition to his wife or wives. (II Sam 5:13; I Kings 11:3; II Chronicles 11:21)
- C. A marriage shall be considered valid only if the wife is a virgin. If the wife is not a virgin, she shall be executed. (Deut 22:13-21)
- D. Marriage of a believer and a non-believer shall be forbidden. (Gen 24:3; Num 25:1-9; Ezra 9:12; Neh 10:30)
- E. Since marriage is for life, neither this Constitution nor the constitution of any State, nor any state or federal law, shall be construed to permit divorce. (Deut 22:19; Mark 10:9)
- F. If a married man dies without children, his brother shall marry the widow. If he refuses to marry his brother's widow or deliberately does not give her children, he shall pay a fine of one shoe and be otherwise punished in a manner to be determined by law.

(Gen. 38:6-10; Deut 25:5-10)

G. In lieu of marriage, if there are no acceptable men in your town, it is required that you get your dad drunk and have sex with him (even if he had previously offered you up as a sex toy to men young and old), tag-teaming with any sisters you may have. Of course, this rule applies only if you are female. (Gen 19:31-36)

#### CALIFORNIA SUPREME COURT HALTS SAME SEX MARRIAGES IN SAN FRANCISCO

The California Supreme Court issued a interim decision today ordering San Francisco to stop issuing licenses to same-sex couples until the Court has a chance to make a decision in the case. The Court ordered the parties to file written arguments in March, and said it would set a hearing for May or June. There is no timetable for a decision after that hearing.

Although the decision is temporary, it still has a dramatic effect on those couples who were turned away at City Hall today - or scheduled to obtain a license tomorrow - who will now be denied the opportunity to marry.

For the more than 3600 lesbian and gay couples who are already married, the Court's decision does not address or question the validity of their marriages.

Nor does the Court's decision say anything about whether the California Constitution allows the state's marriage laws to discriminate. We believe that at some point, our State courts will recognize that denying gay and lesbian couples the right to marry is discrimination that violates our constitution. It does not appear that the Supreme Court will address this-the ultimate question--when it considers this case. It may well leave that issue to the lower courts.

Today we look back, almost disbelieving, on the time when many Americans did not tolerate marriage between Catholic and Protestants, or between blacks and whites. Someday, we'll look back in equal disbelief at this time when our laws denied the right to marry to adults just because they were gay or lesbian.




with a little hard work and elbow grease.

## Gag Order By Matt Lum

Throughout my adolescence and college education, I considered myself lucky. Many of my friends were stuck in majors at the behest of their parents - studying law rather than literature or medicine instead of art history. There was no such pressure from my family.

Instead, I was always encouraged to pursue my dreams and instilled with the confidence that I could accomplish whatever my heart compelled me to do. <sup>3</sup>You can grow up and be whatever you want to be, Matthew.<sup>2</sup>

It wasn¹t until last week that I learned they meant I could be anything but gay. It was a startling revelation, considering I came out to them eight years ago and had always been appreciative of their handling of the news.

I grew up in a small Texas town on the Gulf Coast called Freeport.

Submersed in a conservative media bubble and bound by the Bible's belt, I had no way of knowing that being gay was a viable option as I pieced together my developing psyche. In the time before Will & Grace, nary a non-homophobic gay image made it past the gatekeepers. I felt truly alone.

That's why I was surprised and elated when I read an editorial in my hometown newspaper condemning Bush's support for the Musgrave [Federal Marriage] Amendment. I instinctively wrote a letter to the editor expressing my appreciation, sharing a bit of my experience growing up in that area.

On Monday, the editor called to ask if they could run my submission as a guest column. It was an excellent opportunity to speak directly to my hometown - one I knew to be thirsty for positive and affirming stories about the gay community. I gave the green light to publish, and immediately called my family to let them know.

Mom, who works at the local police department, was very supportive. I left my brother, a new teacher at the local high school, a voicemail - and trusted the word would filter to my father before it was too late.

At 3 AM I was awakened by the phone. <sup>3</sup>What are you trying to do, Matthew? <sup>2</sup> my dad asked. <sup>3</sup>You are so selfish. Don¹t you realize people will be laughing at me behind my back when I go to work tomorrow? <sup>2</sup> Dragging myself to consciousness from a deep

sleep, I realized I was getting to know my family in a whole new way.

For the next half-hour, I listened to some of the most homophobic rhetoric I've ever heard from anyone - and it came from my father. <sup>3</sup>I told you I would never accept it, <sup>2</sup> he said. <sup>3</sup>Two men together is just not right, <sup>2</sup> he stated flatly. <sup>3</sup>You've been brainwashed. <sup>2</sup> he told me.

<sup>3</sup>Gay doesn¹t exist and one of these days you¹ll realize that. You¹ll realize you¹re wrong.<sup>2</sup>

The support of my parents, something I<sup>1</sup>d counted on for the past eight years, was swept away in a flood of words that would have made the Bush administration and their fundamentalist backers proud.

Far from unique, one simply needs to set gaze on Washington, D.C. to see the most high profile incarnation of my experience. Mary Cheney, lesbian daughter of Vice President Dick Cheney, is toiling away for her father's re-election, silent about the proposed constitutional amendment.

Dick once espoused support for his daughter, saying states should be allowed to make their own decisions about gay marriage. Bush forced him to choose between his family and the Party line, and Cheney made his choice. And Cheney's daughter, who must somehow reconcile her father's love with his support for an amendment that guarantees she is forever consigned to second-class status, stands silently by as she watches him throw her rights away.

<sup>3</sup>You<sup>1</sup>re going to kill dad if you print it,<sup>2</sup> my brother told me in a follow-up 5 AM phone call. <sup>3</sup>Don<sup>1</sup>t kill dad.<sup>2</sup>

In those early morning hours, my mom¹s encouragement veered sharply to

the right. Her maternal instinct to circle the wagons to protect the

family meant she, too, took issue with my letter. I can't hold it against her because I know it's in her job description, but she shouldn't be forced to choose, either.

Despite the fact that every argument my family gave me for not publishing my story clearly demonstrated its need to go to press, I pulled my column. I became another child left behind. It hurts.

## Dear Dr. Laura:

Thank you for doing so much to educate people regarding God's Law.

I have learned a great deal from your show, and try to share that knowledge with as many people as I can. When someone tries to defend the homosexual lifestyle, for example, I simply remind them that Leviticus 18:22 clearly states it to be an abomination. End of debate. I do need some advice from you, however, regarding some of the other specific laws and how to follow them.

- 1. When I burn a bull on the altar as a sacrifice, I know it creates a pleasing odor for the Lord Lev. 1:9. The problem is my neighbors. They claim the odor is not pleasing to them. Should I smite them?
- 2. I would like to sell my daughter into slavery, as sanctioned in Exodus 21:7. In this day and age, what do you think would be a fair price for her?
- 3. I know that I am allowed no contact with a woman while she is in her period of menstrual uncleanliness Lev. 15:19-24. The problem is, how do I tell? I have tried asking, but most women take offense.
- 4. Lev. 25:44 states that I may indeed possess slaves, both male and female, provided they are purchased from neighboring nations. A friend of mine claims that this applies to Mexicans, but not Canadians. Can you clarify? Why can't I own Canadians?
- 5. I have a neighbor who insists on working on the Sabbath. Exodus 35:2 clearly states he should be put to death. Am I morally obligated to kill him myself?

- 6. A friend of mine feels that even though eating shellfish is an abomination Lev. 11:10, it is a lesser abomination than homosexuality. I don't agree. Can you settle this?
- 7. Lev. 21:20 states that I may not approach the altar of God if I have a defect in my sight. I have to admit that I wear reading glasses. Does my vision have to be 20/20, or is here some wiggle room here?
- 8. Most of my male friends get their hair trimmed, including the hair around their temples, even though this is expressly forbidden by Lev. 19:27. How should they die?

Couldn't we just burn them to death at a private family affair like we do with people who sleep with their in-laws? (Lev. 20:14)
