BOYCOTT COLORADO ANOTHER OPINION

Dear Editor.

I have become convinced that the Boycott Colorado movement is a hasty and self-defeating response to a very real threat.

As everyone must know by now, three of the communities most affected by this boycott-Denver, Boulder, and Aspen-have gay rights ordinances. "They'll just have to sacrifice" is the usual response of boycott supporters, often with the implied accusation that members of these cities (which voted overwhelmingly against Amendment 2) are at fault for not having done even more to stop it.

This is great hindsight, but lousy politics. The fact is, we're hurting our supporters in hopes that a little of the economic pain will trickle down to our opponents. Sound familiar? Trickle-down punishment even goofier than trickle-down

Amendment 2 came about, in large part, as a backlash against the gay rights ordinances in these three cities. A blanket boycott of Colorado sends out a dangerous message: Your support of lesbian and gay rights is now going to cost you.

In a perfect world, voters might flock to vote their conscience, and to hell with their wallet. In the real world, we invite disaster if we start rewarding our supporters with an economic boycott. A targeted boycott, aimed at businesses and cities that support Amendment 2, would be a far smarter approach.

The boycott movement has quickly taken on an aura of political orthodoxy. On this (as on so many other issues), debute should be encouraged, not squelched. Perhaps the time will come when a blanket boycott of Colorado seems like our only response. But is should be a last resort, not a knee-jerk first response.





"NO" ON RANDALL TERRY, "NO" ON PAUL CAMERON, "YES" ON COMING OUT

Dear Editor and Readers of NVN,

Many people from both sides of the abortion issue have been surprised by my statements regarding Randall Terry, founder of Operation Rescue because I have been supportive of groups like "Missionaries to the PreBorn" and was spokesperson for "Rescue the Heartland.

I have stated Randall Terry is to the Right to Life Movement what Malcolm X was to the Civil Rights Movement. Once you get him off his main topic he is a political extremist but that is a lame description. The media and public don't seem to realize that Operation Rescue was reorganized and is now run by Keith Tucci as Operation Rescue National. Few seem to realize that Randall Terry has been shunned by many pro-rescue people because of questionable behavior. Allegedly, he removed women from decision making positions in Operation Rescue offending Randall Terry apparently has some decision making capacity with Operation Rescue National and the Christian Defense Coalition. The Christian Defense Coalition is headed by Rev. Patrick Mahoney, a pacifist.

What is disturbing is what Randall Terry said in a speech in Omaha recently. His references to homosexuals bears no arguments and causes me to speculate that he is a homophobic latent homosexual himself. Few people would engage in such mockery as to call gays "Sodomites" and say "I'm here, I'm NOT queer, get used to it, dear!" His speech teetered on advocating a totalitarian government and a religious war. Theocracy? I don't know how when he so blatantly abuses quotes from the Bible. Yet Randall Terry has a radio show which can be heard on Omaha's Christian radio. Homophobia is bad enough without Randall Terry

When Nebraska Right to Life had its rally, a few dozen anti-abortion people gawked at the UNL gay and lesbian billboard display in the Student Union. Several comments were made about a pamphlet on gays and the Bible. I was surprised by this rude behavior of gawking. The billboard was brought to the attention of Lincoln's Catholic Bishop who was present at the time.

This is no reason to hide and shudder in a closet. Come out of your closet if you can. As for those already out of the closet, I hope you will remind friends and family to speak out against homophobia and in favor of gay rights as I have Remind them that YOUR life is on the line

A local homophobic threat is seen in the antifree expression groups of Omaha for Decency and Citizens for Traditional Community Values. A shock to the politically correct and the religious right, this pro-lifer defended Madonna's book at a library board meeting. During the proceedings a woman complained about a magazine her son found in the library and gave a copy to the board members. It was Christopher Street.

This shines a spotlight on a need to reform Nebraska's "obscenity" laws which make homosexual pornography "obscene" thus illegal. Please not that Christopher Street isn't legal

I am stunned, even hurt that the Library has gay publications such as The Advocate, Christopher Street, and The New Voice while stores which offer gay and lesbian and even bisexual books don't carry the publications. How come? Could it be Nebraska's porn law? Why is this matter so important?

First, because the gay community needs visibility but secondly everything else is expensive. Tack the word gay on anything and the price seems to jump 20%. It's true with just about anything and the only thing cheap is a magazine. Now are people supposed to come out of the closet without some support to do so? Reading material which expresses and confirms your own feelings helps people take action.
Paul Cameron and his Family Research

Institute (which was quoted by Coloradans for Family Values as saying gays only represent 3% of the population) was quoted in Newsweek's February 15, 1993 article on "Flow Many Gays

Paul Cameron was dropped from membership in the American Psychological Association because of unethical conduct. In 1984, the Nebraska Psychological Association formally disassociated itself from Cameron. In 1986, the American Sociological Association condemned Cameron for "consistent misrepresentation of sociological research." Noted researchers Alan Bell and Dr. A. Nicholas Groth have spoken out against Cameron's distortion of their own work Cameron's response to the AIDS crisis called for a quarantine of all homosexuals and facial tattoos for identification.

Finally, for those of you rattling your knees in the closet because of the wave of anti-gay activism, as a writer I can tell you, you might be overreacting. The most positive response I have received on anything I have written occurred when I wrote an article in favor of lifting the ban on gays in the military. No negative response and two favorable letters. One heterosexual couple with two small children, who live in Colorado Springs, sent a Christmas card of their family and friends. Enclosed was a letter calling for a boycott of Colorado, and photo with the couple wearing shirts saving "Boycott Colorado."

HIV INFECTION: A Game of Tag?

What are some of the pitfalls that gay men in their twenties face as they struggle through their coming out experience and seek to find a selfidentity which they can love and respect, and protect from HIV. Personally, I realize that I became infected with HIV not because of a lack of knowledge on the use of a condom but the subconscious and cultural atmosphere that entwines our lives as young gay men.

The following is a candid look at some of the factors that played a part in my becoming infected in my early twenties

I. Positive self image?

Society has given young gay men a selfimage problem that they need to address. Until they come to love, respect, and see value in their lives, how earnestly will they seek to protect those lives from HIV?

2. Drugs and alcohol?

We must, of course, acknowledge that drugs and alcohol reduce inhibitions and in some instances allow us to attain higher sexual impulses. Use or not of these substances is not my question. but realizing the inability to make rational, safer sex decisions while under their influence. Looking back, many times I repositioned my own personal boundaries after a few drinks, a hit of poppers, etc., etc., etc.

Control in the bedroom?

Top-bottom and passive-aggressive describe the giving and taking of control in the bedroom.

When you're being passive physically, are you also being passive mentally, allowing your partner control in making decisions on safer sex practices? Too many "tops" think that as long as they are not on the receiving end the risk of HIV infection is minimal, and therefore many express less concern at instituting safer sex practices in such encounters.

Subconsciously, risk can be a sexual exhilerator. Is it possible that putting oneself at risk for HIV can also add to this subconscious sexual excitement?

Pornography has a profound impact in gay men's culture and their sexual practices in the bedroom. Only recently have video fantasies started to introduce safer sex practices. What is the effect of stimulating ourselves with video and pictorial images, having intercourse, etc. without using a condom? HIV is reality and seldom rears its head in fantasy.

6. Practically prepared?

Simply put, if condoms and lubricant are not available where and when sexual activity is going to take place, it can't be used. Condoms and lubricant in a bed side table is a great idea, but are you also having sex in places like cars, parks, locker rooms, hotels, etc., etc.? In the heat of passion, if these items are not readily accessible, will you proceed without?

7. Strangers?

In one night stands we certainly have no emotional ties, so how can we expect our partners to have deep concern for our safety? In reality, it is often every man for himself. Assume everybody's HIV positive. Remember, the world has its share of weirdoes. Imagine being on the receiving end of anal intercourse with someone you met only hours before and agreeing for them not to use a condom by saying, "Just don't come

8. Invincibility?

I'm very surprised at how many gay men I meet for which I am the first person they have known to acknowledge that he has HIV/AIDS. So often the things we see in the headlines and on television never directly impact our lives in a personal way. Only when a person realizes the real potential for this virus to infect their life will they act accordingly. For those of us who are infected, by stepping out of that closet we allow others to take it from the headlines into their

9 Oral sex debate

Are most gay men using condoms while having oral sex? No! Why? Let's look at some theories. "Well, as long as he doesn't ejaculate in my mouth, I'm OK. If I'm having oral sex performed on me, I'm OK. If I don't see any precome, what's the problem? Besides it doesn't feel as good, and what's exciting about putting latex in your mouth anyway? If it's lubricated, it tastes terrible. 10. Love and emotions.

Is it OK to ask the other person, "Are you HIV positive?" Would you tell the truth if somebody asked you? Do you even know? How long ago were they tested? How many sexual partners have they had since? Is there such a thing as one hundred per cent safe? Do they have a responsibility to inform me of their status? Our culture has yet to define a moral and ethical responsibility that has been accepted as the norm when it comes to HIV disclosure. The best thing I can say is don't risk your life on it. 12. Male ego.

We as men in this society have been encouraged to think the more the merrier when it comes to the conquest of sexual partners. Need I say more about how HIV rides on the coat tails of this idea?

13. Condom breakage?

Do they break? Yes! I've had two incidents in the past eight years. One of the flaws in usage that I have seen most is thinking that a thin latex condom will last through a half an hour or more of vigorous use

14. Sexual addiction?

What is it? How many of us are willing to compromise safety factors in order to satisfy momentary wants? A therapist sympathetic to gay concerns could be helpful in addressing this, therefore gaining control over possible HIV infection.

15. Our forefathers.

As young gay men in society, who is helping us set our boundaries when it comes to our sexual practices? Our biological fathers? In most cases, no. Our fathers have a difficult time dealing with our sexual identity, let alone having graphic discussions about our sexual practices. We must then turn to gay men in the decades who preceded us. Are they being shining examples to teach the way? In most cases, no. HIV didn't necessarily exists in the world of their youth

16. To test or not.

A worst case scenario. "I haven't practiced safer sex consistently in the past, maybe I'm already infected? I don't want to know. I'll continue taking risks while keeping my fingers

Or, "I just had my six month check up-came

out negative. Six more months of fun. Trust me! These situations will inevitably lead to infection!

REDISCOVERY

Much has been written about the beauty of finding love, dating, establishing a joint household with our beloved, choosing monogamy over an open relationship, and legal problems unique to gay couples. Unfortunately, although a fact of life, we hear little about how to cope with the loss of someone significant to us. It's as if there is a "Code of Silence" which directs otherwise rational, caring individuals to cope with this excruciating pain in solitude and seclusion.

Well-wishing friends and relatives tell us to cheer up, stop thinking about him/her, or they choose our feelings for us. The truth is that everyone experiences loss at some time in our lives. Whether this loss occurs as a result of a death, the end of a love-affair, or in some other form, there is commonality in the emotional unheaval we experience


Thankfully, our minds allow us to deal with no more emotional pain than we can handle at any particular time. We progress through the stages of grief by experiencing both progressions and regressions. These stages begin with shock which is often identified by the numbing effect it exhibits. The second stage is denial, known by the "This can't be happening" syndrome. Next is the anger stage which is probably the longest lasting of the five stages. Bargaining is next. It is during this time when we try to make a deal with our expartner to come back to us, or with God to let us see our loved one once again. The final stage is acceptance. When we reach acceptance we are finally able to deal with the reality of the situation, forgive, let go, and move forward with our own lives.

Keep in mind that the length of time required to grieve varies, depending upon the importance of the loss and the grieving person's willingness to focus on the healing process. During this process it is important to allow ourselves all the time necessary to feel the pain, experience the loss and what it means to us, and to seek the support of others with wisdom and similar experience. In the case of a relationship ending, two partners may greeve at different rates since their perspectives and experiences will, undoubtedly, not be identical.

Common symptoms of grief are to feel sluggish, require much more sleep that usual, forgetfulness, irritability, loss of sex drive, appetite, and fear. Let's face it... this fear includes wondering whether we'll love or be loved again, how we'll juggle any potential financial problems that this loss has created, whether our friends will continue as friends in view of this new single status, and the list goes on It's O.K. to feel any of these feelings and a myriad of others. What's not all right is to decide we can't handle the pain and choose alcohol/drug abuse, addictions to sex, or violence as coping mechanism. And, regarding the question of suicide. keep it a question. It's not really the

If we realize this process is normal, universal, and finite in nature, perhaps we'll fear it just a little bit less. We can turn to friends, develop new interests, redecorate the apartment, start working out, and make new choices about what we want for ourselves in the future. In my experiences, every grief experience has allowed me to grow and to move forward to something more wonderful than I though possible before.

There are no shortcuts through grief. We can't work around it—only through it. Likewise, there are no rules in our culture about how to greeve or how long it should last. I do, however, lave one rule! would suggest. I have experienced the pain of loss more than once in my life. In one instance this pain came as a complete surptice as (cont. page 7).

dishonesty and deceit. In another, the end came after mutual discussion, consent, and an honest exchange of feelings. We agreed to love each other enough to allow both of us to move forward in life in order to find our respective ideals of happiness. In this case, honesty was the key. Have experienced both honesty and deceit in a break-up, I high recommend honesty, and I love and respect that individual for that wonderful gift.

Nature is replete with beginnings and endings. It is the way of things. Learning to deal with loss is at least as important as learning to deal with romance because it is in loss that we truly experience growth and the beautiful gifts we received from another.

Love, live, and lose, but know well you will survive and you will love and be loved again. It is nature's gift.

This is no longer 1967, when you can make sexist, homophobic comments and expect that no one will speak up to tell you that this is unacceptable behavior.

Two years ago EAGLE, a U.S.WEST Resource Group, did a coat drive for the homeless and Pat Phalen took the donations to Open Door Mission. They were promptly thrown on the floor as if they did not appreciate the donations. So perhaps we could all donate to another homeless center that would appreciate us as gays/lesbians.)

Dear Sharon,

Thank you, so very much, for your letter of constructive criticism of December 21, 1992.

I do appreciate constructive criticism, however, I do want to exercise the privilege of correcting your observation, at least in part.

My words were "I abhor homosexuals and heterosexuals who prey upon little children." I am fully aware that there are more children being molested by heterosexuals than by homosexuals. I am also aware that nearly 100% of those who do molest little children have, themselves, been victims of incest. At the Open Door Mission and the Lydia House, we aggressively reach out to both the victims and the perpetrators to the best of our ability. Over the years, we have had many perpetrators of incest within our 12 month, livein, rehabilitation program and we do everything we can to get them the proper counsel. At the present time, I have a friend (a former pastor) who is in the Iowa State Prison. He was convicted of molesting a little boy in the Council Bluffs area. While I abbor what he did (he was married at the time) and while I hate the sin, I love the sinner.

Sharon, I do not agree with your figure of "10% of the population is gay/lesbian." I am sure that you know that many studies have been done other than the Kinsey Report which indicates the gay/lesbian population to be 3% or less.

In the long run, I am not particularly concerned about how many people there are in any category in any survey. I am far more concerned about the person—that they are presented with God's everlasting and redeeming love. This would apply to people who are "up and out" as well as the "down and out."

The policy at the Open Door Mission and the Lydia House is that we accept anyone into our transient program and rehabilitation program who simply "cry out for help". We do have a policy that prohibits any heterosexual (outside of marriage) or homosexual behavior. We are convinced that a shelter for the homeless is not the place for a person to find a mate, irregardless of their sexual preference.

I pray that the above observations only serve to win or earn your friendship and respect. We may not agree ou numerous things in life, but I hope we can han together in our demonstration of compassion and love for the homeless. It may interest you to know that just over 50% of the homeless who are being sheltered in the Omahia area are being sheltered at the Open Door Mission Lydia House. Evidently, we must be doing something right. I believe they sense the love of God and the compassion that springs from that love and they want to be in our two shelters.

I would be happy to pursue this with you in the future and especially if you think we could find some common ground wherein you will not 'tell all my gay and lesbian friends to find another outlet for their giving and sharing".



A SINGLE PINK TRIANGLE

When I'm not wearing a button promoting some political cause or candidate, I often wear an enameled pin consisting of a pink triangle pointing down, superimposed upon a yellow triangle pointing up forming a six-pointed Star of David. The pink triangle is a symbolic reminder of the brutal treatment of thousands of homosexual men by the Nazis during the Holocaust. While today many Gay men and Lesbians perceive the pink triangle as a symbol of pride, its origin as a symbol of oppression and torture should never be

forgotten

If you are in your 20s, 30s, or 40s, the Holocaust may seem like ancient history, and it may be difficult to conceive of six million Jews, and as many as four million others, being deliberately murdered by a modern, civilized society such as Germany. To visualize the enormity of this, imagine the entire population of a city larger than Los Angeles being slaughtered.

In April, 1993, a museum is scheduled to open in Washington, DC as memorial to this episode of people's inhumanity to their fellow human beings. The museum will include a display of artifacts, documents, and other materials. Its purpose is educational—to bear perpetual witness to the horrors of this Holocaust, in the hope that such a horror will never recur.

Homosexuals were the most vulnerable and least mourned victims of the Holocaust. Perhaps the chief reason for this is that we are, even now, a mostly hidden and "closeted" segment of the population. The fate of German Gay men was complicated by the fact that homosexuality had been a crime there since 1871, though the law was seldom enforced, and a liberal atmosphere prevailed after World War I. It was then that what may been history's "Gay Liberation" movement had been founded in Germany by Magnus Hirschfeld. In spite of its illegal status, this movement slowly gained ground until the Nazi takeover in 1933. (Editor's note: The movement had actually gained official government acceptance, which allowed men to "register" and be allowed to cross-dress. This registration list ultimately led to the annihilation of what is estimated to be near 500,000 homosexuals under Nazi rule.)

The Nazis viewed homosexuality as degeneracy which undermined the supermasculine ideal of the Aryan man, and in 1935 even more stringent laws went well beyond the penalty of mere imprisonment to include compulsory sterilizations, usually in the form of castration.

Continuing homophobia has actually suppressed the record and evidence of the slaughter of homosexuals during the Holocaust, resulting in a very incomplete history of the war against Gays. The Holocaust Museum has had very limited success in gathering historic materials on this group.

on this group.

To date, the museum collection includes a lone pink triangle patch, found by a U. S. Army soldier during the liberation of the concentration camp at Dachau. The Museum's Oral History Department has taped two interviews with Gay survivors, and the Photo Archives has obtained a few photos of homosexuals, to be included in the exhibits. The Museum Archives has obtained some police records of roundups and arrests of Gays in two German cities.

If you, or anyone you know, has material on hisosexual victims of Nazism, and would be willing to make it available to the Museum, or if you know of someone who witnessed the persecution of Gays during this period, your help would be of great importance both to the Museum and to the cause of proper recognition of Gays during this period your help would be of great importance to the Museum and to the cause of paper recognition of the fate of Gays during the Nazi era.





BEWARE- IT'S HAPPENING EVERYWHERE

The state of Oregon has been a pressure cooker in the months leading up to the November 3rd election, because of the showdown regarding anti-gay Measure 9. Measure 9 is an outgrowth of earlier events in Oregon. In 1988, the OCA (Oregon Citizens Alliance, an ultra right fundamentalist group) sponsored Ballot Measure 9, which overturned then governor Neil Goldschmidt's executive order banning discrimination against state employees based on excual orientation. In 1991 the city of Springfield passed a municipal ordinance similar to Colorado's Amendment 2. The OCA had the same measure in other municipal elections, but it failed. Through the state's initiative process, although it took two attempts, the OCA was able to get Measure 9 on the ballot.

Following is the summary in our voters' pamphlet (the largest ever in Oregon) regarding

Measure 9:

Amends Oregon Constitution. All governments in Oregon may not use their monies or properties to promote, encourage or facilitate homosexuality, pedophilia, sadism, or masochism. All levels of government, including public education systems, must assist in setting a standard for Oregon's youth which recognizes that these "behaviors" are "abnormal, wrong, unnatural and perverse" and that they are to be discouraged and avoided. State may not recognize

this conduct under "sexual orientation" or "sexual preference" labels, nor through "quotas, minority status, affirmative action or through similar concepts."

The OCA wanted to include necrophilia in this proscription also, but the state would not

allow that

Under the explanatory section of the measure this was elaborated further-the citizens have a right to challenge governmental promotion, encouragement or facilitation of homosexuality, pedophilia, sadism and masochism. Some examples of what would be challenged are the expenditure of public funds either directly or through the free use of government property for sensitivity training that would include gays and lesbians in its focus, for rallies or parades, such as the Gay Pride Celebration and March, and lastly, the employment in government, including public schools, any individual whose primary job duties place him or her in direct and regular contact with children or youth if that person publicly promotes or facilitates homosexuality, pedophilia, sadism or masochism. This gives an idea of the extent to which the OCA is willing to go to pursue their mean-spirited ideals.

The OCA followed this up with statewide distribution of a video edited to show "sensational" excerpts from Gay Pride marches in Washington D.C. and San Francisco. I hear the Traditional

Family Value group in Colorado used the same video. The OCA also blanketed parts of the state with newsletters that attempted to tie in homosexuality with pedophilia, stories of how homosexuals are trying to recruit young people and how the schools promote homosexuality.

I'd like to share with you some of the events during the time of Measure 9, some tragic, some enlightening, some absurd and some just plain

In September the home of a black lesbian and her white male gay roomnate in Salem was firebombed. Both were killed. The suspects in the case are two white supremacists and two of their

A lesbian woman was assaulted at an OCA function by an OCA official. She had been invited to attend, although the OCA had not been aware of her sexual orientation. The case went to trial and the OCA official was found guilty and ordered to pay \$30,000 in restitution. The OCA is appealing this decision.

There were break-ins at one of the groups opposing the ballot measure, at Portland's Metropolitan Community Church and at a Catholic church, where graffiti was spray painted denouncing various minority groups.

Along with this terrible stuff going on were wonderful things too. All of the major candidates from Oregon, regardless of political affiliation

came out against Measure 9. US WEST and other large businesses were supportive. U.S. WEST had a statement in the Voter's Pamphlet. Many professional organizations placed ads in the newspapers opposing Measure 9. The Catholic Archdiocese of Portland, the Ecumenical Ministries of Portland (17 different denominations), NAFLA (North American Fat Ladies Association), some Hollywood folks (Roseanne and Tom Arnold), Timberline Lodge on Mt. Hood, AFL-CIO, other organizations and tens of thousands of individuals made contributions to local PACs opposing Measure 9. Governor Bill Clinton sent a telegram to be read at a "No on Nine" rally in late October urging his supporters to vote against the measure. One evening on my job as an operator I spent what seemed like several minutes with an inebriated customer who made absolutely no sense-but he finished up his unintelligible conversation with me by saying "And I'm going to vote no on 9!" He wasn't such a bad customer after all

Button collectors were in heaven at this time and I guess that includes me, because I would be color coordinated with whatever I was wearing. Buttons came in various colors, shapes and sayings. The most popular one perhaps was a triangle shaped button with various rainbow stripes on it that said "No on 9". My favorite was one that said, "The OCA is abnormal and perverse". Buttons were great conversation

National Operators' conference held in Seattle. An operator from Wisconsin attending the Conference vowed to start a "Straight but not Narrow" group in her area.

Many lawn and other signs dotted businesses and neighborhoods. A favorite in my areas was a sign done in calligraphy: "JOIN THE CULTURAL ELITE—Vote No on 9." All the e's were underlined, at Dan Quayle's expense, no doubt. One street declared itself a "Hate Free Zone" and homes on both sides of the street had personally designed signs.

Sanity could be maintained by volunteering time at one of the PAC offices that were running full steam ahead. Thousands of volunteers participated. Whenever I felt frustrated, down or angry, a stint at the No on 9 office always gave me a lift. A cross section of society was fighting this battle, and they were helping out at various PAC offices.

One day at the No on 9 office, I listened with interest as two gay men were reading some OCA propaganda that supposedly was defining certain words that are used in gay culture. These men were laughing because most of these "gay specific" terms were ones that they had never heard before! Also in this OCA literature was a copy of "The Homosexual Manifesto." These guys hadn't heard of that either. Isn't it curious that the OCA seems to know more about homosexuals than homosexuals do?

Since politicians in Oregon were loudly an ubtliely opposing Measure 9 or remaining silent, the OCA brought in some folks from other states. One was Representative William Dannemyer of California. He came to a Yes on Nine dinner and fundraiser. He informed the good people of Oregon than Lon Mabon, the head of the OCA "isn"t just a man, he's a leader." Reverend Shelton, of California's religious right stated that the churches in Oregon that opposed Measure 9 were a bunch of "half-baked Christians" who "don't accept the Bible as the word of God."

One of the most spectacular ads in the Oregonian, our local newspaper was a list of about 1700 people's names (evidently the majority half-baked Christians) listed by their religious denominations who opposed Measare o

The ballot measure generated a lot of media attention, both nationally and internationally. About two weeks before the election there were journalists from Japan, Scandinavia and the United Kingdom trying to make sense of the crazy senselessness going on in Oregon. On a local television talk show one woman declared that she had proof that the matia was closely tied to the gay community!

Election Day was a quiet day for most. Police beefed up patrols and had extra security

at the No on 9 office as well as at the OCA headquarters. The OCA had set up a road block on the property leading to their office building. All people entering the building were frisked by a metal detector wand and the OCA officials all wore flack jackets. Both sides on the campaign issue received death threats. If's been very ugly.

I spent election day canvassing people to get out the vote, and driving my van, covered with No on 9 signs, filled with people around a couple sections of Portland that would be our cequivalent of Castro or Greenwich Village. We honked, yelled and hand out signs, bumper stickers and buttons. People smiled, yelled and were pleased to see us, except for one man who we thought might pop a gasket yelling at us. One mail carrier came up to the van and

said, "I'm one of you?"

Oregon election results were not announced until 8:00 p.m. I attended the victory party for the No on 9 Campaign at Montgomery Park, an old Montgomery Ward building now revitalized in the form of conference areas with a wonderful atrium. Gail Shibley, an openly gay lesbian State Representative had her victory party at the same location. When the results started coming in, the floor actually shook from everyone's excitement. The early results were 75% to 25% against the measure. As the evening wore on, the percentage changed to a less overwhelming win. The final results were 57% to 43%. Ellen Lowe, the Ecumenical Ministries Chairperson and the spokesperson for No on 9 Campaign stated that now is the time for both sides to try to find common ground and begin to heal. Lon Mabon, the OCA Chair said, "Yeah, yeah, yeah. We're going to retool and be back again, maybe using something like what passed in Colorado has been colorado.

I am afraid of the religious right. They are a damned mighty political force that cannot be underestimated. They have a political agenda that puts us on the top of the iceberg, but there are other areas in which they are dangerous too. Stopping women's right to choose and the separation of Church and State; reintroducing prayer in school and teaching the Judeo-Christian story of evolution are a few of their goals.

A tremendous coalition was built in Orgon over the last year. Maintaining the support of those groups is what is needed to get not "special rights" but equal rights for gays and lesbians. What can we in Oregon do to give support to folks in Colorado or wherever else the religious right starts to attempt to deny people their rights?

The final victories might have to come through the courts.

Essex Hemphill, cultural activist and editor of the critically acclaimed collection. CHANGE DOWN UNDER

Australian Prime Minister Paul Keating last week did what Bill Clinton has vowed to do. He lifted the ban on homosexuals in the military.

U. S. News's Viva Hardigg asked Brig. Adrian D'Hage, Australia's chief military spokesman, how the action is being received. His reply.

The returned services leagues (veterans groups) are all up in arms. The defense force saw the disadvantages toward command and unit cohesion and morale. But at the end of the day, the defense service salutes the flag. If the government says, "Go north," we go north. You can't have the situation you have in some countries, where the military controls what goes on, or you finish up with anarchy.

I don't think there will be a great influx of homosexuals into the armed forces. Our new unacceptable behavior policy still allows an officer to dismiss a homosexual for offensive behaviorbut not because he or she is of that sexual preference. The same rules apply for heterosexuals. Some examples of unwelcome behavior are spreading rumors regarding a colleague's sexual life, public discussion of sexual activities, derogatory remarks to a colleague regarding his or her sexual appeal and indiscreet sexual relationships between a superior and a subordinate that result in damage to unit cohesion. Commanders in the field will lay down some very clear guidelines about what happens if there is a breach of code concerning homosexuals. Poofter-(faggot) bashing will not be tolerated.

Certainly with the combat units, there is a bit of macho mateship, an it will take time before this policy is totally accepted. But the image of the bronzed Australian is mostly mythology. We're pretty normal people down here. We may come from the bottom of the world, but we're not all like that movie of Hogan with the big knife. The SeaSpirit departs St. Thomas every Saturday through April 3, 1993 for 7-day cruises to the U.S. and British Virgin Islands. This summer, beginning July 3, she II traverse between New York and Boston on 7-day "town and country" cruises visiting Newport, New Bedford, Martha's Vincyard, Namtucket and Provincetown. AIDS ACTIVISTS APPLAUD REDEFINITION OF DISEASE

The Centers for Disease Control plan to expand the definition of AIDS to include three additional ailments: invasive cervical cancer, recurrent pneumonia, and pulmonary tuberculosis. A total of 50,000 new AIDS cases were anticipated in 1993 under the existing definition, but the new definition would add several thousand. Expanding the definition could qualify many more people for disability and other benefits. This prompted some groups, such as the National Association of People with AIDS, to oppose the change, fearing it would create a battle for AIDS treatment dollars. But CDC officials stress their definition is a surveillance tool, not intended to determine any type of insurance or federal befits.

LEFT OF CENTER

Left of Center, a subscription supported publication, premieres this March in five major markets. Minneapolis/St. Paul, Kansas City, Oklahoma City/Tulsa, Memphis, and Omahal Des Moines. "We are definitely targeting the midwest," said Bryan R. Feuerhelm, editor-Feuerhelm is also the publisher of The Progress Tribune, the Gay and Lesbian newspaper in South Dakota. "The Gay publications which have recently surfaced are slick, but they appeal to a younger, more coastal readership. Left of Center appeals to the sensibilities of the Gay midwesterner."

The first issue features the story of a young woman who, after finding herself with no place clese to turn, seeks refuge in a homeless shelter. From there she is asked to leave because she is a Lesbian. (Ed. note: This story was originally published in the December 1992 issue of *The New Voice of Nebraska*.)

"If's a raw, honest account, told in her own words," said Feuerhelm.

Other articles support Left of Center's regional boast: cuisine from Oklahoma City, satire from Minnesota, and commentary from Memphis.

"Middle Americans, Gay middle Americans, are bread and butter, hard working, no-nonsense folks. I'd like Left of Center to speak directly to them... The best we can do is shine a spotlight on ordinary individuals and the extraordinary circumstances in their lives. The voices in Left of Center will reflect that spectrum."

LTN NEWSLETTER

The LTN (Lesbian Teacher Network) is a grass roots organization of about 500 women, mostly from the US and Canada, but also representing several countries around the world.

LB 819 SETS UP HIV TEST SITES/MANDATORY REPORTING By Panic Staff

Tim Timmons of the Lincoln-Lancaster Courty Health Department says provisions for anonymous and free test sites is provided for under LB 819, which is scheduled for public hearing on March 10, 1993. Mr. Timmons encourages input from all concerned parties.

The legislative bill will establish and administer a statewide AIDS program for providing education, prevention, detection, and counseling services to protect the public health. LB 819 will require health care providers and laboratories to receive written informed consent prior to confidential screening for the HIV virus; this will provide protection of the public from having an HIV test performed without knowledge or consent. Exceptions would be medical emergencies when consent cannot be given or withheld, or in the case of making an anatomical gift. HIV would become a reportable disease under LB 819 when testing is performed on an informed consent basis. Positive HIV test results would have to be reported to the State Health Department with identifiers, where such information would become privileged and would not be subject to public disclosure. All reporting by the State Health Department to the CDC, or used in scientific analysis would be done in such a manner as to ensure anonymity. However, the bill does allow to the official state and local health departments of other states "reports and notifications, including sufficient identification and information so as to ensure that investigations as deemed necessary are made." Persons violating any of the provisions of the new law would be guilty of a Class III Misdemeanor.

Timmons cited the provisions in LB 819 for providing free and anonymous test sites as one of the bill's strong points, as this would allow the public to seek testing without the fear of having a name attached to the test. However, he does believe that making HIV a reportable disease, when testing is done on an informed consent basis, will allow for more accurate information concerning HIV. Presently only AIDS cases are reported, not those infected with HIV.

WHAT IS LB 395?

LB 395, introduced in the Nebraska State Legislature by State Senator Tim Hall, would prohibit discrimination in employment based on sexual orientation. The bill is expected to go before the Business and Labor Committee within the next few weeks. Following is a policy brief produced by Citizens For Equal Protection regarding this legislation.

1. WHAT ARE WE REQUESTING?

our vote in favor of LB 395 which amends the Nebraska Fair Employment Practice Act to prohibit discrimination based on sexual

Sexual orientation is defined as having an orientation for heterosexuality, homosexuality, or bisexuality, having a history of such an orientation, or being identified with such an orientation. Sexual orientation shall not include transvestism, transsexualism, pedophilia, exhibitionism. voyeurism, gender identity disorders not resulting from physical impairments, or any other sexual behavior disorders

We are not requesting special right. The right to get and keep a job based on ment is not a special right. This legislation does not promote

quotas or affirmative action.

Lesbian and gay Nebraskans seek the same legal protection from discrimination that is now extended to other individuals who have historically been denied equal opportunity to employment.

Employers are free under this bill to hire and fire employees based on their qualifications and job performance

2. WHO NEEDS THIS BILL?

One hundred fifty thousand Nebraskans are gay, lesbian, and bisexual by most estimates.

We are women and men of every age, who live in every community and work in every occupation. We belong to every ethnic and religious group. Your neighbor, co-worker, or family member someone you love may be gay. lesbian or bisexual without your knowing it

It is not only gay and lesbian Americans who need this bill. When people lose their jobs through discrimination or are barassed, their families suffer and the whole community loses And, there is discrimination against people who are thought to be gay, lesbian, or bisexual, whether they are or not

3. WHY IS THIS BILL NEEDED?

There is currently no legal recourse in most parts of the country for people who face discrimination on the grounds of sexual orientation. Results from 21 local discrimination surveys reveal that between 16 and 44 percent of the respondents faced some form of discrimination in employment due to sexual orientation - this included being fired, not hired, not promoted, getting harassed and fearing reprisals if their sexual orientation were known. (Source: "Survey Results on Discrimination Against Lesbians and Gay Men." NGLTF Policy Institute, 1992)

When gay, lesbian, and bisexual people face discrimination, just like discrimination by race, sex, or religion, they are not judged as individuals but as part of a group. They are not judged by their job performance but by an extraneous fact The perceived connection between their private lives and their jobs is based on erroneous stereotypes. And the consequences can be severe

This bill does not require anyone to approve

of how anyone else lives their private life. Likewise, federal law forbids discrimination on the grounds of religion, but it does not require anyone to endorse someone's religion. This bill is based on the principle that Americans can work and live together despite their differences

4. IS THERE ANY PRECEDENT FOR SUCH A LAW?

There is growing recognition of the need for legal protection of gay men, lesbians, and bisexuals from discrimination. Connecticut, Hawaii. Massachusetts, New Jersey, Vermont, Wisconsin. and the District of Columbia have outlawed discrimination based on sexual orientation. Similar laws are in effect in over 100 cities and counties in every part of the country, including Pittsburgh, St. Paul, and New Orleans.

The University of Nebraska-Lincoln has a policy which states "It is the policy of the University of Nebraska-Lincoln not to discriminate on the basis of sex, age, handicap, race, color, religion, marital status, veteran' status, national or ethnic origin, or sexual orientation." Some other businesses in Nebraska which do not discriminate based on sexual orientation are U.S WEST and Bryan Memorial

Hospital.

Many major corporations have included sexual orientation in their fair employment policies. These include DuPont, IBM, Western Union, A.T. & T., Apple Computers, Lotus Computers, General Mills, Ford, and General Motors

Labor Unions have also taken a stand against discrimination. In 1983, the AFL-CIO passed a resolution protesting any personnel actions taken against any worker merely on the basis of sexual orientation. Other unions endorsing this stand are American Federation of State, County, and Municipal Employees, Service Employees International Union, International Brotherhood of Electrical Workers, and the Hotel Employees and Restaurant Employees

5. WHAT RELIGIOUS SUPPORT IS THERE

FOR THIS BILL?

Many major American denominations affirm that discrimination against gay and leshian people is wrong. These include the National Council of Churches (representing 32 Protestant and Orthodox denominations), the United Methodist Church, The Union of American Hebrew Congregations, the United Church of Christ, The Central Conference of American Rabbis, The Presbyterian Church USA, the National Federation of Priests' councils, the Episcopal Church USA, the National Coalition of American Nuns, the Religious Society of Friends, and the National Assembly of Religious Women

6. WHAT IS THE EFFECT OF THIS BILL IF IT IS PASSED?

Sexual orientation auti-discrimination statutes are a cost effective means of eliminating discriminatory practices that are harmful not only to individuals, but also to our economy as a whole. A study done at the John F. Kennedy School of Government at Harvard University looked at the states of Wisconsin and Massachusetts who have laid these laws the longest

In Wisconsin in 1991 only one of 1600 employers had been subject to a discrimination

complaint. And of 7,072 total discrimination charges filed, only 100 or 1.1% were based on sexual orientation. The number of employers affected in Massachusetts was one in 1000 and the percentage of all cases filed that involved sexual orientation was 1.9%. Of the Massachusetts cases, 90% were closed before they reached the public hearing stage or were moved to another

The city of Ames, Iowa passed this legislation in June 1991. One year later, City Manager Sheila Lundt reported four formal complaints filed, with three of those under investigation. Complaints have come from both the heterosexual

and homosexual community.

7. WHY SHOULD THIS BILL BE SUPPORTED?

Most Americans believe discrimination is wrong. One poll showed that 80% of Americans agree that gay, lesbian, and bisexual Americans should have equal job opportunities (Penn & Schoen, 1991). Another poll showed that 71% believe job discrimination is wrong (Newsweek,

Economic models of discrimination also indicate that there are costs associated with discrimination such as training costs to replace terminated employees, undermined employee

morale, and decreased labor supply

Once, biased attitudes against African Americans, Jews, women, and other minorities reigned in the country unchecked and discrimination against these groups was widespread. Many people, including many legislators, privately voiced their support of efforts to end discrimination, but found reason to avoid standing publicly with those being discriminated against. Looking back now, the public inaction served to prolong deeply rooted discriminatory practices that are now widely condemned.

NEWS FROM THE NEBRASKA AIDS PROJECT

Effective January 1, 1993, the Centers for Disease Control announced several new classifications for the diagnosis of AIDS. Under the revised definition, recurrent pneumonia, invasive cervical cancer, pulmonary tuberculosis, and a CD4 count of 200 or below are considered to be clinical manifestations of full-blown AIDS. Due to this revision, the Nebraska State Health Department reported 22 new cases. Since 1983, the total number of reported cases is now 333. We are, therefore, expecting a great increase in our Nebraska monthly statistics as this definition greatly encompasses the present members of the HIV community

Shortly after the Holiday season, the Nebraska AIDS Project began the Partner in Prevention and Caring Membership Drive. Contributors are categorized in the amount of their donation. (\$1000.00 - Visionary, \$500 - Patron, \$100-Benefactor, \$35-Supporter, \$15-Friend). The over \$7000 received through this solicitation goes directly to NAP's general operation fund and will be needed for the 1993 budget. Thank you to all those who contributed to the support of NAP and its services.

Chris Connell, a continuing supporter of the Nebraska AIDS Project recently provided monies donated at an art exhibit at the Garden of the Zodiac. NAP thanks Chris for donating his talent for a very good cause

Also during January, the Nebraska AIDS Project trained 28 new volunteers.

participants went through a HIV Basic Training Course, upon which general information regarding disease progression, transmission, prevention, and safer sex information is given. These volunteers may now take additional training for the Hotline, Practical Support, or the Buddy Program. New volunteers are greatly appreciated as the number of HIV+ persons and those diagnosed with AIDS continues to increase. Thank you to those who have given their time to the AIDS project.

For those of you who recently read articles in newspapers or who saw the outcome of the National Research Council's report on the AIDS Epidemic on television newscasts, the NAP staff wants to provide the public with an address to write individual responses and /or comments. The report stated that the Council sees little threat from AIDS, concluding, "AIDS will disappear, not because, like smallpox, it has been eliminated. but because those who continue to be affected by it are socially invisible, beyond sight and attention of the majority population." 

HIV SCREENING AT THE PANIC

The Lincoln-Lancaster County Health Department offers a walk-in HIV screening clinic the second Tuesday of each month at Panic. The clinic which has been in operation for over a year has been very successful and provides an opportunity for many individuals to be screened whom might otherwise be reluctant to seek testing.

The clinic provides free and anonymous HIV counseling and testing with follow up for test results at the Health Department. The Panic provides an environment which seems to encourage a relaxed and positive attitude towards testing by participants, many of whom are from outside the community. Tim Timmons of the Lincoln-Lancaster County Health Department says the success of the clinic has been tremendous and that the walk-in clinic will continue. In addition to HIV testing the Health Department distributes pamphlets concerning STD's and provides free condoms available at Panic. The State Health Department has put together Q& A Regarding HIV Antibody Test Reporting which Mr. Timmons said is informative and available by calling the State Health Department.

Free and anonymous HIV testing is performed at the Panic, 200 South 18th, Lincoln on the second Tuesday of each month. The walk-in clinic hours are 5pm - 7pm.

The video showed the ruckus in Oregon over Amendment 9, which, Thank God, failed. One of the buttons worn by a demonstrator really made a point, "I'd rather be Queer than be an asshole." The coalition that formed to defeat this measure really saw some strange bedfellows.

There was also a good segment on Marvin Liebman and aging Gays and Lesbians. Some of gays and lesbians face, in the military and in civilian life, I can relate to. Gay bars were definitely off limits when I was in the service. The CID frequently checked these bars and if any personnel were in these bars, the Shore Patrol was called and the person checked out. Many learned the hard way not to wear spit shined low cut shoes as this was a dead giveaway. Here in Omaha when the police frequently checked out the Diamond and, across the street, the Cave under the Hill, same gender people couldn't hold each other — they had to stand apart and dance.

Another segment featured a lesbian conedienne, Lynda Montgomery, who was really, really funny. Ms. Montgomery, who is a vegetarian, told about coming out to her mother, whose response was "My God, Lynda! First a vegetarian and now a Lesbian? Girl, you're not

getting any protein!"

The video also touched on gay and lesbian marriages. Various couples commented on how their marriages are not "sanctioned" and the trouble with sharing with spouses what the "straights" take for granted, such as insurance, survivors' benefits, taxes, etc. These perks, available to straights, are not available for most gay and tesbian couples.

The video ran for 2.1/2 hours but, like all good videos, the time slips by and no one notices.
