Our prisoner project is two years old. It was time to send annual letters for the purpose of seeing that the prisoner was receiving The New Voice of Nebraska and to determine if the person was still incarcerated. Ten prisoners have received the magazine on a monthly basis. The intention of the project was to link the prisoner with the lesbian gay community and ease the loneliness of

As I began to receive letters back from those incarcerated, it occurred to me that I would like to share some of the responses from those who receive the magazine. To ensure confidentiality, I will take some statements and not reveal the

name of the person responding.

"I appreciate your policy of sending your magazine to incarcerated people free. It shows a very caring attitude, not to mention understanding." "I have been receiving your publication monthly. I do feel closer to the gay "I have been receiving your lesbian community because of your magazine. I really appreciate your helping prisoners." "I have been receiving The New Voice every month with much pleasure. I want to thank you at The New Voice for helping me stay in contact with the gay community while in prison." "Thanks for the love and support you have shown to me and the

rest of us who are behind these walls."

As Dick Brown, Terry Sweeney and I read these responses, it was evident to me that we believe that this is one of the most valuable services we offer. Each of us smiled and said "isn't that great" as we read the responses.

Recently a prisoner wrote a letter to the editor

requesting the magazine, but failed to include his prisoner number. Please write again and include your prisoner number so that we can add you to our mailing list. The prison will not deliver mail without this information.

If you are incarcerated and would like to receive a free copy of the magazine, please write to Prisoner Project, Box 3512, Omaha, NE 68103.

Finally I want to say thanks to Lee Donehower for his persistence in making this project a reality. He never gave up and always had a concern about those who were in a position of not being able to interact with the community. So Lee, two years later and we are still sending magazines and hopefully meeting your expectations that we would entertain and inform those who could not get a magazine without this project in place. While Lee is no longer a member of the Steering Committee, he makes himself available to teach, encourage, or scan logos for the magazine.

I also, wrote grants, produced programs such as 'Being Gay in the Residence Halls.", the largest mass media event in Nebraskan gay/lesbian history, UNL Condom Day on February 2, 1987. In addition, I founded the Gay and Lesbian Alumni'ae Association, Inc., the UNL Gay Men's Support Group and pushed for AIDS policy at UNL including education.

I could list hundreds of activities that I used to catalyze the gay/lesbian community in Nebraska. An interesting fact, I won the Sue Tidball Award for Creative Humanity in April of 1986 for my work at UNL.

Abortion is an example. Why did the gay community brain-wash everyone to be "prochoice" when it is very obvious this is detrimental to the gay rights movement? I didn't choose to be gay but letters in the World-Herald constantly attack homosexuality as an "immoral choice." It is bad enough that human affection is considered "immoral." People keep saying homosexuals can "change" that they "chose" this "lifestyle." When a homosexual says their "pro-choice" this only

makes the situation worse.

I try to explain homosexuals don't "choose" to be homosexuals. We are people who don't understand who Romeo loved Juliet and why Juliet loved Romeo. Bisexuals do by homosexuals don't. Juliet and Romeo aren't related so it is a bit confusing as to what sense a homosexual is to make of it without jumping into political theory. When I was 15, my friends were into getting Hustler and Penthouse magazines. After my initial curiosity was fed, I felt I saw one naked woman I had seen them all. So when my friends had amassed over 20 magazines, I thought they were a bit crazed so I dumped the magazines in a dumpster. The system works for him, but is pushes me out on to a plank and into an ocean to fend for myself.

Suicide seems easier than breaking out into the fag community, especially when there is not much of a support network. What sort of movement is to that relies on therapists to help people out of the closet? This is really stupid here isn't going to be must of a gay community in Nebraska unless there is much more visibility of the lesbian and gay community and support

I know I can't be the only isolated homosexual in Omaha who feels this way about the fag culture, so if you feel the way I do, please call me so this isolation can be done away with. And as for the rest of the gay community, try harder.

COLORADO BUSINESSES PREPARING DEFENSE

Boycott Threat Over Gay Law Stirs Action

Rebecca Vories was appalled when Colorado voters unexpectedly approved Amendment 2, the measure banning local laws that protect homosexuals from discrimination. But she didn't figure on the vote affecting her directly.

She figured wrong.

Before the November election, Ms. Vories was asked to join a team working on a project for Los Angeles Department of Water & Power. Her firm, Infinite Energy, provides marketing and promotions for energy-efficient products and environmental programs.

After the election, Ms. Vories was notified that she was being excluded from the project. "The feedback! got was that DWP didn't want me involved because I'm from Colorado," Ms. Vories said. For a small, niche business, she added "every contract counts. This hurts a lot."

Ms. Vories in not alone, even though enforcement of the law has been stalled by a state court injunction. While the wrath of organized boycotters and individual protesters was vented immediately on Colorado's convention and tourism industries, other businesses increasingly are feeling their sting.

New York gay activists have announced a harassment campaign against a Boulder magazine subscription clearinghouse and a "tea party" to dump Celestial Seasonings teas into the East River. Mo Siegel, founder and chief executive of the herbal tea maker, has said that an effective New York boycott could severely injure the Boulder-based company.

In dollars, the economic impact of the passage of Amendment 2 is insignificant so far. Boycott Colorado — the organization urging the nation to ostracize the state and its businesses until Amendment 2 is repealed or overturned — says the verified economic damage to date is \$25 million. That sum is not even a gnat on the hide of a \$75 billion state economy.

Even so, any loss of business is source of dismay for a state that was largely left out of the boom of the 1980s and that, until November's election, was being touted as one of the nation's highest economic lights.

"It's definitely been a setback to what was remarkable process," said John Huggins, director of Mayor Wellington Webb's Denver Economic Development Office. Executives are painfully aware that today's ripple may be tomorrow's tidal wave. How many conventions now in the planning will go elsewhere? How many performers simply will not find time for a Colorado appearance?

A poll of its members by the Greater Denver Chamber of Commerce, the largest business organization in Colorado, found that one-third of the respondents, believe that their own companies will experience a direct negative impact from the passage of Amendment 2. Two-thirds believe that the state's economy and image will suffer.

Business leaders say the fires of protest have been banked, somewhat, by the January 15 Denver District Court injunction, which postponed implementation of Amendment 2 until the Colorado Supreme Court determines its constitutionality. But nobody anticipates a return to normalcy until the amendment is thrown out.

In the meantime, the initiative's surprise pasage — pollsters had predicted that it would fall—has plunged the business community into a sort of regional crash course in political activism and damage control. Individually and collectively, formally and informally, companies are hammering out strategies to combat what they say is a grossly distorted image of Colorado as the "hate state" and to minimize the economic fallout that image is spawning.

Dozens of Denver-area business and community groups have combined forces to form the Colorado Alliance for Restoring Equality, or CARE, a non-profit coalition committed to overturning Amendment 2. Among other actions, the group is planning to hold town meetings on the issue statewide.

Companies that don't have nondiscrimination policies covering sexual orientation are adopting them, and companies that did are letting their position be known.

Ski areas; those snowy magnets for out-ofstate winter visitors, have undertaken an array of measures—from passing out fact sheets in Vail's shops and hotels to posting nondiscrimination messages at the base of Aspen, Snowmass and Butternitk Mountains.

A handful of organizations have taken out advertising to communicate their message to selected markets. The town of Aspen and Aspen Sking Co., the Denver Metropolitan Convention

and Visitors Bureau and the Denver Center for the Performing Arts all have advertised their messages to key audiences.

One of the region's largest public relations firms has donated services to public and private organizations in need of strategic direction.

A computer software company has provided \$1 million in seed money to establish a foundation that will underwrite projects to educate people about cultural diversity.

Despite the black eye that business leaders believe Amendment 2 has given Colorado—and the resultant corporate agonizing—a number of community leaders contend that the measure is a silver-laced storm cloud.

"Good things always come out of bad things," added Barbara Grogan, president of Western Industrial Contractors, a major construction firm and chairperson of the Greater Denver Chamber of Commerce. "This is bringing people together in the community that have never sat down at the same table together."

FAMILY OF PRIDE CAN LEND SUPPORT WITH FAMILY

In 1993 the national theme for the gay community is "A Family of Pride. community has much to be proud about. We're a diverse community which includes gays, lesbians, and bisexuals, not to mention representation from every race, creed, religion, age, profession, culture, size, shape and so on.

Traditionally, membership in this proud 'family" requires only that one announce his her

gay orientation, commonly referred to as coming out. Anyone who has completed this process can attest to the trauma associated with this revelation. What about the trauma experienced by loved ones from our families-of-origin who sometimes react with shock, anger, and denial - symptoms of the abrupt onset of grief and loss?

At this stage our families are thrust into dealing with a perceptional loss. They feel that

the person they knew (or thought they knew) us to be has somehow changed. Reality is no different than it has ever been. We're the same persons we were before. Only their perception of who they believed us to be has been altered.

As with all grief, though, given time, patience, understanding and support, our families are often able to come to acceptance. I believe much of the acceptance our families realize relies heavily (though not entirely) on the level of acceptance we exhibit ourselves. In other words, they take their cue from us. And, as is often the result of the painful experiences in life, this crisis can become an opportunity for growth and an increase in

If our families look to us for guidance and support, where do we secure support for ourselves? I suggest we do this through trusted friends, professional counselors, or support groups Having a separate source of personal support provides us the necessary energy to deal with the reaction of different family members without depriving us of our strength.

We must also remember that, depending upon how "out" we choose to be, our families are required to come out vicariously. For example, by my choosing to be open about my sexual orientation on television and in print media, my family often encounters questions from their acquaintances who happen to see a broadcast or read an article somewhere. Sometimes we are so emerged in the emotional upheaval of coming out ourselves that we forget our loved ones are dealing with their own issues simultaneously

Some family members will require special attention during this process. Where children (yes, children) of the les-bi-gay person are involved, age-appropriate information must be shared and updated continually. My son experienced a crisis of his own after appeared on Channel 7 news recently. One of his schoolmates approached him to ask, "Is your dad gay?" My son was caught off-guard and denied the inquiry I believe that eventually he will benefit greatly by wrestling with this dilemma in his childhood, but it does not negate the pain he is having to endure in the present

The only antidote for him, and for the millions of children of other previously-married gays, is for we, as parents, to provide the love, support, information, and nurturing these children require. PFLAG - Parents and Friends of Lesbians and Gays - is also a resource

These issues notwithstanding, it is my opinion that the greatest gift we can give to our loved ones is an affirmed, happy self who, because of our willingness to share our true inner selves, becomes empowered to develop an honest bond rather than perpetuating a false image or facade

In this way the foundation for building a "family of pride" truly does exist.

If we are ever to achieve serenity and acceptance, either individually or collectively, each of us has to be willing to take this difficult

However, if we carry with us some of the pride our "gay family" has for us, the journey through this process will be much less stormy In this way we can lean on one "family of

pride" while nurturing and building another.

This country has extended equal rights to women, blacks, Hispanics, all walks and races, all religions, and all people, yet somehow I have been left out. Why is this? Why is it that I can be denied certain "public" entities that my tax dollars are going to pay for, when my "straight" neighbor can use them? Why is it that I can't legally get married to a man but I can marry a woman? And why is it that the great Constitution of this country works for you and not for me? I feel I deserve an answer to these questions. Don't I?

I would ask you that you would live up to

I ask you this not because there is political pressure to do so, or because Canada and many other countries have already taken action, but I ask you because it is fair and just and because the Constitution was created with rights. You can't change the minds of millions of bigots in this country, but at least you can create equality under the laws of our nation. And I would pray you would do so for the sake of humanity.

SENATOR EXON RESPONDS

Earlier this year, I sent postcards to Senators Kerrey and Exon asking them to support gays and lesbians in the Military. This is the response I received from Senator Exon. As you can see, he does not clearly support lifting the ban. He wants or 'listen and speak to Nebraskans. Let Senator Exon know how YOU feel about gay men and lesbians in the armed forces. Senator Kerrey's response is on page 10.

Dear Sharon:
I appreciate having benefit of your thoughts regarding homosexuals serving in our armed forces. This is a very important and emotional issue which has fostered intense discussion and

hard feeling all over our country.

President Clinton, during the recent campaign, stated his intention to lift the current ban on homosexuals in the military; however, it did not receive much attention. Shortly after the election, the issue erupted into a full-scale confrontation. I believe the President made a mistake in pushing for this type of change before we tackled the most important national problems such as the economy, deficit and health care. Also, as a senior member of the Senate Armed Services Committee and a World War II veteran, I would not have proposed such a change. However, as Commander in-Chief, the President has the authority to lift the ban on homosexuals although Congress has a role to play with regard to its own Constitutional authority and responsibility for our armed forces. I feel the President should have acted with more deliberation and consultation with the men and women in the services and the Congress

I met with the President on this issue and played a key role in crafting a compromise which forced the President to slow down. Under the interim compromise plan announced on January 29th, a draft Executive Order to lift the current ban will not be proposed until July 15th. This agreement is temporary only and automatically expires in six months. The Senate voted in early February to upbold this compromise plan. Under this interim agreement, between now and July

15th, extensive Congressional hearings and consultations will be held involving all sides. During this interim period, the services will stop asking recruits about their sexual orientation; cease conducting investigations of those already in the services hased solely on their status; and stop formally discharging service personnel based solely on their status. Service members who are identified as homosexuals based solely on their status will be subject to formal proceedings resulting in their transfer to the Standby Reserve and loss of all pay and benefits. Following the July 15th decision on whether or not to lift the ban, they will either be discharged or allowed to petition to re-enter the service.

I want to emphasize that the changes made for this interim period apply solely to service members' status only, not their conduct. Any homosexual conduct contrary to the long-standing military code will continue to be punishable as before. This is very important and a key to my agreement to this compromise. In addition, during this interim period, any commander can transfer a person, as they can now, if it is deemed in the

interest of the military.

Again, while I believe the President erred in his handling of this issue, I will keep an open mind on the end result. I cannot and will not decide on what, if any, changes are in order until we have held hearings and considered this matter in-depth and in an orderly fashion. It is entirely possible that we could go back to the status quo in July or come up with a workable compromise.

The first priority of the armed forces is the national security of the United States. The services are not designed and should not be used to be on the cutting edge of volatile social changes. The open flying of the gay banner in our military simply will not work. Congress has a special obligation to those in uniform of whom we ask so much.

On the other hand, we have always had homosexuals in the armed forces. Many of them have served with distinction. There are many questions to be answered on this subject and these are questions which have never been fully explored in depth. I believe that just because we have done something one way in the past does not necessarily mean we should be bound to never consider changes in the future.

I will use the period between now and July 15th to listen and speak to Nebraskans, play an active role in the Senate Armed Services Committee hearings and consult with those in and out of the military as we work through these difficult problems. There are no easy answers and I appreciate your views which are very helpful.

Thank you again for taking the time to let me know your thoughts.

SEN. KERREY RESPONDS

Dear Ms. Van Butsel:

Thank you for contacting me to express your views of lifting the ban in the military. I appreciate knowing of your interest in this matter.

As you know, President Clinton has stated his intention to remove the current ban on gays serving in the military. I support this proposal in principle, as I believe that those who wish to serve their country should not be prevented from doinG so on the basis of factors that do not affect their ability to perform the tasks required of them. I have reservations, however, about the ramifications of this policy change for our armed forces, and feel strongly that this initiative be implemented in a way that does not undermine the morale of our military personnel.
In early February, the Senate passed a

resolution designed to reflect a compromise worked out by Congressional leaders, the Joint Chiefs of Staff, and the President. Under terms of the agreement, which I supported, Congress will hold six months of hearings to explore this issue from all perspectives in an effort to anticipate and prepare for any problems that may arise. It is important that strict discipline and decorum be maintained within the military, and careful consideration be given to the concerns of our military leaders during these hearings. I believe that a strict code of conduct must be developed defining standards for appropriate and inappropriate behavior by all members of the armed forces, and that if properly adhered to, this will help to facilitate the transition and minimize the affect on our military readiness.

You can be sure that I will continue to follow up hearings closely, and that I will keep your views in mind.

Again thank you for writing. I look forward to hearing from you again about any matter of concern

"I'M IN ANOTHER WAR"

In the Korean War in 1951 I commanded a rifle company. We had a gay soldier with us in combat. Last November I wrote an article for The Washington Post and described the death of that young man

As a result of the article | received a call from the Human Rights Campaign Fund. The caller asked if I would be willing to come to Washington to lobby Congress on behalf of gays in the military. I was impressed by the "Human Rights" portion of his organization, but it turned out that it is the nation's largest gay rights political organization.

Well! That was a shock! Here I am: a retired Army Infantry Colonel, West Point graduate; father of 5 kids, 8 grandchildren and a greatgrandchild on the way, son of a World War II four star general; numerous friends both among my West Point classmates, other friends from my Army service, and my friends from my post-retirement civil life. What would all of them think?

The fact that have that question in my mind is the crux of both the military and national problem concerning gays. We think there's something "wrong" not only with being gay but also associating with them.

After much soul searching, or perhaps just searching my soul, I decided that I had to stand up and be counted. I couldn't deny my article. Nor could I deny my very strong faith in the words of my 5th great-grandfather penned some 217 years

ago: "We hold these truths to be self-evident, that all men are created equal

So for two days in the Senate and the House recently I became a 71 year-old retired soldier activist, not specifically for racial rights or gay rights or women's rights but for equal rights. And several times during the 2 days people asked me if I agreed with General Powell's asserting that "Skin color is benign, non behavioral characteristic Sexual orientation is perhaps the most profound of human behavioral characteristics." I certainly do not agree with him. Skin color was certainly not "benign" back in the 1948 to mid 50's period when we were integrating blacks into the military. General Powell could not now, nor then, understand or feel the emotions of some of the whites during those days. Some of them were every bit as emotional about that integration as some people are about this one, even more so. And I dare say a few still are! And I remind the General that we had a hell of a lot more trouble integrating the Officer's Clubs than we did the battlefield

strongly suspect that like so many others, the general considers homosexuality to be a moral issue: homosexuality is immoral. But is it any more immoral than slavery was? Is it any more immoral that segregation of and discrimination against blacks and women and gays has been and continues to be? And not letting women vote for the first 144 years of the 217 years we've been a

nation?

After my 2 day Washington adventure, I received a letter from my daughter-in-law, Debbie, who lives in Northern Virginia. She told me of being in the checkout line at the local grocery store and having a nice looking man she guessed to be about 50 ask her about a pin on her coat lapel. She had forgotten she had put one there and looked down to see that it was an Inaugural pin with President Clinton's picture on it. Aloud she read the words, "Let the Celebration Begin!", and the man started calling her names, "Queer" and "Lesbian" chief among them. Then he started including the President "Gay! Homo!" She was shocked and embarrassed and hurried out of the store. But before she left she paused to take a good look at this man who she described in her letter as looking "so normal, like he was a teacher or an accountant or even a retired military officer And suddenly I felt incredibly sad.

These were her closing words in the letter.

'Halfway back to the office it occurred to me that this gays-in-the-military thing isn't about gays at all. It's about hate, and its target could be anything. When you came to Washington this week, you didn't just do it for gays (or even the military). You also did it for Blacks and Jews and Asians and Women. Thanks.

Her "thanks" brought tears to my eyes, and I

hope she's wrong about the hate.

I sure hope she's wrong.

CHRISTIAN GROUP **OFFERS YOUTH** OUTREACH

The United Church Coalition for Lesbian/ Gay Concerns (UCCL/GC), a recognized group of the United Church of Christ, has created a new position serving the needs of bisexual, lesbian and gay youth, and youths questioning their sexuality. DIAL 911

The FBI released its first statistics on the indence of hate crimes since passage of the Hate Crime Statistics Act—the first federal law to include sexual orientation in a non-negative manner. In 1991 FBI statistics are shockingly low—noting, for example, only five total bias crimes in the state of California, while NGLTF documented 473 anti-gay incidents in San Francisco alone. The data collection system mandated under the federal law requires only voluntary compliance from local law enforcement agencies.

If your local police department does collect data on anti-gay violence, thank it for doing so. If your police does not do so, eacourage the departments to comply with the federal law and help stem the tide of rising anti-gay/lesbian violence. USOC HOSTS FEDERATION OF GAY GAMES

San Francisco, CA—The executive committee of the Federation of Gay Games visited the U.S. Olympic Committee's headquarters recently in an effort to open a dialogue between the two organizations.

The meetings were an informal exchange with several USOC staff members explaining to the group how the USOC operates in a number of areas including event operations, membership, marketing, and administration. The two groups also discussed such issues as HIV in sports and sexual orientation sensitivity.

"The Federation of Gay Games approached

"The Federation of Gay Games approached us about opening up a line of communication, and we were happy to meet with them," said USOC Executive Director Harvey W Schiller. "It was an excellent informational exchange."

The Gay Games are held every four years and have been in existence since 1982 and is an athletic and cultural event that emphasizes "personal best" and "inclusion for all." Gay Games IV is scheduled for New York City in 1994 and is expected to attract 15,000 athletes from more than 50 countries. The Federation, which is the Gay Games umbrella organization, has no staff and is run completely by a volunteer board of directors from around the world.

"The meeting was very positive and productive," said Federation of Gay Games Co-Presidents Susan Kennedy and Rick Peterson. "We talked about everything from HIV in sports to event logistics. We feel this is the beginning of a long, beneficial relationship."

PARADISE RECOVERY CENTER OPENS

Paradise Recovery Center, a new facility for the treatment of gay, lesbian and bisexual alcohol and drug abusers, will open in Key West at 611 Truman Avenue, currently the home of a worldfamous health spa, the Russell House.

Only four other facilities in the country offer specialized treatment for specific gay and lesbian issues as they relate to chemical dependency.

Paradise Recovery Center, with 60 beds, will be the largest such facility, followed by Pride Institute, in Minnesota. Paradise will offer a greater range of services than all of the other centers. The intensive treatment for alcoholism, drug abuse and co-dependency will include special detox facilities and rehabilitation programs, all offered in a safe, non-clinical resort setting that includes a heated pool, whirtpool and sauna. This relaxed atmosphere will eliminate many of the fears that patients have when entering a hospital-like facility.

The choice of Key West as a location for the center is an important part of the treatment approach, because of the large gay population and the supportive nature of the entire community. The most effective way to treat gay and lesbian patients is in a safe gay environment.

Since treatment centers evolved about 25 years ago, men and women who are gay often found themselves in an environment that, however well intended, was ill-equipped to devote needed time and support to historic gay issues such as ostracism, fear, phobias and shame by a dysfunctional society.

Alcoholic detoxification should always be handled in a properly equipped and staffed medical facility, such as Paradise. After detoxification, the primary concentration will be on intensive courseling, along with education about the disease concept of alcoholism and drug abuse.

Part of the treatment will include dealing with sexual issues and addiction, AIDS awareness, and issues relating to adult children of alcoholics. Paradise's treatment will rely heavily on 12-step programs like Alcoholics Anonymous and Narcotics Anonymous for continuing support, once patients leave the center. Daily AA or NA meetings in the community will be an important part of the treatment.

Complementing the treatment of drugs and alcohol, Paradise will offer the first inpatient co-dependency treatment program for gays and lesbians in the country. A co-dependent is one who is only able to fulfill his her own needs by dependence on others, thus feeding a feeling of low self-esteem that often results in self-defeating behaviors. Treatment for this condition consists of intensive counseling to determine the root cause of the problem and to help the patient to overcome it.

Paradise also operates a crisis, information and referral service which is available to the public at no charge. The toll-free number is 1-800-285-7853. Those in need of help can call 24 hours a day and speak with the center's medical, counseling or administrative staff.

RESEARCH GROWS AT MED CENTERS

The HIV clinic at the University of Nebraska medical Center is trying to expand its research activities for people with HIV infection and AIDS. This will mean more people can have access locally to promising new treatments.

Dr. Sue Swindells, medical director of the HIV clinic, has been given permission from the National Institutes of Health to participate in national protocols, but without any funding as yet. Money is needed for medications, clinic visits and salary support for coordinators. The hospital has agreed to underwrite the costs of tests and X-rays.

JSAT SPONSORS WORKSHOP

February 20, JSAT (Joint Strategy and Action Team) sponsored a workshop "Good News in the Church?" dealing with issues of Faith and Sexual

The workshop, which addressed scriptural issues often used to bash gay and lesbian people, was for all people, laity and clergy, of all sexual orientations, to share in both the good and bad in the Church, to offer lesbian and gay persons and their families resources, support, and encouragement over this most difficult and divisive issue.

Ruth Kruse of PFLAG gave the introduction to a packed audience. I saw many from Omaha in attendance and also from Lincoln, Sioux City, and other communities. Tables were setup offering resources from PFLAG, New Realities, and

Opening the workshop with ahymn, Morning Has Broken, Mrs. Kathy England of PFLAG introduced the keynote speaker, Rev. Matthew Howard from the Universal Fellowship of Metropolitan Community Churches, who gave his now well known presentation "Homosexuality and the Scriptures." I have attended these presentations several times before and each time the presentation seems like a fresh presentation. Many times a person just "parrots" the presentations given before. Not so with Rev. Howard. It is obvious he continues to study, research, and improve upon each presentation. Each time Rev. Howard appears to be more sure of himself and what he is saying. During the questions at the end of the presentation, Rev. Howard holds his own against other clergy who may not be "friendly" to gay and lesbian issues. This workshop, though, seemed upbeat with no hostility-just a need to learn and to understand.

One point, well made, was that a majority of people out in the pews read and interpret the Bible, over all, the same as the fundamentalists read and interpret the Bible. All in all, it was a good morning session, with good material and a good discourse of ideas and opinions.

After the noon break for lunch, a panel of six people discussed pertinent issues within the church. The moderator was from the United Methodist Church and panelists included one from the Presbyterian Church who is heavily involved in PLGC; one with the United Methodist Church in outstate Nebraska; an Episcopalian who has counseled gay and lesbian people; a cradle Catholic who is now exploring the MCC faith; and a former Lutheran Pastor now working spread and viewpoints from the early 20's to over 50.

A wide range of subjects were covered from negativism in the churches, to more understanding and open mindedness in the church. It was

brought out that when asked why they are so against gay and lesbian people, most people don't know why—they just are. Polarization of mainline denominations, fear, and people's natural resistance to change were all discussed. Following the afternoon break, people

gathered in groups to further discuss issues. My group was most interesting. Five people, most diverse. A Presbyterian, a Methodist minister from a small town, a Methodist Lay Leader, a Gay Lutheran, and a Gay Multi-faceted Christian. How's that for a mix! But we did have a good discussion.

The workshop closed with singing Ubi Cari

Tos and with a silent prayer.

It was a good positive workshop and a good turnout in spite of poor weather. Let's hope there will be more of these workshops. We, all of God's Children, no matter our differences, need to work more together, pray more together, the understand each other more. But be assured the gay and lesbian issue won't go away. It is here to stay. We will not go back into the closet. We, too, are also God's Children.

BISHOP JESSON VISITS LUTHERANS CONCERNED

A very interesting Lutherans Concerned meeting was held. Bishop Richard Jesson of the Nebraska Synod E.L.C.A. was invited to attend. And attend he did.

Bishop Jesson told the group he did not come with a prepared agenda — he was there to listen and to learn. He also pointed out gently that he has to minister to both sides of the aisle.

This meeting was well attended with many from outstate and four pastors as well. One pastor told of attending seminary which was their first real exposure to gay and lesbian people. This person found it say to see so many who were gay and lesbian, who were so talented, so caring, so loving, yet dropped out of seminary so they wouldn't have to lie about who they were while so many straight people who were mediocre went on through

One person bore witness to how they were in the Lutheran Church, Missouri Synod, and how their pastor would tell them that they would burn in hell if they didn't stop being homosexual and change their ways (as if they could, just like flicking a light switch.) This person had switched to E.L.C.A. and after attending a Lutheran church in this group found the difference like night and day. In the E.C.L.A. church they were warmly welcomed by the pastor just as they are, with no condemnation. They recounted how this restored their faith in God and made their faith stronger.

Other good points raised and discussed were "Is Homosexuality an ethical issue, or is it a theological issue?" A point well taken was that the gay and lesbian community needs moral guidance from the Church, but how can the Church give gays and lesbians moral guidance unless the Church accepts gays and lesbians.

Also discussed was the issue that, all in all, gays and lesbians are welcomed in the E.L.C.A But the big issue, and a most divisive one, is the ordination of gay and lesbian people.

Discussed was the "Study on Sexuality within the E.L.C.A." which covered three main issues. Sexual Infidelity, Homosexuality, and Gender Abuse It was pointed out that the Bishops responded negatively to the document. They stated the document needed to be of higher quality and that there was a definite need for more talk and study.

Discussed was "Are gay and lesbian people asking for 'Special Rights?" "I've heard this many times before. What "Special Rights?" Is it a "Special Right!" to be treated like a fellow human being, instead of something sub-human, akin to how women were treated and are still treated in many patriarchal societies, of which the Judeo Christian heritage is a part. Is it a "Special Right" to just be accepted as who we are? To be accepted by God, created by God? Is it a "Special Right" to be guaranteed what the straight world takes so for granted; that of "Life, Liberty, and the Pursuit of Happiness?" Call these "Special Rights?" Bovine Feces!!

This was a good evening-a real good evening. It was encouraging to see someone "high up" in the church accept an invitation and attend to just "listen and learn." This is a good



OPINIONS FEATURED IN NEW YORK TIMES ARTICLE by Arry Marie Meek

The March 5th Issue of the New York Times featured the results of a nationwide poll conducted by the Times in February. The poll sampled 1154 adults and found wide variations based on age, sex, education, geography, and religion. Women were more supportive of gay civil rights than men, as were people under the age of 45 and those with higher levels of education. Southerners, Midwesterners, rural residents and those who said religion was extremely important in their lives were all more opposed to "gay rights." As part of the follow-up to this poll, Times reporter, Jeffrey Schmalz, came to Omaha to determine "Middle America's Response."

I was sitting at home on a Friday afternoon. I never could have predicted receiving a phone call from the New York Times. Jeff Schmalz, a feature writer for the Times, was looking for a nice cross-section American town to find good old average homosexuals. CBS and the times had recently conducted a poll on America's views of Gays and Lesbians in Society. They wanted to come to Mid-America and find out how we thought being gay or lesbian affected our lives and the way

we're received by others.

Jeff requested to meet with a panel of gays and lesbians from diverse backgrounds. So, the urgent phone calls began and we all managed to meet at the Neon Goose one Sunday. Reporters are often interviewing our community, but this interview was different. He asked all of his questions from the personal perspective as he was some reporters do. He wanted to know about own day-to-day lifestyle as gays and lesbians living in a discriminatory society. After a lovely brunch, he and an Associated Press Photographer hit the streets of Omaha to get "The Other Side" of the story. Jeff found the Midwest to be surposingly tolerant of our lifestyle with a "live and let live" theory from most.

Recently 1 received a call from the photocition of *The New Yorker* who also donates his time to *Oua*. Omaha is now one of 25 cities to be featured in a 20 page photo spread in *Out* for the Gay Pride Celebration. It will be a day in the life of Gay America
