## American Idol Finalist 'Doesn't Agree' With the Gay 'Lifestyle'

American Idol finalist La'Porsha Ranae doesn't thing gay people are "animals," but she still doesn't agree with their "lifestyle" or "life choices."

McComb, Miss., native Ranae, the runner-up on the last season of the recentlyconcluded Idol series, was asked about her state's new anti-LGBT bill on a conference call with the press, Jez-



ebel reports. Her response raised many evebrows:

"This is how I feel about the LGBT community: They are people just like us. They're not animals as someone stated before. They're people with feelings. Although all of us may not agree with that particular lifestyle for religious reasons, whatever the reason is, you still treat each other with respect. Everybody is a human being. We should be able to coexist with one another."

Her follow-up statement didn't help matters:

"I am one of the people who don't really agree with that lifestyle. I wasn't brought up that way. It wasn't how I was raised. But I do have a lot of friends and a lot of people that I love dearly who are gay and homosexual and they're such sweet, nice people. We should just respect each other's differences and opinions and move on."

Then a tweet from Ranae demonstrated how sold she is on the concept of people choosing to be gay or bisexual.

We don't have to agree with each other's life choices to love/ respect one another. Live and let live. #RENAETION #RespectThatWeAreDifferent

Idol has dealt with numerous LGBT controversies over its 15year run, including similar antigay declarations by finalist Mandisa a decade ago.

### Kansas May Block Trans People From Updating Birth Certificates

Sam Brownback, the Republican Kansas governor, is currently pursuing a policy change that would create more bureaucratic barriers for transgender people to legally change the gender on their birth certificate.

As the law stands now, anyone in Kansas can change the gender on their birth certificate by "providing a medical certificate substantiating that



a physiological or anatomical change occurred or by signing an affidavit saying that the gender was incorrectly recorded," reports The Wichita Eagle.

Brownback proposes to allow a person to change the gender on their birth certificate only if they sign an affidavit saying the gender was wrongly recorded at birth and provide medical records to prove it. This would effectively prevent trans people from making post-transition alterations to their birth certificate.

The proposed new policy was developed by the Kansas Department of Health and Environment and would require no new legislation to enact.

LGBT rights advocates roundly criticized the proposal. "This has been standing in Kansas for a very long time that transgender people are able to get their birth certificates corrected," Tom Witt, the executive director of Equality Kansas, told the Eagle.

"Now they're changing the rules because there are transgender people who are still trying to get their birth certificates corrected ... and Brownback's people don't want that to happen," he added.

If the agency was to allow someone to change their birth certificate, the state would be required to maintain a copy of the original certificate, along with the new one, which would be






marked as "amended." The secretary of state's office would have the power to approve whether an affidavit, along with other evidence, is enough to allow a gender change on the birth certificate.

The proposal comes only a month after Kansas lawmakers proposed a "bathroom bill" that targeted trans students in the state. The bill would allow students to sue their school if they witness a trans schoolmate going into a bathroom that didn't match the gender they were assigned at birth.

In February, Stephanie Mott, a transgender woman, sued the state after it refused to allow her to change the gender on her birth certificate. The proposed changes to the state's current policy on birth certificate alterations came in January, the same month that Mott 's request was denied.

A public hearing on the birth certificate proposal is scheduled for 9 a.m. May 12 in the Curtis State Office Building in Topeka.

## Xena to Be Openly Gay in Reboot

Showrunner hints at 'exploring' the Sapphic sisterhood between Xena and Gabrielle.

Another beloved '90s relic is being brought yelling and cartwheeling back to life with NBC producing a reboot of cult classic Xena: Warrior Princes. Javier Grillo-Marxuach, a writer and producer behind The CW's The 100, is penning and coexecutive producing the pilot he's hinted that Xena is going to drag all the gay subtext of the original series out of the closet.

Grillo-Marxuach responded to a question on his Tumblr about whether fan reaction to the death of a gay character on The 100 would influence his work on Xena:

"I am a very different person with a very different world view than my employer on the 100 - and my work on the 100 was to use my skills to bring that vision to life."

Xena will be a very different show made for very different reasons. there is no reason to bring back Xena if it is not there for the purpose of fully exploring a relationship that could only be shown sub textually in first-run syndication in the 1990s. it will also express my view of the world - which is only further informed by what is happening right now - and is not too difficult to know what that is if you do some digging.

Maybe because hindsight is 20/20, but watching Xena as a kid, I always thought that it was pretty clear that Xena (Lucy Lawless) and Gabrielle (Renee O'Connor) were more than just friends. Especially after Gaby was serving Ellen DeGeneres hair tease in the later seasons.

And Lawless certainly agreed. In a 2003 interview, she confirmed the love that dare not speak its name:

"There was always a 'Well, she might be or she might not be' but when there was that drip of water passing between their lips in the very final scene, that cemented it for me," she said. "Now it wasn't just that Xena was bisexual and kinda liked her gal pal and they kind of fooled around sometimes, it was 'Nope, they're married, man'."

Yup, sounds about right. But it's been 15 years since Xena last hurled a Charkam at someone's face and in that time Xena and Gabrielle have finally earned the right to marry.

## Researchers Have Successfully Figured Out How To Edit HIV Out Of T Cells

#### This is huge.

Researchers at Temple University in Philadelphia say they have found a safe way to eliminate the HIV-1 virus from CD4+ T cells through a gene editing system.

"The findings are important on multiple levels," Kamel Khalili, professor and chair of the Department of Neuroscience at Temple, says in a statement. "They demonstrate the effectiveness of our gene editing system in eliminating HIV from the DNA of CD4+ T-cells and, by introducing mutations into the viral genome, permanently inactivate viral replication."

"Further," Khalili continued, "they show that the system can protect cells from reinfections and that the technology is safe for the cells, with no toxic effects."



The findings were published in Scientific Reports earlier this week and mark the first time researchers at Temple have actually been able to remove HIV from an infected T cell, opening the door for even more in-depth research.

"The questions they address are critical, and the results allow us to move ahead with this technology," Khalili said.

In a press release, Dr. Thomas Malcolm, CEO and President of Excision Biotherapeutics, which holds the exclusive rights to commercialize the gene editing technology, said: "This is a major advance in safety and efficacy for the use of CRIPSR/ Cas9 gRNA HIV eradication for us in humans. These exciting results also reflect our ability to select viral gene targets for safe eradication of any viral genome in our current pipeline of gene editing therapeutics."

Gene editing has long been thought of as a potential cure for HIV, but scientists have feared that if not done properly, the side effects could be disastrous, even fatal. Researchers at Temple believe they have overcome this hurdle, but they are careful to note that challenges remain.

"First, it will be important to maximize elimination of viral sequences from patients," the authors state. "This will require analysis of the HIV-1 quasi-species harbored by patients' CD4+ T-cells and design of suitable, i.e. personalized CRIS-PRs. Second, improved delivery of CRISPR/Cas9 will be required to target the majority of circulating T-cells."

## Discrimination Is Alive In Texas Where Baker Refuses To Make Wedding Cake For Gay Couple

A Longview, Texas baker is in the news for refusing to make a wedding cake for a gay couple. Edie DeLorme, co-owner of Kern's Bakery, will face no repercussions for denying services to the men; discriminating against LGBT people is legal in Texas.

According to the Longview News-Journal, Ben Valencia and Luis Marmolejo plan to marry

on March 27 and went to the bakery seeking a quote for their wedding cake. But when the two showed Delorme a photo of the cake they wanted, she asked them who the cake was for.

"We just went in there to get a quote," Valencia said. "Then she says, 'Who's this for?' We looked at each other."

DeLorme doesn't deny refusing to serve the gay couple. In fact, she's trying like mad to find an excuse for her bigoted behavior – and she's hiding behind her religion to do it.

"And when they said it was them, I said, 'Sorry. We don't provide cakes for homosexual marriages. It's not against people or what they choose to be part of," she told the News-Journal.

"We don't do alcohol-related cakes or risque (ones). We've turned down cake for, like, 'Can you make a giant Skoal can?' ... It's not that we single out one (reason)."

When questioned how the shop responds to other requests that would violate the Bible's laws on marriage, DeLorme hedged. In the Bible, Jesus says that second marriages are adultery if the first marriage ended for any reason other than a cheating spouse. Asked about divorced people who want to remarry, she admits that they fulfill the requests.

"We've talked about that," she said. "We would really have to do a lot of prying to find out. That's something David and I would have to talk about, whether that would be something that we should participate in or not."

Valencia, for his part, is trying to keep a positive attitude despite the baker's bigotry.

"I wasn't really mad," he said. "I was more like saddened by it, because that is the first time anything like that has happened to me."

Following the Supreme Court ruling that legalized same-sex marriage nationwide, "I was excited for people to be able to love whom they want to, to be with for the rest of their lives," Marmolejo told the newspaper. "I don't see how making a cake for somebody is going to compromise your beliefs. I know that there aren't laws that protect discrimination against people's sexual orientation. I think some employers have that in their employee handbook, but I don't think it's a law."

While Texas has already passed a law to allow clergy to refuse to participate in a same-sex wedding, even though that right is already federal law. The day the couple were turned away at the bakery, the legislature was discussing ways to expand that right to business owners who also want to discriminate against LGBT people.

## North Carolina Governor Alters Discriminatory Law — Barely

In reaction to the backlash against its new anti-LGBT law, North Carolina Gov. Pat McCrory has signed an executive order that makes modest changes.

McCrory's order, announced today, maintains the major portions of the law, known as House Bill 2, which prevents local governments from enacting or enforcing LGBT-inclusive employment nondiscrimination ordinances (affecting private businesses or contractors) and bars transgender people from using the restrooms, locker

or Carlotte and Ca

rooms, and other sex-segregated facilities comporting with their gender identity, if these facilities are located in government buildings, including public elementary and secondary schools and state colleges and universities.

The order does affirm that private businesses and nonprofit groups can establish their own policies for these facilities, something that was not affected by the law but has been the subject of some confusion.

McCrory's action also affirms that private businesses, nonprofits, and local governments can establish their own employment nondiscrimination policies — for their own workers. And it expands the state's employment nondiscrimination policy to include sexual orientation and gender identity that is, for state employees.

McCrory said he will also seek legislation allowing workers to sue in state court for discrimination, something that was explicitly barred by HB 2.

In a video (watch below) accompanying the announcement, McCrory decried "selective outrage" over the law and contended it had been misinterpreted. He also denounced what he called "overreach" by the Charlotte City Council in adopting an LGBT-inclusive public accommodations ordinance, which spurred the state legislature to pass HB 2 last month. He called the restroom provisions of HB 2 "common sense," and noted that it allows for special accommodations — that is, single-occupancy restrooms and locker rooms — in government buildings.

Many major corporations and celebrities have condemned the measure. Just today, Deutsche Bank announced it was canceling a planned expansion of its operations in Cary, which is near Raleigh, the state capital.

Activists said McCrory's order does not do nearly enough to mitigate the effects of HB 2.

"Gov. McCrory's actions today are a poor effort to save face after his sweeping attacks on the LGBT community, and they fall far short of correcting the damage done when he signed the harmful House Bill 2 into law which stigmatizes and mandates discrimination against gay and transgender people," said a statement issued by Sarah Preston, acting executive director of the American Civil Liberties Union of North Carolina. "With this executive order, LGBT individuals still lack legal protections from discrimination, and transgender people are still explicitly targeted by being forced to use the wrong restroom." She called on the state to repeal the law, which is the subject of a lawsuit filed by the national ACLU, the North Carolina affiliate, and Lambda Legal.

Equality North Carolina and the Human Rights Campaign also were less than impressed with McCrory's effort.

"While Governor McCrory's Executive Order creates vital protections in public employment on the basis of sexual orientation and gender identity, it does not address the deep concerns we share with members of the business community and citizens across the state about the damaging impact of HB 2," said Equality NC executive director Chris Sgro in a statement on the HRC website. "In fact, the order doubles down on the Governor's support for some of the most problematic provisions of HB 2,"

Added HRC legal director Sarah Warbelow: "The governor's (Continued on page 6)

action is an insufficient response to a terrible, misguided law that continues to harm LGBT people on a daily basis. It's absurd that he'll protect people from being fired but will prohibit them from using the employee restroom consistent with their gender identity. The North Carolina Legislature must act to right this wrong as swiftly as possible. They created this horrendous law, and they need to repeal it."





### Spreading Hate has Backfired on Right-Wing Media: How Fox News Unwittingly Destroyed the Republican Party

For years, Fox News has profited from its vicious, divisive rhetoric — and now a steep price is being paid.

The Republican Party is in a pickle.

The Party itself despises its own two leading presidential candidates, Donald Trump and Ted Cruz. This is a remarkable oddity just in itself. But there is good reason for it. Both of these candidates are so extreme and disastrous that they will almost certainly never be able to win a national election for the Republican Party.

But much worse, if and when one of these candidates does become the Republican Party's nominee, the GOP could very well be torn asunder into factions. This could devastate the party for years or even decades to come.

The Republicans, however, have no one to blame but themselves. This is a crisis of their own creation. And it didn't just happen overnight.

The Republican Party has been fomenting anger and discontent in the base of its own party for years. The mechanism through which this hate has been disseminated has been the network of extremist media of right-wing talk radio and the Fox News Channel, which is essentially talk radio transposed onto television.

Just think of all the right-wing "superstars" who spew messages of anger and hate every single day throughout the land over this enormous megaphone. Rush Limbaugh, Glenn Beck, Ann Coulter, Laura Ingraham, Ben Shapiro, Dana Loesch, Bill O'Reilly, Sean Hannity, to name a few.

And make no mistake, spewing hate has a significant impact upon society. It is the equivalent of modern-day propaganda where the population is barraged with a stream of consistent messaging. As ordinary people go about their daily lives, they are exposed repeatedly, day in and day out, to the same messages in numerous forms and by numerous people. Pretty soon, these messages begin to sink in and take effect. The audience begins to adopt a worldview consistent with these messages, regardless of the degree of truth. It is a remarkable phenomenon.

From Nazi Germany in the 1930s to Bosnia and Rwanda in the 1990s, history is replete with examples of propaganda's effectiveness as a tool for shaping public opinion. Propaganda is powerful stuff. Many people are susceptible to it and can be swayed by it, especially the less educated.

In America today, right-wing media is engaged in this very same activity through Fox News and extremist talk radio. This network is constantly barraging its audience with a stream of consistent messaging. And this messaging is overwhelmingly negative and destructive.

The messaging consists of common themes that recur in various forms. One central theme is a fierce opposition to government, especially so-called "big government." This reappears in various sub-forms as well, such as rage against bureaucracy, regulations, Washington, D.C., the IRS, the Environmental Protection Agency, and federal politicians.

Another big theme is fear and victimization. You had better watch out because government is gonna getcha! "They," whoever that may be, are about to take away your rights. Your freedom is about to disappear. Your religious liberties will be stripped away. You won't be able to make your own healthcare decisions. Free choice will be gone. Your children will suffer. Even though you are just an innocent person minding your own business, you are about to be victimized!

Another common theme is the fear of foreigners, or outsiders. We must protect our own in-group from the vague and mysterious threats posed by those who are a little bit different from us. The particular targeted group changes with the times, but the concept remains the same.

And, of course, someone from the Democratic Party, or some "liberal," is to blame for all of this wreckage. Demonizing a specific target is powerful. If a Democrat is in the White House, then the president becomes the favorite bullseye. Otherwise the demon is some other Democratic politician, typically from Congress.

Now, a political platform comprised of nothing more than hate and anger is not a very viable or sustainable political strategy, especially for a national party like the Republican Party. It may be a good strategy for a specific election or an isolated situation, but an entire political party cannot endure based upon only a message of outrage and opposition.

So why would the Republican Party devise such a strategy that has no hope of success? Well, it turns out that they did not devise this strategy. In fact, it's not even a strategy at all. It emerged not as a result of a grand Republican master plan, but of market economics.

The extremist right-wing network of Fox News and talk radio was not created by politicians, and it is not funded by a political party. It is not supported by donations from people seeking political expression. It was created for one central purpose; to make money.

The founding motivation and the driving force behind all of this propaganda of hate and anger that is being disseminated throughout our society is nothing more than the almighty dollar. It is a business, pure and simple.

And, as it turns out, the business of peddling hate and anger is a fantastically profitable one.

Rush Limbaugh raked in \$80 million for himself in 2015 alone. Sean Hannity was paid \$30 million. Glenn Beck is personally worth over \$100 million. Bill O'Reilly's prime-time show, "The O'Reilly Factor," generates over \$100 million per year in advertising revenue.

If these front men are making this much money, well then you know that their corporate masters are making even more.

Fox News has dominated the ratings as the number one cable news channel for the last 14 years and reportedly earns over \$1 billion in profits annually, making it a golden goose in the overall Fox corporate empire. Fox itself is one of the most valuable brands in the world with sales of over \$13 billion. And the tycoon behind Fox News, Rupert Murdoch, is personally worth \$12 billion.

This is Big Business.

It is no joke. We are not talking about some folks just yearning to express their opinions. No. This operation is not being driven by politics or by a desire to promulgate political viewpoints. No. This operation is being driven by money.

Corporate profits are greatly impacted by governmental policies. Corporations, therefore, desire the government to be controlled by whichever political party is the most favorable to corporate profits. And this, of course, is the Republican Party. So it makes perfect sense that this extremist media network would use its megaphone to attempt to influence politics by urging support for the right-wing Republican Party.

Today, the bottom line is money. Politics is secondary. While the media content is highly political, the purpose behind influencing politics is to serve the primary objective of protecting the big profits.

Corporate profits are what led to the creation and expansion of this extremist right-wing media network. And it is indeed a cozy little business model. The network builds an audience by appealing to people's fear, insecurity and anger, and simultaneously directs its audience to support the right-wing political party that best protects the network's own profits.

It's like a rigged game. The content disseminated over the network masquerades as being objective and informative, but in reality the content has instead been carefully designed to promote the network's own business interests.

What is best for corporate profits, however, is not necessarily best for a democratic society.

From a political perspective, it is certainly not healthy to incite anger and hate within a nation's own population. And it is not very wise to inflame hostility and rage against a nation's own government. From a business perspective, sure, it is perfectly understandable because a corporation can exploit this and profit handsomely from it. But from a political perspective of creating a cohesive society and maintaining peace and harmony among the population, this is disastrous.

Responsible politicians certainly know better and would never endorse any enterprise seeking to inflame anger and hostility in the population. A true political leader would not participate in any such conduct, but instead would speak out against it. A true political leader would not condone the dissemination of false and misleading information, but instead would seek to correct it with accuracy. A true political leader would not sacrifice unity in society in order to capture a few easy votes, but instead would uphold his or her principles and integrity even at the risk of losing votes.

That is genuine political leadership. Doing what is best for society, even in the face of adversity.

But politicians in the Republican Party could not resist. The extremist right-wing network of Fox News and talk radio had built up an audience that could easily be exploited for political support. Even though the extremist media network was fomenting anger and hatred that is disastrous for society overall, the network could also be used to deliver political votes to Republican politicians.

An unholy alliance was formed. The Republican Party would allow the extremist right-wing network to promulgate its destructive propaganda throughout society in order to generate its enormous profits, and in exchange, the network would direct its audience to vote for the Republican Party.

The allure of easy votes was too great. Exercising true leadership was too difficult.

So for years and years, the extremist right-wing media network spewed out content full of anger, hate, and division. And Republican politicians jumped on the bandwagon. They began preaching the same destructive messages and appearing on the extremist right-wing network all across the nation.

And guess what? It worked.

The base of the Republican Party grew more and more angry. Their resentment against our very own government grew ever greater. Their sense of victimization became ever more acute. Their fury at the establishment boiled over.

And then, predictably, it backfired.

The base of the Republican Party became a Frankenstein. It became radicalized into an extreme movement that turned against the established order, including the leadership of the Republican Party itself. It has become a monster of its own that is now roaming the countryside and terrorizing the very political party that created it.

This is the reason behind the rise of candidates like Donald Trump and Ted Cruz. The Republican Party establishment despises these candidates, but the party has no idea how to slay these dragons.

These candidates now pose the enormous threat of causing a split within the Party that could lead to the utter destruction of the entire Republican Party itself.

It is a remarkable story.

The Republican Party has enjoyed its dance with the devil. Now it must pay the piper.



## The Untethered Soul

Have you ever wondered: How can I become less reactive and impulsive? How can I turn down the noisy voice(s) in my head and experience more peace of mind?

Michael A. Singer's book - "The Untethered Soul" - answers ques-



Singer looks at the attention that we – unconsciously – give to our monkey mind so that we can question it (instead of be run by it). While a lot of what Singer talks about sounds really good, how do we actually do it? Here are some practical steps you can take to help calm your "monkey mind" and feel more peaceful and free. Allow me to paraphrase Singer:

Your "monkey mind" will never be content. It always has a problem with something. When was the last time you really had nothing bothering you? I thought so. And before that problem, there was another problem. And after this one's gone, there will be another one.

You'll never be free of problems until you are free from the monkey mind that generates (and obsesses on) problems. The next time a problem is bugging you, don't ask yourself, "What should I do about this?" That just feeds the monkey mind. Instead, ask: "What part of me is being disturbed by this?" If you ask, "What should I do about this?" you're just encouraging your monkey mind to believe that there is a problem that you MUST deal with.

For example, if you're feeling jealous because you think that your partner is flirting with someone at a party, instead of trying to figure out what to "do" about it, instead, you could ask yourself: "What part of me is jealous?" This encourages you to look inside and see that there's a part of you that's having a problem with jealousy.

Once you clearly see the disturbed part, ask, "Who is it that sees this? Who notices this inner disturbance"? According to Singer: "Asking this (question) is the solution to your every problem. The very fact that you can see the disturbance means that you are not it. The process of seeing something requires a subject-object relationship. The subject is called 'the witness' because it is the one who sees what's happening. The object is what you are seeing, in this case, the inner disturbance. This act of maintaining objective awareness of the inner problem is always better than losing yourself in the outer situation."

By not identifying with your problem and feeling that you must DO something about it, you get a bit of distance on it. You are pulling back from your monkey mind and watching it with some emotional neutrality. You aren't letting it run the show. You aren't getting lost and confused by situations like you used to. You no longer allow the monkey mind to define your life as a series of "problems" that need to be "solved."

This may sound a bit heady, but it is VERY practical. If it intrigues you, I strongly recommend that you check out "The Untethered Soul". In it, Singer walks you through a progression of steps to "untether" your soul from a constant need for problem-solving (which never ends).

The monkey mind can be tamed; this book can help.


## Walking Eagle

## **The Hungry Homo**

#### Old Fashioned Goulash

#### Ingredients

2 pounds lean ground beef

2 large yellow onions, chopped

3 cloves garlic, chopped

3 cups water

2 (15-ounce) cans tomato sauce

2 (15-ounce) cans diced tomatoes

2 tablespoons Italian seasoning

3 bay leaves

3 tablespoons soy sauce

1 tablespoon House Seasoning, recipe follows

1 tablespoon seasoned salt

2 cups elbow macaroni, uncooked

House Seasoning:

1 cup salt

1/4 cup pepper

1/4 cup garlic powder

Mix the ingredients together and store in an air-tight container for up to 6 months. Use as a seasoning on meat and when cooking vegetables.

#### Directions

In a Dutch oven, sauté the ground beef over medium-high heat until no pink remains. Break up the meat while sautéing. Spoon off any grease. Add the onions and garlic to the pot and sauté until they are tender, about 5 minutes. Add 3 cups water, along with the tomato sauce, diced tomatoes, Italian seasoning, bay leaves, soy sauce, House Seasoning, and seasoned salt. Stir well. Place a lid on the pot and allow this to cook for 15 to 20 minutes. Add the elbow macaroni, stir well, return the lid to the pot, and simmer for about 30 minutes. Turn off the heat, remove the bay leaves, and allow the mixture to sit about 30 minutes more before serving.

Serve with garlic bread and a salad.

## **Man Pleasing Chicken**

#### Ingredients

- 1 package of skinless chicken breast
- 1/2 c. Dijon mustard
- 1/4 c. Maple syrup (I would use sugar free and sweeten it with Stevia)
- 1 Tbsp. rice wine vinegar
- Fresh rosemary
- Salt and pepper

#### DIRECTIONS:

To make this chicken, which you should absolutely do immediately, preheat your oven to 450°F. Then, mix together 1/2 cup of Dijon mustard, 1/4 cup of maple syrup, and 1 tablespoon of rice/rice wine vinegar.

Put a 1.5 pound package of chicken breasts into a foil-lined, oven-proof baking dish. Six chicken breast came in my package, which made enough to serve 3 people. Then, salt and pepper the breasts. Pour your maple mustard mixture over them, turning the breasts in the mixture so they are fully coated.

Put the chicken into the oven, and let them bake for 40 minutes or until a meat thermometer reads 165°F. Baste the tops of the chicken with more sauce half way through. I find that a meat thermometer is essential in cooking because it allows me to check for doneness without cutting into the meat and losing its precious juices. Let the chicken rest for 5 minutes before serving. Plate the chicken, making sure to spoon some extra sauce

over the top. Sprinkle over some fresh rosemary. If there is ever a time to use fresh herbs, THIS IS IT! The flavors are just so good together. Enjoy the savory goodness of this.





## Liberal Justices Will Destroy 'Traditional Marriage,' Says Ted Cruz's Father

Republican presidential candidate Ted Cruz's father, self-styled minister Rafael Cruz, has delivered yet another antigay rant, saying that the appointment of another liberal justice to the U.S. Supreme Court will bring about "the destruction of traditional marriage."

And that's not all, the elder Cruz told host Stephen K. Bannon today on Breitbart News Daily, a right-wing radio program. "One more justice like that," Cruz said,



meaning the court's four more liberal members, "and we will lose our right to keep and bear arms. We will lose all of our religious freedom. We will see abortion on demand to the day of delivery. We will see the destruction of traditional marriage, and the family is the foundation of society — if the family is destroyed, society will be destroyed."

But as Right Wing Watch points out:

"Of course, the Supreme Court ruled last year in favor of marriage equality — which conservatives deride as 'the destruction of traditional marriage' — and society has somehow managed to survive."

And Rafael Cruz, by the way, has been divorced twice.

Cruz, a born-again Christian who calls himself a pastor but is apparently not affiliated with any church, often appears at his son's campaign events. He has made the argument several times that with the death of Justice Antonin Scalia, it's more important than ever to elect a conservative president — like his son — who will appoint conservative justices.

Ted Cruz's biggest rival for the Republican nomination, Donald Trump, can't be trusted to govern with a conservative philosophy, Rafael Cruz added. "Trump is the biggest enigma we have," he told Bannon. "We don't know where he would be on any issue." While Trump has called Ted Cruz a liar, Trump is actually "the one that lies constantly," the elder Cruz said.

Rafael Cruz has previously characterized gay people as sexual predators and said they want to legalize pedophilia. He has recently appeared at such anti-LGBT events as the World Congress of Families meeting in Utah and "kill the gays" Pastor Kevin Swanson's "religious freedom" conference in Iowa, both held last fall. Ted Cruz and two other presidential hopefuls who have since dropped out of the race, Bobby Jindal and Mike Huckabee, also appeared at Swanson's event. A spokesman for Ted Cruz's campaign eventually said it was a mistake for the candidate to be there.

## Louisiana Gov. to Rescind Predecessor's Antigay Order

Louisiana Gov. John Bel Edwards will soon rescind an antigay executive order issued by his predecessor, Bobby Jindal, Deadline Hollywood reports.

"As far as Jindal's religious liberty order, the governor intends to rescind it in the near future," Edwards's press secretary, Shauna Sanford, said in response to a Deadline inquiry today in the wake of Georgia Gov. Nathan Deal's veto of a so-called religious liberty bill that would have allowed discrimination against LGBT people based on religious objections.



Jindal, a Republican who once sought his party's presidential nomination, last year issued the Marriage and Conscience Order, which bars the state from taking punitive action against an individual, business, or nonprofit group acting in accordance with a "religious belief that marriage is or should be recognized as the union of one man and one woman." While the order says this should "not be construed to authorize any act of discrimination," it was designed to protect those with antigay views — for instance, business owners who don't want to provide goods or services for samesex couples' weddings.

Jindal issued the order after legislation to this effect failed to pass. His order stands until another governor repeals it, and that is what Edwards, a Democrat who took office in January, intends to do.

Edwards has also announced his intention to issue an executive order protecting state employees from discrimination on the basis of sexual orientation or gender identity. Some previous Democratic governors had issued such orders, but not Republicans.

Edwards was elected in November over Republican David Vitter, a U.S. senator. Jindal was not eligible to run for governor again due to term limits.

## Marriage Equality Brings Obama and Justin Trudeau Together

President Obama welcomed Canadian Prime Minister Justin Trudeau to the White House Thursday, marking the first state visit from a Canadian leader in 19 years, reports The New York Times.

The two world leaders discussed health care and climate change, and celebrated the arrival of marriage equality in both countries.



"No matter what province or state you live in, you have the freedom to marry the person you love," said President Obama.

Last month Trudeau announced he would be issuing a posthumous pardon to a man who admitted to police he was gay and wound up being declared a dangerous sexual offender and sent to prison in the 1960s, according to the Canadian Broadcasting Corporation.

LGBT rights advocates hailed the announcement, noting that the prime minister's father, former Prime Minister Pierre Trudeau, had championed a bill to decriminalize private, consensual sex acts between people of the same sex over the age of 21.

Homosexuality was decriminalized in Canada in 1969 — just one year into the elder Trudeau's first term as prime minister. Canada embraced marriage equality by parliamentary action in 2005.

Justin Trudeau, "the scion of a major Canadian political dynasty," according to Vox, has built on his father's liberal reputation and is noted for his progressive political views, being a self-proclaimed feminist and a passionate advocate for LGBT rights.

Trudeau became Canada's first national leader to attend an LGBT Pride festival when he marched in Toronto's Pride parade last June.


U.K. LGBT outlet Pink News notes that Trudeau was a frequent attendee of Pride celebrations in Vancouver and Toronto, but his presence after his election to prime minister made history.

"We're celebrating 10 years of taking the decision the Supreme Court in the U.S. just took," Trudeau said during an interview with Canada's Global News at Toronto Pride, shortly after the U.S. marriage equality decision. "It's a great day for freedom. It's wonderful to see political leaders, celebrating this."

In February, Trudeau took a stand against anti-LGBT bullying, donning a pink T-shirt and filming a video for Pink Shirt Day, an annual antibullying campaign that originated in Nova Scotia in 2007.

"On Pink Shirt Day, we stand up to bullying and vow to spread kindness," the prime minister tweeted last month when sharing his video.

Trudeau's predecessor, Steven Harper, made headlines in 2012 when anxiety arose that his administration was trying to undo the legality of same-sex marriage in Canada. Harper told the public there was nothing to worry about.


