# Mayors Take Stand Against Their States' Anti-Gay Policies

City leaders from several states with gay marriage bans took a stand for marriage equality Monday at the U.S. Conference of Mayors in Dallas, when they signed a resolution calling on the Supreme Court to end marriage discrimination nationwide.

Despite their states' bans on same-sex marriage, mayors from Arizona, Texas, Ohio, Colorado, Missouri and Georgia were instrumental in the resolution's passage. Among the signers were Phoenix Mayor Greg Stanton, Houston Mayor Annise D. Parker and Atlanta Mayor Kasim Reed.

"The United States Conference of Mayors reaffirms its support of the freedom to marry for same-sex couples and urges the federal courts, including the U.S. Supreme Court, to speedily bring national resolution by ruling in favor of the freedom to marry nationwide," their statement reads.

The resolution was also signed by Kevin Faulconer, the Republican mayor of San Diego who serves as a chairman of Mayors for the Freedom to Marry.

Freedom to Marry President Evan Wolfson applauded the resolution in a press release from his same-sex marriage advocacy group.

"From small towns to big cities, America's mayors know that including gay couples in the freedom to marry does nothing but strengthen families and communities for all," he said. "The U.S. Conference of Mayors has made it clear that it's time for the federal appellate courts and the U.S. Supreme Court to follow the lead of numerous states and a wave of over 20 federal and state courts and bring an end to marriage discrimination nation-

wide. A year after the Supreme Court demolished the arguments propping up marriage discrimination, it's time for the Court to finish the job and rule in favor of the freedom to marry once and for all."


# Starbucks Raises Gay Pride Flag Over Seattle Headquarters

Starbucks marked the 40th anniversary of Seattle Pride by rais-

ing an enormous 800 square foot rainbow flag over its headquarters in the Evergreen State.

On hand to witness the raising of the flag on June 23 was Starbucks CEO Howard Schultz, who has long been an outspoken advocate for same-sex marriage and other lesbian, gay, bisexual and transgender (LGBT) Rights.

"We are thrilled that Starbucks is showing their sup-



The Seattle-based international coffee giant has been subjected to conservative criticism for its support of the LGBT causes. Earlier this year, the Americans for Truth about Homosexuality's Peter LaBarbera fired off at Starbucks in a blog post, saying that his Mother's Day was ruined after viewing a new ad for the Teavana Oprah Chai Latte which featured "snuggling Starbucks lesbians" in what he described as "an alphabetic homoerotic embrace."

In 2012, the National Organization for Marriage (NOM) launched an international "Dump Starbucks" campaign after Starbucks joined a then-growing list of major corporations by publicly endorsing same-sex marriage legislation in Washington state.

# Gay US Congressman Sean Patrick Maloney is Now a Married Man

US Congressman Sean Patrick Maloney and longtime partner Randy Florke got married over the weekend in New York.

Although they are technically newlyweds, the couple has been together for more than 21 years and have three children.

The couple exchanged vows at the Church of St. Mary-in-the-Highlands in Cold Spring, New York, according to CBS New York.



It was on Christmas Day that Maloney, 47, and Florke, 51, got engaged as a present to their kids. They had previously vowed to wait to get married when marriage equality had reached every state in the US.

Same-sex marriage is currently legal in 19 US states plus the District of Columbia.

Maloney has represented New York's 18th congressional district since 2013 - the first openly gay person from the state in congress. He is only one of two members of the House of Representatives with a same-sex partner.

# 25 Retired Republicans Back Gay Marriage for Michigan



Michigan's Republican Attorney General may have a harder time appealing a court decision to strike down his state's ban on same-sex marriage after 25 retired lawmakers and leading figures from his own party joined the case in support of marriage equality.

Attorney General Bill Shuette is trying to reverse a federal district court decision legalizing same-sex marriage in the his, but the group of retired Republicans has now filed a 'friend of the court' or amicus brief in which they present a 40 page rebuttal to arguments commonly used to argue against same-sex marriage.

Further more they argue that supporting same-sex marriage is consistent with their values as Republicans and the spirit of the US Constitution.

The group of Republicans includes both members of the feder-

al and Michigan state Houses of Representatives, senior party officials, strategists and staffers, with standouts including former state House speaker Rick Johnson and former majority floor leader of the state House Christopher Ward.

In their amicus brief the Republicans argue that there is 'no legitimate, fact based justification for different legal treatment of committed relationships between same- sex couples,' and that, 'social science does not support' any of the issues cited by the State of Michigan in opposing same-sex couples from being able to marry.

'This court should protect the fundamental right of civil marriage by ensuring that it is available to same-sex couples,' the brief reads.

The brief goes on to state that the court striking down Michigan's ban on same-sex marriage would not be an example of 'judicial activism,' but merely part of the court's duty to 'set aside laws that overstep the limits imposed by the Constitution.'

A federal appeals court for the Sixth Circuit announced earlier this week that it will hear challenges to marriage bans in all four states that it covers simultaneously – deciding the issue for Ohio, Michigan, Kentucky and Tennessee all together.

# More Faith Groups Join Federal Suit to Overturn N.C. Same-Sex Marriage Ban

CHARLOTTE, N.C. — The Central Conference of American Rabbis (CCAR) and the Alliance of Baptists are are joining as plaintiffs in a federal lawsuit challenging North Carolina's ban on samesex marriage.

The United Church of Christ filed the lawsuit in April, challenging North Carolina's state ban on same sex marriage, claiming the ban is a violation of freedom of religion.



The suit is believed to be the nation's first faith-based challenge to same-sex marriage bans.

Now, more clergy members are joining the suit, saying they'd like to perform same-sex marriage ceremonies in their congregations, but that they can't because of the "unjust law."

As it stands, North Carolina law makes it illegal for rabbis, priests, ministers and other religious officials to solemnize the marriage of same-sex couples on an equal basis with opposite sex couples without fear of criminal prosecution and civil penalty.

"This precludes rabbis from participating in one of the fundamental aspects of our Jewish religious traditions with respect to a specific segment of their congregations and communities," said Rabbi Steven Fox, Chief Executive of the CCAR, in a statement.

"Depriving rabbis of the freedom to conduct same-sex marriage ceremonies in North Carolina stigmatizes our religious beliefs and relegates many of our congregants and community members to second-class status." he said.

With more than 2,000 rabbis in the U.S., Canada and beyond, the CCAR is the largest Jewish rabbinic movement in North America and represents an estimated 1.5 million Jews worldwide.

The Alliance of Baptists began in 1987 and is composed of male and female laity and clergy, people of diverse sexual orientations, gender identities, theological beliefs and ministry practices.

"By the joining the lawsuit in North Carolina, we are living deeply into our Christian values and offering a clear, Baptist voice for justice and religious liberty." Alliance President Mike Castle said in a statement.

Additional plaintiffs include local clergy from other faith traditions and same-sex couples in Charlotte, Asheville, Concord and Huntersville, reports the Charlotte Observer.

The case is General Synod of the United Church of Christ vs. Cooper. It is one of four federal lawsuits challenging North Carolina's constitutional ban, which was approved by voters in 2012.

# The BLUEBARN Theatre to Break Ground on New Facility

The BLUEBARN Theatre will break ground on Monday June 23rd on its new facility to be built at the corner of 10th and Pacific Streets, in the center of Omaha's historic Old Market South and Dahlman Park neighborhoods.

The first stand-alone theater to be built in Omaha in a generation, the design brings a unique, flexible, indoor/outdoor performance space unlike any other to the city of Omaha and the surrounding region. The 13,000



square foot, single-story facility is designed by Jeffrey Day and the architectural firm Min | Day, along with theatre design consultant Joshua Dachs of New York-based Fisher Dachs Associates, and is being built by Kiewit Building Group. The theater will include art installations by four local and regional artists: Chris Kemp, Michael Morgan, Daniel Toberer, and James Woodfill.

The building site at 10th and Pacific will contain three separate but integrated components: The BLUEBARN Theatre, Box Car 10 (a three- story property housing condominiums and a street-level restaurant) and Green in the City (a new public park which will be owned and maintained by Blue Barn). The BLUEBARN Theatre and Box Car 10 have both been designed by Jeff Day, enabling a cohesive look between the two buildings. The Green in the City landscape design, by Kansas City-based firm El Dorado, was selected through a national design competition managed by Omaha By Design.

BLUEBARN launched a \$7 million Capital Campaign in 2012, chaired by Nancy Mammel and Kate Noble Weitz, to raise funds for the \$5 million building project plus \$2 million in endowment and increased operating support. To date, 60% of the total campaign goal has been raised. The theater will be completed in May 2015, and Campaign fundraising will continue throughout construction and beyond.

# Betty Crocker Sponsors Twin Cities Festival, Donates Wedding Cakes

The company also announced this week that they will donate wedding cakes to a number of same-sex couples getting married during Pride on Saturday, June 28 in Minneapolis' Loring Park.

"Pride is a way for us to really bring our brand purpose to life by celebrating all families," Perteet Spencer, marketing manager for Betty Crocker, said in a statement. "Not only will we be able to continue the great work we did last year, we'll be able to gain deeper insights into today's modern homemaker as part of our national survey."

# Jason Hanna And Joe Riggs, Texas Gay Fathers, Denied Legal Parenthood Of Twin Sons

It's heartbreaking to think that a state has erased the parents of children and put a family in legal jeopardy, simply because of discrimination against gay and lesbian couples. But that's what happened to a gay couple in Texas after what they described as the "magical" birth of their twin boys.





Jason Hanna and Joe Riggs are the proud fathers of Lucas and Ethan, who were born in April, after they'd connected with a surrogate mom, CharLynn.

Each of the men is a biological father to one of the babies. But, because Texas has a ban on gay marriage (it was ruled unconstitutional by a federal judge last February, but the deci-

sion was stayed pending appeal), and because a judge can use his or her own discretion in these cases, neither of the men is currently on the birth certificates of either of the boys, nor have they been able to co-adopt each other's biological child.

Only the surrogate mother — who has no biological relationship to the boys, since embryos were transferred to her — is on the birth certificates. In essence, the men are not legally defined as the parents of their own children. And though they have DNA tests for proof, they're worried, particularly if something were to happen to one of them while the other still has

not been able to co-adopt the other's biological child.

"As of right now in Texas two men cannot be on the birth certificate," Jason Hanna explained in an interview with me on SiriusXM Progress. "So our attorney followed the letter of the law. We petitioned the court. We had DNA testing there [in court] and petitioned the judge to ultimately remove the surrogate mother from the birth certificate, who has no biological ties to the boys. We would like each biological dad to be placed on the birth certificate of our own son, and then ultimately proceed to the second-parent adoption. The entire petition was denied."

Jason Hanna and Joe Riggs met four years ago and knew they wanted to be together and raise children, so they saved their money, knowing it would be a costly process. They married last July in Washington DC, where gay marriage is legal, and then went back to Dallas to celebrate their wedding with family and friends in August. They found a surrogate mom, and this past April the twins were born.

"We were sworn in and ultimately the judge was saying that with the information she had in front of her, under Texas law she couldn't grant it," Riggs said of their appearance in court last week. "I was shocked. We had a ton of questions as we walked away from that courtroom."

It was particularly jarring to Hanna and Riggs because other gay couples in Texas, including friends of theirs, have successfully completed this process. The couple's lawyer has offered them several options on bringing the petition back, changing the paperwork and the process. But there's no question that if their marriage was legally recognized they would not be having this problem at all.

"In order to grant a second-parent adoption [automatically under current law], it has to be between two married people," Jason explained. "And so, considering we're not legally married in the eyes of Texas, they don't have to grant that secondparent adoption because they don't recognize our marriage... It's up to the judge's discretion on whether or not to grant it."

Hanna and Riggs worry, as they wait for the next step, because they're in a scary legal limbo.

"Without [co-adoption], if something happened to either me or Joe we don't have any legal recourse to keep the other's biological child," Hanna said. "The state could come in and separate these two brothers... We want to reiterate how important it is for a state to recognize each family, whether it's same-sex or opposite-sex, and really to ensure everyone has equal protection from the state."



# Six South Dakota Couples Sue, Seeking to Overturn State's Ban on Gay Marriage

Six same-sex couples filed a federal lawsuit on Thursday, 22 May, seeking to end South Dakota's ban on gay marriage. The plaintiffs include a couple who were denied a marriage license in South Dakota this week and five couples who got married in other states but live in South Dakota and want the state to recognize their unions.



The lawsuit, filed in US District Court in Sioux Falls, leaves neighboring North Dakota as the only state with a gay marriage ban that is not being legally challenged.

It comes on the same week that successful court cases in Oregon and Pennsylvania resulted in same-sex marriage becoming legal in those states.

Cases are pending in 30 states while gay marriage is now legal in 19 states plus the District of Columbia.

The Associated Press reports that South Dakota Attorney General Marty Jackley said he is obligated by law to defend the ban which was passed by voters in 1996.

# Porn Producer: PrEP Drugs Like Truvada Help Porn Performers, But They Don't Replace Condoms

The Centers for Disease Control and Prevention has officially encouraged the use of pre-exposure prophylaxis (PrEP) medications as a method of HIV prevention, but that doesn't mean drugs like Truvada will change the role of condoms in the making of pornography.

Peter Acworth, the founder and CEO of porn site Kink.com, joined HuffPost Live's Ricky Camilleri on May 16 to share his take on the necessity of condoms. Though he is excited by the results of Truvada, he doesn't have plans to lift his policy that all actors on Kink.com must wear condoms in their scenes.

"If someone shows up at our door and says, 'I'm on Truvada, I don't need to use condoms,' we've only got their word to take for it, so we wouldn't feel comfortable relaxing our condommandatory policy," he said. "I don't see this as a replacement. The highest-risk people, I think, should be using condoms and taking PrEP."

Still, Acworth believes PrEP's benefits are important to the industry.

He added that porn actors' personal sex lives are not monitored like their professional performances, meaning intimate encounters outside of work are often more dangerous than what happens on set. That means Truvada can keep outside infections from infiltrating the workplace, Acworth said.

"There have been occasional people test positive, and there's been moratoriums that have taken place, so we've stopped shooting, we've retested the performer pool and we've determined that those infections happened off set," he said. "So the other exciting thing about Truvada is that it could potentially protect performers during their off-set interactions at home, which no bill, no law is going to change what people do in their own time."





# Are You Full Blown Gay Yet?

"Are you full blown gay yet?"





My friend, who I hadn't seen in years, asked me this question in no less than five minutes into our reunion. I was looking forward to catching up on everything that's happened, but the question was a punch in the gut. I was no longer excited to see her. Our transition from teenage years to young adults hadn't changed her misconceptions on bisexuality. Like her misconceptions, my identity hadn't changed.

She isn't alone in her thinking. There are many straight and gay people who really don't know what it's like to be a bisexual person in a "hetero or homo" world. Bisexual people's identities are usually forgotten, ignored, or simply erased for the more palpable binary.

I've been out as bi for about 10 years. I knew what I was before I even knew there was a term for it. Growing up I only heard gay or straight and I actually believed you had to choose between your attractions. But my attractions never changed, I didn't have to choose. My sexuality is just wonderfully fluid.

The thing is, many people see bisexuality as transitory. For



them, it's a pit stop to gayville or as some like to say, "bi now, gay later." And yes, that's true for some people.

Coming out is a hard thing to do when you are raised in a society that expects you to function in heteronormative boxes. When you come out, you're telling the world their assumption of your heterosexuality is false. For some, coming out as bi is a step toward acceptance of your queer identity.

It's really not only for your family and friends, but also for yourself to grab onto what little hope you have that maybe one day you can actually fall in love and marry someone of the opposite sex. Though for these people, eventually they come out as lesbian or gay and their friends and family see their bisexuality as some sort of "phase." They even believe that bisexuality may in fact only be a term used for those trying to brace the impact of coming out. Here's the problem—my sexuality isn't a phase.

Coming out is difficult and if you need to use bisexuality as a transition, go ahead. I would rather you come out as bisexual than live closeted and deal with your queer identity alone. But for the rest, we must realize that while some people use bisexuality as a stepping stone to coming out, for most of us, it's not a pit stop — it's our destination.

It's somewhat ironic that gay and lesbian people say the same thing to bisexual people that they heard when they came out. How many times did people hear from their parents it's "just a phase" or "you'll grow out of it." It's extremely patronizing and eliminates your right to self-identify. And there are a lot of us that self-identify as bi. According a 2007 survey in which 768 self-identified lesbian, gays, and bisexuals participated, approximately half of LGB people identified as bisexual. That's a lot of people to be going through a "phase."

It's really not a phase then, but why do so many gays and lesbians make fun of it?

I think a lot has to do with the fact many just don't understand it. Just like straight people don't understand gays and lesbians, they can't relate to something they're not personally experiencing. But if we keep creating new standards for sexuality, and heck even gender, we're only limiting the fluidity of it. Because whether you understand it or not, we exist and we're part of the community.

The entire assumption that someone's sexuality is a phase is essentially saying that no matter how a person chooses to identify on a spectrum, they haven't fully arrived. It's that the assumed end destination of being gay or lesbian is the goal and that until we've reached that goal, we have yet to achieve our queer identity. That understanding is linear and limiting and it's invalidating of a legitimate sexuality. Fluid sexualities are not "lesser" than those who choose to identify in the binary. They're just fluid and complex with a larger capability for love.

My friend eventually apologized and just rolled her eyes as I chided her for being so careless with my sexuality. Just like she didn't want me to mistake her Hispanic heritage, I didn't want her to mistake my sexual identity. We still talk. Last time I saw her I asked her "Are you still full blown Ecuadorian?"

# NCLR Looks to Ban 'Ex-Gay' Therapy Nationwide

After helping California and New Jersey successfully pass legislation to outlaw the use of so-called ex-gay therapy on minors, the National Center for Lesbian Rights is taking on the practice nationwide in a new campaign.



#BornPerfect: The Campaign to End Conversion Therapy (http://www.nclrights.org/bornperfect/) hopes to hammer the final nail into the coffin of the outdated, debunked practice of "reparative therapy," also known as "sexual orientation change therapy," which attempts to turn gay people straight. The practice has been discredited by every major psychiatric, medical, and mental health organization in the country, with the American Psychological Association — and several other prominent health groups — denouncing the practice as harmful, and likely to increase dangerous behavior, including suicidal ideation.

The new campaign involves working with activists, organizers, lawmakers, and citizens to enact legislation in all 50 states outlawing the use of "reparative therapy" on minors by licensed therapists and counselors within the next five years. NCLR hopes to accomplish this by providing state legislators and LGBT leaders with comprehensive resources to build local campaigns against the discredited practice, then continuing to work closely with lawmakers and advocates as they draft legislation and testifying in support of such bills in state legislatures. The legal group is already in touch with a number of LGBT adults who were subjected to such treatment as children and can speak directly to the harm it caused them.

"By 16, I had lost everything," said Ryan Kendall, a Colorado native who is now 31 and a recent graduate of Columbia University with plans to attend law school. "My family and my

faith had rejected me, and the damaging messages of conversion therapy, coupled with this rejection, drove me to the brink of suicide. I am lucky that I survived, but I will never be able to recover the years I lost to feeling worthless and suicidal because a therapist convinced my family that being gay is a mental illness and that who I am is shameful and wrong. These practices are child abuse, pure and simple."

Kendall and other "ex-gay" survivors have worked closely with NCLR and other LGBT groups to support legislative efforts to ban the discredited therapy in several states — with legislation introduced this year in Minnesota, New York, Hawaii, Illinois, Maryland, Massachusetts, Rhode Island, Vermont, Virginia, Washington State, Washington D.C., and Wisconsin. At press time, none of those bills had passed their state's full legislature — some died in committee, while others were not brought to a vote before the end of the legislative term. In 2012, California became the first state to prohibit licensed therapists from engaging in efforts to change the sexual orientation of minors, with New Jersey enacting a similar law the following year. Both laws were challenged and subsequently upheld in federal court.

### Radio Hosts Fired for Transphobic Segment

Two New York radio hosts were fired for making transphobic comments during their show, it was announced today (22 May). Kimberly and Beck, the hosts of 'The Breakfast Buzz' on 98.9 The Buzz, described trans people as 'nutjobs' in a disturbing, offensive segment broadcast yesterday.

The hosts were responding to the city of Rochester's decision to offer transgender health benefits to employees. In the segment, they play Aerosmith's 'Dude Looks Like A Lady' and repeatedly misgender trans people. Following the hateful comments made, LGBTI people responded in anger.

An Empire State Pride Agenda spokesman said: 'Not only did





the hosts conflate sexual orientation and gender identity and make the ill-informed leap from medically-necessary care to elective surgery, they also degraded LGBT identities more generally, including the outrageous contention that transgender people are "nut jobs". They note providing transgender New Yorkers with medically necessary health care is a cost-saving measure. 'Taxpayers will likely see savings related to mental health, suicide attempts, HIV, substance abuse and other costs that occur when transgender people cannot get their transition-related health care needs met.'

As the outrage grew, the radio station announced they would be suspending the pair. Kimberly then said in a tweet, (her account since deleted, responding to the controversy. She said: 'Freedom of Speech includes the freedom to offend others. You aren't granted a right to not be offended in this life #getoverit #ROC'

And now, the radio station has fired the radio show hosts. A spokesperson for Entercom Rochester said: 'This morning Entercom fired Kimberly and Beck effective immediately, 'Their hateful comments against the transgender community do not represent our station or our company. 'We deeply apologize to the transgender community, the community of Rochester, and anyone else who was offended by their hateful comments. 'We are proud of our past work on behalf of the local LGBT community and we remain committed to that partnership.'

A client gave me the phrase: "Lift others as you climb". It struck a chord in me. After all, helping others as you grow and move up the ladders of success and happiness is a benefit to both you and the recipient of your largess.

If we all move up together – and don't leave anyone behind - what a major win for our community. If we move up ourselves and use it as an opportunity to feel superior to others who haven't had our gifts, talents or good luck, we are sabotaging our community and making ourselves feel better at someone else's expense. This is what insecure people do: they live out some version of "I'm so great and you're a loser."

Who's the loser then?

This sounds easy, but it's not. How often have you been able to rejoice in someone else's good fortune? Or do you secretly look for some flaw in them that you can focus on. For example, "Well, yeah, he does have a good relationship, but he's not too bright." Or "She is very successful, but she's such a bitch."

Another way to lift others as you climb is to be a mentor to others. A mentor is someone that helps, supports, and gives guidance to another person. It can be an older person mentoring someone younger or when a more experienced person teaches, helps, and gives advice to a less experienced person.

A mentor has moved beyond preoccupation with self to foster the growth of the person being mentored. This relationship is good not only for the receiver, but for the giver. The mentor benefits in many ways: it is good for your self-esteem to help someone else. It is very good for us older LGBTers to feel connected and appreciated by younger LGBTers.

If you want to feel alive and worthwhile, giving something back to your community is a great way to do so. Many people, as they age, become more rigid. They make their worlds smaller and smaller, so they can feel in control. This is a perfect set-up for an unhappy, bitter old age. Don't go there.

Aging well requires expanding your world, not contracting it. One of the best parts of getting older is getting wiser. Sharing your wisdom is a path to a happy elder-hood. After all: what good is wisdom if you keep it to yourself? Don't you wish someone had mentored you when you were young, confused and trying so hard to figure out how the LGBT world operates?

Mentoring relationships can provide valuable support to young people. Mentors can help guide younger LGBTers through the difficult developmental stages that accompany the transition into LGBT adulthood.

Traditionally, mentoring was mostly about offering career guidance. But let's take it further: mentors in our community can also serve as role models for leadership, interpersonal and problem-solving skills.

Mentoring is not using the illusion of helping to find a hot, younger boyfriend/girlfriend or to get into someone's pants. When mentors have these kinds of intentions, it makes it harder for anyone wanting to be a legitimate mentor to be trusted. If you want a younger partner, be clear on that. That's not mentoring. Elders of the community: be clear about your intentions and honest with young people on what you expect from them. Don't drag mentoring into the dirt: keep it clean, honest and real.

Who do you want to be when you turn 50, 60 or 70? Bitter and cynical elders don't get that way by accident. A lifetime of envying other people and tearing down others who are successful is the path to an unhappy old(er) age.

Lifting as you climb is a great remedy to this: as you become older, wiser, wealthier and more successful, you reach out a hand to others to help them follow you on the path.

Don't you wish someone had done this for you?

# The Hungry Homo

### **Baked Veggie Casserole**

Veg out tonight with this egg and vegetable casserole that makes for a mouthwatering main meal or scrumptious side dish. When you are looking for a way to integrate more veggies into your recipe repertoire, look no further than this all-in-one dish.

#### Ingredients:

1/4 cup vegetable oil
1 onion, chopped
1 tsp. minced garlic
1 large green bell pepper, finely chopped
2 medium tomatoes, diced
Salt and pepper to taste
Ground cumin to taste
1 (15 oz.) can lima beans, drained
1/4 cup chopped fresh parsley
4 eggs
1 tbsp. butter, cut into pieces

#### Methods/Steps:

Preheat oven to 400 degrees.

Heat oil in a large skillet over medium heat. Stir in onion, and cook 5 minutes, until tender. Stir in garlic, green bell pepper, and tomatoes and then season with salt, pepper and cumin. Reduce heat, and simmer 15 to 20 minutes.

Mix beans into the onion mixture. Stirring occasionally, cook 10 minutes. Toss in parsley, and transfer to a medium baking dish. Break eggs over the top, dot with butter, and season with salt and pepper.

Bake 15 to 20 minutes in the preheated oven, until the eggs are cooked through.





# Brunei Law To Allow Death By Stoning For Gay Sex

The United Nations has responded to the nation of Brunei, a sovereign state in southeast Asia, where officials are reportedly set to roll out a new penal code including death by stoning as punishment for same-sex acts.

Other offenses referenced in the revision of capital punishment regulations reportedly include "rape, adultery, sodomy, extramarital sexual relations for Muslims, insulting any verses of the Quran and Hadith, blasphemy, declaring oneself a prophet or non-Muslim, and murder."

The revised penal code was slated to go into effect April 22, according to Gay Asia News and other media outlets.

"Application of the death penalty for such a broad range of offenses contravenes international law," Rupert Colville, spokesperson for the Office of the UN High Commissioner for Human Rights, said in a statement. "We urge the Government to delay the entry into force of the revised penal code and to conduct a comprehensive review ensuring its compliance with international human rights standards," he told a news conference in Geneva.

Brunei has reportedly not carried out any executions since 1957.

Brunei is the latest in a series of countries to pass anti-gay laws that could result in extreme punishments for those engaging in same-sex acts.

In February, Uganda's president signed a bill that calls for firsttime offenders of same-sex acts to be sentenced to 14 years in jail, and "repeat offenders" could receive life in prison.

Additionally, Nigeria has a similar anti-gay law that makes same-sex relationships illegal and sets penalties of same-sex acts at up to 14 years in prison.
