Together, we will stand. Divided we will be slaughtered as were the Jews, the communists, the trade unionists, and Pastor Niemoeller who learned his lesson too late.

# What Happens to Your Article?

Have you wondered what happens to your article once submitted to The New Volce? Here's a synopsis.

First, your article is checked and approved by the editor. Minor changes may be made. Then it goes to the typing staff.

This issue was typed on an Atari ST computer using WordWriter ST and on a Radio Shack (IBM Compatible) using PFS Professional Write. Articles were spell checked using word processor dictionaries and a draft was printed.

Draft copies went to the proofreader. He checked for typos and any misspelling missed by the dictionaries. Then back to the typesetter for corrections and final typeset.

Final corrections were done on the Atari ST and saved to disk. Articles were then loaded into DeskTop Publisher ST on the Atari. Headlines. Inserts, etc., were formatted. Final print (2 copies) was done on a Star NX15 dot matrix printer.

Final copy then went to the layout staff. There, the final camera ready copy of the magazine was produced, using final typeset copy, ad copy, art work and fillers. Then its off to the printer. The result is your magazine -The New Voice of Nebraska



# Ageism

Now that you've read the litte, you might be assuming that I'm going to write about ageism committed by the younger generation against the older generation. Well, I'd hate to be too predictable. Actually this article is about reverse ageism, that committed by the elder person in a relationship against the younger partner.

I can almost hear the eyebrows raising. What do I mean by reverse ageism? First of all, let me define "ageism" as pertaining to this article: a discrimination against a person of an age different than you own. And here I'm confining myself to talking about relationships where the difference in ages between the two partners runs ten or more years. I'm diplomatically leaving the definitions, however, of "younger" and "older" up to you.

I started thinking about ageism while reading a short article recently in the Lesbian Connection. The author of the article revealed that she has been involved for the past fourteen years with a woman thirteen years her senior. I noticed this article because there happens to be sixteen years between my partner and me. We also know a few other couples, male and female, who are in similar relationships.

A common thread I've been noticing is that the elder partner, at some point, becomes concerned that the younger lover will eventually leave for someone more his/her own age. It's an understandable concern. None of us is oblivious to what time and gravity do to the aging human body. Wrinkles appear. Gray hair replaces Brown. Breasts and bellies sag, and bags lodge themselves under eyes. Looking in the mirror becomes, well, depressing. We wonder how anyone could find that body attractive anymore.

That's when the questioning starts. "Will you still love me even if I'm old and gray and wrinkled? Or did you only want me because, a few years ago, I was more attractive than I am now?"

No one can be blamed for asking those questions. They're a very real concern. But don't let it get out of hand. Speaking to those in relationships who just happen to be a decade or more older than your partners: have faith in yourself and have faith in us kids.

The women writing in the Lesbian Connection complained of the way her lover had begun the questioning and wouldn't give it up. The elder partner was convinced in her own mind that this woman would leave her for someone younger. The elder woman apparently is becoming more and more possessive and suspicious. I won't go into any more details, but you can get the picture that this reverse ageism is hurting their relationship.

Being the younger partner myself, I sort of compared notes with another younger partner because I was curlous just how common reverse ageism might be. While it was not as much a problem for either of us in our relationships as it was for this other writer, we both acknowledged that our elder partners had expressed concern that maybe we wouldn't care for them as much as they aged.

I don't mean to confuse concern with ageism here. Concern is something else altogether, it can lead to a form of discrimination, however. When the concern becomes so prevalent in the mind of the elder partner that it becomes an annoying irritant to the younger partner, then it becomes ageism.

The younger partner may quickly thre of repeatedly having her love and devotion questioned. Frankly, it hurts when someone questions whether you love them or not. And when you get hurt in the same way often enough, you get angry. Anger gets in the way

of a healthy relationship. Unfortunately, the only thing that will prove love and devotion is time itself. And if the elder lover persists in doubting the younger one, that's one sure way of turning those doubts into a self-fulfilling prophecy.

One thing the elder partner should remember is that the younger person probably loves you for the inner person. Chronological age may be ascribed to the outer shall we call the body, but there is an inner person whose age may or may not match the body's age. You've heard the expressions "He's not acting his age" and "She's young at heart," haven't you? Well, that's what I mean about the age of the inner person. Perhaps these "May/September" relationships result because the younger person is too mature for her contemporaries, or perhaps the older person feels too young at heart to conform to the way others tell her she should act or think.

What really matters, I believe, is the age of the inner person. Keep looking at your own inner person and that of your partner. Maybe you're a lot closer in age than chronology suggests. And if that's the case, you're being loved for the person inside rather than the person outside.

There's also a saying that love is blind. If the younger person is blind to the crow's feet, than allow that. If she doesn't act like she cares that your hair is turning gray, then assume that she really doesn't. A certain amount of concern is natural, but don't let it turn into ageism, or you really might be lonely in your old age.





# Preliminary Survey Results Available

Since the beginning of 1988, Joel Brodsky, a Ph.D. Candidate in Sociology at UNL, has been interviewing gay men in Lincoln and Omaha about their health care. Now that the Interviewing is complete he would like to share some preliminary results with the community.

"We don't have any way of precisely measuring the gay population, so actual figures are not really very useful to anyone who is a professional researcher. On the other hand, certain trends in the data are interesting, and I think people might be curious."

One area which concerned Brodsky - who taught a course about AIDS at UNL last fall - was knowledge of AIDS. The men (and one transsexual) in the study had a good understanding of the disease - practically everyone knew that it can be transmitted from only one sex partner, that a person can carry the HIV virus for years without becoming ill, and that condoms can help prevent the spread of the disease.

When it came to the "nitty-gritty" of safer sex, however, some 1033 Were respondents knowledgeable. Quite a few, for example, did not know that nonoxynol-9, a common spermicide found in various water-based gels and lubricants, has been shown to kill HIV. Some were not aware that oilbased lubricants, like vaseline, crisco, or cold cream, weaken the latex in condoms in a matter of seconds, and that only water-based lubricants should be used with condoms. A few did not realize that anal sex is considerably riskler than oral sex.



### Submission Deadline

Brodsky commented: "These are life-saving facts which the media tend to ignore. A person even considering anal intercourse with anyone who is at any concelvable risk at all for having been exposed to HIV, needs to be extremely knowledgeable about risk reduction. Not only must a condom be used - and used properly with a water-soluble lubricant containing nonoxynol-9, but some people are double bagging - using one condom over another - and withdrawing before they come. People should play with condoms when they're by themselves or with friends, to see what makes them break and to become skilled at handling them. I really enjoy masterbating into condoms, and many people are finding they're fun in oral sex, too."

Although most of interviewed said they knew someone with AIDS, many did not know if any of their friends had tested positive for HIV antibodies. In Nebraska, Brodsky pointed out, people diagnosed with AIDS are legally disabled and protected from discrimination, but those who are HIV positive have no such protection. "There's not much to gain and a lot to lose by discussing antibody status. As a result, gay Nebraskans may underestimate the extent of infection. It is clearly in the public health interest to legally protect people from discrimination on the basis of HIV antibody status."

Another problem is health insurance. Quite a few of the men had no health insurance, and for others their health insurance was fied to their jobs. Some thought it possible they might lose their insurance if their insurance company found out they were gay. Many thought it possible gay men might have difficulty in obtaining health insurance, and everyone supported the idea of legislation designed to protect people from anti-gay discrimination by insurance companies.

Those Interviewed were a fairly diverse group, including all races, education and income levels, and a wide assortment of occupations. Their ages ranged from 21 to 65. Most lived either with a gay partner, lover, or close companion, or else lived alone. A few lived with room-mates or family members. Most worked full-time.

# COLAGE Under Attack

The UNL Committee Offering Lesblan and Gay Events (COLAGE). formerly called the Gay/Lesbian Programming Committee (GLPC), is currently undergoing a funding crisis. The committee originally requested \$1600 for programming for educational and social events on gay and lesblan concerns. COLAGE is a part of the University Program Council. The committee above the University Program Council, the Committee on Fee Allocations. lowered the amount to \$749. The request then went to the UNL Student Senate, the Associated Students of the University of Nebraska and they struck all of the funding citing such things as biblical morality, not enough money available, questioning whether gay and lesbian people are a minority and a 1987 election survey where a majority voted down funding for gay/ lesblan programming. The Vice Chancellor for Student Affairs, James and Chancellor Massengale now must decide whether to reinstate funding or deny it. If funding is denied from these officials. COLAGE may be able to challenge the decision, based on an 8th Circuit Court decision - Gay and LEsbian Students Association v. Gohn, which upheld the rights of gay/lesblan student organizations to receive funding when they are judged on content and state action exists.


According to Gay and Lesbian Students Association v. Gohn, "In brief, we hold that a public body that chooses to fund speech or expression must do so evenhandedly, without discriminating among recipients on the basis of their ideology. The University need not supply funds to student organizations: but once having decided to do so, it is bound by the First Amendment to act without regard to content of the ideas being expressed." This case, which sets the precedent for funding, is binding on the University of

Nebraska-Lincoln. The Nebraska Civil Liberties Union has expressed a willingness to assist COLAGE with a lawsuit, should the Vice Chancellor for Student Affairs and the Chancellor deny funds to COLAGE.

The Committee Offering Lesbian and Gay Events has been very active over the past couple of years. They have sponsored "My Friend is Gay and I Don't Understand," movies, speakers, a National Coming Out Day demonstration and a Lesbian and Gav Pride Week with the UNL Gav/Lesbian Student Association. The Pride Week included a keynote address by Louis Crompton, Ph.D. English on the Gay/ Lesblan Civil Rights Movement, a dance, a poetry reading, a movie, a coffee house reunion and other events. Some current activities include: playing the game, "Alternatives," a situational game demystifying homosexuality to combat homophobia, using a human sized board game and in public view of the student union.

The battle for COLAGE to receive funds is still being fought. # ACT UP in K.C.

Kansas City, MO--About thirty members and friends of ACT-UP/KC converged on March 2nd at Telecheck Mid America headquarters in Overland Park, Kansas Protesters demonstrated at the facility to let Telecheck Pres. Dale Flaxbeard and the public know that his decision to fire employee Mark Sweetland because of his AIDS diagnosis is unethical and immoral.

The state of Kansas has ordered Telecheck to reinstate Mark to his job and give him his back pay. Telecheck has refused to do this and intends to gain court approval to discriminate against people with AIDS. It was Telecheck's decision to refuse to abide by the state's order that prompted ACT-UP to take the issue to the streets.

ACT-Up member Jim Huil said "AIDS is a disease similar to any other catastrophic illness. I doubt if Mark would have been fired if he had contracted cancer, heart disease, or diabetes. All of these illnesses are just as deadly as AIDS. Telecheck's decision to fire Mark because he had AIDS is based on the unrealistic fear of this disease and the widely held belief that this is a Gay disease and Gay people don't deserve protection in the workplace."

During the demonstration, marchers performed a die-in at which time ACT-Up member Jon Barnett stated, "AIDS has been used to fuel the fires of homophobia, leading to even more harassment and gay-bashing. Yet, in response to hatred and tragedy, Gay men and Lesbians have led the way in confronting the crisis with intelligence and compassion. In the face of bigotry and AIDS, we set an example of love and healing for all people."

# The Second Most Important Room in the House

Before I start talking about salad dressings, I want to tell you right off that I dislike olive oil mainly because I dislike where olive oil comes from -- that is, Olives. Green, ripe, pitted, or stuffed - I dislike them all. Which in a way is too bad because my love likes olives. If you insist upon using olive oil in your salad dressings, please use virgin olive oil. Virgin olive oil is nothing more than oil obtained from the first pressing of the olives. If it doesn't say "virgin" on the olive oil bottle, it means the oil is cheaper, but girls, don't you deserve the best?

Salad greens are in abundance most of the year at your local market. Don't limit yourself to just the basic greens, such as iceberg lettuce and spinach. Talk with your produce person about the different varieties after ail, as I told Luke Warm the other day, "those cute young things are here to help you. Just don't squeeze the tomatoes and make sure you wash the wax from the cucumbers before you use them in your salad."

Commercial salad dressings, the kind that come all prepared, offer variety and convenience, but they are often expensive. Besides, if you have taken a bit of trouble to buy fresh ingredients for your salad, why not go all the way ... and make your dressing from scratch. Here are a couple of dressings that take only minutes to prepare and your "guests" will love you for it.



# Sesame Seed Dressing

(this makes about one cup)

1/2 cup oil (the original recipe calls for sesame oil)

1/4 cup honey

1/4 cup cider vinegar

3 Tbl sesame seeds, lightly toasted

2 Tbl Lemon Juice

dash of garlic Juice

Combine all ingredients in a jar; cover tightly and shake well. In fact, you can shake the hell out of it. Chill the dressing and shake again before serving.

### Blue Cheese Dressing

(this makes about 1 cup)

1/2 cup vegetable oil

1/4 cup cider vinegar

4 ounces crumbled blue cheese

1/2 tsp salt

1 tsp black pepper, coarsely ground

1/2 tsp dry mustard

1/2 tsp paprika

1 tap Worcestershire sauce

1/2 tsp prepared horseradish (optional)

Combine all ingredients in a jar, like the jar in the sesame seed dressing (see above) and shake the hell out of it. Chill and shake again before serving.

#### Lime-Honey Dressing for Fruit Salad



eighty-five cents we are charging above the regular ticket price is to help cover the costs of mailing and advertising.


in the event we do not meet the guarantee, the theatre management will open up the house to the public, but we will be able to sit as a group for the performance.

The program focuses on 16-year-old Ryan White, a hemophiliac who contracted AIDS through an infected blood product, as he attends high school classes and answers questions for a group of fifth-graders.

AIDS: What Do We Tell Our Children, airing Sunday, April 9, at 8:30pm, offers a positive story--with lots of practical how-to ideas for others--of how the school system worked with students, the media and parents to disseminate timely and accurate information and prevent public panic.

# Some Condom Lubricants Are Unsafe

LOS ANGELES - A wide range of lubricants commonly used with condoms - including Wesson oil, Nivea hand cream, Vaseline Intensive Care lotion and baby oil - can cause the contraceptives to break within 60 seconds after being applied. This is far more quickly than researchers had believed, a new study has found.

Safe lubricants include waterbased preperations such as KY Jelly, as well as generic contraceptive gels that contain spermacide nonoxynoi-9, according to Bruce Voeiler, president of the Mariposa Foundation, a sex research organization. Current needs of GALA include: funds to begin mailings, letters from alumni, faculty and students expressing a wish to join and volunteers to help with the administration and origination of the organization.

Future plans of GALA could include: fundraisers, annual alumni dinners, newsletter about campus concerns, employer referral and establishment of a national network of gays/lesbians/friends of the campus gay/lesbian community.

# Nebraska Representatives Rank Forty-Fifth

ALYSON PUBLICATIONS, Inc. release - Feb. 23rd, 1989

The Nebraska congressional delegation ranks forty-fifth of all fifty state delegations on votes supporting gay Interests. Nebraska senators and representatives voted with the National Gay and Lesbian Task Force position 48% of the time.

Those figures appear in the forthcoming Alyson Almanac, a reference book for the gay and lesbian community, which will include a complete breakdown for all 50 states and all 535 U.S. senators and representatives. The ratings are based on talles by the NGLTF for the 1987-88 sassion.

The top-ranked state was Massachusetts, whose delegation includes the country's only two openly-gay congressmen, with a 94% rating. Washington state, at 91%, was second. The worst ratings went to New Hampshire (33%), Idaho (31%), and Wyoming (23%).

We decided to get a general sense of which states have the best political climate for gay people and gay activism by looking at the overall voting record of their congressional delegation.

The following figures were derived from the preceding section. They show what percentage of the votes cast by senators and representatives from each state were the "correct" vote, as defined by the National Gay and Lesblan Task Force. These statistics can also be found in the upcoming Alyson Almanac.

On Lesbians: "Most lesbians are like, 'Hi there, my name is Dallas. I own my own security business. Fucking big bitches, man, have an ass bigger than yours."

Warner Bros. has put warning stickers on the albums and tapes saying the opinions expressed do not reflect its views, and has agreed to include an AIDS information insert in albums and tapes released after the initial Nov. 8th distribution (a small percentage at best.)

This is not a sufficient response to this level of dehumanizing defamation. Remember, most gay bashing attacks are committed by teenage males (like, say, Kinison's audience of mainly angry, frustrated, rocked-out teens).

Let Warner Bros. know that they've attacked you, and that you do not intend to buy albums from a company that makes money be degrading the gay and lesbian population.

#### Iraq Bans Male Hairdressers

An Iraql government decree now bans all men from working as hairdressers and orders all beauty salons to dismiss all male employees.

The interior Ministry said the decision was made because the work of the men in the profession "is contradictory to the profound values of the nation and authenticity," according to government newspapers.

Most tradis are Mostems, and the Islamic religion forbids men and women to mingle in public, unless women are velled. The ministry warned that it will inspect hairdressing salons to make sure the order is observed.

### Landlord Gives OK to Gay Flag


A West Hollywood man who sued his landlord for the right to display his rainbow Gay and Lesbian Pride flag on the balcony of his apartment reached a settlement recently that will allow him to resume displaying the banner.

Under the settlement, landlord Mitchell Shapiro will allow tenant John Stout to display the 3' by 5' rainbow-striped flag as long as it does not protrude beyond the perimeter of his apartment. Shapiro, who recently assumed management of the building, told stout he had a policy against signs or political placards on the outside of the building. Stout complained that the policy violated his constitutional right to free speech and violated a city ordinance barring discrimination on the basis of sexual orientation.

#### A Common Bond for G/L Jehovah's Witnesses

A national support network based in Pittsburgh has been established to benefit former Jehovah's Witnesses who are gay or lesbian.

Known as "A Common Bond" the group seeks to unite in a spirit of healing gay ex-Jehovah's Witnesses suffering the stigma of being excommunicated from the faith because of their sexual natures.

Unlike some religions who condemn homosexuality but reluctantly welcome the homosexual, Jehovah's Witnesses tolerate neither. Their governing body, Watchtower Bible and Tract Society of New York, incorporated, excommunicates, or disfellowships, thousands of Jehovah's Witnesses each year for offenses ranging in severity from using tobacco to disagreeing with the sect's doctrines. An estimated seventy percent of the total are ousted for reasons of sexual immorality. But, according to Dan Restld, a former third-generation Jehovah's Witness and founder of "A Common Bond." it doesn't stop there.

"The Watchlower Society requires its members to shun disfellowshipped witnesses and treat them as dead." he explained. "They are so adamant about this that Jehovah's Witnesses who communicate with former members do so at the risk of being ousted themselves."

Restid further explained that many people who have grown up as Jehovah's Witnesses find themselves with few friends when they leave the Watchtower Society.

"All our lives we were taught that only Jehovah's Witnesses will survive the coming end of the world and that if we socialized with people who weren't Jehovah's Witnesses we may be exterminated along with them."

"A Common Bond" does not subscribe to any particular belief system. Some former witnesses remain sympathetic to the Watchtower's teachings while others have joined different churches or remained neutral.

Restid was on the verge of suicide when he voluntarily left the Witness in the spring of 1985.

"Although It has meant alienation from family and many life-long friends, it has been worth it," he recalls: "I'm at peace with myself. I now have a sense of self-worth and a treasury of friends. I've experienced a remarkable renewal."

He recently had the opportunity to tell his story in Revelations: A Collection of Gay Male Coming Out Stories released last fall by Alyson Publications of Boston.

# **Billy Sipple Dies**

SAN FRANCISCO - On September 22, 1975, Billy Sipple, Gay ex-marine and disabled Vietnam veteran saved the life of then president Gerald Ford by knocking away the .38 caliber revolver of Sara Jane Moore who was about to shoot the president.

On February 2, 1989, Sipple's decomposing body was found in his apartment in San Francisco; he had died of natural causes, alone.

The resultant publicity from the lifesaving and the fact that the papers had described him as a prominent member of the Gay community had permanently estranged him from his family to the extent that he was not welcome at his mother's funeral. He had sued several newspapers for invasion of privacy and lost. His case has become a classic for law students, and mentioned in one movie, Absence of Malice.

"The guy died in pain, with a bottle by his bed. That's pain. That's need for anesthetic," stated John Wahl, his lawyer in the privacy cases.

## Skinheads First to be Tried Under New "Hate" Law

Three members of a "skinhead" gang from Huntington Beach, California will be the first persons to be tried under a new california law which makes it a civil offense to harass people because of their sexual orientation.

The three men also face charges of attempted murder, assault with a deadly weapon, and inflicting bodily injury resulting from two other recent attacks on gay men in Laguna Beach.

The Orange County District Attorney's office claimed that the skinheads went to Laguna Beach expressly to beat up on gays.

"We're sending a message that you cannot come to Laguna Beach and attack someone, and that if you do, you will be caught and go to jail," said openly gay City Councilor Robert F. Gentry.

# Poppers Outlawed

A new federal statute outlawing the sale, production and distribution of any isobutyl nitrite product (poppers) quietly went into effect on February 15. The new law means that the popular "room odortzers" will no longer be available to the public in any state.

The measure makes illegal "all consumer products used for inhaling or otherwise introduced into the body for suphoric or physical effects." The ban on poppers was included in the Drug Omnibus of 1988, which was signed by Pres. Reagan last November. It provides for civil and criminal penalties as mandated in the Consumer Protection Safety Act.

Reaction to the prohibition against poppers was mixed. Nationally some AIDS activists halled the new law, noting that it has long been believed that poppers harm the immune system.

Popper manufacturers have indicated they plan to introduce another product similar to butyl nitrite within the next month. Propyl nitrite is the compound which they will market. It is not covered by the federal law.
