As a long-time member of the Chorus, I can tell you how you — our audience — affects us: a big audience gives us lots of adrenalin when we come out (and I mean COME OUT both ways) on stage. Our spirits, energy, and singing is better, and the audience goes home and tells their friends about the great time. (Ask any Chorus member about the feeling when 1,200 people gave us a standing ovation in Seattle.)

Conversely, seeing only a few people in the audience can be a major letdown, and it negatively affects our performance.

Less energy, a lower performance level, less for the audience to "ooh" and "aah" about, less for the audience to tell their friends about. As another example, how about the JEB presentation at U.S. West? It brought tears, smiles, and pride to those of us there. It was a national-quality production, presented RIGHT HERE in Omaha. And it was FREE! But the audience was not large.

Just once, JUST ONCE, I'd like to see a crowd the size of a Saturday-night bar crowd at one of these non-bar events. It's done in other cities, but we apparently haven't found the "magic formula" in Omaha or Lincoln yet. (This year, the Pride Week committee even went to great trouble to carefully schedule each event so it wouldn't conflict with the other.)

No more excuses. Let's put Gay and Lesbian Community events near the top of our personal calendars. ▼

I remember going to Coronation that year, and marveling at the magic that night created. I had never seen that many gay men and women outside of a bar before. I had thought at the time that the only way I could meet people "just like me," was in one of the four drinking establishments in our city. So many things were new to me then: cruising, drag queens, leather, you name it. That night people told me more about the Imperial Court and what it did; the organizations that it raised money for, the activities that it sponsored throughout the year. And I thought, what a great idea, now I have a group to belong to that's not into the petty bitchiness I had found in the bars. A place to go to actually help the gay community grow and prosper.

That was two years ago. And just like growing up, and realizing that nothing is ever what it seems, I have seen this organization digress into a rag-tag collection of personalities running amok, each fending for their own idea of how things should be run. I have seen vital people leave the court due to inept discussions based on personal whims and reputations. I have seen people shot down from their good work due to mistakes all of us have made at one time in our lives.

Sure, the good work is still there. Money is still being raised, and functions still happen. But at what cost? All a facade is, is just that, a facade. Now is the time for those of us who have thought that there must be more to "gay life" than scenes and situations such as these to speak out. All we have is ourselves.

We are sorry that the organization of T.W.O. does not feel that we serve the purpose of the Gay/Lesbian community, but please note the financial records of ICON and ICON/PWA (the latter being an organization founded by ICON).

The ICON board is more than willing to meet with T.W.O.'s membership to discuss differences and to work with them. It is vitally important that we do so during this time of fighting for Gay/ Lesbian rights.

Last month I went to one of those intimate, little dinner parties and met my
heart throb (Thump! Thump! Be still my

A week after the party, I finally got on my feet and called the host and begged her to tell me a few of the recipes. We had started the evening with peach margaritas and guacamole.

Here is her recipe for GUACAMOLE 2 ripe avocados (about 1 1/2 pounds) 1/4 cup finely chopped onion 1 Tbl finely chopped chili peppers 1 1/2 Tbl white vinegar 1 tsp salt 1 medium-sized tomato, peeled

Remove pit and peel avocados. Mash with potato masher, Add onion, chili pepper, salt, and vinegar; mix well. Put into a plastic bowl and freeze. To serve: Thaw guacamole, add finely chopped tomato and mix together. Serve with tortilla chips or raw vegetables. If you have a food processor, chop the onion and chili pepper in the bowl, add salt, vinegar, and avocado and process to a puree. Freeze as mentioned above.

Dinner consisted of grilled chicken thighs, a vegetable trio of snap peas, red pepper, and zucchini. The starch was a delightful orange flavored rice, served in orange cups. Dessert was a masterpiece — ALMOND TULIPS WITH STRAWBERRIES, WHIPPED CREAM, AND STRAWBERRY SAUCE!

STRAWBERRY SAUCE

4 cups fresh, hulled strawberries

1/2 cup water

1/2 cup plus 2 Tbl granulated sugar

4 tsp cornstarch

2 Tbl orange flavored liqueur

In a saucepan combine strawberries, water, and sugar. Cook over medium heat, stirring constantly, until the sugar dissolves and the berries start to soften. Turn the heat up a bit, and bring the mixture to a boil. Boil for about 4 minutes, until the strawberries form a puree. Strain the mixture through a sieve into a bowl. In the saucepan, make a paste using a small amount of the strawberry liquid and the cornstarch. Add the rest of the strawberry liquid and cook over medium heat, stirring all the time, until the mixture comes to a boil. Boil one minute. Strain this thickened mixture through a sieve into another bowl and let cool to room temperature. Stir the orange liqueur into the sauce and refrigerate until 30 minutes before serving.. This sauce can be placed on the plate under the tulips to form a pool, or poured over the tulips.

ALMOND TULIPS

1/4 cup softened unsalted butter

1/2 cup powdered sugar

1 tsp almond extract

egg whites from 2 large eggs, room

temperature

1/4 cup flour

1/3 cup blanched, sliced almonds, toasted

lightly

Preheat oven to 425 degrees

In a bowl cream the butter, add the sugar and beat until fluffy. Add the egg whites, and almond extract and beat for 5 to 10 seconds, or until smooth but not frothy. Sift the flour over the mixture, sprinkle the almonds over the mixture and gently fold it all together. The batter will be a bit lumpy. Spoon 1 1/2 Tbl batter onto greased baking sheets and with the back of a spoon which has been dipped into cold water spread batter into 5 inch rounds. Bake 5 to 6 minutes, or until the edges are a golden brown. Let the cookies stand for about 30 seconds, until they are just firm enough to hold their shape. With a metal spatula transfer each cookie to a glass bowl and pinch the four sides to make a tulip shape. If the tulips

become too firm to remove from the baking sheet, put them back into the oven for a few seconds to soften. Let the tulips cool on racks until ready to use. Cut up 3 cups of strawberries and make some whipped cream. Just before serving, put the tulips on dessert plates, fill the tulips with strawberries and add a generous dollop of whipped cream. And don't forget the super strawberry sauce. Now, I've got to get off my feet and back to Lief. See you next month.



PRIDE WEEK KALEIDOSCOPE

The 1989 Pride Week activities held something to interest almost everyone. As the community turned out to support those activities, we had the chance to make new friends, renew old acquaintances, and to strengthen the bonds within the Gay and Lesbian community.

The festivities began with the traditional pomp and circumstance of the Imperial Court Coronation. Breaking with tradition, Coronation was held at The Max as an audience of over 200 saw Joe, Forte de Sade, and Deb crowned as the new monarchs. On Sunday afternoon, 45 persons gathered at Lowe Avenue Presbyterian Church for an Ecumenical Worship Service featuring participants from six organizations serving the spiritual needs of the Gay and Lesbian community. Tears came to many during an emotionladen reading of "I Am What I Am" by Kathy England of Parents and Friends of Lesbians and Gays.

P-Flag participation was notable throughout the week's events, but only a few members of the Gay and Lesbian Community attended the open forum conducted by P-Flag on Monday night. Those who attended participated in an exercise specific to developing pride in one's self and in the community.

Tuesday night took 70 people to U.S.

West to see and hear the presentation by
Joan E. Biren (JEB) on the 1987 March on
Washington, "For Love and For Life",
JEB's challenge to our community was to
join together and stand up for our rights.
Her inspiring presentation, brought to
Omaha by the Employee Association of
Gays and Lesbians of U.S. West
(EAGLE), encouraged several members
of the Pride Week Committee to begin
discussing activities to recognize National
Coming Out Day in October.

Metropolitan Club opened its doors to the Gay and Lesbian community as representatives of over a dozen organizations took the stage to tell the group assembled just what their particular organization offered to the community. Over half of the 50 persons were attending Metro Club for the first time.

Thursday night was the bar night with pamphlets displayed from several organizations at each of the bars. Hardy souls from River City Mixed Chorus and the UNO Gay/Lesbian Student Group took to the bars and sold Pride Week buttons to all those who crossed their path. (If you happened to be missed, contact The New Voice. We have just a few buttons left.)

We got better acquainted with the UNO student group on Friday night as they hosted a movie night on the UNO campus. There was good natured rivalry over which television would be playing the loudest until a tragedy struck — 3/4ths of the way through, the tape of "I Heard the Mermaids Sing" died and could not be revived. Those of us who had chosen to see "Maurice" sympathized but continued watching.

Saturday brought the River City Mixed Chorus to the stage for their summer concert "A Little Travelin' Music". The selections challenged the chorus members as they once again demonstrated their commitment to vocal excellence; however, it was the arrival of the seven "dwarfs" (aka the 6 shortest chorus members and the tallest member trying to think short) which enchanted the audience. Our hats are off to all the dedicated members of the chorus and to Sam for the buffet and hospitality enjoyed at the after concert party.

At long last, on Sunday afternoon, people gathered for "the event billed as the 1989 Gay/Lesbian Pride Parade". 110 people joined together to walk from 20th and Farnam to Turner Park, wearing arm bands with pink triangles, carrying signs with such slogans as "Closets are for Clothes" and "Silence=Death". While spectators were few, people driving by as they left the Summer Arts Festival rolled down their windows to shout encourage-

ment, to jeer, or to stare in fascination. The police were cooperative and allowed the parade to proceed at an orderly (even leisurely) pace. Reporters waited at Turner Park to conduct interviews with those willing to appear on television or to have their names in print. Our hats are off to JoJo, Pat, Terry, Vince, and Dick for speaking so eloquently for our community.

The week's excitement wound down as a hundred people remained to picnic at Turner Park. At the final event of the 1989 Pride Week Activities, 30 people joined with Reverend Matthew Howard of Metropolitan Community Church of Omaha to celebrate Vesper Services in the Park. The New Voice would like to extend our thanks to the news staffs of KMTV and KETV for their coverage of the Pride Parade. We would also like to thank the Omaha World-Herald for providing coverage which, if not totally without bias, certainly far exceeded the coverage given in previous years. A special salute is extended to Carol Schrader for her "Viewpoint" program of June 18 which featured an interview with Rev. Matthew Howard of MCC-Omaha, Wes Perry, chairperson of the 1989 Gay/ Lesbian Pride Week Committee, and Terry Sweeney, Co-Chairperson of EAGLE. Her interview was fair, unbiased, and professionally done.

Letters of invitation were sent to 43 political office holders in Nebraska, including U.S. Senators Exon and Kerrey, Representative Hoagland, Governor Orr, Mayor Morgan, the City Council, the County Commissioners, and the State Senators from Omaha and Lincoln. None of those invited chose to attend any of the week's events, though Mayor Morgan did agree, at the request of EAGLE, to proclaim the week of June 19-23 "Gay/ Lesbian Awareness Week". So, Pride Week '89 is all over, but plans have already begun for 1990. After all, the Gay '90's are coming and we plan to be there to celebrate the occasion. ▼

CHORUS SHARES AT INTERNATIONAL FESTIVAL

"A Spirit with a mighty voice is a Spirit mighty strong."

Those words are from "Come Out Singing!", the closing anthem of the Third GALA (Gay and Lesbian Association of Choruses) Festival, held in July in Seattle, Washington.

It would be very difficult to express the joy, sharing, and love my fellow chorus members (River City Mixed Chorus, Omaha) and I experienced this past week at the GALA Festival. It was like walking through the looking glass.

The Festival—held every three years—brought together some 2,500 representatives from 48 of the 70 men's, women's, and mixed choruses making up the GALA network across the U.S. and Canada. The event was held on the University of Washington campus, which became a virtual "gay/lesbian mecca" for the seven days. (You KNEW everyone else was "one", too, and you could be yourself. That's quite a big deal to those of us from Nebraska's closeted communities.)

From the San Francisco Gay Men's Chorus, the "granddaddy" of the gay men's choral movement, to choruses as new as a year old, friends met, listened, sang, and became immersed in a community of gays and lesbians joining in song. Everyone made new friends, some became reacquainted with friends from past events, we all heard great music, and we came home exhausted, walking on clouds. It's also safe to say each chorus returned with ideas for future concerts.

River City—as did most participating choruses—performed our own 25-minute set of music on stage for the other singers. It's a terrific feeling to get a standing ovation from an audience of 1,200! (Our director, John Kelly, had the unique opportunity to direct on stage twice, since he also directs the Des Moines Men's Chorus, another GALA member.)

At the end of the week, for the finale, choruses joined together to sing newly commissioned works, including music by composers Bernice Johnson Regon, Conrad Susa, Janice Giteck, and Paul Patterson. Men's, women's, and mixed choruses each sang several of these new musical works. After that, we all went outdoors, became a chorus of 2,500 (!), and sang the Anthem for the Festival, "Come Out Singing!" by Holly Near.

GALA is one of two national vocal music "networks" for gays/lesbians (the other being the Sister Singers Network.) In addition to the Festivals, GALA services to its members include director and leadership conferences, information networking on topics from incorporation to dealing with AIDS, and vast music resources to share pieces and to commission new works. Music is a great way to celebrate for ourselves, for our gay communities, and for the larger community. The next GALA Festival is scheduled for July, 1992, in Denver. Our own chorus, the River City Mixed Chorus, is proud to have been a part of this Festival. We encourage more people to get involved with our chorus. Call 341-0763, or write Box 315, Omaha, 68101. *

UNL COLAGE MAY RECEIVE FUNDS

in the 1989-90 school year, UNL Committee Offering Lesbian and Gay Events was denied the requested amount of \$749 in student fees due to "homophobic" administrators, student leaders, and morality. As a result of a meeting between Vice Chancellor James Griesen, UNL Attorney, Dorothy Walker - an NCLU Cooperating Attorney and COLAGE members, Vice Chancellor Griesen added \$1000 to the University Program Council's committees: Talks and Topics (\$800) and Special Events(\$200). COLAGE could then apply to cosponsor a program with one of those committees. The Vice Chancellor was not able to guarantee that COLAGE would receive any of the funds. Although an agreement has been reached, COLAGE may still retain the right to sue the University. The Committees don't have to give the COLAGE the money, even though they probably will.

Sounds like homophobia to me! As chairperson of UNL Gay and Lesbian Alumni/ae Association, Inc. and cofounder of the Gay and Lesbian Programming Committee (formerly COLAGE), I think that the Vice Chancellor is placating and fraudulent in promising the COLAGE funds put into two other committees. Why doesn't he put the money where it belongs? He has been known to play politician before! By not putting the money into COLAGE, he is being homophobic!

SPECIAL U.S. POSTAL STAMP CANCELLATION RECOGNIZES GAY PRIDE

New York, NY — At the request of the Gay & Lesbian Alliance Against Defamation (GLAAD), the U.S. Post Office issued a special stamp cancellation (featuring art work designed by prominent artist Keith Haring for Heritage of Pride, and reproduced below) that was available at the June 25 lesbian and gay pride march in New York City. The cancellation was issued in conjunction with 20th Anniversary of the Stonewall uprising, when patrons of a gay bar fought back against police harassment and launched the modern lesbian and gay liberation movement.

When apprised of the cancellation, Senator Helms, castigated the Post Office on the Senate floor for celebrating "perversion." He attacked the lesbian and gay movement for trying to subvert "American values."

Craig Davidson, Executive Director of GLAAD, responded "The nastiness of Sen. Helms' remarks reveals the desperation of a one who knows he is losing his battle to deny Americans the truth that lesbian and gay people are decent, loving, and proud." He added, "The Post Office regularly celebrates the cultural diversity of America with special stamps and stamp cancellations, and that is exactly what they have done here. While Sen. Helms wishes a "pox" on postal officials who approved our cancellation, we thank them for their fairness — the most fundamental of American values.

ADMINISTRATION CHANGES AIDS IMMIGRATION POLICY

The Bush Administration announced it is changing its immigration policy to allow some foreign visitors who have AIDS or HIV into the U.S. for a limited amount of time.

Under the policy change, HIV-positive persons will be admitted into the country for up to 30 days to attend scientific conferences, obtain medical treatment, conduct business, or visit family.

The policy change comes in response to an international uproar caused by the detention of a Dutch city official for five days last April by the U.S. Immigration and Naturalization Service (INS).

The official, Hans Paul Verhoef, came to the U.S. to attend the Lesbian and Gay Health Foundation Conference/National AIDS Forum in San Francisco. Following a hearing, local immigration officials ruled that Verhoef could enter the country and attend the conference, but INS headquarters in Washington, DC, blocked that decision. Finally, an immigration judge ordered Verhoef admitted on bond. The incident sparked widespread criticism of U.S. policy, which violates international standards formulated by the World Health Organization with U.S. participation. It also raised concerns about plans to hold the Sixth International AIDS Conference next year in San Francisco.

Organizers of the Fifth International AIDS Conference in Montreal in June were also concerned that thousands of foreigners, many with HIV infection, might be prevented from travelling through the U.S. on their way to or from the conference. "The United States does not import AIDS," said Robert Bray, Human Rights

Campaign Fund communications director.

"We have the largest number of cases in the world. Restrictive and paranoic immigration policy does nothing to control the epidemic. It only contributes to the spread of AIDS by limiting the free exchange of information and discouraging infected people from seeking testing or treatment."

"The Administration has recognized the global embarrassment that would result if the U.S. could not host international scientific AIDS meetings that included people with HIV infection," said Vic Basile, Executive Director of Human Rights Campaign Fund (HRCF).

Basile promised HRCF would "continue lobbying the Administration and Congress for free travel and immigration rights for persons with HIV infection." ▼

John Kelly Gentry, Jr.

John Kelly Gentry is considered armed and dangerous. He also uses the aliases William Veith, Kung Fu, and Jim.

F.B.I. Alert!

The Federal Bureau of Investigation has asked the New Voice of Nebraska and the Gay/Lesbian Community to help them locate John Kelly Gentry, Jr., who is charged with murdering two people.

In 1982, John Kelly Gentry, Jr., was convicted of felonious assault after he attacked and crushed the Adam's apple of a homosexual man with whom he had lived for 11 months. While serving this sentence, Gentry befriended Barbara Gerber, a civilian cook at the Toledo, Ohio, jail.

Upon his release from jail, Gentry moved in with William Veith, a known homosexual, but commuted to Barbara Gerber's home in Monroe, Michigan, where he also maintained a residence.

On April 12, 1983, Barbara Gerber's nude body was found in her home. Her throat had been slashed and an attempt made to burn down the house. The next day William Veith's body was found in the basement of his business. He had been bludgeoned to death with the blunt end of an axe.

DONALD KOWALSKI RESIGNS AS GUARDIAN

On June 12th, Sharon Kowalski moved to Trevilla of Robbinsdale, an extended care facility near Minneapolis, MN, that provides rehabilitation and transition to less structured care for brain-injured persons. The move is the first step in the rehabilitation plan recommended by Kowalski's therapists at the Miller-Dwan Medical Center in Duluth, as reported to St. Louis County District Court Judge Robert V. Cambell. Meanwhile, Kowalski's father, Donald Kowalski, has requested that he be removed as her guardian.

Sue Wilson, Thompson's attorney, said Donald Kowalski has asked Campbell to terminate his guardianship of his daughter, "because if he can't do it his way, he doesn't want to do it." Campbell has specified that he will not appoint Thompson as guardian. His selection of a third party guardian is pending.

Prior to the move to Trevilla, Kowalski spent several weeks at the Ebenezer Caroline Center in Minneapolis, awaiting a vacancy at Trevilla.

In their September evaluation report the Miller-Dwan doctors wrote, "Ms. Kowalski's level of social and psychological well-being is quite low related to the difficulty of the social situation as well as the chronic nature of her placement in a nursing facility." Their medical report, presented to Judge Campbell in March, recommended that Kowalski move immediately to Trevilla. While there, they wrote, she should prepare "to maximize independent living skills by completing the Transitional Living Program at Courage Center." Finally, they recommended that her ultimate goal be "to return to premorbid home environment." The cover letter to Cambell from Dr. Matthew Eckman stated, "We believe Sharon Kowalski has shown areas of potential and ability to make rational choices in many areas of her life. She has consistently

continued from page 19 indicated a desire to return home, and by that means to St. Cloud to live with Karen Thompson again."

Donald and Della Kowalski have refused to attend any medical or legal meetings regarding Kowalski's care since they saw the March report.

While at the Caroline Center, Kowalski participated for the first time in a medical staffing conference about her care, and received a pass to attend a barbecue with Thompson and other friends. It is expected that her medical team at Trevilla will be aggressive in recommending further activities that allow her to leave the facility.



NGRA BEATS DAN-NEMEYER IN COURT GAY LIBEL SUIT TOSSED OUT

San Francisco A Superior Court judge in Sacramento sustained the demurrer of the Bay Area Reporter (B.A.R.), a gay newspaper published in San Francisco. In a libel suit brought against it by Rep. William Dannemeyer (R-Orange County, CA).

Dannemeyer alleged in his lawsuit that B.A.R. reprinted a memo which said, in part, that Dannemeyer was "foaming at the mouth", "a live grenade", and "far to emotional to do any good" to the Republican Party with respect to the AIDS issue. The court held that the B.A.R. article was protected under the California "Fair

SOLDIER WINS REINSTATEMENT TO ARMY

Because of his 14 years of exemplary military service, openly gay sergeant Perry J. Watkins must be reinstated to active duty by the U.S. Army, a San Francisco federal appeals court ruled.

This latest decision, however, did not rule on the broad constitutional issue of equal protection for homosexuals in the military, much to the disappointment of gay and lesbian observers.

Rather, the court ruled on narrow issues, chiefly that of the Army's responsibility to be consistent with its own regulations. The Army repeatedly broke its own rules by retaining and reenlisting Watkins for 14 years despite the fact that its own record indicated that he is gay going back to when he was drafted in 1967.

Spending a significant amount of time recounting Watkin's outstanding service record, the court ruled that the military's general band on homosexuals as unfit for service may not be applied in the Watkins case.

Despite the Court's sidestepping of the larger issue (equal protection), the ruling is considered an enormous first step because it shatters the stereotype of homosexuals in the military. The Court was not swayed by the military's argument about homosexuality being incompatible with the service.

It is not yet known whether the Army will appeal this decision. Watkins, however, indicated that if the ruling stands, he will re-enlist.

NGLTF CONFERENCE

Continuing the innovative programming that characterized its annual conference last year, the National Gay & Lesbian Task Force (NGLTF) Creating Change conference will be held from November 9-12, 1989 in the greater Washington area.

The Conference will begin on Thursday, November 9 with a special pre-conference Training Institute focusing on fund raising for gay and lesbian organizations. The faculty for the Institute will include foundation directors, development and direct mail experts, and activists from organizations of different sizes and budgets.

On Friday the luncheon keynote address will be delivered by former Staff Sgt.

The NGLTF Creating Change conference is committed to being accessible to all organizations and activists.

Perry Watkins, who recently won a federal appeals court decision ordering the Army to allow him to reenlist despite his homosexuality. The experience of gay and lesbian service members will be the subject of a Friday afternoon demonstration at the White House calling for an end to the military's discriminatory policy. On Saturday the luncheon keynote address will be delivered by longtime gay activist, media critic and author, Vito Russo. Russo is author of Celluloid Closet, a book on the treatment of gay and lesbian issues in Hollywood and in the media. The keynote address on November 12 will feature Arkansas-based lesbian feminist activist Suzanne Pharr. Pharr is author of "Homophobia: A Weapon of Sexism". She is founder and staff member of The Women's Project.

The NGLTF Creating Change conference is committed to being accessible to all organizations and activists. CENTER KIDS FROM THE CENTER VOICE

When the Center's (the Lesbian and Gay Community Services Center in New York City) contingent marched down Fifth Ave. on Lesbian and Gay Pride Sunday (June 25), one group in that contingent stood out parents and their children. That is gay and lesbian parents and their children, participants in the Center's new program called Center Kids.

Center Kids started last year with informal get-togethers of men and women-couples and singles- who had embraced parenthood after coming out or were interested in doing so. They discussed parenting

issues, adoption, and alternative insemination. They also shared concerns about the need to expose their children to positive social experiences with other children who also have gay or lesbian parents.

Word about the meetings spread fast. The mailing list grew longer, living rooms tighter, and eventually the Center seemed the logical hub for meetings and social events. Discussions with the Center President David Nimmons led to an approach to the Board of Directors.

In the winter the Center welcomed Center Kids as its newest program for the lesbian and gay community. As a social program, Center Kids primary focus is on the children, giving them, in Wayne Steinman's words, "a gay-supportive environment" through various activities with other children and their lesbian and gay parents.

The program is also educational and informational. Now that it's based at the Center, it will sponsor workshops, support groups and forums devoted to legal and other issues that concern parents and prospective parents.

Mother of Metropolitan Community Church Founder Dies

Edith Allen Perry, 73, died of cancer in Los Angeles on May 17. She was the mother of Rev. Troy D. Perry, Founder and Moderator of the Universal Fellowship of Metropolitan Community Churches.

From the earliest days of Metropolitan Community Church, she was one of its strongest supporters and faithful volunteer. She worked closely with Troy for decades, and in 1980 was named "Women of the Year" by Christopher Street West, Los Angeles' Gay Pride organization. As the first heterosexual person to receive this annual award, she was honored for her outstanding contribution to the Lesbian and Gay community.

Mrs. Perry was born September 11, 1916 in Jasper, Florida. She is survived by five sons: Troy, Eugene, Jimmy, Jack and Jerry, and their families. Funeral services were held May 25 at Forest Lawn Cemetery in Los Angeles. A memorial fund has been established for the Edith Allen Perry Library at UFMCC's Samaritan College in Los Angeles.

Comment" doctrine and the First Amendment. Leonard Graff, NGRA Legal Director, said, "William Dannemeyer can't use frivolous lawsuits to intimidate the gay press. The courts have consistently held the First Amendment protects the right of newspapers to publish opinions about public figures." The court also held that the statements in the reprinted memorandum were statements of the author's opinion, not literal statements of fact. Thus, although Dannemeyer was granted leave to amend his complaint, the effect of the court's ruling is that there is nothing he can allege that would make the statement libelous. V


FBI FINDS YOU UNFIT

A federal district judge recently ordered the Federal Bureau of Investigation to overhaul its system for promoting racial and ethnic minorities, finding that the agency's employment decisions have long been marred by significant discrimination. Unfortunately, the decision does not address the FBI's long history of discrimination against hiring and promoting gays and lesbians.

An excellent article in Parade, the national Sunday newspaper supplement, recently took the FBI to task for discrimination against gay people. "How ironical," wrote Lloyd Shearer, "when one realizes that J. Edgar Hoover may well have been gay himself and that police departments throughout the country are slowly beginning to hire homosexuals for training."





Daley Leads Gay Parade in Chicago

Chicago — For those who remember times when being gay meant secrecy and fear, Sunday's sight reminded them how much life has changed in 20 years.

There was Mayor Richard M. Daley in a bright blue T-bird convertible, leading the Gay and Lesbian Pride

Parade.

He is the first mayor ever to participate in the annual event. Titled "Stonewall 20: A Generation of Pride," the parade was part of nationwide celebrations of the birth of the gay rights movement two decades ago.

Police officers marched several groups behind the mayor's car. That also was a first, organizers said.

"It's really something, really something to see the police in the parade, and the mayor," said Jon Legris, 37, a jeweler.

Some gay activists credit Daley, then a mayoral hopeful, with helping to rally crucial City Council votes in December that led to passage of a local human rights ordinance.

As Daiey shook hands with onlookers, he said: "They asked me to participate in their parade, and I'm very happy to be here. They are important people to the city, and I get good support from them."

Marches in cities throughout the nation commemorated the June 27, 1969, riot at the Stonewall Inn in New York City, where gay bar patrons for the first time fought back during a routine police raid.

More than half a million people marched Sunday in New York; Minneapolis; West Hollywood; Birmingham, Ala.; Lansing, Mich.; and Chicago, The Associated Press reported.

In San Francisco, a cheering crowd estimated by organizers at 300,000 people and by police at 140,000 turned out for the 19th annual Lesbian-Gay Freedom Parade, The parade was led by a scantily clad women's motorcycle contingent.



Fifth Year for Parade

In Omaha, 110 Join in Downtown March

About 110 people walked from 20th and Farnam Streets to Turner Park Sunday evening in an event billed as the 1989 Gay-Lesbian Pride Parade.

Organizers said this was the fifth year the homosexual and lesbian community has held a parade in downtown Omaha to celebrate Gay-Lesbian Pride Week, which ended Sunday.

The marchers chanted, "Human rights now," and carried signs and banners. One sign said, "One in 10, we are the invisible minority." Another said, "Closets are for clothes," and a third said, "God is greater than AIDS."

Pink Triangles

Some marchers wore armbands marked by pink triangles, a symbol they said homosexuals were forced to wear in Nazi Germany.

Less than a dozen spectators watched from sidewalks along Farnam Street from 20th to 30th Streets. Marchers stayed in the right-hand traffic lanes of westbound, one-way Farnam Street while the usual automobile traffic was permitted to pass on the left.

Occasional cheers and jeers came from the passing cars.

Three police cruisers escorted the paraders.

The marchers gathered at Turner Park for a short speech by organizer Pat Phalen, then held a picnic.

Phalen said the parade had grown from its beginning five years ago when 60 people marched, some wearing masks or paper bags to hide their identities.

"Next year bring another friend. It's OK to be gay in Omaha, Nebraska," be told the marchers.

There were no masks or paper bags evident at this year's march. Vince Percy, who carried a flag at the front of the parade, said the lack of disguises showed that marchers had more selfconfidence and less fear about their employers' or families' reactions to their being homosexual.

'Legitimate Relationships'

Phalen said this year's march commemorates the 20th anniversary of an incident in New York City, when police raided a bar known as a gathering place for homosexuals, and the patrons of the bar fought back.

Marcher Terry Sweeney said a major issue among homosexuals currently is over the legalization of their same-sex partnerships and living arrangements. "We want our relationships legitimized," he said.

Groups that carried banners in the parade included the Metropolitan Community Church, a University of Nebras-ka-Lincoln group called the Committee Offering Lesbian and Gay Events and an organization of U S West employees called the Employee Association for Gays and Lesbians. Members of that group said U S West has a policy that it will not discriminate against homosexuals and Jesbians.
