As The New Voice enters its third year next month our goals and purpose remain the same. As a voice of the community we respect all businesses, organizations, and individuals. However there is constant bickering and back-stabbing among the different factions. It is easy to be critical. It is more difficult to be actively involved and serve others in a positive manner.

**Lesson A- HOW TO DESTROY AND FRAGMENT THE GAY/LESBIAN COMMUNITY.**  
1. Create rumors about individuals, organizations, and businesses to make them look bad. Believing the rumors can be even worse. (The New Voice has been accused of being both pro-pornography and anti-pornography).

2. Give little or no financial backing to organizations. Organizations are the life-blood of the community and their existence is based on our support.

3. Businesses who use the gay community to make a profit. Recently a bar owner told me the only reason he schedules fund-raisers is to make a profit. He showed only a superficial interest in helping the community.

4. Creating feuds and factions. I have seen two major events planned on the same evening. Some performers have told me that they are unable to entertain at certain clubs.

5. Starting one new organization to hurt another organization.

6. Trying to sabotage the efforts of a group or organization.

Lets improve our community through communication and striving to work together. You will find the results to be more fulfilling.

My greatest "burn-out" is due to my inability to fulfill my responsibilities to The New Voice, as I see them. Granted, often I would like to run off to a mountain retreat screaming, BURN-OUT, no one wants to run off with me, and my concern for the magazine and the gay community will not allow it--so you're stuck with me--just in a less "official" nature.

## EVENTS

### Spirituality and Homosexual Persons -A Dialog Conference

A precedence-setting conference exploring being gay/lesbian and being Christian will be held in Lincoln, February 28-March 1 at the Unitarian Church, 6300 A Street. Keynote speaker is retired United Methodist Bishop Melvin Wheatley who sparked controversy in 1981 when he appointed an openly gay minister to a Denver church. Since that time, Bishop Wheatley has been a vocal supporter of gay and lesbian Christians. Other leadership includes three persons from National Affirmation: United Methodists for Gay and Lesbian Concerns.

The Conference is entitled "Spirituality and Homosexual Persons: A Dialog Conference." Six workshops are planned: Reconciling Congregations, Biblical/Theological Understandings, Counseling Issues, The Church and AIDS, Family Issues, and the Church and Homophobia.

The Conference is planned to help participants explore spiritual dimensions of homosexual experience. It is aimed at gay, lesbian, and bisexual Christians, other church members and leadership (clergy and lay) and other spiritual searchers and seekers. Cost is \$20.00 (\$10.00 for students).

The Conference has been planned cooperatively by a 3-denomination Joint Strategy and Action Team (JSAT) on Ministry with Homosexual Persons and Their Ministries of Nebraska. The three denominations are The United Methodist Church, The Christian Church (Disciples of Christ) in Nebraska, and the United Church of Christ. Also part of the planning has been Community of Grace, an Interdenominational Worshiping Community of Lesbians, Gays, and Others Identified With Us.

Other Co-Sponsors include the Nebraska Conference Board of Church and Society, and the United Church of Christ Nebraska Conference Shalom on Earth Committee, Lutheran Metropolitan Ministries of Omaha, Ministry in Human Sexuality, and Affirmation. Continued on page 3...





# Gay Pride Week in Omaha

On Thursday, January 9, 1986, representatives from MCC Omaha, Dignity, The River City Chorus, The Page, The New Voice of Nebraska, The Emerald Court, The Stagedoor, The Diamond, The Run, and The Chesterfield bars gathered at The Chesterfield Bar for the monthly meeting of the Gay/Lesbian Organizations and Bars of Omaha.

Constructive criticism was offered in regard to The Page, and several upcoming events were listed for publication. We were reminded that at present, The Page is basically a one-man operation, and everyone present was encouraged to list activities when dates are set--rather than waiting for the deadline.

Discussion centered primarily around plans for Gay Pride Week 1986 and a Gay Pride Parade for Omaha. Those present were in agreement that

Omaha's celebration of Gay Pride Week should be the week of June 15th through 22nd.

Tentative plans include a Gay Arts Fair sponsored by the River City Chorus giving opportunity for members of the Gay/Lesbian community to offer their arts and crafts for sale or display, and a concert would be included by The River City Chorus, and a presentation of two one-act plays on the final weekend of the celebration.

On Sunday, June 29, the celebration will be climaxed by a Gay Pride Parade, which will lead to a candlelight worship service conducted by the religious leaders of our community. Other items being considered include a community-wide pot-luck picnic, a sports tournament, a recognition of an outstanding worker from within the gay/lesbian community of Omaha, a contest prior to celebration to find a logo for the celebration and selling of pins and T-shirts bearing that logo during the week-long celebration, as well as having special events as the various

bars in Omaha.

There is a lot of work to be done yet, and willing workers are indeed welcome to attend our meetings, which are held the first Thursday of each month at rotating locations throughout the city. A well-planned celebration will mean an enjoyable time for everyone from our community. If you have ideas, don't keep them secret until after the celebration and then ask why we didn't have this or that. Gay Unity goes hand-in-hand with Gay Pride.

## Love and Relationships

### Feelings of Love and Devotion

After having marvelled at many spectacular sunsets, been awed by the majesty of the Rocky Mountains, seen the many blue-green hues of the Caribbean Sea; having been spellbound by the morning sun breaking through the fog in a Pacific Northwest pine forest, I am convinced that nothing would be more devastating than losing my sight and no longer having the ability to behold these wondrous sights again.

Doug and I have known each other for eighteen years, and have been lovers for the last seven. We have been to many places around the North American continent together, including a gay Windjammer cruise. We have seen the many breathtaking views that this glorious land has to offer.

Four years ago, Doug's eyesight began to annoy him. Looking at a ledger sheet, the printing would disappear, leaving a greyish, blank sheet of paper in front of him. After shaking his head, the writing would reappear. An appointment with an ophthalmologist showed that he had retinopathy, a condition caused by the hemorrhaging of the blood vessels in the retina, a condition that leads to blindness.

A procedure called laser surgery was begun to arrest the condition, but there were no guarantees that it would be successful. Over a period of a year, he had eleven such

operations, but his eyesight was slowly diminishing, nevertheless.

Small tasks were becoming large problems. The use of a screwdriver was a chore; he couldn't see the slot in the screw without a magnifying glass. Eventually, Doug was forced to resign from work and go on disability. For a long time, he was very satisfied with his new status as a "retired" person.

After several months, Doug registered with a service for the blind, and although reluctant to join in their programs at first, he finally started. The training began at home, with a trainer coming to the house twice a week, and after two months, he was told that he should move to Lincoln to continue his training. This meant we would be separated for about nine months, except weekends, and the painful decision for him to go was weighed very carefully.

There were many doubts flowing through my mind. Most important, would I lose him if he went away for that long? (The male of our species tends to be terribly promiscuous at times.) How could I get accustomed to living alone for that long, and when he returned what changes would have to be made in our lifestyles? It was all so uncertain and frightening. Similar thoughts were running through Doug's mind also.

The decision was finally made, and preparations were at hand to get him situated in his new home in Lincoln. Emotions were extremely high, and both of us were tense. On moving day there was a lot of crying between us. The first week was the most difficult; I felt I should have taken off from work, but I numbly carried on instead.

Evenings were the loneliest, especially at bedtime. This was the period of our day which had always been the most fulfilling. The loving touches, along with our final thoughts of the day, always reminded us of our love and devotion to each other before drifting off into a peaceful sleep filled with content.

Several months have passed since, and instead of the dreaded anticipation of separation, our love has rejuvenated itself and has become stronger than ever before. In his absence, I realized that I needed him more than I previously thought. His strength and wisdom have kept my life on a steady course ever since we met. Before he came into my life, I was never ready to settle down to one job, one man, or one apartment for very long. Flitting off to another adventure somewhere in Never-Never Land seemed to be more exciting to me... The so-many-men-so-little-time syndrome that we all know about.

Maturing with another person through the good times and the bad really does have something to say for itself. I never knew two people could feel as one until I met Doug and experienced life with him through the peaks and the valleys. Yes, there were times that we nearly threw in the towel, but it was his actions that kept us together.

At the Center, Doug learned total self-confidence along with the ability to fend for himself in any situation. Because of his absence, we have learned to love each other in more different ways than we have known in the past. We "feel" our love radiating over the 63 miles that separate us.

When two men, both born of Fire Signs, join together it is a deep and emotional experience. Our love is constantly tested. This experience has been the strongest test of our love and devotion since our joining, and we have endured the tempest. Now that Doug is coming home for good, we can put our lives back together and enjoy each other as if we were new lovers, putting the inexperience of courtship behind us, picking up where we left off, and building an even stronger relationship than we had before.

## FOR CLAYTON


The theme of "What it takes"

## Gay Couples— Dealing with Conflict •

"You did too do it!" "I did not, and I don't want to hear anymore about it!" "Remember the last time you told me that, and then it turned out that you did do it?" "No, but you are always saying things like that and I hate it!" "You hate it, do you? Well, so what? I think you are not very assertive and should loose some weight. You never carry through on any project!" "I'm leaving. This relationship is going nowhere!!" "You always leave instead of facing problems!!"

Conflict! How does it start and how does it end? No two people can live together for very long without some kind of conflict. Each of us has our own style of conflict. Some folks are very verbal and would rather sound like the couple above. Other couples are quiet and rather passive-aggressive with their anger. It doesn't really matter what your style is, as long as it is effective and the problem between you and your partner gets resolved.

We generally get into conflict because we don't like something that our partner is doing. He or she is bugging us. There are many things that we overlook in our relationships, but there are some things that we just can't overlook. When we talk about arguing, the issue does not really matter because we generally use the same style of conflict resolution whether we are talking about the garbage, or monogamy.

I would like to suggest four simple rules to follow to help in bringing a conflict to resolution:

(1) Before approaching your partner, think about why you are angry. Try to tell your partner as clearly and simply as possible what you are irritated about and let him or her know that you want to discuss it.

(2) Set a time limit to discuss the problem. A half hour to an hour is reasonable. Discussions that last more than an hour usually degenerate and end with

a blow-up. Name-calling can release anger, but is not very useful in solving problems. If you are not finished before the time limit, stop the discussion and decide if you want to continue for another fifteen or thirty minutes. I would recommend that you stop the discussion and come back to it at a different time, perhaps the next day.

(3) Once into the discussion, stay in the here-and-now and DO NOT bring up old garbage. (The time limit will help with this.) Once folks have been discussing for a half-hour or so they tend to get tired and forget the point of the discussion.

(4) If you are unable to resolve an issue even after several attempts, you may want to ask a third party to help you. A third party needs to be agreed upon by both partners, however.

There are some conflicts that are really unresolvable. Couples in this situation either decide to live with the situation by agreeing to disagree; or decide not to live together anymore.

I tried to keep the above rules as simple as possible. If you plan to use them to change your current style of conflict resolution, try writing them down and putting them in the place where you usually have your arguments. Changing old habits is difficult and will take some time. So, if you get discouraged, remember that this formula does work. I have used it successfully both with clients, and in my own life. Keep trying, and get some help if you need it. Remember, some issues are not resolvable.

## Dealing with Stress in a Relationship

In last year's February issue, I wrote down a few ideas for adding a little romance to a relationship. This year I want to look at stress --stress not directly related to a relationship but certainly affecting it.

We all have stress factors in our lives: financial, social, personal. We each deal with stress in our own way. But when you're in a relationship, you have to consider how your stress affects your companion and the relationship you share. Ways of dealing with stress when you are "single" may not be useful when you're in a relationship.

Here are some suggestions:

Be sure to communicate. Tell your companion what is causing stress for you. If there are problems at work, for example, share this and your feelings about it. Stress that is kept inside will come out in other ways and in the long-run may prove destructive to a relationship.

Don't be afraid to share. Remember, your companion loves you and cares about you... she/he also knows you and will probably sense when something is bothering you. Don't shut him/her out. Sharing feelings of stress won't destroy a relationship, but keeping them bottled-up can. Allowing your companion to be there for you can be a tremendous experience in love and trust for both of you.

Work together to cope. Usually a companion can lend gentle insight to a stressful situation, not to mention support and encouragement. Because stress affects both people in a relationship, your companion needs to cope with the situation also. Make her/him a part of the process if possible. However, if you need an objective approach as well...

Don't hesitate to get counseling. Sometimes a stressful situation can become more than a person can deal with on his/her own. You can probably tell if the situation merits professional help. Rather than try to handle it on your own, get counseling (even on a temporary basis). If you are comfortable with the idea, you might want your companion to join you. In high stress situations, counseling can make the difference between a momentary, manageable life crisis and tragedy.

In any case, don't let pride or fear keep you from dealing with stress effectively. Don't let it destroy your relationships--life is too short and love too precious.

It was learned later that no arrangements had been made with either bar for housing. The group split with many harsh words and some acts of vengeance. Three of the group moved out on Friday the 10th, and the other two left on Wednesday, the 15th.

Tripping over makeup kits, gowns, and shoes was not the worst part of this encounter. I had been lied to. While with me, no one asked, but helped themselves to what food was in my home, a can of shaving cream was used, a chenille bedspread was soaked and stashed on top of magazines to absorb the ink, and a wool comforter was folded wet to mould, and so far, over \$15 in long distance phone calls have been recorded.

Yes, I have been ripped off beyond the cigarettes which I willingly gave, and rides, etc. It is not the first time and will not be the last. Thank goodness, I have had many good experiences through hospitality. The people that "took advantage" of me did not do so because they were female impersonators, drag queens, or gay. These men have no respect for me or my property--or possibly for themselves.

Yes, I do love my neighbor, and some bad apples will not spoil my ability to love. Not all love is returned or even accepted graciously, but I must continue to love and be hospitable.

## Health

### Is Nonoxynol 9 Safe and Effective

Nonoxynol-9 is a mild soap used in spermicides and various other "feminine hygiene" products to prevent pregnancy and provide protection against sexually transmitted diseases (STD's). Nonoxynol-9 works by bursting the outer protein cap of sperm and various pathogens. In laboratory tests, it quickly and effectively kills herpes, gonorrhea, syphilis, CMV, yeast, trichomonas, and amoebas: most recently, there have been reports that under laboratory conditions, it also kills AIDS virus. This is promising news, however it is not known whether the agent prevents AIDS virus from being transmitted under sexual conditions or whether it is of any use for curing AIDS itself.

Generally speaking, nonoxynol-9 and related soaps are considerably more effective under laboratory conditions than they are in actual sexual use. The two main reasons given by researchers are:

(a) The inert ingredients in spermicides--the foams, gels and creams which distribute the soap--do not always spread evenly or form a suf-

ficient chemical barrier for nonoxynol-9 to kill the pathogens before they can reach uninfected tissue; more importantly,

(b) People often use spermicides incorrectly and only when they "think" a partner is infected.

When used consistently and correctly, spermicides are very efficient at preventing transmission of the common STD's and since they are approved for vaginal intercourse, are an important form of protection to incorporate into a safe sex lifestyle.

It is obviously tempting to use nonoxynol-9 as a layer of prevention against AIDS while engaging in oral sex and anal intercourse. But approach nonoxynol-9 with caution. A few researchers and physicians began to advocate this approach in 1981, but the idea is relatively new, and the research very incomplete. Make sure spermicides don't irritate your skin, your mouth, or your rectum. Consult with your doctor.

Some important points to consider when deciding whether to use nonoxynol-9 products are:

1. Studies show that spermicides used properly and every time a person has vaginal intercourse can provide as much as 94% protection against common STD transmission (remember, we do not know about AIDS). However, these statistics drop quickly to 70% or less effectiveness when not used exactly as instructed on the label.

2. The most effective way to use nonoxynol-9 by far is in conjunction with condoms and carefully following the directions for both. When spermicides are used with condoms, there is a synergistic effect that raises the user effectiveness of each as much as 30% in tests of STD and pregnancy prevention.

3. Nonoxynol-9 spermicides have had a very good safety record for over 30 years, but they have only been tested specifically for human use on skin such as the penis or in the vagina. The FDA upon reapproving these products in 1980 noted that spermicides are regularly swallowed during oral sex, and because of their extremely low toxicity in animal tests of oral consumption, the FDA provisionally concluded that the products are safe when eaten in small quantities by humans. Whether

such products are effective against oral transmission of STD's or AIDS is not presently known.

4. The same animal tests revealed that most nonoxynol-9 was excreted through the intestines and that no damage or abnormalities were observed upon autopsy of test animals. But at this point, not enough is known about the effect of nonoxynol-9 on human intestines (especially during sex) or about the AIDS virus to recommend spermicides without question.

5. Nonoxynol-9 foams are much more effective than gels or creams for vaginal intercourse because they create a more efficient chemical barrier, one which spreads and clings to the vaginal walls better. Again, research overwhelmingly recommends that spermicidal foam be used in conjunction with condoms. If a rubber breaks during ejaculation, immediately insert spermicidal foam in the vagina and leave it there for six hours.




