## **VOLUNTEER PROGRAM AND** SERVICES OPPORTUNITIES

A core base of active volunteers enables the Center to plan and facilitate programs and services. The Center offers many ways to volunteer, so there's truly something for everyone. Whatever volunteer opportunity you choose, volunteering is a great way to give back to our community, meet new people, get involved. and have fun.

We greatly appreciate your interest in becoming more involved. Below are some volunteer opportunities. Some may require training and a longer commitment of several months to a year.

#### \* FRONT DESK RECEPTIONISTS

Help make the Center a friendly place by answering phones. greeting visitors, and providing information referrals. This position is a great way to meet new people and get to know the resources in our community. The commitment involves 3 1/2 hours each week or every other week. Fill out a volunteer profile online by visiting our website at RainbowOutreach.org and if you happen to need easy online access, visit us at 1719 Leavenworth Street to use the free, high-speed internet access provided by the GLBT Center.

#### \* PROGRAM COMMITTEES

Program committees don't require as consistent a time commitment, and typically entail a monthly meeting with a committee of five or more other program volunteers. You'll usually spend a few hours between monthly meetings working on various tasks to prepare for events and programs. Work gets more intensive just before an event you help organize. These committees are a great way to get to work closely with a dedicated group of people, and to really contribute ideas, creativity, and



leadership to the GLBT Center.

The Center currently has a Library Committee and an Activity Committee.

ACTIVITY COMMITTEE: We need volunteers for the Center Activity Committee to help create, plan and implement social, educational and recreational offerings and special events both at and away from the GLBT Center, such as Open Houses and Center Outings. The Center Activity Committee meets 7-9PM on the first Thursday of each month at the GLBT Center, 1719 Leavenworth, Omaha.

LIBRARY COMMITTEE: We need volunteers for the Center Library Committee to help with our GLBT community library: to shelve and catalog titles, to maintain the collection of more than 1,150 books, and to develop and expand related services and educational outreach. A great opportunity for people who love books, like to use their organizational skills, and work well with people. The Center Library Committee meets 7-9PM on the third Sunday of each month at the GLBT Center, 1719 Leavenworth, Omaha.

#### \* OTHER OPPORTUNITIES

If a weekly or monthly commitment sounds too timeconsuming for you, other volunteer opportunities are available. which are more sporadic and require less commitment. Many of them are very social and may involve working with large groups of volunteers, while others are more individually focused.

SPECIAL EVENT VOLUNTEERS: Volunteering for special events is a great way to get involved on a short-term basis. The Center hosts many special events including Community collaborations, open houses and more. Help is needed with planning, set up, clean up, selling tickets, and other duties. If you would like to be consider as a potential Special Event Volunteer, please let us know.







### Toronto Lesbians and Police Come to a Settlement

The raid of a lesbian bathhouse party in Toronto, Ontario, has led to an unprecedented settlement by the city's police service. The settlement stems from an incident that took place on Sept. 14, 2000, when police raided a special event called the Pussy Palace, which attracted 355 nearly naked women.

The Toronto Women's Bathhouse Committee filed a human rights complaint, claiming in part that two female police officers checked inside the bathhouse for liquor violations, and then five male officers entered and lingered in private areas. Several of the committee's members filed a \$1.5 million classaction lawsuit.

Several officers named in the complaint said they had launched the raid after anonymous complaints surfaced alleging drug use, physical violence and sexual activity.

In 2002, Judge Peter Hryn of the Ontario Court ruled the defendants' privacy rights had been breached in a situation that did not require urgent police action.

During the defamation trial that followed, Judge Janet McFarland of the Ontario Superior Court declared, "It is no part of a police officer's job to breach the Charter of Rights of any citizen. To do so is misconduct of the most serious kind."

Under the terms of the settlement, the Toronto Police Service will pay \$350,000 to a group of lesbian complainants, and all current and future Toronto police officers -- including police chiefs -- will have to undergo gay and lesbian sensitivity training. When the settlement was reached, both the human rights complaint and the lawsuit were dropped.

"The larger battle here is for the police to understand the community they serve," defendant Hornick went on to say. "That is the most important and exciting part for me."

#### San Francisco again takes center stage on gay marriage

After a coast-to-coast airing in family rooms, courtrooms, the Oval Office, and polling places, the debate over same-sex marriage returns this week to the city where an exuberant but short-lived gay wedding march inspired a flurry of imitators and detractors. A trial judge in San Francisco is scheduled to hear arguments Wednesday in a pair of lawsuits that seek to put California on par with Massachusetts, the only state where gay and lesbian couples can legally wed. The lawsuits seek to have the state's "one man, one woman" marriage law declared unconstitutional.

#### Same-sex marriage stance fetches year-end honors for Newsom

San Francisco Mayor Gavin Newsom may be busy tackling his city's homeless problem and budget deficit these days, but his decision to open City Hall to same-sex couples seeking marriage licenses is still resonating beyond the Golden Gate. Time Magazine named the 37-year-old Democrat to its list of "People Who Matter." The designation followed Newsom's selection as "Person of the Year" by the editors of Planet Out, a San Francisco-based media company that operates gay-oriented Web sites around the world. The award recognizes the individual who most profoundly impacted the lives of lesbian, gay, bisexual and transgender people.

#### A Time to Remember, a Time to Review

On a day when millions of people from all over the world remembered those who have died of complications from AIDS, a study taken in the United States indicated that the struggle to eradicate the disease is far from over. armingly, new HIV infections among gay and bisexual men increased 11% between 2000 and 2003, according to a report released by the Centers for Disease Control and Prevention on World AIDS Day, Dec. 1. New HIV infections among gay and bisexual men also accounted for 44% of people diagnosed with HIV or AIDS during those years.

#### Target becomes target of antigay boycott

Religious groups representing millions of evangelical Christians are calling for a boycott of retail giant Target to protest its recent decision to prohibit the Salvation Army from collecting charitable donations with their signature red kettles outside Target stores. The company said it decided that it could no longer make the Salvation Army the sole exception to its rule against solicitation at stores. But the far-right groups are claming that the Minneapolis-based retailer has bowed to pressure from gay

rights groups that are upset with the Salvation Army's refusal to offer benefits to employees' domestic partners.

A bill to be put before the Utah legislature in the new session could provide some of the benefits of marriage to gay and lesbian couples. But, none of the bill's supporters will call it a gay rights bill. Instead, the legislation has been crafted to give benefits to a wide swath of the state - from unmarried couples to relatives who live together and depend on one another. In conservative Utah, a gay rights bill would most certainly go down to defeat. But, its supporters argue, who could oppose giving benefits to two aged siblings who depend on one another for support.

#### Vermont Marks 5 Years of Civil Unions

## Oregon High Court Hears Gay Marriage Case

lenge to the state marriage law, Li v. Oregon.

The American Civil Liberties Union, along with Basic Rights Oregon, filed suit last spring on behalf of nine same-sex couples. After a gay-friendly ruling from the lower court, however, Oregon voters passed an amendment to the state constitution defining marriage as the union of one man and one woman.

The Nov. 2 general election delayed oral arguments in the Li case that were scheduled for later that month. Instead, the justices asked the lawyers to brief the question of whether the lawsuit itself was rendered moot by the new amendment. Not surprisingly, the marriage opponents said yes.

The ACLU, on the other hand, argued that while the institution of marriage may be pre-empted by the amendment, the principles of equality embedded in the state constitution require that gay couples and straight couples be treated the same. As such, same-sex couples should be able to access the same rights and responsibilities of marriage under state law that are available to other couples, albeit using another name or parallel institution.

The high court must also decide the legal status of some 3,000 same-sex couples who were married in Portland's

Multnomah County last spring. The lower court in this case ordered state registrar Jennifer Woodward to register the marriages just as she would register a heterosexual marriage. However, the judge left it to future courts to determine whether those duly registered marriages would be placed on par with others.

Of course, the lower court ruling was issued well before Nov. 2. At that time, the lower court also ordered the Legislature to make certain that marriage rights and benefits were dispersed without sexual orientation discrimination. In essence, the court ordered lawmakers to set up Vermont-style civil unions at the very least, as soon as possible. That demand is under review by the state Supreme Court along with the rest of the previous ruling.

Without the intervention of the amendment, gay advocates had high hopes for a positive decision out of Oregon, which could have become the second state to equalize marriage laws. Now it's possible that Oregon's neighbor to the north will have that distinction.

Washington justices have also fasttracked a same-sex marriage case, which is scheduled for oral arguments in March. There is no constitutional amendment pending in Washington, where amendments may be initiated only by the lawmakers, not by the citizens.
