Greg Louganis Makes History as First Openly Gay Grand Marshal of Rose Parade

Forty years after competing in his first Olympics, Greg Louganis is still making history.

The Olympic diving legend will be the first openly gay man to ride as grand marshal of the Rose Parade in January.

Louganis, 56, was chosen for the honor along with fellow Olympic medalists Janet Evans and Allyson Felix.



The parade takes place on 2 January in Pasadena, California and its theme is Echoes of Success.

In a Twitter post, Louganis described himself as 'incredibly honored.'

The three athletes have been active in promoting Los Angeles' bid for the 2024 Summer Games.

Louganis, who has been living with HIV for three decades, won two gold medals in 1988, two in 1984 and a silver medal in 1976 while still in high school.

Although he did not come out publicly as a gay man until 1994, Louganis was rumored to be gay and that seemed to hurt his commercial endorsement opportunities.

But in recent years he seems to be getting more his due especially since the airing of the Emmy-nominated documentary Greg Louganis: Back On Board.

Earlier this year, Louganis and Evans along with fellow Olympic legend Edwin Moses received the long overdue honor of being placed on boxes of Wheaties breakfast cereal.

'It means more now than it probably would've then, because they would've been celebrating the athlete (back then),' Louganis said in a July episode of Where Are They Now? 'I'm a gay man living with HIV. I feel like I'm being embraced as a whole person, and not just a part of me.'

Orlando to Buy Pulse Nightclub and Install Permanent Memorial

The site of the most deadly hate crime in modern U.S. history will likely be purchased by the City of Orlando and turned into a memorial.

City officials announced today that they've negotiated a price of \$2.4 million to buy Pulse, the nightclub where a gunman and 49 others were killed in June.

"This location is now a permanent part of Orlando's history," said Orlando Mayor Buddy Dyer. "It's the site of the most tragic event that has ever occurred in the City of Orlando. We want our entire community to be a part of this site."

The site has been visited by President Obama, Vice President Biden, Hillary Clinton and her running mate Tim Kaine, plus visiting world leaders, and a number of celebrities. But most frequently, it's visited by everyday people who want to remember those lost.

Talks about the club's future took place for the past few

months, according to Cassandra Lafser, press secretary for the mayor's office, and a final price was reached this week. The Orlando City Council will vote on the purchase Monday, two days after Orlando's annual pride celebration, Come Out With Pride.

On June 12, Fort Pierce man Omar Mateen opened fire in the Orlando LGBT club. In phone calls to police, Mateen swore an allegiance to leaders of ISIS. Mateen ultimately died at Pulse, where police shot him eight times before taking control of the club. Pulse regulars say Mateen frequented the club, leading to speculation he was gay, but family members and the FBI dismiss that.

The attack occurred on Latin night at Pulse, and a disproportionate number of victims were Latino. Dyer stresses the massacre, though, tore at all of Orlando, and the Pulse now should serve as memorial site recognized by the entire community.

"It has great significance, not just for the LGBTQ community and the Hispanic community, but for all of us that live and love Orlando," Dyer said.

A timeline for turning Pulse into a formal memorial has not been set, but Dyer says the club will remain in its current state for the next 12 to 18 months. In the wake of the shooting, Pulse and the fencing surrounding turned into a makeshift monument to the fallen 49. The logo for the Pulse since became a mourning and rallying cry. But the site has also drawn trespassers and criminals breaking into the property, according to the Orlando Sentinel.

The Sentinel notes owners Barbara and Rosario Poma negotiated a price well beyond the \$1.65 million appraised value of the club. Pulse has not re-opened since the shooting.

Barbara Poma opened the bar in 2004 and named it in honor of her later brother John, who died from AIDS in 1991. Poma issued a statement earlier this year expressing her desire for part of the club to include a memorial. Dyers said a public process will determine what sort of memorial gets created at the site.

Remembering the Gay Man Who Saved 17 Million Lives

"[Alan Turing] was and is a hero of all time...a man who is a gay icon, who didn't deny his nature, his being, and for that he suffered. ... This is a story that celebrates him, that celebrates outsiders; it celebrates anybody who's ever felt different and ostracized and ever suffered prejudice."

I usually find movie award shows to project primarily fluff and silliness, and they rarely stir

t listening to Benedict Cumberbatch

deep emotions in me. But listening to Benedict Cumberbatch accept the award for Best Actor at the American Film Awards for his portrayal of Alan Turing in the film The Imitation Game two years ago brought me to tears.

This stemmed from a sense of deep pride and an endless abyss of sadness. Cumberbatch's commitment and passion shined through on stage as he talked about transforming Turing's story, his brilliance, and his humanity to the silver screen, helping to give Turing the long-overdue wide-scale recognition he rightly deserves.

Alan Mathison Turing was a pioneering computer scientist, and he served as a mid-20th century British mathematician, logician, and cryptanalyst who, working during World War II at England's Government Code and Cypher School at Bletchley Park, succeeded with his team of scientists and linguists in cracking the "Enigma code" used by the Nazi command to conduct covert communication operations.

Because of Turing and his colleagues' efforts, Cumberbatch said, there is now general agreement that they shortened the war by at least two years, saving an estimated 17 million lives.

Prime Minister Winston Churchill singled out Turing as the person whose work contributed the most to defeating the Germans.

The Imitation Game also highlights the enormous obstacles placed in the way of women entering the sciences, especially mid-century. In this regard, Keira Knightley made an equally moving speech at the American Film Awards in accepting the Best Supporting Actress award for her portrayal of Joan Clarke, who worked with Turing in deciphering the code.

"Particularly now, when women are such a minority in all fields, her story and the fact that she really perseveres, and she had space and time and grace, is really inspiring," she said.

Though initially considered a national hero in Britain, in 1952, government officials arrested and prosecuted Turing on the antiquated charge of "gross indecency" when he "admitted" to maintaining a same-sex relationship. Rather than serving time in prison, Turing chose to undergo estrogen injections then considered in men a form of "chemical castration" eliminating sex drive. Turing took his life two years later by swallowing cyanide just two weeks short of his 42nd birthday.

I find it deeply ironic that while Turing and his team helped defeat the Nazi war machine, a nation intolerant of any form of difference including same-sex relations (especially between men), the primary "allied" nations fighting Nazi Germany – United States, Britain, and the Soviet Union – all maintained laws criminalizing homosexuality.

Under King Henry VIII in 1533, England passed a

"buggery" (or sodomy) law, doling out the penalty of death for "the detestable and abominable Vice of Buggery committed with mankind or beast." Under the rule of Elizabeth I in 1564, death for same-sex acts between men became a permanent part of English law until the 1880s. British courts at the time concluded that sex between two women was impossible and, therefore, exempted women from the statute. By 1885, English Criminal Law punished homosexuality with imprisonment up to two years. This remained in effect until homosexuality was decriminalized in 1967.

In addition, Soviet dictator Joseph Stalin criminalized homosexuality with eight years imprisonment or exile to Siberia. And in the United States, consensual same-sex relations were against the law at one time in all states, and remained illegal in some states as late as 2003, when the Supreme Court finally overturned such bans in its Lawrence v. Texas decision.

In 2009, British Prime Minister Gordon Brown officially apologized to Alan Turing on behalf of the people of his nation for "the appalling way he was treated." Parliament finally brought up a bill of "pardon" in 2013, and on 24 December, 2013, Queen Elizabeth granted Turing a posthumous pardon.

Though the English government never actually forced a physical stigma onto Turing's body, they branded the symbol of the outsider, the pervert, the enemy deeply into his soul. This branding seriously deprived the British nation and the larger world community of his continued genius, his generosity, and the many additional gifts he could have imparted.

I agree with Benedict Cumberbatch that Turing's wide-scale recognition is long overdue.

Gay Cops Accused of Having Bareback Sex Parties with Underage Boys

Gay cops in New York state are under investigation over allegations they held bareback sex parties with teenagers below the age of consent.

A number of New York police departments are now investigating the allegations.

It is alleged those parties were attended by teenagers below the legal age to either drink alcohol or consent to sex with an adult.

Schenectady Police Department and Albany Police Department are

both involved in the multi-agency police investigation. It is claimed they are investigating that gay officers attended or hosted the 'breeding parties'.



'I'm not really in a position to say anything about it at this point,' Albany Police Chief Brendan Cox told the Times Union.

'There is a case we are looking into but we are not in a position to even gauge whether or not there is any truth to what has been alleged.'

According to the Times Union, the investigation was triggered after an officer's live-in boyfriend was arrested last month.

Sgt Jonathan E Moore and his partner, Anthony Aubin, were trying to buy a car when Aubin was arrested on felony charges for allegedly using a fraudulent check.

They claim these fraudulent checks were provided to them in payment for work.

Aubin was on parole for a previous conviction.

Separate fraud, parole and porn investigation

There is no evidence yet that indicates Moore and Aubin were involved with the teen sex parties.

All we do know is that Aubin reportedly made statements about those parties and officers' involvement in gay sex with teenagers at Albany County Jail after his arrest on the fraud matter.

This led law enforcement officials to start a separate investigation. It's the new investigation that is looking at whether unnamed officers had underage teen sex.

Separately, it is known that Moore made a sworn statement admitting he had debt issues.

Aubin reportedly offered to help out with by producing gay porn for Florida-based Bear Films.

When the deal fell apart, the couple signed up with another porn company, it is claimed.

But when they failed to receive payment from that new company, it is claimed their female agent for the porn work gave them the fraudulent checks.

Aubin is being held at Albany County Jail without bail; his case for fraud is pending in Albany Country Court.

Moore is on paid suspension from the police department while they investigate his conduct. This investigation is apparently focused on his relationship with Aubin, because he was on parole, and Moore's involvement in gay porn.

Kim Davis Attempts to Skirt \$230,000 Legal Fees

Kim Davis, who attempted to prevent gay couples from acquiring marriage licenses, is being asked to cover the legal fees of the people she discriminated against.

The couples who sued Kim Davis are lobbying the Rowan County, Ky., clerk to pay their legal fees, amounting to over \$230,000, but lawyers for Davis are attempting to block the request.

Liberty Counsel, the right-wing legal firm based in Florida, has been representing Davis since she was briefly



jailed for contempt of court in September 2015 after shutting down all marriage license operations to avoid issuing same-sex couples marriage licenses. Davis's attorney, Roger K. Gannam, argued that because the case was resolved after the state of Kentucky opted to take clerks' names off marriage licenses, she shouldn't be forced to pay.

The state legislature passed that law in April, codifying what Gov. Matt Bevin had done through executive order in December 2015, shortly after he took office.

Couples who sued disagree with that assessment, the Lexington Herald-Leader reports. They say it doesn't change the fact that Davis blocked their right to be wed and they had to sue to be able to exercise their legal rights.

The American Civil Liberties Union is leading the effort to recoup their expenses. "Courts recognize that when successful civil rights plaintiffs obtain a direct benefit from a court-ordered victory, such as in this case, they can be entitled to their legal expenses to deter future civil rights violations by government officials," said ACLU of Kentucky legal director William Sharp in a press release issued in September.

"By filing today's motion, we hope to achieve that very objective — to send a message to government officials that willful violations of individuals' rights will be costly."

The decision on this matter will go to U.S. District Judge David Bunning, the same judge who issued a contempt of court ruling against Davis last year. "Our form of government will not survive unless we, as a society, agree to respect the U.S. Supreme Court's decisions, regardless of our personal opinions." Bunning said at the time. "Davis is certainly free to disagree with the Court's opinion, as many Americans likely do, but that does not excuse her from complying with it. To hold otherwise would set a dangerous precedent."

No matter Bunning's verdict, Rowan County has already said that it would not foot her bill, claiming that Davis acted on her own behalf in refusing to issue licenses. "County clerks are not employees of the county," Jeffrey C. Mando, an attorney for the county, stated in a press release, "but instead are the holders of elective office pursuant to the Kentucky Constitution."

Legalizing Marijuana Will Help Disenfranchised Families

An LGBT cannabis proponent says Californians — and voters in Nevada. Arizona, and Maine — need to embrace the future.

When I started in the cannabis business more than a decade ago, my sole purpose was to create a safe space for women to access clean, quality cannabis. For 10 years, I've been drawn into a legalization war that rages on with aggressive conflict between our state and federal governments, between cultivators and law enforcement. But with successive legalization in states across the country, it's clear that legalization in California is no longer an issue of "if" but "when." The LGBTQ community has tremendous power when we work and vote together. Proposition 64 — which would legalize recreational marijuana — is our chance to make positive changes that could reverberate nationally.

The 2016 presidential election ensures a high voter turnout, and it's our opportunity as a state, as counties, as compassionate communities, to send a clear message at the ballot box. We want cannabis legalized. Period. Prop. 64 is imperfect; that too is something most people agree on. But do we stand still and create the "perfect" proposition? How much longer do we wait? Or do we move forward and correct course as we go like the pioneers we once were? California once led the charge in progressive lawmaking, especially regarding cannabis. Now we lag behind states like Alaska, Washington, Oregon, and Colorado.

At the crux of Prop. 64 is access. It removes the barrier that says, "Cannabis is OK for me but not for you." Under Proposition 215, marijuana isn't legal; it allows medicinal use and provides immunity to prosecution. Big difference. Prop. 64 makes marijuana legal. That automatically eliminates the gross waste of resources being poured into combating cannabis use, and not just the ticketing and arrests, but all the way down the chain—prosecution, detainment, housing, appeals. The agencies dealing with this suffer from a lack of proper equipment and training. Wouldn't those resources be better spent combating real social problems or providing better services? I refer you to the massive police raids on dispensaries and cultivators only this past summer right here in California.

One concern people have expressed is that Prop. 64 kills small business, but has this been true in the wine industry? Craft beer? Micro-distilleries? The coffee industry? There will always be a place for artisanal, small-batch, premium-quality products. At Natural Cannabis Co., we do very little vertical integration and instead work exclusively with small farms and cultivators. That's what our clients want. It varies by communi-

ty, but speaking for Sonoma County, we have a loyalty and passion for supporting independents and small businesses. Prop. 64 adds a residency requirement through 2019 and has antimonopoly and pricefixing language. Is it perfect? No. But it allows people with prior cannabis convictions to



get licenses to operate a legal business, something Prop. 215 lacks. It eliminates the irony of refusing cannabis cultivation licenses to people who have been convicted of cultivating cannabis — imagine that!

Did you know that there are still people in prison for cannabis in recreational-use states? With Prop. 64, California has a chance to set an important nationwide precedent by addressing that very issue.

Consider this: "Individuals serving sentences for activities that are made legal or are subject to lesser penalties under the measure would be eligible for resentencing."

The proposition also says, "Individuals who have completed sentences for crimes that are reduced by the measure could apply to the courts to have their criminal records changed."

Another important issue Prop. 64 addresses is guaranteeing privacy and parental rights. In communities of color and LGBTQ families, parents have more to fear when it comes to losing their children to protective services. Prop. 64 means you will not lose your children for cannabis use. Isn't it time to end the terrible irony of so many lives ruined over a plant that has caused exactly zero overdose deaths? Those ruined lives have disproportionately been in disenfranchised communities.

Part of civilization is compromise, and that's what Prop. 64 is. It's seeking to balance the concerns of both sides; people who love and consume cannabis and nonusers alike. By its very nature, it's not meant to be 100 percent satisfactory to everyone. That's simply not possible. It's still a big step forward, not just for people actively using cannabis now, but for the people who have been victims of this failed drug war and their families as well. In all the squabbling over money and power, the humanity gets forgotten.

Currently, Prop. 215 forces people to disclose their personal and medical information to seek recommendations for what's basically an herbal medicine. They're paying for these visits, renewing their cards every year, and still we can't guarantee these people, many of them vulnerable, are getting safe, clean cannabis. Whether you're using it for medical reasons or recreationally, you deserve safe, clean, quality product, Prop. 64 helps by setting guidelines and regulations meant to protect the consumer. We have four recreational-use states showing us that legalization does not inflate prices, it has not increased vehicular deaths, and it has not increased teen drug use. What it has done is create a tremendous revenue stream, a boost in tourism, and dramatically reduced marijuana arrests.

This is a new era for cannabis. People who would have never considered cannabis a couple of years ago are seeing life-changing results in people close to them. The increase in cannabis use directly correlates to a reduction in opioid deaths. People are finding relief and enjoyment in this humblest of plants,

and now is the time to make it legal for everyone who chooses to use it, for whatever they want to use it for. Living in the heart of wine country, it's hard not to look at that industry and our acceptance and celebration of alcohol, a substance with virtually no medical benefit and directly responsible for the deaths of more than 3,000 Californians annually.

The time to usher in a new stage of acceptance for cannabis in California is now. Time has proven that minds and laws change. More people than ever approve of legalization. Legalization can happen now or we can stagger along behind Nevada, Arizona, Maine, and other states where recreational marijuana is likely to pass next week, waiting for that "perfect" proposition. Northern California, in particular, is known around the world for cannabis, so why are we so far behind the times? Vote yes on Prop. 64.

Transgender Woman Shot to Death in Virginia

Another transgender woman of color has been murdered: Noony Norwood, who was shot Saturday in Richmond, Va., and died in a hospital the next day, just five days after her 30th birthday.

Police are investigating, and they are circulating photos of a man who was seen near the site of the shooting, GayRVA.com reports.



This is the 24th reported murder of a trans person in 2016; the majority have been transgender women of color. The year is the deadliest on record, already surpassing 2015's total of 21. The actual total for any year is likely higher, given that some deaths are not reported and some victims are misgendered by police or media.

Friends said Norwood was a vibrant presence. "Noony's energy always brightened the room. She cared about her community and always lifted up and supported her friends and family," Zakia McKensey, founder and executive director of Richmond nonprofit Nationz Foundation, told the Virginia Anti-Violence Project. Nationz Foundation is a health and wellness group that focuses on serving LGBT people.

McKensey, who was a mentor to Norwood, last saw her about two weeks ago, when she invited her to a meeting of a transgender support group at the foundation, she told

GayRVA.com. "She used to call me "Mom'pie," and so she said, 'Mom'pie, I promise I'm coming.' I told her to be safe and be careful," McKensey said.

Janet Wright, who calls herself Norwood's aunt although they are not related, told Richmond TV station WWBT that Norwood was "a beautiful person" who "would give you anything, would help anybody without even a second thought."

"She was a wonderful person, and they took somebody great from us, seriously," Wright said.

The Virginia Anti-Violence Project noted that while it is yet unknown if Norwood's killer was motivated by anti-transgender bias, trans people are high risk for violence. "While there is still an active investigation happening into the shooting of Noony Norwood, we absolutely do know that perceived and actual gender identity and race often play a role in escalating violence against LGBTQ+-identified individuals," the group wrote on its website. "VAVP hopes that throughout the investigative process, the media, police, and the public atlarge, will respect Noony's identity and maintain a level of decorum and understanding when interacting with her family and other individuals who identify within transgender and nonconforming communities."

American Hate Preacher Tries to Escape Charges for Promoting 'Kill the Gays' Law

SPRINGFIELD, Mass. (AP) — A Massachusetts evangelist will ask a federal judge to reject a lawsuit that accuses him of waging a long campaign to persecute gays in Uganda.

An East African gay advocacy group filed the lawsuit in 2012 against minister Scott Lively under a statute that allows non-citizens to file U.S. court actions for violations of international law.

Lively's Springfield church is known as Redemption Gate Mission Society. He has called the lawsuit "absurd" and

"completely frivolous."

Lively said he has preached against homosexuality, but advised therapy, not punishment.

The New York-based group Center for Constitutional Rights filed the suit on behalf of Sexual Minorities Uganda.

A hearing will be held Wednesday in U.S. District Court in Springfield on Lively's request for summary judgment to keep the case from going to trial.

How to Behave at a Sex Party

Lately, I am getting quite a few questions from clients about sex parties that are apparently happening all over San Diego County. People ask me what I think about them, are they a good thing or a bad thing? Should they stay away



from them or embrace them with open arms (and legs)?

Frankly, I don't have an opinion about sex parties. Nor do I have an opinion on where and when people have sex. I don't' think the externals are what make sex fulfilling or not. You can have wonderful, deep, loving sex with a stranger in a bathhouse and meaningless, crummy sex with someone you know very well in a romantic room set with candles, your favorite music and a blanket by the fireplace. This is because good sex is mostly in your head and heart (yeah, and also in your genitals, we'll address that too).

My definition of good sex: (1) no one seroconverts and (2) when the experience is over, you feel good about yourself, good about your partner(s) and good about life in general.

By that definition, how much good sex have you had recently? You can see, by that definition, that it's more about your experience of what happened as opposed to what you did, he did, she did, etc. It's more about having a good connection with someone else, as opposed to who topped who, who came first, who stayed hard the longest, etc.

You can have good sex anywhere. It's not the environment that matters, it's your attitude. This is why I don't condemn sex parties, bathhouses, or orgys (like some therapists do) as long as the people involved are having good sex (by my definition). People have been having sex in as many places as you can imagine ever since time began. Making some situations right and some wrong isn't helpful.

Let's turn to the matter of sex parties. Why do people go to sex parties? Don't assume you know their motivation. I have had clients who were sex workers who told me that most clients came to them because they were lonely, not because they wanted to have fabulous sex. We never know someone else's motivation for doing something, especially something as complex as having sex. So, instead, focus on yourself. Ask yourself: What's my motivation for going to a sex party? Is it to have fun, meet people, be social, get off, feel attractive, combat loneliness, boost your self-esteem? Tell yourself the truth and then proceed accordingly.

That said, I have consulted some my "experts" in the Sex Party department and have the following suggestions if you are considering attending:

Party tip #1: Sex parties are not about finding a long term relationship. Sex parties are about having sex. Don't confuse a sex party with a social gathering, whose purpose is primarily to meet people, eat, drink and talk to people. If that's what you want, go to a social event. Again, be clear on your motivation. If you want Italian food, don't go to a Chinese restaurant.

Party tip #2: Communication at sex parties isn't like a social event. Smiling or being friendly to someone at a sex party might give him/her the impression that you're interested in them. Instead of "nice", aim for "neutral" and you should stay out of trouble (or get into trouble with someone you're hot for).

Party tip #3: At a sex party, everyone is fair game and no one is a mind-reader. Simply ignore people you're not interested in. If they touch you, take their hand off your body, calmly say "no thanks" and walk away. No muss, no fuss, no attitude. And if you approach someone and they take your hand off their body, don't take it personally. Move on and have fun with someone else.

Party tip #4: No matter what your HIV status is, use condoms. No matter how tempted you are, stay healthy and help your brothers and sisters to do the same.

Party tip #5: Be respectful, playful and open to new experiences. Ask for what you want, and see if you get it. Have good boundaries: be able to say no to what you don't want and stick to it. Don't have "pity" sex, where you feel sorry for someone and give them what they want. Take good care of yourself and have the kind of experience that makes you feel good about yourself.

The Hungry Homo

Pudding Cupcakes

Ingredients Cupcakes:

1 1/2 cups self-rising flour

2/3 cup packed brown sugar

1/2 cup milk

1 egg

I tsp. vanilla extract

3 tbsp. sweet butter, melted

1 1/4 cups chopped dates

Topping:

1/2 cup packed brown sugar

2 tbsp. sweet butter

2/3 cup boiling water

Steps:

Preheat oven to 375 degrees: line 8 muffin tins with baking parchment. In a bowl, combine flour and sugar. In another bowl, beat milk, eggs, vanilla, and butter until smooth and pale. about 2-3 minutes. Pour the batter over the flour mixture; stir with a wooden spoon. Fold in the dates; scrape mixture into the muffin pans, filling each about halfway. For the topping: sprin-

It makes you wonder if one day, lab-grown or donated penises will be grafted on to men who have extreme concerns over size.

And at the start of March we learned about a study of 15,000 penises, finally answering the question of average size.

The typical penis is just 13.12cms (5.16ins) long and 11.66cms (4.6ins) around when erect.




