Candidate Issue Comparison

Following is a comparison of Vice President George Bush and Governor Michael Dukakis on lesbian and gay civil rights and AIDS issues. Also included is a comparison of the Democratic and Republican Party Platforms.

GAY AND LESBIAN CIVIL RIGHTS

George Bush:

POSITION: Opposes gay and lesbian civil rights as awarding "special privileges"

to one group.

RECORD: Reagan-Bush admin-istration supported Supreme Court 'Hardwick' decision denying Constitutional protections to gays. The admini-stration has not opposed the immigration reform bill.

Michael Dukakis:

POSITION: Supports civil rights bill and immigration reform bill. Supports non-discrimination with regard to security clearances. Opposes executive order protecting government employees.

RECORD: As Massachusetts legislator, introduced state gay rights bill in 1974. As governor, he has lobbied for

bill.

HATE CRIMES:

George Bush:

POSITION: No known position. RECORD: The administration had indicated it may support collecting statistics on crimes against gays and lesbians.

Michael Dukakis:

POSITION: Supports legisla-on providing specific penalties for violence against gays and lesbians.

RECORD: Supported Massachusetts law that helped to define an assault due to sexual orientation as a civil rights rights crime.

AIDS TESTING:

George Bush:

POSITION: Advocates confidentiality of HIV test results; supports mandatory or routine testing for military, immigrants, marriage licenses, those seeking assistance for sexually transmitted diseases and drug dependence and prisoners. RECORD: The Reagan-Bush ad-

ministration has left issues of

confidentiality and availabil- Michael Dukakis: ity to the states. It requires testing of military personnel, immigrants, Peace Corps and Job Corps workers, foreign service employees and federal prisoners.

Michael Dukakisi

POSITION: Supports increased voluntary, confidential coun-seling and testing; advocates mendatory testing of military personnel and immigrants.

RECORD: Dukakis issues regulations banning testing for health and group life or disability insurance. Allows life insurers to require test for individual policies over \$100,000.00.

AIDS PREVENTION:

George Bush:

POSITION: Believes people should be educated about AIDS, but prevention efforts should stress traditional moral values end strengthen the concept of "family". Content decision should be made at the local level.

RECORD: Under the Reagan-Bush administration, a nationwide mailing, originally conceived in mid-1980's, was not sent until June 1988 due to political in-fighting over contents. The administration refuses to provide explicit information on sex and drug use.

Michael Dukakis:

POSITION: Believes that AIDS education, including explicit information on sex and drug use, should begin in primary school with information based on age and ability to absorb material.

RECORD: Massachusetts was the first state to do a houseto-house AIDS prevention mailing.

AIDS DISCRIMINATION:

George Bush:

POSITION: Supports federal legislation outlawing discrimination based on HIV infection status.

RECORD: The Reagan-Bush Administration opposes efforts to enact legislation to prohibit discrimination based on HIV status.

POSITION: Supports federal legislation outlawing legislation outlawing discrimination based on HIV infection status.

RECORD: Endorsed Massachusetts bill to protect people with AIDS, HIV or perceived to have AIDS against Discrimination.

PRESIDENTIAL HIV COMMISSION'S REPORT

George Bush:

Endorses POSITION: the recommendations of the Presidential AIDS Commission. However, his campaign rejected endorsing the report in the Republican Platform.

Michael Dukakis:

POSITION: Endorses recommendations of the Presidential Commission on the HIV infection.

PARTY PLATFORM:

Republican:

No mention of lesbian and gay civil rights. Rejected endorsement of Presidential HIV Commission Report, Calls for research, compassion and expedited FDA drug review. Also calls for "protecting those who do not have the disease, AIDS education that emphasizes "abstinence from drug and sexual activity outside of marriage" and confidential testing and contact tracing. Advocate that people "remain on the job or in achool as long as they are capable." functionally

DEMOCRATIC:

POSITION: Calls for lesbian and gay civil rights and the "rebuilding" of the civil rights enforcement machinery. AIDS planks call for "increased support for expedited research on treatments and vaccines, comprehensive education and commpassionate prevention, patient care, adoption of public health community consensus on voluntary and confidential testing and counseling, and protection of the civil rights of those suffering from AIDS, AIDS Related Complex, or testing positive for the HIV antibody."

The Second Most Important Room in the House

RIBS. When preparing ribs there are 3 things to remember.

1. Allow at least 1 pound per person at a minimum. 2. Parboil the ribs first. 3. Ribs are only as good as the barbeque sauce you use. And remember to baste frequently, especially if you are cooking on an outdoor grill.

Ribs tend to be very fatty and have little mest on them. That is why you should allow at least 2 pound per person. Because too much fat is not good for anyone to eat you you should parboil the ribs first. I know of a woman who bakes the ribs in her oven for about an hour to remove the fat, but boiling is easier. While comes to a boil, peel an onion and stud it with 6 or 7 whole cloves, then drop the studded onion into the pot of ribs. (Some cooking terms are SO exciting...) if you are going to cook the ribs indoors you might add a couple of might add a couple of tablespoons of liquid smoke. Add 2 or 3 peppercorns to the water and just let the ribs boil. Some cook books suggest you parboil in this manner 5 minutes or so, others suggest you boil the ribs up to an hour. The important thing to remove the fat and make I usually boil ribs tender. them for an hour.

Barbecue sauce can be made at home, and there are more variations than there are readers of the New Voice of Nebraska; also there are scads of bottled sauces on the market. You could be adventurous and add some ingredients found around you kitchen to your favorite bottled sauce.

Here is a goodie from San Francisco called San Fransican Chinese Spareriba. Serves 4.

4 lbs. pork spareribs parboiled as described above. Sauce:

l cup catsup
1/4 cup sherry
3/4 tsp salt
4 slices fresh ginger root,
shredded
1/3 cup Soy Sauce
1/4 cup sugar
4 cloves garlic, minced
optional: 1 1/2 TBL hoisin
seuce

Mix all these ingredients in a bowl.

Shake 1/3 cup flour in a large oven cooking bag. Pour sauce into bag and swish around dissolve flour. to spareribs in bag and turn bag several times to coat ribs. Using a twist tie, close the bag and put bag into a baking dish. A 13x9x2 is a good size pan. Make 6 slits on the top side of the bag and cook at 325 degrees until ribs are tender and hot, about 30 minutes or so. If you have perboiled the ribs only 5 or 10 minutes it will take longer to cook. 30 minutes should do it if you have parboiled the ribs for hour and have not cooled the ribs after parboiling.

Here is a sauce that can go on just about any kind of meat: ribs, steaks, chicken, and brisket to name a few.

Stir together in a bowl the

following ingredients: 2 1/2 cups catsup 1 1/2 cups chilisauce

1 1/2 water

3/4 cups lemon juice 1 TBL celery seed 2 TBL Soy Sauce black pepper to taste 3/4 cups brown sugar 1 1/2 cups wine vinegar 3/4 cups beer

1/2 cups prepared mustard 4 TBL Worcestershire sauce 2 cloves of garlic, minced

dash or two of hot pepper sauce,e.g. Tobasco Sauce Stir this all together and refrigerate until ready to use.

To serve: Put ribs on a serving platter and brush with 1/3 cup of light corn syrup to give them a nice glaze. Spoon the remaining barbecue sauce over the ribs. Rice and pea pods will go nicely with this entree.

Next month it's turkey time, the traditional Thanksgiving Dinner. A bunch of us are going to get together for the annual event. I hope Ertha Quake doesn't do her infamous belly dance. The Virgin Machine

(Die Jungfrauenmaschine) -West Germany, 1988

At first glance this new film by Monics Treut recounts a very simple story, that of a young woman who sets out to did find happiness, as Parsifal, the simple fool.

Unhappy in Germany, and pursued by her former lover Heinz, Dorothy Muller decides to continue her investigation of romantic love in America. following the footsteps of her mother, who immigrated to the U.S. many years before. In the mythical dreamland of California, Dorothy by chance meets several very remarkable women.

Susie Sexpert initiates Dorothy into the arsenal of the practical the American pragmatics of love. Dominique, a Hungarian from Uruguay presents herself as a humorous, sisterly friend, and finally the sly lesbian sex therapist with whom Dorothy falls romantically, naively in love.

This dream romance quickly dissipates and Dorothy finds something else: a narcissistic, self-ironic relationship with herself; robbed of her dreams, but still serious enough for us to know that this is not the end of her adventure.

With the expert camera work of Elfi Mikesch, Monika Treut employs a unique experimental

form allowing us to enter the protagonist's world so that we may see and hear the world through Dorothy's eyes and ears. The direction and camera styles also reflect the film's two locales, Germany where Dorothy experiences paranois, and California, the wonderland where Dorothy reacts with amazement at the strange land and people.

The Passion of Remembrance

THE PASSION OF REMEMBRANCE -Great Britain, 1986

Produced by the Sankofa Black Workshop, a film cooperative formed in 1983 by black, feminist, and gay filmmakers, THE PASSION OF REMEMBRANCE is a work about racism, sexism, homosexuality, and the generation gap, and the effects on a black British family. The film has two story lines: one features a black man and woman in a desert landscape, discussing the plight of blacks in the U.K. He is aggressive, she shows restraint. The second shows life for the Baptiste family through its personal histories from the 50s to the 80s. Issues of race and sexuality arise, fragments of identities surface and suggest the diversity of a black family's experience in Britain. Writer/directors Maureen Blackwood and Issac Julian also use footage from the inner-city riots that swept Britain city riots that swept Britain in 1981 and shots of gay demonstrations to portray the government's harsh attitude toward its minorities. Anita, Dances of Vice

ANITA, DANCES OF VICE is based on the life of Anita Berber, considered by many to have been the most scandalous woman in 1920's Berlin. She was the first to dance nude to the public; she was openly bisexual; her use of drugs was no secret; and she preferred her performances to be on subjects such as Vice, Horror and Ecstasy. She died of tuberculosis in 1928.

In Von Praunheim's film the forgotten star becomes alive in the visions of an old woman who claims to be Anita. The police commit her to a mental institution, where in the old woman's dreams and exchanges with staff, scenes from the life of Anita appear. As the film offers images of the dancer's great eraExpressionist, Silent, but in shimmering colors-the captive remembers her wild, short life to its bitter end...and dies




GALA Conference



Is Dukakis a Good Lesbian?

Although the evidence probably wouldn't hold up in court, the residents of the tiny Greek village of Pelopi are not afraid to declare that presidential hopeful Michael Dukekis is a Lesbian.

That's because Pelopi, the birthplace of the Massachusetts governor's father, Panos Dukakis, is located on a lush little island off the Turkish coast called Lesbos. island's name, from which the word "lesbian" was derived, is best known as the birthplace of Sappho, who wrote poetry about ar desire for other women.

The Pelopi according to The villagers, Washington Post, don't seem to mind that the Democratic nominee for the presidency visited the island only once, for a few hours 12 years ago, or that his father never spent much time on the island before moving to United States at the age of 15.

"He belongs to the village even if he was not born here. Mayor Constantinou caid Stephanou. "Once a son of Pelopi." always a son of

Damianos Vasilellis, amateur historian living on the island, said the villagers are proud that Lesbos, in the sixth century B.C., was the home of the world's first democracy.

"If Dublicis is a good Lesbian," Vasilellis told the Post, "he will display the special characteristics of his ancestors - seriousness, oroductivity, contentedness and irony."

Circle K Drops Restrictions

A barrage of bad press prompted a multi-state chain of convenience stores this month to suspend its policy of dropping employees from the company's health care program who contract aids as a result of "certain personal life-style decisions."

Officials at Circle K
Corporation, the second largest
convenience store chain in the
country, announced on Aug 10
that the company is studying

the policy to decide whether to revise it or eliminate it

altogether.

Last December, officials sent out a letter to the 8,000 of the 26,000 employees enrolled in the company's health plan explaining that employees contracting AIDS through any means other than a blood transfusion would not be eligible to receive health care coverage throughout the company. The letter indicated that company officials were concerned about the impact some employees 'personal-life-style decisions' would have on health care costs for the company.

Company officials said no claims had been denied under the new policy before it was

suspended.

Circle K Senior Vice President Charles Shoumaker told 'The Wall Street Journal' that its original decision concerning lifestyles was made after the company found that about \$500,000, or nearly 4% of its health care budget had been spent on treatment for 9 employees with AIDS. He said only 1% to 2% of other employers' health care budgets go for AIDS.

Shoumaker said he expected criticism from Gay organizations but believed that it would be scattered and short-lived. He said there was virtually no response until Aug. 3 when a local newspaper was informed about the policy by members of an AIDS group. 2 days later the story was in many national newspapers.

One of the most vocal opponets to the plan was Arizona Gay activist Ed Busk, a key leader of the successful campaign to oust Arizona Gov. Evan Mecham earlier this year.

Buck said the plan was a "spur of the moment corporate decision rather than firm policy." Officials of Circle K, which is base in Phoenix, said Buck's comments at a meeting with them prompted them to "push the pause button" on the plan until it could be studied further.

Arizona Insurance Commissioner Susan Gallinger said the policy would be illegal if the company was an insurance company, but preempts state law since Circle K pays its own

medical bills.

Court Rules For Student Association

A federal court recently ruled that the University of Arkansas violated the free-speech rights of a homosexual student group by denying it funds.

"The Chronicle of Higher Education" reports that the ruling, handed down by a 3 judge panel of the U.S. Court of Appeals for the Eight Circuit, ordered the university to provide financing to the group, the Gay and Lesbian Students Association.

The ruling overturned an earlier federal district court's decision and marks the first time a federal court has required a public university to provide funds to a gay group. The Court said the university had denied the money because of the views the group expressed.

The Gay and Lesbian Students Assoc. had requested \$165.00, and was the only student group denied funds in 1985. The university turned down an appeal from the group after the student senate refused its funding request.

The American Civil Liberties Union, which argues the case on behalf of the Arkansas students, called the case a major victory for gay and lesbian rights.

Reading, PA - 6 men who said a church-run program to rid them of their homosexual urges

them of their homosexual urges didn't work are now asking for their money back, according to the 'Philadelphia Gay News'.

The men, 3 of them under the name 'John Doe', filed suit in Berks County Court of Common Pleas last month against the General Conference of the Seventh Day Adventists and Colin Cook, former executive director of the church's Quest Learning Center.

The men claimed that rather than providing a cure, Cook sexually molested them. They said Cook forced them into nude massage sessions in order to "desensitize" them. One man said that Cook asked him to masturbate in front of him.

The men are seeking up to \$20,000.00 each in damages as well as the money they paid for fees and expenses while enrolled in the program.

Teachers Pass Anti-Discrimination Statement

The American Federation of Teachers recently passed a resolution opposing discrimination on the basis of sexual orientation, according to the San Francisco 'Sentinel'.

The AFT statement calls for legal and educational equity for homosexuals, and was a combination of 2 separate resolutions submitted to the annual convention. "I think it's a total victory," said Paul Thomas, author of the

propossi.

The resolution, which passed by voice vote, did not include support for domestic partners' benefits, revised school curriculum or support for a national Day civil rights bill-flowever, Thomas said he is confident that these items will be included at next year's convention in Boston.



NGLTF Conference

The National Gay & Lesbian Task Force (NGLTF) announced plans to host a national conference for gay and lesbian organizations November 18-20, 1988 in Washington, D.C. The conference, entitled "CREATING CHANGE: A NATIONAL CONFERENCE FOR GAY AND LESBIAN ORGANIZATIONS," is open to all gay and lesbian organizations. The Conference will also serve as a gathering of NGLTF's more than 100 member or Cooperating Organizations. The NGLTF Cooperating Organizations. The NGLTF Cooperating Organization Program was created in 1987 to knit the nation's gay and lesbian organizations into an effective activist network.

The CREATING CHANGE Conference has three goals: 1) to foster skill, resource and information sharing; 2) to support and develop gay/lesbian leadership at the local, state and national level; and 3) to strengthen our political movement by supporting the organizations and institutions that serve our community.

Technical skill-building workshops led by activists from across the country will be offered in the areas of lobbying, grassroots organizing, media action, development and fundraising, and direct action. Panels also will focus on current political debates within our movement.

The conference will be held at the Hotel Washington, Pennsylvania Avenue and 15th Street NW, Washington. Registration fees will range from \$50 - 100 depending on the size of an organization's annual budget.

COMING OUT



he phrase is heard often in the gay community used to describe the act of acknowledging our sexuality not only to ourselves but to other people as well. It's a deceptively simplistic phrase

implying that all of this is accomplished as easily as taking a single step out of the closet.

But coming out is much more. It is a life-long journey begun when we take that first step toward self-discovery. It involves whom we tell about our gayness and how we present survivelves to the world. It includes widening our spheres of pride and self-esteem with each new step we take. It is the life-long journey of integrating our homose smallty into the fabric of our lives. There can be no final destination to the journey, for with each new person we meet we are confronted with the same questions: Should I tell this person about my sexuality? When should I tell him? How should I tell her?

The first step is often the most difficult. At an early age we begin to hear the negative stereotypes about homosexuals. Confronting these myths with the image we have of ourselves requires a great deal of strength, and it as a step that a person ultimately must make by himself or herself. Not until he or she has taken that momentous step can they seek support within the gay community. As the gay lifestyle is discussed more openly in newspapers and magazines and on television and radio, the person on the threshold of taking that first step can learn that they are not alone in their feelings.

The second step usually involves seeking out other gay people. At this stage we are eager to share with them an openness that seems impossible elsewhere. We discover that there are all "types" of gay people, and we start to feel more comfortable in the fact that our sexuality is only a part of the fabric of our lives. A step beyond that involves coming out to people we are close to: family members and friends. This step is generally accompanied by the fear of rejection. Occasionally these fears will be realized, but many gay people find it difficult to maintain a relationship in the midst of constant deception, and they decide to take the risk. The majority of cases of "coming out" to femily and friends has lead to more honest and satisfying relationships with those around us, and our self esteem increases as we discover that there are others in the world who can accept and love us as

Despite all the positive effects, "coming out" may not always be the right thing to do. The question is not whether we should come out, but whether—and how far—we can afford to do so in any given situation. The reality in some people's lives demands that they keep their homosexuality a secret. In every case the decision to come out to someone must be a personal one.

If you're ready to tell someone but just don't know what to do, these guidelines may be useful:

- 1) Expect the unexpected. The person you expected to be most understanding may turn away from you, and those you thought would be most hart may experience no shock at all: "I always thought you were different, and I thought this might be a possibility."
- 2) Make sure you have the right motives. Too often the announcement slips out during a family argument when anger and hurt are the mutives. The transition to acceptance may take much longer when people are told in this fashion. Remember: you are telling someone because you love them and want to share your happiness with them.
- 3) Be confident, straight-forward, secure in your sexuality. Sometimes a parent's first

reaction will be: "we'll get you help. I've heard people can change." Confidence in your sexuality will go a long way in convincing them that it is not your sexuality that needs to change but their attitudes toward it.

- 4) Be prepared with facts. Be able to answer their questions or refer to them to literature that can help in their understanding. The books that helped you to accept your sexuality may be great literature and required reading of all gay people, but they may not convince purents that it is alright for their child to be gay. Books that include graphic passages of sexual activity are not generally comforting to parents. Many fine books written for parents are available. (See suggested reading for some of these.)
- Surround yourself with a strong support system.
 If your announcement is met with rejection, you will need someone who can supply emotional

- support. Maintaining your sense of self worth is critical.
- 6) Be patient. People often see the announcement with a sense of loss. Many of the same emotions that aurround the death of a loved one can follow the announcement that aurence is gny. Denial, anger, bargaining, depression, and finally acceptance are the stages a person goes though in dealing with grief. You can help them through these stages, but it is also important that you understand and accept the grief they are feeling.
- 7) Choose your words carefully. Words can wound as well as heal. This may be particularly important when parents are dealing with guilt. Guilt and blame assume something is wrong. Assure them there is nothing wrong with your sexuality and, therefore, no reason to feel guilty. Help them to understand that your sexuality has nothing to do with the way you were raised, and that homosexuality is not the result of family dynamics or the vegetables they made you eat.

Iowa State Adopts Non-Discrimination

Ames, IA -- Iowa State University has become the third college in the stats to adopt a non-discrimination policy protects gays and lesbians.

The expanded policy, first recommended in 1986 by the University Committee on Women, was approved during the summer by President Gordon Eaton.

"It is my hope that the revision in this policy will reflect the university's the university's continued committment to equal employment opportunity employees and will heighten the university community's aware-ness of the affirmative action necessity to hire individuals based on their abilities and

contributions educational environment," Eaton said.

The policy change affectional preference to the list of protected classes, which elso includes age, color, known handicaps, national origin, religion, sex, veteran status and marital status.

In the past two years, recommended policy change had been endorsed by such groups as the University Human Relations Committee, the Faculty Council, Professional and Scientific Council and the Supervisory Confidential Council.

The University of Iowa and Grinnell College have similar non-discrimination policies.



JEWISH GROUP ADDS GAYS

WASHINGTON- The Anti-Defamation League of B'nai B'rith - a longtime leader in the push to combat crimes motivated by hate of minority groups - revised its model hate crime statute this month to include crimes

against Gays.

The sexual orientation provision was added to the model statute by the Jewish group in response to a formal request by the National Gay and Lesbian Task Force in January. The model statute call for increased criminal penalties for acts of intimidation and harassment "in situations where persons are victimized on account of their actual or perceived race, relig sexual orientation, ancestry." The statute religion, also calls for training police officers in "identifying, training police responding to and reporting all criminal offenses motivated by race, color, national origin, or sexual orientation."

Only 4 states - California, Connecticut, Minnesota, and Wisconsin - have passed laws that either increase penalties for anti-Gay violence or require the collection of

data on such crimes.

"Given the key role that the Anti-Defamation League has played in promoting hate crimes laws throughout the United States," said Kevin Berrill, director of NGLIF's Anti-Violence Project, "the inclusion of 'sexuel orientation' in its model legislation should help to get our concerns heard when state bills are being drafted."

Karen Thompson was the keynote speaker at the 1988 Mini-Con sponsored by the Sioux Empire Gay and Lesbian Coalition on September 10 and 11 in Sioux Falls, South Dakgta.

Karen spoke eloquently of her journey from a totally closeted woman who happened to be in love and in a committed relationship with another woman to her present role as a Lesbian Activist. She described how she and Sharon Kowalski lived together for four years after exchanging rings, buying a house, and concealing their relationship from their families.

Karen told of the auto accident that left her lover brain damaged and of the months of intense work she devoted to helping Sharon return to a more normal life. Then she told of the anger and alienation between herself and Sharon's father who could not accept the fact that his daughter was a lesbian. Mr. Kowalski still claims that Karen is lying, that his daughter could never love another woman.

The Minnesota court system has appointed Sharon's father as her legal guardian and he has moved her hundreds of miles away from her former home in 5t. Cloud, placed her in a nursing home, and has forbidden her lover to even visit her.

Karen Thompson showed video tapes of Sharon Kowalski after the accident, as she was slowly and painfully learning to function with her new to function with her new limitations. She also shared with us graphic descriptions of how Sharon has deteriorated and regressed since entering that nursing home and being separated from those that truly Karen Thompson still love her. Karen Thompson still continues her battle to bring Sharon Kowalski home and will continue to do so. Sharon's story is told in a new book, "Why can't Sharon Come Home," and will be featured on a CBS special this fall. Plans are being made for the story to be in a movie with Miss story being This case Thompson consultant. serve as a landmark for cases not only of gay/lesbian rights but also for the rights of all physically challenged persons.

Sadly, though, Karen Thompson may never know personal victory in this case. As she said, "I don't know if we can still have a relationship. She's changed and I've changed so much in the three years since I could last see her. I don't know if we'll be able to fall in love all over again. I don't know if she'll love me as an activist but I know I can't go back."

Karen left us with one clear

Karen left us with one clear and shining message. If you are a gay or lesbian couple, take steps to protect your rights. Take out durable powers of attorney, draw up wills, make sure you are protected, but most of all, as Karen Thompson stated, "COME DUT OF THE CLOSET. This would never have happened to Sharon and I if we had been out. We will be made victims of the system as long as we let them do so. Coming Dut is the only way for us to be recognized and gain our rights."

BOSTON - About 60 attendees of the eighth Annual Black and White Men Together Convention last month presented the bellmen at the Boston Park Plaza Hotel with onions to express their displeasure with the bellmen's "homophobic and insensitive actions" during the week-long event.

Former BWMT Co-Chair Dean J. Credle said after members presented orchids to other staffers who had been particularly helpful during the convention, they decided to give the onions to the bellmen.

"They had been very blatantly whispering and pointing as members of the organization walked through the lobby." Credle said. "It was obvious that they had seldom seen people in a racially mixed group, especially a Gay group, showing affection for each other. They reacted very rudely."

Credle said during the convention new national officers were elected. San Francisco's John Teamer and Memphis' Michael Warner replaced Credle and Tom Horan as the organization's cochairs. Portland's Tim Wilson replaced Robert Addison as treasurer, and Tallahassee, Florida's Ullie Lee Taylor was once again named secretary.


