2006 Pride Walk 12PM Saturday May 13

Event day registrants please show up on Walk Day (Saturday, May 13, 2006) at First United Methodist Church, 7020 Cass in Omaha, between 12:00PM - 1:30PM. Use the 69th Street entrance. Go to the area marked Walker Registration.

If you register on Walk Day and do not submit any other pledges, your registration fee is considered your own participant pledge (30% goes to the GLBT Center, 70% goes to the second beneficiary you select during registration). You can choose to help all seven charity beneficiaries! You can pledge more during registration if you wish. All but \$5 of this participant pledge (your same day registration fee, plus anything else you contribute above that) is tax deductible.

Registration is \$35 on Walk Day, \$10 for participants under age 21 with ID.

There are refreshments before the walk and a barbecue supper afterward included in the price. You can pay your registration fee by Visa, MasterCard, cash or check payable to either "Rainbow Outreach Metro Omaha GLBT Center" or simply "Rainbow Outreach". Participant pledges do not qualify toward fundraising incentives, except a participant pledge above \$75 makes you eligible for Draw Prizes on Walk Day, which include a Wine & Champagne Gift Basket, and an iPod Shuffle.

Anyone who registers for the Pride Walk receives a ticket for Raffle Prizes, which include a Cuisinart Mini-Prep Food Processor. Additional raffle tickets are available at the Walk. Visit www.PrideWalk.org to learn more.

Everyone is invited. The Pride Walk Barbecue is part of the Finish Line Festivities where supporters reunite with walkers. The Barbecue serves up food and drink 3PM-6PM on Saturday May 13, 2006 (arrive 15 minutes early to cheer walkers crossing the finish line).

The Barbecue is open to all supportive community members, whether you signed up for the walk or not. Registered walkers receive free tickets to the Barbecue when they sign-in before the walk, while everyone else can purchase Barbecue tickets for \$8 each at the event site (\$5 for kids under 13).

All proceeds from the Pride Walk Barbecue go to support all seven charity beneficiaries - GLSEN Omaha, ICON Foundation, PFLAG Lincoln, PFLAG Omaha, Proud Horizons Youth Group, River City Mixed Chorus, and the Rainbow Outreach GLBT Center. Come celebrate with walkers, enjoy food and entertainment, and explore the expo.

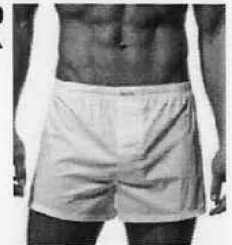

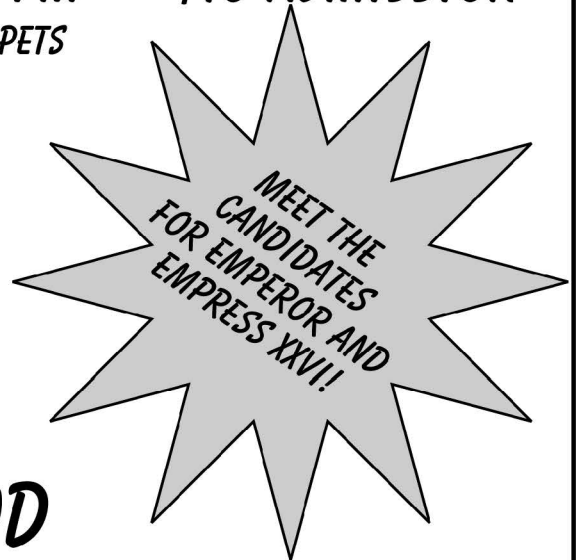

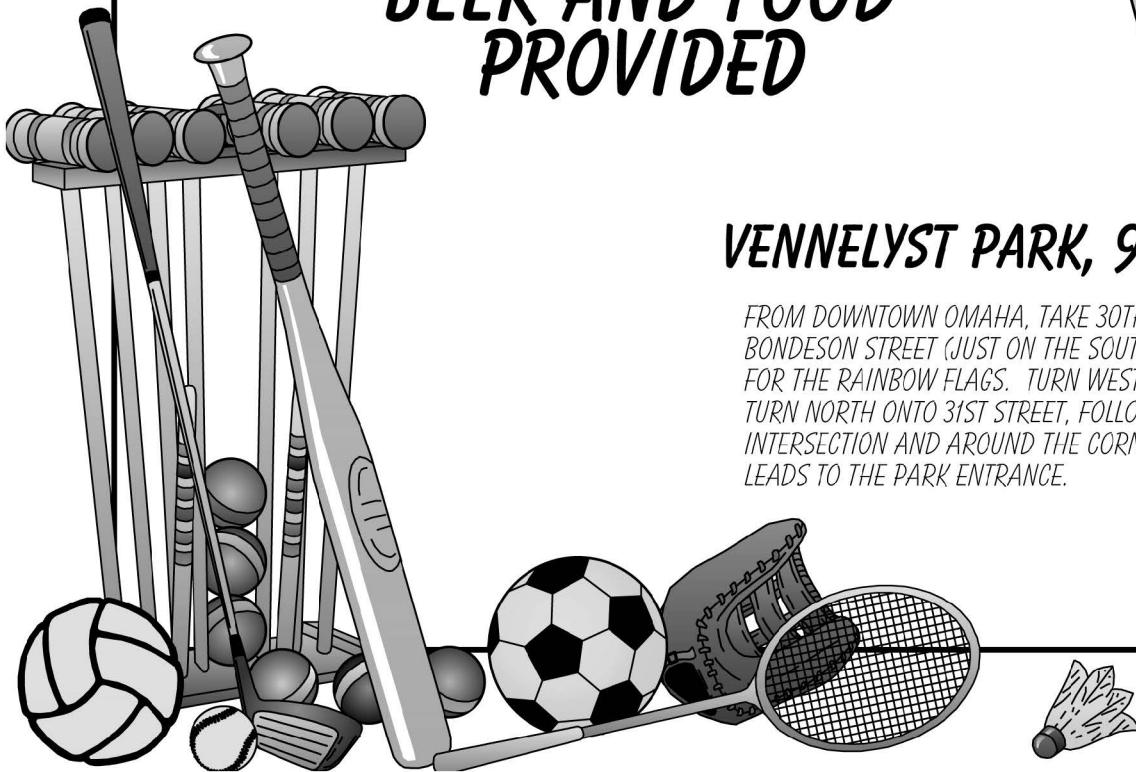

Thank You Dave !!!

On June 8, Omaha PFLAG will say thank you to Dave England for his 15 years as the primary adult leader of Proud Horizons, the PFLAG-sponsored youth support group. During that time, Dave has helped hundreds of gay, lesbian, bisexual and transgender young people at a critical time in their lives

Dave is stepping aside in June, and Tom and Barb Johnson will take over as the lead facilitators of Proud Horizons.

PFLAG members invite the entire community to join them in thanking Dave and his wife, Kathy, at a reception that will replace the group's monthly support meeting at 7 p.m. on Thursday, June 8, at First United Methodist Church, 7020 Cass St., in Mead Hall (separate entrance, west end of church).

Both Dave and Kathy are past presidents of Omaha PFLAG. They are widely known in the community due to their work in River City Mixed Chorus, Rainbow Outreach Center and other groups. Dave helped start Proud Horizons in 1991 when there was no place in Omaha for GLBT youths to come together and talk. Since then he has spent most Saturday afternoons at Proud Horizons meetings. Nothing is more important, Dave says. "After being in the group, youths learn they are not alone. They form social networks, increase their self-confidence and solve what seemed to them to be insurmountable problems."

HEARTLAND RODEO 2006

The 8th Heartland Rodeo presented by Casteel Venture Group will be held at the Sarpy County Fairgrounds in Springfield NE May 20-21. More than 70 contestants from throughout the United States and Canada are scheduled to compete; several International Champions among them.

Since 2000 HGRA has donated over \$80,000 to local charities. The Heartland Rodeo is part of the International Gay Rodeo Association (IGRA) which is the second largest rodeo sanctioning organization in the United States. IGRA produced its first rodeo in 1985 and has raised millions of dollars for charity.

This year's rodeo will begin at 4pm on Saturday May 20th and immediately following the rodeo Nashville recording artist Steff Mahan and her band will be in concert. Local recording artist Tamara Marks will also entertain and sing a few songs from her soon to be released CD. On Sunday the rodeo will begin at noon. On Sunday we will wrap it up with the awards ceremony at 7:00pm at the fairgrounds.

"Attention: Omaha area GLBT homeowners in trouble! There is a solution!"

Many Omaha area gay and lesbian homeowners who have had trouble with credit cards and so on have found that there is *one* place in Omaha where they can be treated with respect.

No "better than you" attitude, no "b.s.", no guilt just for being gay or lesbian.

At last, finding financial help doesn't have to be like a "coming out" at Thanksgiving dinner with everyone pointing fingers, and finding fault.

Mindy Hahne, of Service First Home Mortgage in Omaha's Midtown area works at a GLBT friendly outfit that *specializes* in helping Omaha area GLBT homeowners in need.

Hahne says she takes great pride in being gay and lesbian friendly. And treating the folks she helps like family.

"A lot of people in the GLBT community don't realize that even *without* gay marriage, or civil unions, there are already several equal protections in place for gay and lesbians as real property owners! Maybe because *no one else* wants to tell you about them!" Mindy says.

"Being gay or lesbian doesn't have to be a barrier to equal treatment anymore!" Hahne says.

Hahne has helped many gays and lesbians over the years, many personal friends.

"I am the one person in town that *specializes* in helping gay and lesbian folks with debt consolidation, cash out, credit repair and so on!" Hahne says.

"These are good people with damaged credit reports and/or hard to prove income! Not through any fault of their own! I *specialize* in helping the gay and lesbian community get a *fair shake* from the financial industry!" Hahne says.

Hahne says she has a lot of connections to Wall Street money, "I have personal relationships with investors *nationwide*, even *internationally*! Fair-minded people who want to fund loans for people with past credit problems!" she says.

"Many of them have a social conscience! And they take pride in helping gay and lesbians in particular! Just like I do! They use my *proprietary* system as their own little bit of "social activism!" Hahne says.

These investors are people who buy 'pools' of mortgages of 50 million dollars at a whack! 50 million bucks! It's taken me 4 long years and it's been *really* hard to find these 'fat cats!' People who are 'like-minded' about what I do for the Omaha gay and lesbian community!" Mindy says.

"Not only is it *illegal* to discriminate against the GLBT community, it's just plain *wrong!*" Hahne says. "The self-limiting perceptions held by some in the community are just as much of a problem as the crooked people who perpetrate the discriminatory practices themselves!" she says.

Hahne says, "It's my *personal mission* to change the mindsets! And to *liberate everyone* from the restraints!"

"I grew up in a house where we didn't have much money! And my parents understood just how money *really* works even less! Nowadays, it's a lot of fun for me to help people get control over their money and their lives!" Mindy says.

AN OPEN LETTER TO THE COMMUNITY

FROM MAXCO II, LLC
Patrick M. , President

Over the past three years, you may have heard the story of how we stole the building at 1407 Harney Street, formerly known as Gilligan's Pub. It is my intention to give you the facts of the case:

1. In the winter/spring of 2003, the building was being foreclosed on by the Bank of Auburn, Nebraska. Ken Carlson could not get any bank to make a loan for him to cover the Auburn loans. I referred him to two banks myself.
2. Ken Carlson had not paid the real estate taxes on 1407 Harney in five years. The building was in tax sale and would have been sold had I not paid the taxes.
3. The building had been condemned by the City of Omaha for bricks falling from the upper floors. Remember the scaffold out front for all those years.
4. Ken Carlson never paid Town and Country for the heating and air-conditioning system installed in the building.
5. Ken Carlson never paid Nebraska Furniture Mart for the flooring and in fact won a judgment for \$30,000.00 against the Mart.
6. Ken Carlson never paid D.J. Electric for work on the building until a court order required him to do so.
7. Ken Carlson borrowed \$40,000.00 from his sister J.D. and her husband to pay D.J. Electric. They mortgaged their house for him and J.D.'s husband had to delay retirement because of this.

In the winter/spring of 2003, Ken Carlson approached me to purchase the building. He said "If I'm going to lose the building, I might as well lose it to you." I bought the building and contents by paying off the Auburn Bank loans, paying all the back taxes and repairing the brick work on the building.

I agreed that Ken could operate Gilligan's as long as he paid his rent which covered my costs. I would profit from the building by developing the upper floors. Ken Carlson paid rent for six weeks then stopped. I had no choice but to file an eviction. This started a three year legal battle while I continued to pay mortgage payments, taxes and insurance on the building.

Now Carlson has declared bankruptcy and is trying to [avoid] paying the back rent that the court has awarded me and many others who are included on the list of creditors I have attached.

I have hired an attorney to contest Ken's bankruptcy. Ken should be held accountable to the people who tried to help him over the years.

It was never my intention to close down Gilligan's Pub. It was my intention to help Ken keep the business operating even though he was going to lose the building. Ken has showed his true colors through this battle. He is solely responsible for the downfall of Gilligan's Pub. If he had run the business right from the beginning and paid his bills like the rest of us, he would own the 1407 Harney Street property outright. Ken, however, decided to run things by deceit and deception. He can point that long finger at everyone else around him, but ultimately there are three fingers pointing right back at him. Project Samson

The Rural AIDS Prevention Project (RAPP), headquartered in Norfolk, Nebraska is pleased to announce the start-up of a new HIV risk reduction/prevention initiative called Project Samson. This is an entirely free and anonymous program targeted toward Men Who Have Sex With Men, and is conducted entirely on-line via live chat. The program is presented as a series of sessions offered throughout the day.
