



## Duck Dynasty's Phil Robertson Goes on Another Anti-Gay Rant

Duck Dynasty patriarch Phil Robertson has doubled down on his homophobic Christian views, giving an Easter sermon in which he lumps gay people in with thieves and swindlers.

Duck Dynasty patriarch Phil Robertson has again aired his homophobic views that saw him temporarily suspended from the show in an Easter sermon that was posted online on 20 April.



The video was posted by Robertson's Whites Ferry Road Church so it seems he wanted people to see it. In it he compares gay people to thieves, drunkards and swindlers and complains about how he was treated over his former comments. 'They were mad at me ... because instead of acknowledging their sin, like you had better do, they rail against me for giving 'em their truth about their sin.'

Robertson says in the video 'Don't deceive yourselves. You want the verse? The news media didn't even know it was a verse. They thought I was just mouthing off.' Robertson then went forward to double down on his previous comments about gay people saying, 'Is homosexual behavior a sin?' 'Do you not know that the wicked will not inherit the kingdom of God?'

Don't be deceived. Neither the sexually immoral, neither the idolaters, nor adulterers, nor male prostitutes, nor homosexual offenders, nor thieves, nor greedy, nor drunkards, not slanderers, not swindlers, will inherit the kingdom of God.'

Robertson's A&E network temporarily suspended him from his show after his last comments, but they are yet to respond to these more recent comments.

## US Postal Service Dedicates Stamp to Gay Rights Icon Harvey Milk at White House Ceremony

US Postal Service: Americans can now begin mailing letters with a stamp bearing the likeness of Harvey Milk, one of the nation's first openly gay elected officials. The stamp was dedicated at a White House ceremony on Thursday (May 22nd) which was attended by Stuart Milk, co-founder of the Harvey Milk Foundation and the slain politician's nephew.

Milk joins other civil rights pioneers honored with stamps including Martin Luther King Jr and Caesar Chavez.



'We have this beautiful stamp to remind us that hope resides in you, hope resides in me,' Stuart Milk told the crowd. 'As President (Barack) Obama said about Harvey: 'Hope unashamed. Hope unafraid.'" Obama, traveling to New York, did not attend the ceremony. But other political leaders did including House Minority Leader Nancy Pelosi and Congresswoman Tammy Baldwin, the first openly lesbian woman to serve in Congress.

Baldwin said to the crowd: 'Standing here as a United States senator and a lesbian, it's incredible to look back upon a time when running for San Francisco supervisor as an openly gay man seemed like a revolutionary act, and Harvey knew that. He welcomed the attention, he weathered the insults, he shrugged off the death threats. And it wasn't to satisfy his own ambition but rather to answer the call he felt, to move the cause of equality forward.'

She added: 'He ran for office so others wouldn't have to run from who they were. He spoke out so others wouldn't feel

compelled to live in silence.'

The stamp dedication took place on what would have been Milk's 84th birthday and what in California is Harvey Milk Day.

He was the first openly gay man to be elected to public office in California as a member of the San Francisco Board of Supervisors. Milk fought hard against discrimination - including Proposition 6, a ballot initiative that would have made firing gay teachers - and any public school employees who supported gay rights - mandatory. It lost by a million votes.

As a supervisor, Milk was responsible for passing a stringent gay rights ordinance for the city. But just 11 months into his term, he and Mayor George Moscone were shot to death inside City Hall by former Supervisor Dan White.

Milk was just 48 years old and had been a gay rights activist for less than a decade. 'He gave his life,' Stuart Milk said of his uncle. 'He knew those bullets were coming. That did not stop his message, which was that people have to be present, they have to be authentic, they have to take off their masks.'

This stamp represents the fact that, 35 years after he was assassinated, we are seeing historic levels of people being visible.

# RuPaul: I love Using the Word 'Tranny'

RuPaul Charles has defended his use of the transphobic slur 'tranny'. The world's most famous drag queen broke his silence following the outrage by some transgender people who criticized him as well as the show RuPaul's Drag Race.



Trans performers Monica Beverly Hillz and Carmen Carrera, who were contestants on the show, have also objected to the slur being used.

'Does the word tranny bother me? No. I love the word tranny,' Charles said. 'It's not the transsexual community who's saying that. These are fringe people who are looking for storylines to strengthen their identity as victims. That is what we are dealing with. It's not the trans community. 'Cause most people who are trans have been through hell and high

water. And they've looked behind the curtain at Oz and go, "Oh, this is all a freaking joke." 'But some people haven't and they've used their victimhood to create a situation where, "No! You look at me! I want you to see me the way you're supposed to see me!"

Charles added: 'If your idea of happiness has to do with someone else changing what they say, what they do, you are in for a freaking hard-ass road.' He said he believes everybody has the right to be whatever they want to be. 'I ain't stopping you. But don't you dare tell me what I can do or what I can't — say or do. It's just words, like, "Yeah, words hurt me!" 'Bitch, you need to get stronger. If you're upset by something I said, you have bigger problems than you think.'

In the interview with Marc Maron, the drag queen also addressed the controversy over the 'You've Got Shemail' — the pun that introduces the challenge each week. 'Just recently, our show got into some thing with,' he said. 'But these are four people who have a Wi-Fi connection, sit behind a computer in God knows where, and deliberately misinterpret our verbiage, and decide, "You hurt me."

'We are not doing anything to you. That's how you interpreted it. And you have the freedom to do that. But we are coming from a place of love. 'You know, I can call myself a nigger, faggot, tranny all I want to, because I've fucking earned the right to do it. I've lived the life,' he added. 'I've actually stayed away from this dialogue forever because it's a lose-lose situation. You cannot win with this. 'I believe what I believe. You believe what you believe. Let's just call it a truce.'

## Utah Ordered to Recognize More than 1,000 Gay Marriages

SALT LAKE CITY (AP) — A federal judge ordered Utah officials Monday to recognize more than 1,000 same-sex marriages that took place in the state before the U.S. Supreme Court issued an emergency stay.

The American Civil Liberties Union filed the lawsuit in January on behalf of four couples who said the state's decision to freeze benefits for same-sex couples violated their rights. The couples cited concerns such as having a partner legally recognized as a child's second parent.

The gay and lesbian couples married in Utah after a federal judge overturned the state's same-sex marriage ban Dec. 20. Those weddings came to a halt Jan. 6 when the Supreme Court granted the stay.

Utah officials argued that they had no choice but to hold off on benefits until an appeals court rules on the state's same-sex marriage ban.

U.S. District Judge Dale Kimball disagreed in his ruling Monday, saying Utah's decision to freeze all benefits put the couples in an unacceptable legal limbo regarding adoptions, child care and custody, medical decisions and inheritance, among other things.

"These legal uncertainties and lost rights cause harm each day that the marriage is not recognized," Kimball wrote.

He stayed his ruling for 21 days to allow the state an opportunity to appeal the ruling to the 10th U.S. Circuit Court of Appeals in Denver.

Utah officials didn't immediately have any comment.

The ruling has no bearing on a decision pending from the 10th U.S. Circuit Court of Appeals in Denver about the constitutionality of the same-sex marriage ban that Utah voters passed in 2004.

The couples who brought the lawsuit celebrated the rul-

ing.

"It's nice to see our relationships recognized with such compassion," said Marina Gomberg. "It's a big win for Utah and for Utah families."

She said the ruling means they can once again begin planning to have children. The couple said they didn't want to start a family without knowing they would be able to both be legally recognized parents.

But the legal limbo isn't completely over. The state may still appeal, and what happens with adoptions remains unclear.

On Friday, the Utah Supreme Court ordered a temporary halt of several district judges' orders requiring the state health department to issue birth certificates in adoptions by same-sex parents. The attorney general's office praised the decision, saying the stay will remain in effect until the issue has been resolved by the court. The court has not yet announced a date for oral arguments.

Matthew Barraza and Tony Milner married in December and have a pending request to have Milner recognized as a legal parent of their 5-year-old son, Jesse. Barraza said the ruling has made him and his husband ecstatic and hopeful, but they remain cautious.

"We're happy, obviously with it, but we've learned also to not pop the champagne just yet," Barraza said.

The conservative Sutherland Institute of Utah decried the ruling in a statement, saying it rewards "judicial overreaching" and gives too much merit to a "novel ruling" by one judge.

"Our system is weaker when judicial gamesmanship is not kept in check," said Bill Duncan, the institute's director of the center for family and society. "We trust the 10th Circuit will do that quickly."

The ACLU argued that the marriages performed during the 17-day window when gay marriage was legal are valid no matter what the appeals court rules.

In issuing the freeze in early January, Gov. Gary Herbert told state agencies to hold off on any new benefits for the couples until the courts resolve the issue. Agencies were told not to revoke anything already issued, such as a driver's license with a new name, but were prohibited from approving any benefits.

The state tax commission announced, however, that newly married gay and lesbian couples can jointly file tax returns for 2013.

The state has made clear it was not ordering agencies to void the marriages, saying instead that validity of the marriages will ultimately be decided by the 10th Circuit, which is weighing the state's appeal.

The 10th Circuit heard arguments in Utah's case in early April, and a ruling is expected soon.

Since its founding in 2003, IPN has helped students bring GSAs and LGBT groups to 20 percent of public high schools and 80 percent of colleges, impacting thousands of students each year. GSAs are student-led groups and clubs that focus on educating classmates to combat homophobia, transphobia and bullying. IPN's student advocates have played a key role in changing laws and policies that impact young people at the local and state levels, including helping to pass Iowa's historic Safe Schools Law and amended Civil Rights Law in 2007.

"Under the leadership of One Iowa, Iowa Pride Network's student organizing and GSA efforts will continue to grow and ex-

pand its work to every corner of the state," said Donna Red Wing, Executive Director for One Iowa. "For the past several months, One Iowa and IPN leadership have had some remarkable conversations about the potential these two organizations might have working together. IPN has been a leader working with Gay Straight Alliances in Iowa, and we are delighted and honored to bring this work into our One Iowa family."

"Our students will become our future equality leaders, and we must ensure that they feel safe and protected no matter where they are--but especially at school, where LGBT students can often feel most vulnerable," Red Wing added. "We honor and recognize IPN's historic work over the past decade and we look forward to providing its students with the support and resources they need to lead the transformation of our state into one that embraces equality for all Iowans, including our LGBT youth."

"The union between Iowa Pride Network and One Iowa will allow us to amplify the voice of young people," said Ryan Roerman, co-founder and departing Executive Director of IPN. "This collaboration will mean a great deal for Iowa's LGBT youth, and we are excited to make this historic step forward with One Iowa."

While all schools in England must teach pupils about HIV as part of the science curriculum, campaigners say it is not good enough.

A survey carried out by the Sex Education Forum in 2011 found one in four young people learnt nothing about HIV at school.

Government guidelines say schools should cover the issue in Personal, Social and Health Education, but as the subject is not compulsory they can choose not to follow this advice.

Daisy Ellis, acting director of policy at the Terence Higgins Trust, said there was "too much variability" on how sex education was taught in schools and that children should not have to rely on a "random biology lesson" to be taught about HIV.

She added: "There really is no guarantee that young people are getting the right skills, the right knowledge and understanding that they need to have healthy adult relationships."

"We want to see sex and relationships education as part of the curriculum so it has that equal footing and isn't just something that's pushed to one side."

If Labour wins the next general election in 2015, leader Ed Miliband has pledged to make sex education compulsory in state-funded primary and secondary schools.

Wales already has compulsory sex education, but in Scotland there is no statutory requirement for schools to teach it.

A Department for Education spokesperson said: "Pupils must learn about sexually transmitted infections such as HIV/AIDS as part of sex and relationship education."

## Federal Judge Strikes Down Oregon's Gay Marriage Ban

PORTLAND, Ore. (AP) — A federal judge on Monday struck down Oregon's voter-approved ban on gay marriage, saying it is unconstitutional.

U.S. District Judge Michael McShane said the ban unconstitutionally discriminates against same-sex couples and ordered the state not to enforce it. State officials earlier refused to defend the constitutional ban in court.



McShane joined judges in seven other states who have struck down gay marriage bans, though appeals are underway.

Oregon state officials have said they'd be prepared to carry out same-sex marriages almost immediately, and couples lined up outside the county clerk's office in Portland in anticipation of the McShane's decision.

Laurie Brown and Julie Engbloom arrived early Monday at the Multnomah County Building to form the line for marriage licenses. The two have been a couple for 10 years. Engbloom proposed in April, when they celebrated their anniversary by climbing Smith Rock in Central Oregon.

"We always knew we wanted to spend our whole life together," Brown said. "This opportunity has come, it feels right, everything has fallen into place."

Four gay and lesbian couples brought the Oregon cases, arguing the state's marriage laws unconstitutionally discriminate against them and exclude them from a fundamental right to marriage.

Democratic Attorney General Ellen Rosenblum refused to defend the ban, saying there are no legal arguments that could support it in light of decisions last year by the U.S. Supreme Court.

She sided with the couples, asking the judge to overturn the ban, and says she won't appeal.

The judge denied a request by the National Organization for Marriage to defend the law on behalf of its Oregon members.

A panel of the 9th U.S. Circuit



Court of Appeals on Monday refused the group's request for an emergency stay of that decision, allowing same-sex marriages to proceed.

Gay rights groups previously said they've collected enough signatures to force a statewide vote on gay marriage in November. But they said they would discard the signatures and drop their campaign if the court rules in their favor by May 23.

The U.S. Supreme Court last year struck down the 1996 Defense of Marriage Act, which barred the federal government from recognizing same-sex marriage. It determined the law improperly deprived gay couples of due process.

In addition to Oregon, federal or state judges in Idaho, Oklahoma, Virginia, Michigan, Texas, Utah and Arkansas recently have found state same-sex marriage bans to be unconstitutional. Judges also have ordered Kentucky, Ohio and Tennessee to recognize same-sex marriages from other states.

But opposition remains stiff in many places. Critics note most states still do not allow gay marriage and that in most of those that do, it was the work of courts or legislatures, not the will of the people.

Oregon law has long prohibited same-sex marriage, and voters added the ban to the state constitution in 2004. The decision, approved by 57 percent of voters, came months after

Given all of this, it's a miracle that more of us aren't really screwed up by growing up LGBT in a very non-LGBT world. Many of us grow out of the "best little boy/girl in the world" syndrome into healthy, mature men and women.

But, many of us still struggle with this internal censor, this superego-driven life that continually tells us that we aren't good enough, don't do things right or (our deepest fear) that we are fundamentally flawed and there's nothing we can do about it.

Using Freudian terms, I want to introduce the ego and the id. The id is the part of you that wants to go wild, be free and spontaneous. Good little boys/girls are usually terrified of their ids: they want us to stop being so careful and perfect.

Welcome the hero/ine of our story: the ego. The ego is that part of us always seeking balance: continually balancing our extremes to keep us neither too rigid/repressed nor too wild/out-of-control.

For many of us, our ego is pretty weak. A strong ego can handle a lot of stimulation and not get overwhelmed. A strong ego won't let you get too rigid or controlling: it'll warn you in a myriad of ways, "Danger, danger...this isn't making me happy."

A strong ego means death to hyper-achievement and the end of the best little boy/girl in the world syndrome.

We live in a terribly heterosexist world that isn't a good fit for us in so many ways, but - with a strong ego - we can find our own path and create a loving, supportive world for ourselves no matter where we choose to live and work.

Luckily for us, the ego never stops: the id is always screaming, "Let me out, I wanna be free!" and the superego continually tells us, "Just shut up and suck it up, or there's gonna be trouble."

The ego is like your ideal parent, protecting you from too much scary stuff and encouraging you to try new things and take risks to grow.

Although most of us were raised to be the best little boys/girls in the world, we don't need to continue to be this way. Begin to give yourself the freedom to be the best version of yourself, rather than having to be someone else's idea of "the best".

It's time for all of us best little boys/girls in the world to grow up.

Here's the bottom line: there is nothing wrong with you. You are not flawed. You are a human being on a journey through a very complex world and you are doing the best you can.

You are the perfect version of you: unique and wonderful. Be open to these truths and begin to leave your old rigidity and perfectionism behind.

## Life Beyond Therapy

The Best Little Boy in the World

In a recently published study, Drs. John Pachankis and Mark Hatzenbuehler have substantiated what's called the "Best Little Boy in the World" syndrome (from the 1973 book by Andrew Tobias).

It's the idea that young, closeted men deflect attention from their sexuality by overinvesting their energy in achievement-related success: good grades, elite employment, competition and an over-emphasis on appearance, much more so than heterosexual men.

What does this mean for us LGBT men and women? To me, the bottom line is:

"We're fundamentally flawed and we'd better hide it well."

- 1 lb. Italian sausage, casings removed
- 1/2 cup celery, diced
- 1/2 cup onion, diced
- 1 14.5 oz. can peeled and diced tomatoes
- 1 15 oz. can tomato sauce
- 1/4 tsp. garlic powder
- 1/2 tsp. salt
- 1 tsp. dried oregano
- 1 lb. dry ziti pasta
- 2 4.5 oz. cans sliced mushrooms, drained
- 8 ozs. mozzarella cheese, shredded
- 1/4 cup grated Parmesan cheese

### Steps

1. Preheat oven to 350 degrees
2. In a skillet over medium heat, mix sausage with celery and onion. Cook for about 5 to 10 minutes until sausage is evenly browned. Drain grease and set aside mixture.
3. In another skillet over medium-low heat, mix tomatoes, tomato sauce, garlic powder, salt, and oregano. Let it simmer while preparing pasta.
4. Bring a large pot of lightly salted water to a boil. Cook pasta for 8 to 10 minutes, or until al dente; drain.
5. In a 3 quart baking dish, layer ziti, sausage, mushrooms, mozzarella cheese, and sauce. Repeat layers, and top with grated Parmesan.
6. Bake for 45 minutes in the preheated oven, or until browned and bubbly.

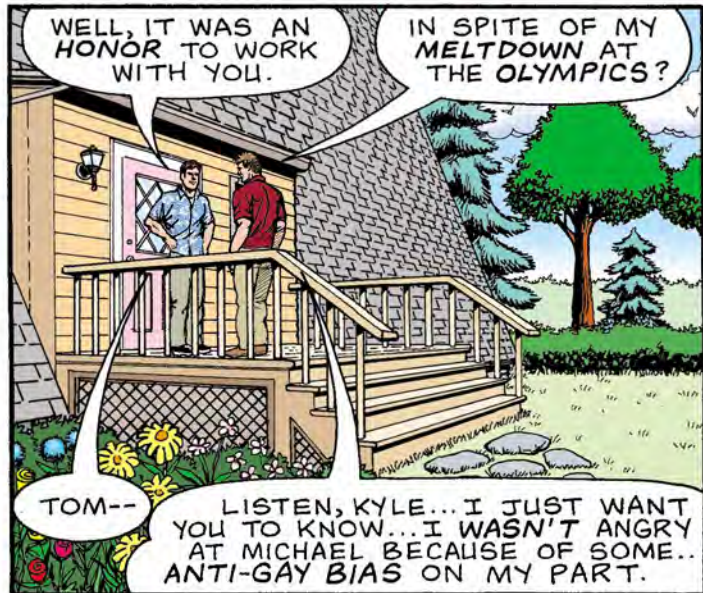
