Naked AIDS Activists Protest at Boehner's Office



The activists, with slogans painted on their bodies, were objecting to proposed cuts to AIDS programs.

Seven naked protesters occupied one of House speaker John Boehner's offices this morning, demanding that budgets for AIDS-related programs not be cut, and three were arrested.

Boehner was not present at the office in the Longworth House Office building in Washington, D.C., as he generally uses an office suite in the Capitol, across the street. However, several aides were there as the protesters stripped to reveal slogans painted on their bodies, such as "AIDS Cuts Kill" and "Fund PEPFAR, Fund Ryan White, Fund Global Fund, Fund Medicaid, Fund HOPWA." The activists represented Queerocracy, ACT UP New York, and ACT UP Philadelphia.

The protest came as President Obama and congressional leaders are engaged in budget negotiations, with both tax increases and spending cuts on the table. Eustachia Smith of ACT UP New York said in a press release that if proposed cuts go through, "global health programs will lose \$689 million, while domestic AIDS programs will lose \$538 million."

Added Cassie Gardner of Queerocracy: "When you strip away the rhetoric of the fiscal cliff and the grand bargain, you see that these terms are a way to thinly veil draconian budget cuts that will leave millions around the world with absolutely nothing."

They also noted that Secretary of State Hillary Clinton is scheduled Thursday to release a global plan for ending AIDS, but the proposed cuts would make it "nearly impossible" to stop the pandemic. On Saturday, World AIDS Day, hundreds of AIDS

activists are expected to march on Washington in hopes of preventing the cuts.

A Capitol Police spokesman told ABC News that three women protesters were arrested on charges of "lewd and indecent acts." It was unclear why the other four demonstrators, all men, were not.

Petition Calls For Barclays, Citibank To Condemn Uganda's 'Kill The Gays' Anti-Homosexuality Bill

More than 370,000 people have signed a Change.org petition calling on Citibank and Barclays to condemn Uganda's so-called "Kill the Gays" bill.

In the introduction to the petition, creator Collin Burton of



Washington, D.C., explains:

Ugandan legislators have re-introduced the dangerous Anti-Homosexuality Bill, a proposed law that would criminalize homosexuality in the country with extreme penalties. Under this proposed law, LGBT people could be killed or sentenced to life in prison, solely because of their sexual orientation or gender identity.

As the bill's author, David Bahati, has said he believes the government of Uganda should "kill every last gay person." (1) And recently, the Speaker of the Ugandan Parliament vowed to pass this dangerous legislation before the end of the year, calling it "a Christmas gift." (2) The vote is expected to happen any day.

As Joe Mirabella, Director of Campaigns at All Out, pointed out in a recent blog post, the Ugandan parliament officially



added the bill to its schedule last Wednesday and could be voted on this week.

"It is expected to easily pass, and then it will be up to Ugandan President Yoweri Museveni to veto the bill," Mirabella wrote in a blog for The Huffington Post.

Museveni's veto could still be overturned by the assembly, however.

In an email to subscribers of the petition site on Tuesday, Mark Anthony, a Change.org senior campaigner said that "one way to stop this bill is to get pressure from banks that have significant resources invested in the country, such as Citibank and Barclays."

The two banking giants, explained Anthony, together "have hundreds of millions of dollars invested in Uganda and wield significant influence in the country, just as banking lobbyists wield influence with Congress in the US." A vocal condemnation of the "Kill the Gays" bill by Citibank and Barclays might therefore "be the best -- and only -- chance to stop it."

This, says Burton, a gay Citibank customer and LGBT advocate, is why he chose to spearhead this call to action.

"I expect Citibank and Barclays to live up to the values of equality and fairness, not just list them on their websites," he said earlier this year, according to a press release.

Citibank and Barclays are well known for their LGBT-positive policies. Both banks received a 100 percent rating from the Human Rights Campaign's Corporate Equality Index this year, earning them the accolade of the "best places to work for LGBT employees" in the United States. Earlier this year, Barclays -- regularly ranked as one of the best companies for LGBT employees -- was also named the most LGBT-friendly company in Scotland.

The petition, which is addressed to the two banks, reads: With the "Kill the Gays" moving quickly in Uganda's parliament, you have unique and necessary voice that could help stop this bill in its tracks. Your presence in Uganda is significant, and your voice in opposition to the Anti-Homosexuality Bill could have a profound impact in keeping LGBT people safe in Uganda.

In 2010, the UN Special Rapporteur on health, Anand Grover, warned that the bill is "not only a violation of the fundamental



human rights of Ugandans, but will also undermine efforts to achieve universal access to HIV prevention, treatment, care and support."

Like in many other sub-Saharan African countries, same-sex relations are already criminalized in Uganda. However, the bill, first introduced in 2009, would make the penalties far more severe.

Although the BBC and other news organizations reported last week that Uganda's parliament has dropped the controversial death penalty provision of the bill, Think Progress notes that it would be "irresponsible to suggest that the death penalty has been removed without a thorough investigation of the bill's new language" -- something that has not been made public.

Regardless, even without a death penalty, the law would still "represent a barbaric regression for Uganda's human rights record," wrote Jim Burroway on Box Turtle Bulletin after dissecting the bill.

Elmo Sex Scandal: Kevin Clash Faces Third Underage Sex Allegation

Kevin Clash, the voice of Elmo, faces more allegations of underage sexual activity.

Today's sex allegation is brought to you by the number three.

Puppeteer Kevin Clash, who resigned amid controversy as Sesame Street's voice of Elmo, faces yet another allegation of underage sex.

In a lawsuit filed today, Clash is accused of sexual activity with a 16-year-old in 2000, according to the New York Daily News.

The unidentified accuser, now 29, alleges that he



met Clash on a gay chat service about 13 years ago. His lawyer, Jeff Herman, told the paper that the two met at Clash's New York apartment and engaged in "some sexual activity."

The new allegation comes just a week after 24-year-old Cecil Singleton filed a lawsuit claiming that the two had inappropriate contact when Singleton was 15, according to TMZ.

Singleton, who is also represented by Herman, is suing Clash for more than \$5 million in damages in that case.

Clash resigned from his longtime job at the children's television program after he was accused by yet another defendant, Sheldon Stephens, who also claims that he was 16 when Clash had sex with him.

In a confusing turn of events last week, Stephens recanted his story in a settlement with lawyers, and then renewed his accusations. Stephens claims that he was pressured into the flip-flop for a \$125,000 settlement.

Sesame Workshop, the non-profit organization behind Sesame Street, issued a statement last Tuesday announcing Clash's resignation. According to the Wall Street Journal:

"Unfortunately, the controversy surrounding Kevin's personal life has become a distraction that none of us wants, and he has concluded that he can no longer be effective in his job and has resigned from Sesame Street."

Clash maintains that he never had sex with a minor, and his lawyer told the Daily News that the newest allegations have "no merit."

France to Open World's First Gay Mosque

According to the Jerusalem Post, a gay French-Algerian man, Muhammad Ludovic Lütfi Zahed, is planning to open the first gay mosque in France at the end of this month. A Turkish newspaper, Hurriyet, repoted that the mosque will not have the gender exclusions that other mosques do.

"In normal mosques, women have to sit in the back seats and wear a headscarf and gay men are afraid of both verbal and physical aggression." Zahed told reporters. "After performing the Hajj, I realized that a mosque for gays was a must for gay Muslims who want to perform their



prayers." The new mosque, says Zahed, will not segregate

women and women even during prayers.

Zahed's marriage to Qiyam al-Din earlier this year was reportedly approved by an imam and made national headlines after they married (legally) in South Africa but France refused to acknowledge it.

'Ex-Gay' Pastor Charged With Sexual Assault

A Minnesota pastor who participated in an "ex-gay" ministry that tries to "pray away the gay" has been charged with sexually assaulting two men he was counseling, reports the Star Tribune.

The Rev. Ryan J. Meuhlhauser, 55, is the senior pastor at Lakeside Christian Church in Cambridge, Minn. and was a counselor for Outpost Ministries, based in Robbinsdale, Minn., reports the Star Tribune.

Citing the criminal complaint that landed Meuhlhauser in court on Tuesday for eight felony counts of fourth-degree criminal sexual conduct, the Star Tribune reports:

"One of the men told investigators that Meuhlhauser has 'blessed' him by cupping his genitals outside of his clothing several times and that Meuhlhauser asked the man to masturbate in front of him for 'spiritual strength.' Meuhlhauser would

also fondle the man at times. Their encounters occurred over a period of nearly two years."

The criminal complaint also details similar allegations of sexual assault made by another man, who claims the assaults took place at the church, in a "prayer cabin" belonging to the



church, and at the home of a relative of one of the victims.

According to its website, Outpost Ministries "exists to help the sexually and relationally broken find healing and restoration through relationship with Jesus Christ," and regularly refers to same-sex desires as "sin."

"Outpost Ministries is deeply grieved over the allegations regarding Ryan Meuhlhauser," said a statement on Outpost's homepage. "Outpost fundamentally stands against sexual abuse and exists, in part, to minister to those who have been wounded by such violence. Ryan is not and never has been a member of Outpost staff nor was he a pastor to whom we referred clients. We continue to stand with the two young men who experienced this atrocity and we desire to help them in any way we are able. Our sorrow and prayers go out to all who have been sexually violated."

Aside from distancing itself from Meuhlhauser - without actu-

ally confirming that he never worked for the "ministry" — Outpost's statement recycles false claims often used by antigay pundits who claim that same-sex attraction is a result of suppressed sexual trauma, incest, or a lacking relationship with a parent of the same sex. Additionally, every major psychological and medical association has disavowed "ex-gay" treatments, also known as "reparative therapy," calling the practice harmful and based in prejudice against LGBT people.

Lakeside Christian Church told the Star Tribune that it was "deeply saddened" by the allegations, and urged any potential victims to contact police.

Anti-LGBT Crime Still Increasing in Washington, D.C.

This month may not be the bloodiest in Washington, D.C., but anti-LGBT violence is still on the rise there despite a change in police procedures aimed at lowering these crimes. According to the New York Times, city data shows anti-LGBT bias crimes are rising, but "there is disagreement over whether the numbers reflect an actual increase in violence, more reporting of crimes, better record-keeping by the police or some combination of all three."

Last month a 23-year-old gay man was beaten in the city's Columbia Heights neighborhood, though it was nothing like last year's rash of high-profile attacks (mostly against trans women and gay men) including one by an off-duty police officer.

While some of the city's most prominent LGBT leaders have been voicing their frustrations with the official police response to the record 51 LGBT hate crimes so far this year, the Times reports that Chief Cathy L. Lanier argues that the department "has been doing everything in its power to stem the violence, going so far as to seek an outside review of the department's procedures that have been the subject of criticism. The results of that review are expected late this year or in early 2013."

"We feel like everything that we can do, we're doing, and yet we get these complaints back from some of the advocates," she said.

One of the debated changes that Lanier insituted, according to the Times, is redistribution of the ciy's officers on the Gay and Lesbian Unit. Once there were police officers assigned to Dupont Circle, the city's gay neighborhood, but now they are distributed throughout the city.

"The events of 2011, the intense violence, really showed that the restructuring had failed to create any kind of meaningful reaction and response," Jason A. Terry, an anti-violence activist and a volunteer with the DC Trans Coalition, told the Times.

But many activists seem to support Lanier's efforts, or at least place the blame elsewhere. A. J. Singletary, a co-chairman of a city anti-violence group called Gays and Lesbians Opposing Violence, told the Times he feared that Chief Lanier's commitment to improvement had not reached all the way through the ranks of the department.

"I know that's what Chief Lanier wants, and that's what we want," he said. "Now we just want to make sure that actually happens."

Drag Ban on Drag Star Cruise Now Reversed

Carnival Cruise Lines has rescinded a ban on cross-dressing and drag costumes in public areas on a drag-themed cruise after a public outcry.

The Carnival ship Glory is hosting the Drag Stars at Sea cruise, featuring performances by contestants from RuPaul's Drag Race, departing from Miami Sunday. However, there will be other passengers on the ship besides those attending Drag Stars at Sea, and Carnival yesterday sent attendees an email stating that drag costumes would be allowed only for performers and only onstage.

"Carnival attracts a number of families with children and for this reason; we strive to present a family friendly atmosphere," the email reads in part. "It is important to us that all guests are comfortable with every aspect of the cruise. Although we realize this group consists solely of adults, we nonetheless expect all guests to recognize that minors are onboard and, refrain from engaging in inappropriate conduct in public areas. ... Guests are not allowed to dress in drag for the performances or in public areas at any time during the cruise. We're sorry to say that any guest who violates our policies and/or whose behavior affects the comfort and enjoyment of other guests, will be disembarked at their own expense and no refund will be given."

Today, Carnival Cruise Lines president and CEO Gerry Cahill sent out the following letter:

"Within the last 24 hours, we became aware of a miscommunication between Carnival Cruise Lines and AlandChuck travel, who have booked a large special interest group on the upcoming Carnival Glory cruise departing December 2, 2012.

"The group, 'Drag Stars at Sea,' includes several performances by stars from



Logo TV as part of a series of private events onboard. When the group was presented to us we were advised that only the performers would be dressed in drag during the private events. However, we are now aware that this was not clearly communicated to members of the group and therefore anyone who wishes to dress in drag may do so. Please keep in mind that our safety and security procedures require guests to present government-issued ID, and to be recognizably that person.

"At Carnival, we are proud to carry more than 4.5 million guests every year and we welcome them all aboard. We do not practice any form of discrimination against the LGBT or any other community. We sincerely apologize for the miscommunication and for any unintended offense we have caused.

"Given this misunderstanding, anyone on this cruise who wishes to cancel for any reason may do so and will receive a full refund of their cruise fare, as well as reimbursement for any non-refundable travel related expenses.

"We constantly strive to provide our guests with a fun and memorable

I'M FAT

Here is a recent email I received (with details changed for confidentiality):

Dear Michael:

I am 35 years old, 5'11" and I weigh 280 pounds. I've weighed this much most of my adult life. I know why, it's no mystery. I love to eat. Food is my friend, my best friend. After dating other gay men, who only wanted to use me because I'm so fat, I gave up on dating. Food, books and the internet are my best friends. I've tried every diet that's around, and none make a difference.



Last year, I lost and gained the same 15 pounds over and over. Can you help me?

Fat and unhappy

If I were responding to this gentleman via email, here's what I'd say:

Dear Large and unhappy:

First off, I don't like the word "fat" so I changed it to "large". You pose challenging questions...a billion-dollar industry exists merely to answer them. But, I'll give it my best shot here. Let's start with:

Why do you eat so much? Scary times can push us to eat things we don't need, when we really want comfort, not calories. I have a client, a very successful businesswoman, who gains 10-15 pounds whenever she's launching a new venture. She knows this about herself and later, when things calm down, she always loses it. She eats when she's scared and she knows it. Another client of mine gained 25 pounds when his boyfriend left him. Once he came to terms with it, the pounds came off. Consider this idea of food as protection and comfort when times get tough. Does it ring true for you?

Now, let's look at your idea of "food is my best friend". Food is nutrition. It is not a companion. Food is a vehicle, not a goal. Food is a sensory experience, not consolation for a lousy life. Your relationship with food is distorted. You can't get free of a food addiction/dependence without asking yourself some uncomfortable questions. For example, the next time you open the refrigerator or kitchen cabinet to get something to eat, stop and ask yourself, "What am I looking for here?" Are you bored, sad, depressed, lonely, angry? If so, food won't help you. In fact, it can make you feel worse because it cannot fill your emotional needs. Food is not a good "best friend". It is a substitute for a best friend, and a poor one at that.

Are you are ignoring your needs for connection with other people? We all need friends to talk with, commiserate with, laugh with. You sound like you've given up on people and focused on objects to meet your emotional needs. It doesn't work. Ask yourself: Am I afraid of people? Why don't I have any friends? Take responsibility. You're an adult, so don't blame mommy or daddy or even that bag of Oreos. If you can't relate to people and don't know why, get yourself to a good psychotherapist and get some help.

Why did you allow other gay men to "use me because I'm fat"? Since when does large = masochistic? Do you think that being used is/was all you deserve? Your worth is not dependent on what the scales tell you. Plus, you've got some anger at your gay brothers for not finding

you desirable as you are. Own up to this. Be willing to modify your self image: you may be more of a sexy Bear than a twink type. Be open to seeing yourself differently, and others will follow, regardless of what you weigh.

Some people feel so overwhelmed by losing weight that they don't even try. To avoid that self-sabotage, take any weight loss regime slowly. Start by setting yourself small, reasonable goals. Don't push yourself too fast...this is a great way to just give up and sit home with junk food and self-pity. There is no one way to lose weight that works for everyone: we are all unique. Work with your doctor and consider structured programs like Weight Watchers or Jenny Craig if that appeals to you. Follow your intuition, start listening to your body. It will tell you what it really wants if you slow down enough to listen.

Chicago Cop Fired Over Work as Bar Bouncer, 'Lube Wrestler'

A gay Chicago police officer has been fired for moonlighting as a bouncer and "lube wrestling" participant in nightclubs — and he's planning to sue the city in hopes of being reinstated to the force.



Jonathan Maynard was on convales-

cent-duty status, recovering from injuries, when he worked at two gay clubs, Hydrate Nightclub Chicago and Halsted's Bar and Grill, between June 2008 and October 2009, as a substitute bouncer, and when he took part in a "lube wrestling" event at Hydrate in November 2007, the Chicago Sun-Times reports. He broke department rules against working in a liquor establishment, and working at all, while on his leave, the Chicago Police Board decided last month. He was a "flagrant abuser" of departmental policies, the board ruled.

Maynard, however, told the Sun-Times this week that officers with "much more serious" infractions have been allowed to keep their jobs. "I have been singled out," he said. He also said he has been harassed by fellow cops for being gay.

He said his work at the clubs was unpaid, a favor to management. One executive of the clubs, Maynard's former boyfriend, presented records to the police board indicating he had been paid, but Maynard said his ex has a grudge against him and falsified the records. He also claimed a witness who videotaped the wrestling has an "ax to grind," arising from a landlord-tenant dispute in a building owned by Maynard's grandmother.

Maynard, 34, has been on the police force for 11 years. He plans to file suit to get his job back, he told the newspaper.

vacation. We look forward to welcoming everyone onboard Carnival Glory and again want to apologize for the misunderstanding and for any offense we have caused."

Yesterday, after any of those planning to go on the cruise expressed outrage, Al Ferguson of Al and Chuck Travel, the gay-owned, Florida-based company booking the cruise, issued an explanation on the company's Facebook page, saying the ban on costumes was due not to homophobia or transphobia but security considerations. He also said transgender passengers would be able to dress in their preferred clothing.

"We are sympathetic to your sentiments that you have expressed via email and social media," Ferguson wrote. "As a gay man who has been partnered for 25 years, I have suffered many forms of discriminations because I am part of the GLBT community. But please take note, Carnival's regulation is NOT an example of discrimination. Carnival is an ally of the GLBT community. Please understand that this cruise could not even be happening on the GLORY if Carnival was not an ally of our segment of society. When they say they are a 'family friendly' cruise line they mean it in both the traditional and metaphorical sense of the phrase.

"Carnival's 'no costumes rule' is NOT meant to be an insult to the gay community. As a gay business, we would not have organized this cruise if they were prejudiced against gay people. This rule goes for both GAY and STRAIGHT passengers that travel on all Carnival cruises. It is in response to the post-911 world we live in. It is meant to protect passengers and guests — NOT to marginalize a few.

"Additionally, we know that transgendered members of our communi-
