OUR TURN: VIEWS AND OPINIONS OF THE NEW VOICE STAFF

THANK YOU, NEW VOICE STAFF

As I've worked on the final details of putting this issue of The New Voice together, I've been especially impressed with what a good job the Steering Committee and staff do in publishing this magazine every month. We are rapidly approaching our tenth anniversary — ten years of putting out a monthly magazine (This month marks the 6th anniversary of when The New Voice moved to Omaha). And we've never missed an issue. I think that's a pretty good accomplishment for a volunteer organization.

With that basis in mind, I want to give a personal "Thank You" to some very hard working people and also let you know a little bit of the process that we go through each month

As soon as one month's issue is distributed, we start the process for publishing the next month's issue. Dick Brown, our Treasurer and Advertising Manager, does all the billing and pays all the bills, keeps all the books, and balances the checkbook each month. (Each month he copies the bank statement and gives a written reconciliation to all members of the Steering Committee. And each month of the last 5+ years his books have balanced to the penny.) If some group or business is slow about getting their payment in, then Dick calls and sends more statements, etc. In addition, Dick solicits and does the contracts for all advertisements which appear in The New Voice. He consults with advertisers about the size, composition, and placement of their ad and collects completed camera ready copy.

However, many of the ads which appear in The New Voice are ones which we design and typeset ourselves. For that job, Dick teams up with Sharon McCartney, our Subscription Manager, Typist, Proofreader, and Typesetter. Sharon and Dick spend several hours together each month determining the actual placement of the advertisements within the magazine and

typesetting advertisements.

In addition, Sharon McCartney maintains the subscription roles, printing mailing labels, addressing envelopes, and sending notices when subscriptions are due for renewal. She adds new subscribers and removes those whose subscriptions have expired. She also maintains the "Exchange List" - that list of publications, organizations, and individuals who receive a complimentary copy of The New Voice each month. Sharon also does the bulk of the typing of the articles in the magazine, transforming press releases and other submissions into a set of files on Macintosh computer discs.

As editor, I go through stacks and stacks of mail each month, determining which press releases and submissions will be used, and editing them for length, grammar, etc. I receive the articles from our very talented writing and reporting staff and add them to the other material. The edited copy then goes to Sharon McCartney for typing.

Then, each month, Sharon delivers two discs one with the template of the magazine and the other with the files of typed material - to Sharon Van Butsel (me) and Carla Petersen. Carla and I have been also been typing other articles (usually local news and late submissions) onto Macintosh disc, as well as composing stories about local events. I combine the two Macintosh discs, print out a directory, and prioritize articles so we can include the most "important" articles first.

The actual layout of the articles within the magazine is something that Carla and I work on together. Carla does the bulk of the layout, but I help when her work schedule gets too hectic. We use a PageMaker program to place articles, create headlines, do special effects, etc. It's a lot like doing a jigsaw puzzle as we try to make the articles fit around the advertisements.

The process of laying out the magazine takes 10 hours at the computer, and once it's done, the finished product is again put on disc and goes

back to Sharon McCartney. She proofreads the entire magazine and prints out the final copy which goes back to Dick Brown.

While all of this has been going on, Terry Sweeney has been working on artwork for the cover of The New Voice, combining clip art and graphics into the striking covers which have become the trademark of The New Voice. Terry's artwork goes to Dick Brown to be added to the

rest of the hard copy.

Dick pastes in all photos (which he took to Bob Ewing at Printing Plus earlier in the month so they could be half-toned), the artwork for the cover, and the camera ready display ads. Dick then delivers the finished copy to Bob Ewing at Printing Plus who does the printing, collating, and stapling of the finished product

Pat Phalen picks up the finished magazine from Bob, puts the copies for subscribers in their envelopes, packages magazines to be sent to distribution points outside of Omaha, and sorts and prepares the envelopes for bulk mail. After these issues are mailed. Pat makes his rounds to all the bars, businesses, and organizations and delivers the finished product for distribution. With that, the Steering Committee begins the cycle all over again.

Once again, I salute all the other members of the Steering Committee: Dick Brown, Sharon McCartney, Pat Phalen, Terry Sweeney, for a job well done. A special salute also to my partner, Carla Petersen, for her talent in writing articles and in doing the final layout of the magazine. And a salute and a heartfelt thank you to all of our writers and reporters - especially to those who write on a regular basis like RJ, Scott Lowther, Shelley Foster (who donates her syndicated column each month), R.N. Hedges and Greg Hicks (B & G). Keep up the good work!!

RESPONSE TO SEPTEMBER LETTER

Dear Editor:

In your September issue, you ran a classified ad and letter from a man who wrote from prison. As an editor, you should be aware of high probability that such ads turn out to be seams that seek to obtain money from gay men.

seek to obtain money from gay men. Frontiers gets about one of these letters each month from a "gay" man who is in prison, ALWAYS requesting a free classified that seeks pen pals. Once they start getting to know those who write (generally targeting closeted gay men, the prisoners always describes themselves in the letters as good-looking men, and the "victim" is usually bound that such a handsome man would be interested in them), they ask for loans or other financial assistance.

These requests are almost always scams. And since Frontiers (as likely your publication as well) does not have the resources to check out which are true, we simply don't print any of them.

I hope you take this as a warning that printing such ads is a great disservice to your readers.

UNITED STATES HOLOCAUST MUSEUM

The United States Holocaust Memorial Museum is dedicated to presenting the history of the persecution and murder of millions of innocent people by the Nazis and their collaborators. Though Jews were the primary target of Nazi extermination policies, many others were

victimized for various reasons.

Communists, Social Democrats, trade unionists, and pacifists were arrested because of their politics. Homosexuals were imprisoned because of their sexual preference. Dissenting clergy faced arrest if they spoke out against the regime, Jehovah's Witnesses were punished for their refusal to swear allegiance to the state and, because of their Communist ideology, Soviet prisoners of war were the only POW's singled out for barbaric treatment and starvation through a special German directive.

The majority of victims, especially the Jews. were targeted for extermination because of their racial origins. In Nazi thinking, humanity was divided into a series of "higher" and "lower" races. Like the Jews, Roma (Gypsies) were deemed racially "inferior," and similarly. Poles and other Slavs were believed to constitute a threat to the "pure Aryan" Germans because of their "substandard" racial makeup. The mentally and physically disabled were regarded as social

burdens on the German state.

Through artifacts, documents, videotaped eyewitness testimony, historical photographs and

film footage, the wartime experiences of these various victims will be included in the Museum's Permanent Exhibition, special exhibitions, collections, library, archives, educational programs and resource materials

The new chairman of the United States Holocaust Memorial Council, Miles Lerman, a Holocaust survivor, spoke about the need to become involved with the Museum. "I don't care where the prejudice grows, whether it's against Jews, blacks, Jehovah's Witnesses or gays - it doesn't make any difference. Hate is hate. Our job has just begun. We need to reach out to all of

America," Mr. Lerman said.

Radu Ioanid, Director of the Jewish Holocaust Survivor Registry, spoke about the Museum's Research Institute. "We have a serious need for more material and would appreciate donations of any photos or archival material," he said Mr. Lerman underscored the desire for more material about gays in the Holocaust. "I cannot tell you how hard I worked to get information on this subject. We need it. Please help us gather information, artifacts and oral histories through your own sources and contacts," he said.

The fundraising effort to complete the costs of building the Museum is not finished. More than 25 million dollars still needs to be raised. Contact for the gay fundraising effort is Brenda A. Fraser who can be reached at 202-4888-2662. Tax deductible pledges, payable over five years, and all other donations to the Museum can be sent to her attention at 100 Raoul Wallenberg Place, S.W., Washington, DC 20024-2150. Checks marked with the code 8014 will be earmarked as gifts from the gay and lesbian community.

Persecution of Homosexuals in Nazi Germany

As part of their attempt to purify German society and propagate a "master race," the Nazis condemned homosexuals and lesbians as "socially aberrant." Soon after taking office, Hitler banned all homosexual and lesbian organizations. Meanwhile, storm troopers razed the institutions

and gathering places of the homosexual and lesbian community

Because of the criminalization and social stigmatization of homosexuals in European countries for decades following the Holocaust, it is particularly difficult to collect material on this subject. Very few artifacts have survived, most survivors were discouraged from telling their stories, and most material consists of documents and published laws. (If you, or anyone you know, has material on homosexual victims of Nazism and would be willing to make it available to the Museum, or if you know someone who witnessed the persecution of homosexuals during the Holocaust, we urge you to contact us.)
In 1934, the SS chief, Heinrich Himmler,

created a special police bureaucracy primarily to combat male homosexuality. As early as December of that year, homosexual men were subjected to systematic criminal prosecution. Many of them were imprisoned in concentration The uniform sometimes bore an identifying mark, usually a black dot. Later, this

mark was replaced by a pink triangle.

The majority of homosexual victims were lesbians were spared systematic persecution. Between 10,000 and 12,000 homosexuals, most of them German and Austrian, were imprisoned in the camps. They often received the hardest work assignments, and as a result, more than half died. Many homosexuals were also sentenced and interned under other categories. The mortality figure is believed to be at least 2,200 - 5,000. Apparently, as many as 63,000 men were convicted of homosexual offenses in courts from 1934 - 45

Under the Allied military Government of Germany, homosexuals were forced to serve out their terms of imprisonment, regardless of time

spent on concentration camps

The Nazi law against homosexuality remained in effect until 1969. Homosexual concentration camp prisoners were not acknowledged as Nazi victims, and any German reparations were refused.

CLEANING OUT MY CLOSET: WHAT'S THE DIFFERENCE

I've forgiven TJ for being heterosexual. And she's absolved me of any responsibility to her around my particular life choices.

Which is good, because we're really close

friends

We once were also partners, trying to create an advertising agency out of a couple of untended dreams, and way too little capital. Just at a time when the financial ground under New England feet was shaking and crumbling. There wasn't enough business to keep us in business. But, in spite of our differences, there was enough friendship to last.

She, her husband, and her two teenage-boy children left the state we were in and headed innocently into Oregon. I headed for warm South

Florida fortunes.

Now TJ visits us once a spring to get a tan. (They don't specialize in sunshine in the Pacific Northwest.) And also to get her yearly fill of female. When you're surrounded by that much testosterone for fifty weeks, you're due a little estrogen relief. So TJ spends her days beaching, her evenings cooking us gourmet meals, none of which call for hot dogs or peanut butter as a key ingredient, and her nights talking woman-stuff.

She loves it. We love her. We don't have to cook for a week. We eat well, watch sappy movies in the afternoon when I'm done writing, or go touring, and generally, it feels like we go on vacation together. Which is great for Judi and me, because we don't pay airfare, and TJ buys the

groceries.

One outdoor afternoon on Ocean Avenue, feasting on Miami Beach warmth, the tourist array, and the hideously guilt-inducing satisfaction of News Cafe burgers and fries, I decided to talk Oregon. (Florida is facing yet another selfrighteous religious fanatic attack and it's always helpful to get perspective from a winning arena.)

"So, what was the Oregon fight like from a straight person's perspective," I queried, mental note-pad poised for helpful hints on our local struggle. I didn't get any. Instead, I got umbrage.
"You can't do that to me!"

"Do what?"

"Ask me a question like that. It presumes that

we're different. It separates us.

Phew! Hard to disagree on that. Haven't I spent hours of ink, haven't we all spent hours of effort, telling the Thems that we weren't different? That we were just the same as everybody? That we were just like them and they shouldn't treat us differently?

But I realized in that conversation, in fact, that we are different. Oh, not the way David by Shelley Roberts

Koresh wannabe's want us to be. Not so much in sexual practice, as in survival practice. We, in circling our wagons, have created ourselves as a culture. Not as author Frank Browing suggests, a Culture of Desire, but a Culture of Survival . One that gives us common ground even in our fractioned diversity, a common perspective from which to voice our shared experiences, hopes and fear. When Browning asks what a gay North Carolina Pig Farmer, and a New York City drag queen have in common, meaning "nothing", I say to him what I said to TJ: "Lots!"

The differences aren't so much genetic as

societal.

I asked TJ if she knew who Kate Clinton was. Did she listen to Romanovsky & Phillips? Did June mean anything more to her than National Watermelon month? Had she heard of Stonewall? Read anything by Michaelangelo Signorelli? Or Jewelle Gomez? Where had she put herself on the Kinsey scale? Had she considered weighing herself on such a scale? Could she recite the dialog from the movie, Lianna, by heart? Or seen Desert Hearts? If I referred to "the kiss" on LA Law, would she know what I was talking about? Sure, she knew about Harvey Milk, but did the name David Kopay ring a bell? Did her magazine rack hold 10 Percent? Or Out? Or Lambda Book Report? Did San Francisco hold a special place in her heart for anything beyond dungenous crab and cable cars? Had she studied Loulan?

I didn't mean to exclude her, but as we talked, it became clear to us both that there were differences in our lifestyles. And it didn't revolve around either of our stereotypes. When my son was young, I spent as many hours as she did baking cookies and at PTA. Though she'd never listened much to Chris Williamson, she does like

KD Lang, and the Indigo Girls.

While we were swabbing our fires, we came to an understanding. It wasn't necessary to us to be exactly the same in order for us to share love, and honor. Our human qualities, the ones that were the same, like laughing and crying, and loving and dying, and most of the one-on-one emotional interactions between, were enough to forge strong links. And that there was still sufficient space to allow for our diversity. That it was okay for us to be not-exactly-carbon-copies, because out of that difference could come respect.

I guess I hadn't thought of us like that before Not until TJ demanded that I not make myself different from her, did I begin to examine the reality of our differences. The richness and value of a culture that I hope we're not willing to sacrifice in the name of assimilation. Someone

asked Frank Browning on my radio show, if he thought that our culture could survive the success we seek. He said he didn't know, but that since he thought it could "take a couple of hundred years for us to achieve that success, what difference did it make? We'd all be gone by then.'

If he'd have asked me, or TJ, after that afternoon on South Beach, I think we would have disagreed. We'd have said that it will be the combination of the richness of our cultural differences and similarities that will create the

acceptance we're after.

I can't wait till TJ's next visit. I know we're oing to continue this conversation. And by then, I should have worked through enough cholesterol angst to order another burger. Her, too. It's something we have in common.



LEGALIZED DISCRIMINATION IN VIRGINIA CUSTODY CASE

On September 7th, a Virginia judge declared Sharon Bottoms an "unfit" mother because she was open and honest about her love for another woman, April Wade. Sharon's mother will retain custody of her two-year-old son, Tyler. This decision is a tragedy for Sharon, April and Tyler, for all Virginians, and indeed all Americans—parents and children, gay and straight alike.

The case of Sharon Bottoms has received national attention in the media because it is believed to the be the first decision by an appellate court where someone other than a parent successfully sues for custody of a child based on

a parent's homosexuality

But custody battles—involving ex-spouses and even grandparents—are nothing new in our community. The threat of losing custody of one's children in court has been and still is a danger for millions of gay and lesbian Americans. The American Bar Association estimates that there are over four million lesbian and gay parents in the United States, raising six to eight million children.1 "Disputes over child custody and visitation," reports John Sheets, President of the Gay and Lesbian Parents Coalition International (GLPCI), "are the number one reason lesbian and gay Americans go to court."

While we were hopeful that a favorable decision for Sharon and her family would correct past injustices against gay and lesbian parents in Virginia, this decision is not entirely unexpected. Historically, Virginia has been one of the slowest states to adapt to changing social patterns. In the 1960s, marriage outside one's race was grounds

for imprisonment in the state.

Virginia still interferes in the lives of its citizens with one of the most repressive antisodomy laws in the nation. And Virginia is one of two states with the most unfavorable legal situations for lesbian and gay parents. Lesbian and gay parents in Virginia have always been hesitant to be open, because they know such unfavorable laws exist.

The decision in the Sharon Bottoms case is based on HOMOPHOBIA—the irrational fear and hatred of lesbians and gays. Because of homophobia, judges ignore expert testimony on the overwhelming "fitness" of lesbian and gay parents and "normalcy" of our children. Instead, "they listen to the lies and perpetuate the MYTHS," says Vickie Harris, GLPCI's Executive Vice President, "myths that destroy families in the name of Family Values."

We must confront and destroy these myths! Are our children unhealthy psychologically or vulnerable to mental breakdown? — No, study after study shows that there are no significant differences between our children and the children

of straight parents.

Are lesbians incapable of maternal feeling?
No, America is in the midst of a "Gay Baby
Boom" as more and more lesbians are making
their dreams for children come true. And likewise,
more and more gay men are acting on their desire
to become fathers.

Do our children grow up confused about their gender identity and sexual feelings? — No, they do not, but they often grow up more accepting of

people who are different.

Do all of our children grow up to become lesbians or gay men? — No, they do not. They grow up to be exactly who they are meant to be. And our children are lucky to be born into families that love and accept them — whatever their

sexual orientation.

Do gay men and lesbians, including parents, molest children? — No, the typical abuser of children is a straight, male family member.

Are gay and lesbian parents "unfit" to be parents? — Absolutely not!, says the American Psychological Association of Social Workers,

among others.

With the Sharon Bottoms custody decision, the Virginia courts took a giant step backwards—while the rest of the nation is slowly moving forward. Twice as many states have appellate court rulings stating that homosexuality per secannot be used against parents in custody decisions, as opposed to states where it can. An increasing number of jurisdictions have granted "second purent adoptions"—allowing the partner of a lesbian or gay purent to become a second legal parent to the child. 2 More and more adoption agencies are realizing that the lesbian and gay community is a largely untapped source of outstanding homes for children needing parents.

What can we do to fight for what is right in Virginia? The anti-sodomy statute must go! We can change hearts and ninds by coming out to our family and friends, our neighbors and co-workers. We can write letters, speak out, volunteer and

vote. We can Destroy the Myths!
Sharon, April, Tyler – keep fighting! Our hearts are with you! Love makes a Family!

COLAGE, Children of Lesbians and Gays Everywhere, is the only national organization run by and for the daughters and sons of lesbians and gay men. Our 600-plus members represent only a tiny fraction of the six to eight million Americans

with lesbian and gay parents.

We know firsthand that the judgment in the Sharon Bottoms case was inaccurate, prejudiced and does not reflect the reality of growing up with a lesbian mother. Scientific studies and our own experiences show there are no bad effects of growing up with lesbian and gay parents. However, the secrecy many of must maintain because of the threat of custody cases is a burden. The irony of this judgment — "in the best interests of the child" - is that decisions like these cause the most problems for us.

Our hearts go out to two-year-old Tyler. We all have experienced some type of negative reaction to our families; custody rulings based on sexual orientation of our parents are simply an

extreme form.

Fortunately, this case does not reflect the positive trend in courts and other institutions toward our families. We believe this trend will continue as more and more Americans realize that children aren't raised by their parents' sexual

orientation, they are raised by their parents' love. Further Information

PERI JUDE RADECIC NGLTF EXECUTIVE DIRECTOR



PERI JUDE RADECIC BEING INTERVIEWED FOLLOWING OMAHA'S 1992 PRIDE PARADE

The Board of Directors of the National Gay and Lesbian Task Force (NGLTF) named Peri Jude Radecic as the organization's new executive director. Radecic, the organization's current Deputy Director for Public Policy, replaces Torie Osborn. "Peri Jude is a Task Force success story," said Efizabeth Birch, Co-Chair of the Board of Directors. "With her dynamic leadership abilities, institutional knowledge, and tireless energy, the Task Force could not be in better hands."

Radecic, 33, brings more than 15 years experience in movement organizing, management, communications, and top notch political skills to her new position. She joined the staff of the Task Force as a lobbyst in 1987, organizing the lobby days around the 1987 March on Washington. She moved on to become the organization's first Legislative Director, then was promoted to her current position as Deputy Director for Public Policy in 1991. Radecic was a central figure in the successful effort to pass the Hate Crime Statistics Act, a key legislative victory for the gay, lesbian, and bisexual community, and was invited to witness President George Bush signing the bill into law at the White House.

"Our work will be a strategic mix of building and strengthening our movement at the state and local level, combined with a more aggressive Federal lobby. The work of the National Gay and Lesbian Task Force has never been more critical," said Radecic. "New programming priorities, such as health policy with a focus on lesbian health care and AIDS, campus and workplace organizing, state and local civil rights organizing, strengthening our response to increasing threat of the Far Right, are at the heart of our movement."

Radecic earned her Bachelor of Arts degree in Speech Communication at the University of Pittsburgh, where she was collegiate All-American discus thrower in track and field competition. She cut her political teeth working with the National Organization for Women as the Lesbian Rights Program Director at the national office.

BATTLE AGAINST MILITARY BAN MOVES TO COURTS

The U.S. House of Representatives voted to set into federal law an anti-gay military policy—a virtual replica of the 50-year old Defense Department policy. The policy, put forward in an amendment by Rep. Ike Skelton (D-MO) and Sen. Sam Numn (D-GA), is part of the 1994 DoD authorization bill that President Clinton is expected to sign when the bill reaches his desk while the House vote codification discrimination against gay men, lesbians and bisexuals, the 169 votes against codification indicates a solid base of support in Congress for ending discrimination. The battle against the ban will now continue in a variety of court cases challenging the Constitutionality of the policy.

The House voted on an amendment offered by Rep. Marty Mechan (D-MA) to strike the Nunn-Skelton codification amendment. That measure, which was identical to a measure offered in the Senate by Sen. Barbara Boxer (D-CA), was defeated in a 169-264 vote. Rep. Duncan Hunter (R-CA) offered an amendment to reinstate asking the sexual orientation of those entering the military. That amendment was defeated in a 144-291 vote. The House voted 302-133 in favor of the Skelton amendment, which will make the anti-gay policy a federal law rather than a DoD directive.

"The votes in favor of the Meehan Amendment in the House and the Boxer Amendment in the Senate are encouraging, in spite of the opposition from the White House and vigorous opposition from the Pentagon," said Peri Jude Radectic who takes over as Executive Director of the National Gay and Lesbian Task Force (XGLTF) on November 1. "The White House completely acquiesced on this, allowing supporters of the ban to carry the day. With White House support, the Meehan and Boxer

amendments might have passed."

The focus of the battle against the ban now moves to the courts, where there are at least a dozen challenges to the old policy, the interim policy and the new policy. Last week, a U.S. district court judge ordered Sec. of Defense Les Aspin to appear in his courtroom to explain why the DoD has not followed the judge's order to stop discharging gay men, lesbians, and bisexuals. The order was issued in the case of Petty Officer Keith Meinhold, an openly gay man, who is challenging the military's policy. In January, U.S. District Judge Terry Hatter issued an order reinstating Meinhold and directing the military to stop discharging soldiers on the basis of their sexual orientation. Aspin or a representative is scheduled to appear in court September 30.


In addition to the Meinhold case, other pending challenges include the following: Joe Steffan, a former midshipman at the U.S. Naval Academy who recently presented oral arguments before a U.S. court of appeals; Zoe Dunning, an active Navy reserve officer, who has been recommended for discharge because she is a lesbian; Justin Elzie, former Marine Corps Sergeant and Marine of the Year award recipient; Tom Pannicia, former Air Force Sergeant, who was discharged last year for his sexual orientation; Joyce Walmer, an active duty Army Major who remains on active duty under a temporary restraining order; Margarethe Cammermeyer, a former colonel in the Washington State National Guard, who filed suit last year after acknowledging during a security background check that she is a lesbian; and Dusty Pruitt, a former captain in the Army Reserves, who won a partial victory at a circuit court level that demanded the military present a substantial rationale for her discharge under the anti-gay policy

"The legislative chapter of this issue is now closed, but the litigation chapter is only beginning," said Tanya Domi, NGLTF Military Freedom Initiative Director. "As we've said all along — this battle won't be linished until discrimination against gay men, lesbians and bisexuals is no longer institutionalized or supported by the U.S. government. The issues won't go away, and we're not going away."

U. S. HOUSE PASSES NEW HATE CRIME LEGISLATION

In a major victory for lesbian, gay and bisexual Americans, the U.S. House of Representatives passed the Hate Crimes Sentencing Enhancement Act of 1993 by an overwhelming voice vote on September 21st. The vote marks only the second time in history that legislation specifically including lesbian and gay Americans has passed the House.

At a time when lesbian and gay issues are at the forefront of our national political agenda, Congress put aside partisan differences to unite against gay bashings and hate crimes," notes Tim McFeeley, Executive Director of the Human Rights Campaign Fund, which strongly supported the legislation. McFeeley was among those who spoke at a Spring press conference when the bill was introduced. The legislation, sponsored by Rep. Charles Schumer (D-NY) and Rep. James Sensenbrenner (R-W1), now moves to the Senate where Senator Jesse Helms (R-NC) is expected to oppose the inclusion of sexual orientation as a category in the bill. The legislation, if passed, will increase, by three offense levels, the sentence for federal hate crimes where the victim was targeted because of race, color, religion, national origin, ethnicity, gender, or sexual orientation.



CLINTON GIVES DENVER LESBIAN NOD TO HIGH POST

In a phone interview Carol Bellamy, director designate of the Peace Corps, confirmed that Judy Harrington, former campaign advisor to Equal Protection Only Colorado (EPOC) campaign, has been selected by President Clinton to assume a high post with the Peace Corps. When contacted at her Denver home, Harrington explained in an interview with Preferred Stock, "the position didn't require Congressional confirmation" but a security clearance was mandatory. The White House couldn't confirm the appointment, but the Peace Corps press office acknowledged Harrington is under consideration for a Senior Policy Making position which will be in place through the term of the Clinton presidency. The Peace Corps has a five year limit on a job with the agency, so Harrington would be required to leave in the middle of Clinton's second term if he

is re-elected in 1996.

Harrington and Bellamy both served as Peace Corps. volunteers in the 60s, Harrington in Venezuela, Bellamy in Guatemala. For a portion of 1969, Harrington was editor of Peace Corps Magazine. She first met Bill Clinton during their work together in the McGovern campaign in 1971-72. She worked in Clinton's Little Rock presidential campaign organizations. assumed the job of campaign director to the Colorado campaign against Amendment Two in January 1992. For much of 1993 she has been on temporary assignment in Washington reportedly working for Clinton. When asked about her appointment, Harrington said her selection "was not a news story". She had assumed a similar posture during the course of the 1992 campaign against Amendment I'wo and was widely criticized for running such a "low key" campaign. Many EPOC donors were furious that she chose a media strategy that didn't confront the endless

"lies and myths" put forth by the Colorado Springs organization backing Amendment Two. She has consistently declined to discuss the 1992 EPOC campaign with reporters.

After the campaign, there were unconfirmed reports that Harrington had channeled campaign funds to a Little Rock research group to "prop up" her chances of receiving a presidential appointment. Such allegations have been denied by EPOC spokespersons. Campaign records attest that the Arkansas-based group was responsible for early polling data to determine attitudes of Colorado voters toward homosexuals and the proposed amendment. The campaign acknowledges and Secy. of State files confirm staffers were paid as contract labor and that EPOC escaped payroll tax. EPOC maintains they are attempting to clear up any tax questions and will pay any amounts owed. According to Tina Scardina, EPOC's secretary, the campaign has over \$20,000 left in its coffers. A final campaign report, filed with the Secy. of State in December reflected a balance remaining of \$47,525. Many questioned such a large sum of money remained when the campaign organization claimed to have shut down. Scardina contends that a January meeting, salaries of 3 employees through March, phone and postal billing all came due since the last filing and have taken out a "large chunk of The campaign is not required to file a money. financial report until December of 1993 or when they officially disband. Colorado for Family Values terminated their campaign organization in January 1993. It is alleged they are currently engaged in raising funds for the 1994 election. If so, they will be fined and required to file a campaign committee.

On July 2 Clinton nominated Carol Bellamy to head the agency. She is expected to receive Senate confirmation when Congress reconvenes. Bellamy has held elective office first as a New York State Senator in 1973-1977, and then as President of the New York City Council 1978-1985 Virginia Appuzo, a longtime lesbian activist, now serving as a director in New York State's Housing Department said Carol Bellamy is an "extraordinary woman whose integrity and competence is needed in government." Appuzo recalls her ardent support of Bellamy in 1977 when Bellamy determined to leave state office and run for NYC council. Appuzo said when she made her bid as the first openly gay candidate to run for New York state assembly, Bellamy did not support her. Appuzo says, "that's water over the dam and she holds no ill will." Appuzo believes "the community of lesbian and gays must move past petty political infighting and rally around those who have been our long-time supporters." Bellamy is acknowledged to have a long history of support for minorities, women and gays.

The Peace Corps faces reorganization under Bellamy. Officially established in 1961 under President John Kennedy, the agency promotes world peace with a budget of \$218 million dollars. Its organizational mission is to provide trained workers to countries in need, thereby fostering a better understanding around the world of American people. Clinton in his inaugural address, challenged Americans to a "season of service—to act on your idealism by helping troubled children and keeping company with those in need." Since those first volunteers went to Chana in August 1961, more than 138,000 yolunteers have served in more than 138,000 yolunteers have served in more than 100 countries. An old Peace Corps recruiting slogan said, "it's the oughest job you'll ever love," and for most who served it remains "the best job we ever did."

RUNNING AGAINST OUR "FRIENDS"

Since the election of Harvey Milk to the San Fancisco Board of Supervisors in 1977, lesbians and gay men have made striking gains in securing elected office in the United States. But given our share of the electorate, our high level of political activism, and the need for heightened response to issues affecting our community, there simply aren't enough lesbians and gay men in public office — even in progressive, pro-gay cities.

The reasons are many, the high cost of running for office, the unfair stereotype that lesbian, gay, and bisexual candidates are "single issue", and the barriers erected by political machines to preserve their power. But in the final analysis, the problem isn't that we can't win office, but that we re too often afraid to run—against our "friends" if necessary.

In 1976, Harvey Milk first ran for the California State Assembly against Art Agnos, the candidate of San Francisco's Democratic Party establishment. Harvey insisted that it was not enough for lesbians and gay men to count on friendly liberal politicians to carry our issues—politicians who would claim their voice would be most likely to be heard in decision-making bodies. He insisted that lesbians and gay men need to have sufficient pride to run for office ourselves. Agnos went on to be strongly pro-gay legislator and mayor. But the political machine of which he was a part has continued to block gay political self-empowerment, holding the line against such highly qualified lesbian and gay candidates for

Congress and the State Assembly as Harry Britt, Roberta Achtenberg, John Duran, and John Laird.

It is clear that, despite the strength and loyalty we have brought to the Democratic Party, we are still not tapped by the power brokers to run for political office. Time and time again — in California and throughout the country — the gay political community has been disappointed to have the power establishment run their own handpicked candidates, people they feel they can "count on", against viable gay candidates in mees that we could win. Responding to the pressure they receive from a homophobic society, straight party leaders become nervous at the thought of openly supporting us for office.

Many in the party still subscribe to the condescending and self-serving notion that only politicians have the experience and can claim the respect necessary to secure legislation on issues affecting lesbians and gay men. Pro-gay legislators have even suggested that we should leave them alone and run our candidates in districts with homophobic incumbents — districts where they could never win. Our "friends" just can't understand why we're not simply grateful for everything they've done for us.

There's no question that many straight elected officials have supported the lesbian and gay community on issues including civil rights and AIDS. Certainly, we appreciate their efforts. But let's be realistic: our strongest champions serve in districts where a strong record on gay rights

and AIDS is required to stay in office.

For the political reality, the lesbian and gay community should not be so grateful that we do not assert ourselves in electoral politics. Our community must be willing to run against our straight friends to meet our goal of self-empowerment — just as African Americans, Latinos, and other minorities often must challenge white allies to win self-representation.

The goal of electing lesbians and gay men to office is not simply to flex our muscles. We can be far more articulate and uncompromising in representing our issues than non-gay elected officials can. Beyond that, lesbians and gay men to office have shown that we are effective on every policy levels of government. Most importantly, the power we gain by electing ourselves to office is the power to break down homophobia and change public attitudes about lesbians and gay men.

As the numbers of lesbian and gay officials have grown, and now with the teadership of Gay and Lesbian Victory Fund, we have been able to provide a higher level of practical support for lesbians and gay men considering races for public office. But the most important advice we can give is to simply have the courage to run. Power is never relinquished, it has to be taken.

SUPPORT CLINTON'S HEALTH REFORMS

The Human Rights Campaign Fund, the nation's largest lesbian and gay political organization, will support President and Mrs. Clinton's efforts to ensure access to health care for all Americans. "The general principles and reforms outlined in the plan address the greatest flaws and inequities of our current system," said Tim McFeeley, the Campaign Fund's executive director. "The concerns of gay, lesbian, and bisexual Americans in health care are also the principle issues for all Americans."

McFeeley praised President Clinton for addressing issues such as the practice of insurance underwriting to exclude from coverage people with preexisting conditions. "We believe that access to health care is a basic human right People with AIDS and HIV know how preexisting conditions have been used to deny them access to health care. President Clinton has stated repeatedly that this practice should be eliminated and if his plan passes it will be. We will be with

him in this fight."

President Clinton's health reform plan includes "funding for health care costs associated with clinical trials, and provides coverage for prescription drugs. We are continuing to lobby for these provisions, and for coverage of 'off-label' uses of prescription drugs, at last in the case of life-threatening or disabling illnesses," said Beswick, the AIDS Research Policy Analyst.

McFeeley noted that the debate over health care reform will take many months before final legislation is voted up or down. "Our community has a vital stake in health care reform. This debate affects every lesbian, gay and bisexual American, every woman concerned with breast cancer and reproductive rights, and every person with HIV and AIDS."

AIDS Action Council Executive Director Daniel Bross visited the White House to express to President Bill Clinton AIDS Action's support of the president's health care initiative.

"People living with HIV/AIDS are in dire need of fundamental change in the health care delivery system," said Bross. "AIDS Action Council applauds President Clinton for taking this historic step to reform the nation's health care system. The AIDS epidemic, more than any other public health crisis, has exposed the woeful inadequacies of our existing health care delivery system."

AIDS Action Council has evaluated the Clinton plan and found that many of its provisions address the AIDS communities' concerns.

"The broad principles in the proposal set forth by the president provide the first comprehensive national framework for addressing a range of health care issues facing people living with HIV/AIDS, from the elimination of preexisting condition exclusions to the preservation and enhancement of Ryan White CARE Act programs," said Bross. "We look forward to continuing to work with the administration to assure that issues and concerns of special interest to people living with HIV AIDS are addressed.

"AIDS Action will press for more specific assurances regarding the confidentiality of medical records and civil rights protection for health care consumers, and will work to see that reform challenges existing shortcomings in the delivery of health care to poor and undeserved communities, Bross continued. "For instance, services for people seeking treatment for substance abuse and mental illnesses must be responsive to all communities."

HRCF's MANDY CARTER RECEIVES PEACE PRIZE

Long-time lesbian activist Mandy Carter has been chosen to receive the War Resisters League.'s 1993 Peace Award. WRL, which is currently celebrating its 70th anniversary presented the Award to Carter and say other recipients at its Annual Dinner in New York City on October 16, 1993.

Carter, a grass-roots organizer for more than a quarter of a century, has been a public policy advocate for the Human Rights Campaign Fund

since April of 1992.

One of the nation's foremost African-American lesbian activists, she is being honored for her exemplary service to the Peace Movement during the 1970s when she served on the staff of WRL and was instrumental in organizing demonstrations to end the Vietnam War. In 1990, she was Director of North Carolina Senate Vote '90, an independent political action committee supporting Harvey Gantt's bid to defeat conservative Senator Jesse Helms. She is also an elected member of the National Steering Committee for Stonewall 25.

On being notified of the Award, Carter expressed great thanks to the War Resisters League, and reflected that 'in silence and secrecy, lesbians, gay men, and bisexuals have served in every struggle for peace, civil rights, and social justice that has ever moved this nation forward. As one of the many African-American lesbian and gay activists who was politically born in the peace and justice movement of the 1960s and '70s, it is extremely gratifying to now be honored openly."



SERVICE MEMBERS LEGAL DEFENSE NETWORK

A nationwide network of attorneys today announced the formation of the Servicemembers Legal Defense Network to provide pro bono legal assistance to gays and lesbians serving in the armed forces. The Servicemembers Legal Defense Network will respond to requests from active duty servicemembers and, using a national network of attorneys who have agreed to assist on a pro bono basis, provide local counsel and advice to gays and lesbians who are subject to harassment, investigation, discharge or imprisonment based on their sexual orientation. 'The debate of the last nine months has left lesbian and gay servicemembers unsure of their rights and unsure where to turn for help," said Michelle Benecke, co-director of the Network. "The new policy is in many respects worse than the old policy, and has given commanders license to continue investigations and discharge proceedings at bases across the world," she continued. "Every day, we hear from gay and lesbian servicemembers who live in fear for their lives and their careers," said Dixon Osburn, co-Director of the Network." The Network will coordinate and expand the nationwide network of attorneys willing to offer their services, will monitor the implementation of the "Don't Ask, Don't Tell, Don't Pursue" policy, and will publish analyses of ongoing cases and military policy to assist advocates who are counseling servicemembers. The Servicemembers Legal Defense Network is headquartered in Washington, D.C. and is directed by Michelle M. Benecke and C. Dixon Osburn, respected attorneys and scholars on issues relating to gays and lesbians in the military. UNITED AIRLINES ADDS SEXUAL ORIENTATION TO EEO POLICY

United Airlines, the nation's largest airline, recently revised its corporate Equal Employment Opportunity (EEO) Policy to prohibit discrimination against gay and lesbian employees. The new policy, which became effective July 1, states that "... it is corporate policy to fill positions, with qualified candidates regardless of race, color, sex, age, religion, national origin, disability, veteran status, or sexual orientation", and that the policy applies to "employment, subsequent job placement, acceptance into our apprenticeship programs, training, compensation and all other areas of personal practice..."

The EEO policy revision makes United Arthurs one of the largest corporations and the lirst U.S. air carrier to ban discrimination based on sexual orientation. Responsible for the revision was an association of gay and lesbian United Arthurs employees called the Gay/Lesbian United

Employees or GLUE Coalition.

GLUE Coalition is a not-for-profit employee association dedicated to full and equal recognition for all gay and Iesbian employees of United Arthres

GLUE Coalition members represent almost every job classification at United Airlines, and reside throughout the United States, Latin America

and Europe.

A FAMILY PROJECT

"Alexzandria was a fighter, very full of life," Charlyne Biggs says of her two-year-old daughter who passed away in July of 1992. For Brian and Charlyne Biggs and their two surviving daughters, the Quilt offered a way for the whole family to face their grief together. "It's something that you just have to do," says Charlyne.

The Biggs' had relocated from Chicago to the D.C. area to be near the National Institutes of health, where Alexzandria was receiving medical treatment. After they lost their daughter, Brian and Charlyne heard about the upcoming international display of the Quilt in Washington, D.C., they knew their family had to get involved. Every day they went to The NAMES Project National Capital Area workshop to work on Alexzandria's panels. During that time, they shared support and developed close ties with other panelmakers.

When the display arrived, the whole family pitched in. Mr. and Mrs. Biggs read names at the display. Their daughters Therica and Nichole, ages 10 and 11, helped put together red ribbons. A few months later, the whole family marched together with Quilt panels in President Clinton's inaugural parade.

For Alexzandria's two panels, they chose cotion because it's soft and folds easily. Flowers represent the garden which Alexzandria loved. A shooting star represents her "shooting for the skies." A rainbow sewn onto one panel has a special story behind it. When the Biggs' were choosing a burial site for Alexzandria, they came upon a beautiful spot by a tree. As they considered the site, a rainbow appeared — a sign from Alexzandria.

"Everyone is put here for a purpose," says Charlyne Biggs, "and I believe Alexzandria did what she was supposed to have done." Alexzandria's strength has helped Mrs. Biggs to cope with HIV in her own life. "People think that AIDS means you're already dead," she says. "They shouldn't treat you like that — they should admire and respect you." She expresses these feelings by writing poetry. On September 3, the Biggs told their story on the ABC program Good Morning America.

When you look at me, what do you see? Do you see the pain that is in my heart? Do you see the suffering of a weakening body, Or the struggle of a fighting spirit, Which refuse to sit back and let this wicked

BLINKY PROTECTS QUILT

Opting for a low-tech solution to an increasingly complex problem, the NAMES Project recently recruited Blinky to help out in the area of Quilt conservation.

Dramatic improvements in Quilt storage, safety, and handling were made possible by the move to new facilities last winter (including a state-of-the-art sprinkler system) but one problem has cropped up that no one else has been able to handle. Mice.

"There aren't a lot of them, but we want to keep it that way," observes Evelyn Martinez, Ouilt conservator. "Blinky has proven quite effective where more high-tech solutions have failed. And with all the cat images on the Quilt, I think he feels quite at home.

Before the adoption, staff and volunteers debated the pros and cons of cat fur vs. mice and decided that a little bit of cat fur was certainly preferable, particularly since it only gets on the back of the folded 12' X 12's.

Blinky has become quite an acrobat-jumping from shelf to shelf and into friendly arms.

He is a welcome addition to the staff of The NAMES Project Foundation, frequently sharing 'quality time" with his fellow co-workers.

LOOKING FOR STUDY PATIENTS

The National Institutes of Health is undertaking an interventional study using oral Lcarnitine therapy in HIV-infected patients with AZT myopathy, evaluating individuals who are currently treated with AZT and have symptoms of either fatigue, muscle pain, or weakness. There are no CD4+ cell requirements to participate in this study.

To be seen, a brief referral letter from the patient's physician and recent medical records should be sent by FAX or mail. After a screening history and physical examination, candidates will undergo laboratory evaluations, EKG, echocardiogram, and muscle biopsy. The result of all studies will be forwarded for the patient's clinical care. Those included in the study will be randomized and followed bimonthly for 6 months.

There is no cost to the individual for being seen at the National Institutes of Health. Patients will only be responsible for travel costs for the initial visit. If included in the study, subsequent travel will be provided free of charge.

Other conditions currently being studied in the Neuromuscular Diseases Section include HIVassociated inflammatory myopathy and HIVassociated demyelinating neuropathy. Again there are no CD4+ cell requirements for these studies. People with symptoms of numbness, distorted sensation, or weakness starting distally and progressing proximally will be evaluated.

UNDERGROUND AIDS THERAPIES

Believe it or not, adults in the United States make more visits to providers of unconventional therapy (425 million in 1990) than to all mainstream primary care physicians combined (388 million in 1990)* Most of these patients seek care for chronic rather than life-threatening conditions. But the national survey that uncovered this information also underscores some startling truths that physicians who treat people with HIV disease should keep in mind. Younger patients with relatively more education and higher incomes are more fikely to turn to unconventional therapies such as spiritual healing, dietary and herbal regimens, homeopathy, and folk remedies, and most are not inclined to report these alternative treatments to their physicians.

Although many people with HIV disease have tried alternatives to orthodox medical care. they and their advocates have also demanded something more; wider access to experimental and unlicensed drugs. The ways in which AIDS activists have sought and obtained this access demonstrate that orthodox therapies can themselves be obtained by unorthodox means. In the process, activists have helped to create a movement for self-empowerment. The central tenet of this movement is that waiting for the mainstream medicine to produce a cure just isn't good enough - that aggressive treatment must be had immediately, even if this means selftreatment. Like others with life-threatening diseases - but more publicly and successfully than ever before - persons with HIV insist that critically ill people have a right to try drugs not yet demonstrated to be effective in clinical trials. as long as those therapies have been shown to be

What unproven drugs do people with HIV disease use? Since the AIDS underground was established in the mid-1980s, four types of treatments have been available.

*Drugs licensed in this country for one or more indications but used off-label by person with HIV disease, such as azithromycin (Zithromax) and clarithromycin (Biaxin Filmtabs) for Mycobacterium avium-infracellulare complex.

*Drugs not licensed in this country but available elsewhere, such as oral amphotericin B for azole-resistant candidal infections or oral Nacetyleysteine (NAC) to inhibit fumor necrosis factor, which is elevated in late-state HIV disease.

 Experimental agents not licensed anywhere, such as peptide T, currently inder investigation as a treatment for HIV-related dementia and peripheral neuropathy, compound Q, (trichosanthin, GLQ223) a possible antiviral; and sublingual interferon alfa (Kemron), a potential immune enhancer.

*Products available without a prescription, such as St. John's Wort (hypericin) and Shosaiko-to (SSKT, an Asian herbal preparation), both possibly possessing antiviral properties.

Most underground therapies are conventional medicines licensed in other countries. Indeed, many agents now widely prescribed for persons with HIV disease — drugs such as pentamidine serbionate (NebuPent, Pentam), fluconazole (Diflucan), zalcitabine (Hivid, also known as ddC), and clarithromycin — were once available to persons with HIV through the underground.

What alternative therapies might patients be trying? Studies indicate that persons with HIV disease have sought out modalities such as acupuncture, aromatherapy, colon cleansing, crystal therapy, cupping, dietary regimens, herbal therapy, homeopathy, hypnosis, massage, medication, ozone therapy, reflexology, spiritual healing, visualization, and high-dose vitamin therapy. Although most of these alternative treatments are benign, some are potentially dangerous, and others are considered exploitantive. For example, patients have contracted infections from colon cleansing performed with unclean instruments, and others have spent large sums of money on treatments such as ozone therapy and IV vitamin C, which have no proven efficacy.

Where do people with HIV disease get underground drugs? Some off label drugs are prescribed by physicians, but most pharmaceuticals are obtained through buyers' clubs. A significant part of the self-empowerment movement, these are community-based organizations that provide clients with information about and access to drugs not otherwise available to them. Most agents sold through buyers' clubs are imported from other countries specifically because they are unlicensed here, but approved drugs may also be sold if they can be obtained less expensively from foreign manufacturers or if the supply in this country is limited. The Food and Drug Administration's personal use importation policy - the rule that permits the importation of unapproved drugs from other countries for personal use - has now been tacitly extended to buyers' clubs.

Because buyers' clubs are unregulated organizations, not all are run the same way. Some the PWA Health Group, for instance, which is the largest and oldest buyer's club in the country—sell drugs at the lowest possible cost, operate as nonprofit organizations, request a physician's prescription for agents that require medical monitoring for sale use, and provide information on the safety and efficacy of their products. Others are less objective about what they sell, promoting their products freely. The PWA Health Group sells primarily pharmaceuticals, but the inventory of some buyer's clubs consists largely of triannis, berbal therapies, and other products of the kind available in health food stores.

Underground AIDS drugs and the FDA: An uneasy truce

Until recently, the Food and Drug Administration (FDA) was silent on the subject of AIDS buyers' club, which help persons with HIV disease gain access to unproven drugs. But on May 26, the FDA delivered a letter to all known AIDS buyers' clubs formally acknowledging their existence for the first time The letter, signed by Randolph F. Wykoff, MD, director of the FDA's office of AIDS Coordination, mentions the agency's "personal use importation policy...to allow individuals with life-threatening diseases to bring in small quantities of unapproved products for personal use." Some buvers' clubs, the letter says, "have taken the position that their activities fall under the guidance provided by the policy." The FDA appears willing to allow buyers' clubs to operate under this assumption, even though the clubs are technically illegal, provided three criteria are met

Persons who patronize buyers' clubs are purchasing the drugs for their own personal use and using the drugs under a physician's care.

The buyers' club does not commercialize or promote its products.

The product does not "represent an unreasonable risk," because the safety of the agent itself is unknown or because its purity, sterility, and strength cannot be guaranteed.

At least one buyer's club is "heartened" by

the FDA letter, Sally Cooper, Executive Director of the New York City-based PWA Health Group, the largest and oldest AIDS buyers' club in the country, told Patient Care that "the FDA came around and inspected the buyers' club about a year ago. This letter is in part a response to those visits, and I think it shows that they didn't find anything particularly egregious. Obviously, the FDA can't sanction self-medication," Mrs. Cooper adds, "but the government also recognizes that there is no good existing antiviral treatment for HIV. That is the reality we all live with."

According to Ms. Cooper, the PWA Health Group "works closely with physicians. We have physicians on our board, and most of our patients are referred by physicians. We require prescriptions for many of our products — and we actually require monitoring forms in two cases where they're not required by the FDA. We also ask every client to read and sign the personal use regulation." Not all buyers' clubs work closely with physicians or within the system. Ms. Cooper says, "Some clubs sell primarily nutritional supplements for which there are no FDA guidelines for physician involvement. But I don't know of any buyers' club that sells prescription drugs without requiring a prescription."

On May 27, Dr. Wykoff testified before a subcommittee of the House Judiciary Committee on the subject of health fraud and AIDS. His opening statement mentions the FDA's letter to the buyers' clubs and the agency's "willingness to allow continuation of the beneficial aspects of the personal use importation policy, as long as abuses of the policy are prevented." The statement also addresses the issue of AIDS fraud, situations where "an unscrupulous person preys on the terminally ill patient and, for personal profit or sell-aggrandizement, exposes that patient to a fraudulent product." Ms. Cooper says, "These scams and quick cures are also a concern of ours. But we feel the FDA makes a distinction between them and buyers' clubs, which by and large are nonprofit and run by people with AIDS for people with AIDS "

Well-run buyers' clubs, Ms. Cooper maintains, "fill a gap in the beath care system for persons with HIV disease and will continue to do so, at least until the FDA develops a parallel track program to the point where the need for inderground distribution of potentially promising new drugs disappears. No doctor has ever gotten into trouble sending patients to buyers' clubs," she says, "and I don't think any doctor ever will."

Buyers' clubs: Guidelines for ethical operation

In January 1992, representatives for 11 AIDS buyers' clubs met in Fort Lauderdale, Fla. to develop a set of voluntary principles to guide their operations. Persons with HIV disease looking to purchase underground therapies should seek a buyers' club that subscribes to the principles and goals listed here.

*The self-empowerment of clients. The club will work to help people make cducated treatment decisions of their own accord by providing unbiased information, access to resources, and encouragement to seek qualified medical supervision and advice.

 Refraining from giving medical advice or promoting particular treatments or interventions.
 The club will work to disclose its own biases regarding any treatments it provides and will refrain from making medical recommendations unless qualified to render such advice.

 Quality assurance. The club will work to ensure that products it provides meet the highest possible standards with respect to purity, potency, lack of contamination, and truth in labeling.

CAREGIVER PROMOTES EDUCATION IN UGANDA

Noerine Kaleeba, director of the AIDS Support Organisation (TASO) of Uganda, has written a book entitled We Miss You All, the title of which is drawn from a Quilt panel. The AIDS Memorala Quilt includes four panels created at TASO. The original TASO panel was the first African panel to be included in the AIDS Memorial Quilt.

Since losing her husbnad to AIDS in 1987, Mrs. Kaleeba has devoted her efforts to educating people about AIDS and the need for support for those living with HIV/AIDS and their loved ones. "The courage of the families who have put the names of their loved ones on the quilts have contributed towards a more open and supportive attitude towards people with AIDS," she says.

The following is an excerpt from We Miss You All:

"My very first encounter with a person with AIDS was very brief and promptly dismissed.

Today the experience is very vivid in my mind. "I had gone to one of the medical wards in Mulago hospital to locate a paraplegic patient for a practical demonstration on the techniques of transferring a paraplegic from bed to a wheelchair, for physiotherapy students. I located a young man who couldn't have been more than thirty years old. I introduced myself and explained what I required of him. He was very receptive and gave permission for my students to learn from him that afternoon. His medical notes indicated that he had paraplegia due to Immunosuppression Syndrome, but I did not know what that was. I went to the ward sister to get permission to teach the students on her ward that afternoon, and to tell her which patient I had identified for the demonstration. She came closer to me and said 'I wouldn't touch him if I were you. He has AIDS. We don't touch him, we only show his mother what to do

"I did not use him for the demonstration, neither did I go back to him to explain that I would not be coming. I cancelled the class and arranged for another patient from the orthopedic ward.

"I did not think about him again, until the diagnosis of AIDS came through my front door. Today there isn't a day which passes when I don't wonder what happened to him. With whom did he carry the burden? With whom did his mother carry the cross? What friends did she have to share her emotions? How much did he know about AIDS? What support did he have: God, children, loved ones? I suppose I will never know."

FRED GRANDY TO MODERATE IOWA PUBLIC FORUM ON SEXUALITY

On February 8 a group of four lesbians and gays from Sioux City plus a straight liberal clergy couple who are very interested in gay rights had a meeting with Congressman Fred Grandy (after having tried for six months to get an appointment). The purpose of the meeting was to share with him our concerns as lesbians and gay men in Northwest Iowa, to hold him accountable for his votes on our issues, and to begin an ongoing dialogue.

All of those attending came away from the meeting feeling as though he had listened to us seriously and that, although he has not always voted for our issues, he is not in principle opposed to gay rights. He does, however, come under a lot of pressure from the Christian Right, who is much more vocal and better organized that we have been up to this point. When we don't contact our elected representatives about our issues, they think we don't care.

As a result of this meeting (and to our stunned surprise), Congressman Grandy volunteered to serve as a neutral moderator of a public forum on human sexuality issues at which we would, along with other straight supportive experts in various fields (Bible, AIDS, human sexuality), have a public discussion of our issues with whoever shows up. It will be our job to organize the forum, but Mr Grandy will lend his name and prestige (if not his partisanship) to the gathering. We feel that a public discussion of this sort is long overdue and were delighted that he would be involved. Planning will start immediately, and we will let you know the date, time, and place when they have been decided. Things are starting to happen in Northwest Iowa!!

GREEN GATEAU DISCRIMINATES

Coalition calls for boycott of local restaurant

The civil rights of a Lincoln man have been violated by a blatant act of bigotry. The victim is Sean Bolte, who waited tables at the Green Gateau until two weeks ago, when he was unexpectedly fired. The perpetrators are Bill and Bev Livengood, owners of the Green Gateau, who fired Bolte because he is gay

According to Bolte, the Livengoods received a phone call from a customer who complained that Bolte was too efferminate and would attract

"the wrong sort of people."

Gia Rauchnot, an employee of The Green Gateau since it opened last October, quit upon learning why Sean was fired. "I wouldn't work for anyone who would treat their employees that "she said.

Scan was wonderful, the best waiter (at the Green Gateau)," Rauchnot added.

Kevin Caughlin, who also quit when Sean was fired, agreed. "I was impressed with the way Sean worked. Sean was fired solely because he is gay, not because of his job performance." Both Rauchnot and Caughlin support a boycott of the

Said Caughlin, "I can't see them making money after this. When they fired Sean, they didn't expect anyone to do anything.

So why, after ten months of service was Bolte suddenly fired? The Livengoods claim his work schedule wasn't compatible with theirs.

"I don't know anything about any phone call," Bill Livengood said. "We want full-time employees. You can't run a restaurant with parttime employees.

Caughlin and Rauchnot both confirm the phone call that Livengood denies. In addition, Bolte pointed out that he was originally hired to work only two days per week, and that The Green Gateau had only four full-time service employees.

There are at least six servers who work less than 25 hours a week," he said, "and others that work less than two or three days a week."

When asked whether he would discriminate against an employee based on sexual orientation, Livengood responded, "I'm not saying what I would do." It was clear that the Livengoods don't want the "wrong sort" of employees or customers at The Green Gateau.

In an effort to help make the Livengood's dream of gay-free restaurant come true, the Coalition for Gay and Lesbian Civil Rights is calling for a boycott. If you believe that the rights of gay, lesbian, and bisexual people should be respected, please support this boycott

CHEP (pronounced See Fep) stands for Citizens For Equal Protection, Inc. We are a 3 year old organization dedicated to fostering a community which accepts, honors, and prospers by the diversity of its people. We believe that society's perceptions of gays, lesbians, bisexuals, and transgenders will change with education and legislation

We educate through 3 channels. We publish, we lobby, and we speak out. We publish a newsletter called CFEP NEWS, which is distributed regularly to our members. In the CFEP newsletter, the public relations committee reported on Omaha's National Coming Out Day-one of the largest celebrations in the United States. CFEP's legislative action committee reported on the status of LB395, a Nebraska bill which when passed will prohibit discrimination in employment based on sexual orientation. The community outreach committee is recruiting supporters in greater Nebraska to call and write their senators. And the fundraising committee unveiled its financial development plan for 1993 and 1994.

The CFEP NEWS keeps you informed and in touch with your gay and lesbian legislative action group. We've developed new relationships with the major media in Omaha and continue to feed them the other side of the story. 

Coalition president, Pat Greene, reported that about 75 people took part with 25 inside the restaurant and another 50 on the sidewalks outside with signs and handing out leaflets supporting LB395 and protesting discriminatory practices of the Green Gateau, where a waiter was fired for being too "effeminate". The group gathered at about 10 a.m. with about 25 members going inside, being seated, ordering a cup of coffee and remaining at their tables until after 1 p.m., effectively blocking the restaurant's lunch time business. Ms Greene reported that the demonstration was done with dignity and integrity. There was evidence of effective self monitoring - people showed up and, with great respect to all people they encountered, stood on the sidewalk and picketed, and handed out leaflets. The Coalition has contacted all other comparable restaurants. All other Lincoln restaurants stated they have non-discriminatory hiring policies. Former Governor Kay Orr was an unwilling participant when she and her family came to the restaurant for lunch. Mrs. Orr declined to take the leaflets that were offered by the demonstrators. Restaurant owner, Bill Livengood, never showed his face during the demonstration, but did talk with an interviewer on Nebraska Public Radio. When asked if he had indeed fired the waiter for being homosexual, Mr. Livengood declined to respond, saving "I'm not going to make any comment on that.




