### Mich. Bullying Bill to Drop Religious Exemption

LGBT and Muslim activists are voicing relief that a Michigan antibullying bill will be changed so it no longer includes an exception for expressions of "sincerely held religious belief or moral conviction."

The state Senate earlier this month passed a version of the bill including that language, which some observers thought amounted to a license to bully LGBT people or members of minority faiths. The House last week



approved a version without that exception, and Republican senator Rick Jones, who backed the provision, agreed Monday to drop it from the Senate version, Religion News Service reports. The bill requires all Michigan school districts to have antibullying policies.

"Senate Republicans only wanted to protect free speech, Jones said, and never intended to create a religious exception for bullying," the news service reports. "Had he foreseen the controversy, Jones said he would have removed the problematic language."

Still, the legislation does not go far enough because it does not list characteristics, such as sexual orientation, that might make students vulnerable to bullying, **Michael Gregor (pictured above)** of the LGBT group Equality Michigan told the news service. "We are grateful that this legislation moves forward without the license to bully based on an outrageous religious exception, but that said, it won't be effective," he said.

Dawud Walid, executive director of the Michigan chapter of the Council on American-Islamic Relations, also said such a listing would strengthen the bill but still expressed relief that the controversial language will be excised. "It would have been a disaster," he said.

### 5 Reasons State Lawmakers Want DOMA Repealed

The case against the Defense of Marriage Act is widening as more lawmakers step forward to condemn the law. The latest last week included governors and mayors, largely from states where marriage equality is recognized.


They sent a letter to the Senate Judiciary Committee ahead of a vote on whether to repeal DOMA. The repeal advanced to the Senate on a party-line vote.

The argument against DOMA is still solidifying. For example, companies such as Google, Microsoft, and Starbucks filed a brief in a the case challenging the constitutionality of DOMA and argued that the law is just another form of government regulation that puts a burden on business, leading to wasted resources and money.

The governors and mayors made a similar case, claiming government overreach as they trumpeted states' rights. In the broad understanding of party values, it's the sort of case you'd expect to hear from Republicans, though the list was mostly Democrats.

Here are the top five reasons they say DOMA should be repealed:

- DOMA disrespects states' rights, they argue. Although the policy was born from a concern by conservative states that they might be forced to recognize same-sex marriages performed in other states, these lawmakers say DOMA has actually trampled states' rights. "By denying federal recognition for some of our states' lawful marriages, DOMA does not just deny married same-sex couples these and other critical rights and benefits," they wrote. "It disrespects our states' decisions to treat all of our citizens equally."
- But they aren't minimizing the importance of gaining equal rights. The federal government is interfering in the lives of state citizens, they say. Same-sex married couples are "constantly hamstrung" by the more than 1,100 rights they cite being withheld by the federal government. "While we are proud that our states have eased the burdens on families, these provisions of federal law are beyond our purview and Congressional action is required," they demanded.
- Similar to the argument made by U.S. companies opposed to DOMA, the lawmakers say it forces them to discriminate. They say DOMA "even requires our states' governments, when we jointly administer federal programs like Medicaid, to actively discriminate against our own lawfully-married citizens." The companies complained of having to identify those legally married couples that are gay among their workforce so they can be denied benefits.
- DOMA is dangerous, the lawmakers argue, referencing the epidemic of LGBT suicides among youth who are struggling to be out in a world that does not seem to accept them. "For LGBT youth, DOMA sends a dangerous message that that they cannot be full and equal citizens of their country," they warn.
- DOMA affects straight people too. Starting with the children of same-sex couples "who suffer from the financial instability DOMA creates for their parents," the law also impacts straight families and friends "who must step in with financial and emotional support to mitigate these problems."

California governor Jerry Brown sent his own letter because his state is in the predicament of having legal samesex marriage taken away at the ballot box — a change that is being challenged in the court system.

### Girl Takes Life After Gender-Based Taunting

A 10-year-old Illinois girl has committed suicide after enduring bullying that included being called a boy when she had her hair cut short.

Ashlynn Conner, who lived in the small town of Ridge Farm in eastern Illinois, was found hanged in her closet Friday night,

and family members believe she took her own life due to bullying and teasing that had gone on for several years, the Associated Press reports.

"When she started cheering for youth football, we'd gotten her hair cut in a bob," said Lory Hackney, her grandmother. "The kids started making fun of her then. They started calling her a boy." She was subsequently called "fat," "ugly," and "slut," relatives said.

Vermilion County sheriff Pat Hartshorn said investigators "are not ruling out bullying, but we don't have any firm evidence to support bullying," the AP reports.

However, Ashlynn's mother, Stacy Conner, said the girl came home from school Thursday complaining about taunting by fellow students and asked if she could be home-schooled. Stacy told Ashlynn, a fifth-grade honor roll student who hoped to become a veterinarian, that she would discuss the teasing with her school principal this week. But Friday, shortly after having a phone conversation with a friend about the problem, Ashlynn was discovered hanging in the closet. Hackney, a retired nurse, tried unsuccessfully to resuscitate her granddaughter.

"I don't know what was so bad she couldn't wait," Hackney told the AP.

### So What Exactly is a Short Sale?

In today's economic crisis and down real estate market this is a term that comes up a lot. But what exactly does it mean? In simple terms, a short sale is a tool that is used by banks and borrowers who have come on difficult times, as an alternative to foreclosure when a borrower cannot repay their loan.


- They can simply wait for the bank to take their home or walk away from it.
- They can try to get a loan modification, where the bank will change the condition of their loan and either lowers the principal amount owed, the interest rate they are paying, or the term of the loan and thus lowering their monthly payments to an affordable amount.
- 3. They can give the property back to the bank (known as a deed in lieu of foreclosure) or
- 4. The final option is that the bank can authorize a "short sale"

A short sale is an agreement by the bank to allow the borrower to sell the property at a discounted price.

The homeowner will hire a real estate agent and put the house on the market just like any other sale, except the home will be priced according to current market value and conditions, which is typically much less then the homeowners owes on their mortgage. Buyers will come and tour the home and make offers.

In the end, the bank will have to approve any "short sale" offer made by a potential buyer before the sale can continue. Once the bank has made that agreement, the property can be sold just as it would normally.

The bank is essentially agreeing to accept the purchase price as a payment in full on the loan that is owed. It frees up the borrower to walk away from the property without a foreclosure on their credit, and it keeps the bank from having to take the property back.

It's my opinion that a short sale is a better option than a foreclosure, as you're cooperating with the bank in selling a home they loaned you money on, that you can no longer afford ~ short sale or foreclosure, expect your credit to be damaged.

Additionally, it's important as part of the short sale agreement, that the bank agrees not to come after you for the "short payoff"... in some cases with foreclosure or short sale, the bank may attempt to collect from you the negative balance and or 1099 you for the "gift", which you'll pay taxes on.

# Texas Transgender Widow Appeals Benefits Decision

Nikki Araguz, the transgender widow of a Texas firefighter, is appealing a judge's decision that found their marriage invalid and denied her his death benefits.

Araguz was in court Monday in Wharton to appeal Judge Randy Clapp's May decision that her marriage to Wharton County fire captain Thomas Araguz was not valid because Nikki was born biologically male, Houston TV station KHOU reports. Nikki, who had long identified as female and lived as a woman for some time before their marriage, underwent genderreassignment surgery afterward, and she says their union was legal. He died last year while fighting a fire.

Thomas Araguz's family says his death benefits — \$600,000 — should go to the two children he had with his previous wife, instead of a share going to Nikki. The appeals process in the case could go on for another year, attorneys said.

The case stands to have wide-ranging implications for gendervariant individuals.



### Study: GSAs Produce Healthier People



who participate in GSAs "have better mental health as young adults, are less likely to drop out of high school, and more likely to attend college," according to a release.

The study shows the benefits of GSAs diminish as victimization of LGBT students at school increases — in other words, GSAs aren't enough to fully counteract harassment, bullying, and violence; additional resources are required.

"This new study on the benefits of GSAs to health and education adds to our growing understanding of the importance of social environments and the need to provide institutional support for LGBT youth to promote well-being in adulthood," Caitlin Ryan, coauthor of the study and Family Acceptance Project director, said in a press release.

### NOM Injects Race Into Gay Parenting Debate

A subgroup affiliated with the National Organization for Marriage is outwardly condemning adoption for gay parents while attempting to provoke African-Americans to take a stand against the practice.

Jennifer Roback Morse, the head of NOM's Ruth Institute, which educates college students on the merits of heterosexual marriage, was referencing Raise a Child, a campaign to encourage same-sex couples to adopt, according to GoodAsYou.org. "Why aren't we recruiting stable heterosexual married couples to be foster parents." Morse wrote. She went on to say that gay people raising children is an "untried social experiment" and that male couples acting as parents is "exceedingly uncommon"

Morse then made a point about the races of the children and parents in the ad campaign, posted throughout Hollywood. "And look at the children in these posters. I wonder what the African-American community thinks about recruiting gay men to become foster parents for the children of their community who have been taken from their parents."

The Raise a Child initiative is a partnership between the Los Angeles County Department of Children and Family Services and three nonprofit adoption organizations. According to Raise a Child, there are nearly 500,000 children in foster care, with 115,000 available for adoption.

Robyn Harrod, adoption director at the Southern California Foster Family and Adoption Agency, one of the partnering organizations, said in a press release that half of the families her agency works with now are headed by single or partnered gays and lesbians. "Ten years ago there were very few LGBT families that understood that they could foster and adopt through the county," Harrod said.

### **After Topless DMV Fiasco**

A transgender woman in Tennessee is asking the state to make a consistent ruling about her gender after a government office labeled her a male but police arrested her on a female-specific charge.

Andrea Jones of Morristown, Tenn.. who had gender reassignment surgery and has been recognized as a woman by the Social Security office, decided to make a statement after her local Tennessee Department of Safety office refused to let her change the gender on her driver's license from male to female.

She walked out to the parking lot and removed her shirt, which she reasoned would be acceptable if the state recognized her as male.

Instead she was arrested for indecent exposure.

The police report even referred to her as a man: "Mr. Jones continued to yell that he had the right to show his breasts in public," it read, "and wanted to be recognized as a female."

"If I was a male, I had the right to, when I stepped out the door, take off my shirt," Jones said.

Jones says even though she has a "statement from a surgeon saying I no longer had my testicles," the Department of Safety told her she would need more proof to be listed as female on her license.

"It's not right for the state to ask me to be both male and female," Jones told local TV station WATE 6. "A choice needs to be made. They cannot hold me to both standards."

The Department of Safety told the news channel that a gender change can be made on a license "if an applicant presents a doctor's statement indicating that a full sex change has occurred and the procedure is complete."

Which means for now Jones will be considered a female by the Social Security office but a male to the Department of Safety — and evidently the police department.

### HOW TO CHANGE YOUR LIFE

In my private practice, a lot of clients come to me and complain about disappointment. Disappointment with their new job, new lover, new home, new diet. Self-help books make it sound so easy to make major changes in our lives. But is it? How often have you heard someone say, "Hey, it's time for a change, Γ m



really ready to change my life". But, a few months (weeks?) later, check in with them. They're likely to be disappointed and say something like: "I thought it was gonna be so great with this new job/lover/diet, but it's the same old shit as before." Most of us can only sustain this kind of change for about three days max. After that, we fall back into the same old patterns. After all, we've had years to develop these patterns, and yet we expect in three days we can undo the cumulative damage of decades?

Self-help books, claims of wise gurus and infomercial promises aren't enough: nothing "magically" changes just because we say so. If we want things to change, we need to take action and create the change by behaving and thinking differently. Change is hard work. Before you undertake any major change in your life, it's helpful to look at what stands in your way. Here are some obstacles to change that I see in many of my clients. Are they familiar?

You aren't willing to do the work: If you just wait for happiness (more money, a new lover, a better job) to come to you, what do you think will happen? Likely, nothing! New results require new thoughts, actions, speech, and intentions. Instead of giving up on your desires for change, look past the obvious and dig deeper. For example: if you want a boyfriend, what for? If it's to stop feeling lonely, then a boyfriend may not fix your problem. Your loneliness is the real problem. If you think you need a new job, what for? Do you want to leave your current job because you find some of the people difficult? Guess what? There are usually difficult people at every job. Rather than running away, set your intention to learn how to deal with difficult people. See what I mean about digging deeper? A recent client told me he wanted to look like actor Daniel Craig in his naked scenes in those James Bond movies. I asked him why. He said, "because then I'll feel sexy and confident." I suggested we work on how he can feel that way WITHOUT looking like 007. I helped him identify and remove what blocked him from feeling sexy, confident, strong and hand-

You're too impatient: How many of us feel impatient about change and don't want to wait forever to become happier? (In all honesty, I'd raise my hand to this one). After all, we de-

serve to be happy, don't we? Look at how long we're suffered already. If you've spent 25, 35 or 45 years feeling you're not worthy of a good job/partner/house/whatever, do you really expect that just simply deciding to change will transform your life? When my clients want to take on big psychological "makeovers". I encourage them to take it slowly. We can't sustain major change when we try to do it dramatically and quickly. I know it isn't as exciting – it wouldn't make good reality TV – but lasting change in our lives comes gradually, step-by-step.

You expect too much: When I have a new client who says, "I have so many problems, I don't know where to start", I encourage him or her to make a list of all the things that bother them and to rate these problems (on a scale of 1 to 10) by how much pain each one brings them. For example, "I hate my job" is a 7, "I feel so lonely" is a 9, "I don't like my body" is a 3. We start to work on the most painful stuff first and we focus on one problem at a time, breaking it down into small, do-able action steps. For example, saying "I hate my job" over-and-over is only going to bring you misery. Instead, ask yourself questions like: "What about my job bothers me the most? What do I like about it?" Any seemingly unsolvable problem can be broken down into a series of smaller, more easily solved problems.

You're too hard on yourself: You may think that you're a slacker, but, in reality, you're probably too hard on yourself. Punishing yourself isn't the way to make changes. You've been punishing yourself for years, and you haven't changed. That's not the way to do it. Here's a better way: make a list of 10 ways that you can be kinder to yourself in the next week and start to do them. I guarantee you that by being kinder to yourself, any changes you want to make in your life will happen more quickly and painlessly. I'm sorry to tell you it won't be fast and dramatic: change comes from being persistent and consistent. Try it and don't be surprised when you life starts to change, in small ways...and then keeps on changing.

Arguing that the Montana constitution guarantees fair and equal treatment to all people, the American Civil Liberties Union is appealing a District Court's dismissal of a same-sex domestic partnership case.

Donaldson and Guggenheim vs. State of Montana was filed by Jan Donaldson and her partner of 27 years, Mary Anne Guggenheim, after a doctor refused to speak with Donaldson without a release after Guggenheim had hip replacement surgery.

"This case is about treating people fairly and humanely," Donaldson said. "We just want the dignity of having our committed partnership recognized as worthy of those legal protections."

The ACLU says recognition of same-sex partnerships is necessary to uphold fair treatment for all, which is guaranteed by the Montana state constitution.

"Anyone who works and pays taxes should be treated equally and fairly by our state," said Jennifer Giuttari, interim legal director for the ACLU of Montana. "When two people are in a committed relationship, they should be eligible for benefits, like filing a joint tax return, regardless of whether they are a same-sex couple or a different-sex couple."

# Brazil Grants Residency to Same-Sex Partner

Published reports say the Brazilian government has for the first time granted permanent residency to a noncitizen based on a same-sex relationship.

According to the Associated Press, Antonio Vega Herrera of Spain, who lives in the Brazilian town of Aracatuba with his native-Brazilian partner, has been granted the right to live in the country permanently based on an October ruling by Brazil's Supreme Court "that recognized same-sex marriage, giving gay couples the rights such as the ability to jointly file taxes and to

jointly adopt a child."

Julio Moreira, president of the Rio de Janeiro gay rights group Arco Iris, applauded the move, saying, "We're advancing our rights as part of a conversation about democracy in this country. Our constitution says no one should be discriminated against, so we see this in the same terms as the fight against racism and sexism."

Moreira says the next hurdle is getting Congress to pass legislation guaranteeing those rights so that individual cases won't have to be tried in court.

# Transgender Rights Bill Headed for Crucial Votes in Massachusetts Legislature

Proponents of a bill that adds transgender people to the list of groups protected under the state's civil rights laws said this afternoon that they are lobbying members of the Legislature as they prepare for a House vote and a potential Senate vote this week.

The bill has languished in the Legislature for nearly six years. But a top House lawmaker promised today that the Judiciary Committee would vote on the bill in time for a debate on the House floor this week. Opponents plan to hold a press conference Tuesday.

"This is a historic step forward," said Representative Carl M. Sciortino Jr., a Medford Democrat who co-sponsored the bill.

Advocates said transgender people are subject to discrimination and physical violence. The bill would extend to them protections against housing discrimination, employment discrimination, and credit discrimination. The bill would also add gender identification to the state's hate crimes law.

Gunner Scott, executive director of the Massachusetts Transgender Political Coalition, told the story of a transgender woman who felt physically threatened in her apartment and had to move as she transitioned into a woman, and then was asked to leave a hairdressing school. Scott said there are 33,000 people who identify as transgender in the state.

"This is the equivalent of Fenway Park," he said.

He said 15 other states have legal protections, as do more than 100 cities and towns around the country.

The bill that will be debated will not have controversial language that protected transgender people in public accommodations, which had led critics to label it the "bathroom bill."

"The bill is not perfect, but this is a critical step," Sciortino said.

Representative Byron Rushing, a Boston Democrat and cosponsor, said the bill is in line with protections for other oppressed groups.

"This is a group that has been discriminated for a long time," Rushing said.






