The past three years have been exciting for the Czech Heritage Foundation. We have initiated several projects and worked with groups when their plans were related to Czech heritage and culture. We are interested in the Czech Village and its development. One major goal is the realization of the Czech Library - Museum, a long time project. Progress is slow in some areas but coming along. I am confident of ultimate success in this and the other undertakings . . .

Members of the Foundation have felt it rewarding to become involved in planning concerts, trips, setting up exhibits, meeting with groups to talk about our Czech heritage. The interest of our members as well as by the community-at-large indicates a real sincere desire to see our Czech heritage preserved in our area...

The Czech Heritage Foundation is a new organization, not directly related to any previous groups but realted to all who are of Czech ancestry and interested in the work of the Foundation. . .

INTEREST in CZECH BOOKS IS BOOMING!

It is heartening to know that not only we but others are gathering books in the Czech language. Our Czech Library collection now must number some 170 volumes. Elsewhere such developments are: at the main building of the AMERICAN SOKOL in Berwyn, Illinois the collection is 95% in Czech. The books have been cataloged and cross-indexed. Also a file of pamphlets, music, folk dances and other items are in the collection. All materials and books must be used in the library.

AND at the WESTERN FRATERNAL LIFE
ASSOCIATION Home Office here in
Cedar Rapids(better known as the
ZCBJ to older folks) the Library
has some 1500 books with some
100 in English-all others Czech.
They were indexed and shelved by

Agnes Dvorak, Melvina Svec, Lillian

#### -- AND MORE MUSEUMS !

In Wisconsin, The Fraternal Herald reported in December 1976 issue, of the plans to preserve Czech culture in that state. They, too, are seeking heirlooms for the Museum. Many of the lodges as well as individuals have pledged from \$10.00 to \$10,000. Some items are to be on "loan" and others are permanent gifts. Altho the Museum will be in Milwaukee, all Wisconsin Czechs are interested in the development.

### COUNCIL OF HIGHER EDUCATION Matice Vyssino Vzdělaní

Many local lodges and groups make an annual contribution to the scholar-ship fund of the Council of Higher Education. It was funded and founded in 1903 in Cedar Rapids by Mr.W.F. Severa with the support of Dr.Bohumil Shimek, Professor of Botany at the University of Iowa. Mr.Joe Mekota of Cedar Rapids was the legal advisor. Later the office was moved to Illinois and now is in Berwyn.

It was a loan from that fund that helped me at college. No interest is charged and one is honor-bound to make the repayment as soon as one is able. The loans vary as to the needs of the student, academic standing, and knowledge of the Czehc heritage.

The first secretary was Paul Korab of Iowa City. Then Ted Hlubucek held the office for many years. Only one student has defaulted in repayment over the years! The loans are available to students of Czech ancestry.

In the last 8 years an average of 34 students are helped each year - the loans average around \$640.00 per student.

#### THE CZECH HERITAGE FOUNDATION, INC.

The Constitution of the Czech Heritage Foundation, Inc. is in reality the Articles of Incorporation, recorded in the Office of the Secretary of State of Iowa, February 14, 1974, under provisions of Chapter 504A, 1973 Code of Iowa.

The Charter and Certificate of Incorporation are on file in the volume,
Corporate Records, in the keeping of the Secretary of Czech Heritage Foundation, Inc.

BYLAWS

of the

CZECH HERITAGE FOUNDATION, INC.

of

Cedar Rapids, Iowa

#### ARTICLE I - MEETINGS

Section 1. The Board of Directors shall meet at least once a month at a time and place to be agreed upon by the Executive Committee. Additional meetings shall be held at the request of the President or at the request of three members of the Executive Committee.

Section 2. Fifty-one per cent of the membership of the Board of Directors shall constitute a quorum.

Section 3. The Annual Meeting of this Foundation shall be held on the third Monday in January, at a time and place to be arranged by the Executive Committee.

#### ARTICLE II - MEMBERSHIP

Membership in the Foundation shall be open to all citizens and residents who are interested in our Czech heritage.

#### ARTICLE III - DUES

The annual dues of members of the Foundation shall be determined by the Board of Directors, presented to the members at the Annual Meeting and voted upon at that time.

#### ARTICLE IV - ELECTION OF OFFICERS

Section 1. The Nominating Committee shall consist of one member of the Board of Directors from Czech Heritage Foundation, and one from the Czech Fine Arts Board, and one member-at-large. The committee will designate the chairperson.

Section 2. The Nominating Committee shall prepare a slate of officers of one candidate for each office, and no less than six names for the slate of Board Members, to be presented at the Annual Meeting in January. Nominations may be made from the floor at this time.

<u>Section 3.</u> Any member of the Czech Heritage Foundation may nominate a candidate or declare (his)(her) own candidacy by communicating with the Nominating Committee.

<u>Section 4.</u> Election of members to an office or to the Board of Directors will be judged by a majority of the votes received by the candidate.

#### ARTICLE IV - OFFICERS

- Section 1. The officers of this Foundation shall consist of a President, Vice President, Secretary, and Treasurer.
- Section 2. All officers must be members of the Czech Heritage Foundation at the time of election and during the term of office.
- Section 3. Whenever a majority of the Executive Committee shall agree that an officer has been grossl; negligent of the duties as defined in the Bylaws, or is incapacitated or voluntarily resigns from office, they shall declare the office vacant.
- Section 4. An office declared vacant by the Executive Committee shall be filled for the unexpired term by election of a replacement from the membership of the Foundation by action of the Executive Committee.
- Section 5. All documents and property of the Foundation shall be surrendered to the Executive Committee upon the termination of services of such an officer.

#### ARTICLE V - DUTIES OF OFFICERS

- Section 1. The President shall preside at meetings of the Board of Directors, the Executive Committee and Annual Meetings; appoint all standing committees and special committees as needed, serve as ex-officio of all committees. The President shall represent the Foundation in public events as occasions require.
- Section 2. The Vice President shall perform the duties usually attributed to the office, and serve as chairperson of a major standing committee.
- Section 3. The Secretary shall keep accurate MINUTES of meetings and keep copieson file and tend to other correspondence as needed.
- Section 4. The TREASURER shall receive and disburse all monies concerned with the operation of this Foundation. The Treasurer will be assisted by a Financial Secretary to keep accounts in proper form in the ledger to facilitate the Treasurer's monthly and annual reports.

#### ARTICLE VI - EXECUTIVE COMMITTEE

- <u>Section 1.</u> Membership of the Executive Committee shall consist of the officers and the immediate past president.
- Section 2. Authority of the Executive Committee shall be the executive authority for this Foundation, and to conduct affairs as needed between meetings of the Board of Directors.

#### ARTICLE VII - BOARD OF DIRECTORS

The Board of Directors of this Foundation shall consist of the Executive Committee and a minimum of six and a maximum of 25 members-at-large.

#### ARTICLE VIII - STANDING COMMITTEES

The STANDING COMMITTEES will be established by the Board of Directors with a Board Member or Officer to chair a committee. Additional members of committees shall be chosen from the general membership.

- Section 1. MEMBERSHIP Committee shall have the responsibility of securing renewals, increasing membership, maintaining the file of records (names, address, zip code, phone number) and keeping the file up-to-date, mailing membership cards and responding to inquiries.
- Section 2. BUDGET & FINANCE Committee shall be chaired by the Treasurer. A budget shall be presented to the incoming officers no later than February following the election of officers in January. Auditing shall be provided for prior to the January Annual Meeting.
- Section 3. PUBLIC RELATIONS & PROMOTION. This Committee shall see that publicity and news items and newsletters are received by the news media, (radio, TV, papers) in ample time to be of use in promoting projects; should provide for a speakers bureau and list topics and available speakers; arrange for events that will promote Czech heritage and culture so community will be aware of these features. Arrange for exhibits and materials at appropriate local events, (fairs and similar events in area).
- Section 4. NEWSLETTER & PUBLICATIONS Committee shall develop no less than three issues of the newsletter to the membership during the year, take care of sales and distribution of any booklets, keep the accounts of sales etc., develop other possible materials that are appropriate. Deposits of sales shall be made to the Treasurer. Be responsible for additional printings of materials as needed.
- Section 5. PROGRAM COMMITTEE shall plan and provide periodic events that keep the Czech heritage before the community, Programs shall often be in cooperation with Czech Fine Arts Foundation and other groups in the community. When more than one Annual Meeting is held, provide for the program and events.
- Section 6. SOCIAL Committee shall be in charge of hospitality and hostessing at general meetings for the membership and be responsible for teas and receptions as they occur.

#### ARTICLE X - DISSOLUTION

- Section 1. The Foundation may be dissolved by a two-thirds vote of those present at the Annual Meeting in January or at a Special Meeting of the membership called to consider the dissolution.
- Section 2. Upon dissolution, the Executive Committee shall make provisions for the payment of all liabilities of the Foundation, and shall dispose of all assets by transferring them to such groups as are organized and operated for purposes comparable to this Foundation.

#### ARTICLE X - AMENDMENTS AND RULES OF ORDER

- Section 1. Robert's Rules of Order shall be followed in the conduct of meetings when a procedural problem arises.
- Section 2. The Constitution and Bylaws of this corporation may be amended by a majority vote of the members present at an Annual Meeting providing the recommendations have been approved by the Board of Directors and further, that notice of changes will have been included in the last edition of the newsletter prior to the Annual Meeting.
