I received your contact information from Terrell Austin in reference to the Ware Lyndon House.

I am a landscape historian working on a project at the house under a contract with Athens Clarke County. We are designing some improvements to the grounds at the front and west side of the historic house. I have attached a 1918 Sanborn Map which shows some outbuildings adjacent to the house. We know the "pink" colored structure was brick and the yellow structures are wood frame. We assume the frame structure south (front yard) of the house was the playhouse that is referenced in an oral history of the home, but we do not know what the use was of any other outbuildings. Do you by any chance have any idea about the use of these outbuildings?
