Hi, Keith – Sorry for not responding sooner. A few notes:

- (1) Please change my organization to A-C Heritage Foundation or Athens-Clarke Heritage Foundation. We are not "ACC." Minor but might as well get it right.
- (2) I did not come away from the meeting with the impression that the kitchen garden should be a priority in this project. I think we may need to talk about it more.
- (3) I feel the same about the existing foundation plantings along the side of the house. I don't know that we HAVE to keep these. More discussion needed, I think.
- (4) The biggest thing for me is the 1897(?) photograph. I know that I SHOULD have been aware of this photo but I wasn't. I thought the 1938 aerial was the earliest photo-documentation we had, and it shows very little. (Again, I apologize for not doing my homework.) I wish we had looked at the photograph at this meeting because I believe that it gives that central walkway more legitimacy, especially given Mack's theory that the house did not likely have a formal garden in the front. Is it possible that the house always had a central walkway? I don't want to do a fancy Italianate garden that makes it look like we are putting on airs if we can document the central walkway.

I know this is putting a huge fly in the ointment but I do think the 1897 photograph is significant.
