AN ORDVINANCE PROHIBITING THE DISSEMINATION OF MATERIALS THIS ORDINANCE MAY WHICH PROMOTE AND INCITE GROUP HATRED BE CITTO IS 3 V.O. #19-5-N-995 WHEREAS, the dissemination of any material within the Village of Skokie which promotes and incites hatred against members of any group by reason of their race or national 5 ancestry is repugnant to the local standards of morality of 6 the people of the Village of Skokie. 7 NOW, THEREFORE, IT IS HEREBY ORDAINED: 8 Section 1: That Chapter 28 of the Code of Ordinances of 9 the Village of Skokie be amended by the addition thereto of 10 Section 28-43, as follows: 11 Sec. 28-43 Prohibition of materials promoting or 12 13 inciting group hatred. Sec. 28-43.1 The dissemination of any materials within 14 the Village of Skokie which promotes and 15 incites hatred against persons by reason 16 of their race, national origin, or religion, 17 and is intended to do so, is hereby pro-18 hibited. 19 Sec. 28-43.2 The phrase "dissemination of materials" 20 includes but is not limited to publication 21 or display or distribution of posters, signs, handbills, or writings and public 22 23 display of markings and clothing of symbolic 24 significance. 25 Sec. 28-43.3 The Corporation Counsel of Skokie is hereby 26 empowered to seek an injunction in the 27 Circuit Court of Cook County to restrain 28 any person, group or organization from vio-29 lating this ordinance. 30 Sec. 28-43.4 Any violation of this ordinance shall be 31 deemed to be a misdemeanor and upon con-32 viction thereof, any person found guilty 33 shall be punished by a fine of not more than \$500.00, or by imprisonment in the County Jail for not more than six (6) 34 35 36 months, or by any combination of the fore-going for each offense. 37 38 Sec. 28-43.5 The invalidity of any section or part of 39 this ordinance shall not affect the validity

of the remaining sections or parts.
