PATRICK KENNEY HOUSE

The Patrick Kenney House located in Bexar County near Somerset, TX was built around 1877-78, after Patrick Henry Kenny purchased 46 ½ acres of land for \$186.00 from D.W. Heard on 22 December 1877. The acreage was originally a part of the Clemente Bustillo grant, Survey #348. This purchase added to the already extensive acreage Kenney had previously purchased located on from the Michael De Chaumes grant.

In the 1977 and 1999 surveys of the property conducted by the Alamo Area Council of Governments, the Kenney House was described as being a one-story limestone and stucco house with an east/west orientation. The windows were 6/6 and the house had a tin roof over shingles. The chimney was located on the north side. A porch was noted on the east side. Frame additions had been made to the house. Several outbuildings were also seen on the property. On a visit to the property in 2010 by several members of the Historic Farm & Ranch Committee of the San Antonio Conservation Society, an underground basement accessible from the west side of the property was observed. The house was being used primarily for extensive storage and a porch type structure on the west side was in a collapsed state.

Patrick Henry Kenney, born 1 February 1839 in Mayo County, Ireland, was the son of John Kenney and Catharine Brannon Kenney. He is reported to have immigrated to this country in 1849 with his parents and his siblings, although the family has not been located on the 1850 census. He became a naturalized citizen in 1856 and registered to vote in Bexar County on 15 July 1867. At the time of registration, Patrick Kenney indicated he had been in Bexar County for 11 years which indicates an arrival date of 1855 or 1856.³

On 14 May 1869, Patrick Kenney and Rosa Zink (Zensch) were married in San Antonio by Catholic priest, Vincent Barzynsk. Witnesses were: Jacob Halamuds and Jacob Deyes.⁴⁵

Rosa Zink was born on 18 August 1850 to Frank Zink and Francisca (Frances) Leopold. She indicated on the 1900 census she was born in Russia/Poland and that she had immigrated to Texas in 1856. Rosa and Patrick Kenney had 9 children: John Joseph, William Franklin, Catharine, Patrick Henry, Thomas, Alvena Rita, Annie, Margaret, and James (detailed later).

Bexar County tax records for 1874 indicated that Patrick Kenney paid taxes on 160 acres valued at \$520.00, 9 horses valued at \$140.00 and 102 cattle, valued at \$525.00. The property was on the M. Chaumes grant. By 1875 Kenney had doubled his property ownership to 320 acres valued at \$990. However, his livestock ownership had changed to 8 horses, 14 cattle and 25 goats/hogs. He continued to purchase land and in 1876 he owned 480 acres valued at \$1260.00 on the M. Chaumes grant. Seven years later in 1883, Patrick Kenney paid taxes on the same 480 acres on the Chaumes grant, but he also paid taxes on 41 acres on the Clemente Bustillo grant valued at \$2120.00, 3 buggies/wagons valued at \$75.00, 4 horses/mules valued at \$455.00 and 30 cattle valued at \$450.00. Land purchases continued and the 1890 tax records indicated Kenney not only owned 480 acres on the Chaumes grant valued at \$2000.00 but he also owned and paid taxes on 192 acres on the Bustillo grant which was valued at \$750.00. He owned 3 buggies/carriages valued at \$90.00, 9 horses, valued at \$225.00 and 40 cattle valued at \$200.00⁶

On 9 November 1876, Patrick Kenney filed his brand marks for his cattle: one brand to be placed on the left rib of each cow and another brand to be placed on the cow's ear. (See document on this website re: Brands).⁷

On 24 August 1883, Patrick Kenney sold to Bexar County, 2 acres of land from the Bustillo grant near Elm Creek for the purpose of establishing a school. The selling price was \$37.50.8 Over 40 years later in 1925, these same two acres of land were sold back to Patrick Kenney for \$100.00 by W.H. Koehler, President of the Somerset Independent School District.9

In 1891 St. Patrick's Church Catholic Church was erected in Bexar, Texas. The one-acre property was donated on 7 May 1891 by Patrick Kenney to Rev. J.C. Narez, Bishop of the Diocese of the Catholic Church for the church and the cemetery. Prior to this donation, Holy Mass had been held in the home of Patrick Kenney. With a group of Irish, German and Mexicans, Patrick Kenney assisted Father Domingo Vento in building St. Patrick's Church. The cemetery was established and has expanded over the years into the area where the original church building was located. Many of the members of the Kenney family are buried in this cemetery as well as over 300 other souls. Later when the railroad came through the area in 1907-1909, most of the people in Bexar moved to the newly formed town of Somerset. The church congregation split and St. Mary's Church was established in Somerset. In 1958, the Bishop of the Archidocese decreed that the original St. Patrick's Church building be closed due to its deteriorated condition. The building was eventually demolished. ¹⁰ ¹¹

Bexar County census records for Patrick Kenney indicated he was a farmer as well as a landlord, a tradition carried on by his sons. In the 1900 Bexar County census, the sons William (age 27) and Thomas (21) were living in the Patrick Kenney household and their occupations were given as "farmer" and "farm laborer" respectively. On 27 April 1905, Patrick Kenney was commissioned as postmaster at Bexar, Texas. (Bexar is pronounced BEX-R when referring to this community which is no longer in existence with exception of several cemeteries and a few small houses.)

On 4 October 1917, Patrick Kenney and his wife, Rosa entered into a lease agreement with Gulf Production Company to lease almost 1000 acres of land on the M. Chaumes, Jason Smith and Clemente Bustillo grants. The company was given the right to explore for oil, gas and minerals and agreed to pay the Kenney's \$306.00 monthly plus royalties on any products produced. This lease expired on 11 December 1923 and the property was returned to the Kenneys by F.L. Thomas, President of the Grayburg Oil Company who had assumed the lease in the interim.

Rosa Zink Kenney died on 5 December 1923 at the age of 73. Seven years later on 1 August 1930, her husband, Patrick Kenney died at the age of 91. Both are buried in the Saint Patrick's Catholic Cemetery in Somerset, Texas. 15

With the death of Patrick Kenney, the three youngest Kenney children, Margaret (Maggie) Kenney Caruthers, James A. Kenney and Annie Kenney each inherited 1/3 undivided interest in the Kenney property, totaling approximately 225.24 acres. The land included Tracts 4, 5, and 6 of the Chaumes grant and 4.50 acres of Survey #348 of the Clemente Bustillo grant. The partition and distribution of the property on July 31, 1933 indicated that the three Kenney

siblings along with Texas Caruthers, Maggie's husband, were living on the property. The Kenney siblings established a joint tenancy with a life estate, stipulating that with the death of each, their share of the property would pass to the remaining siblings.¹⁶

On 14 August 1935, Annie Kenney, James Kenney, Maggie Kenney Caruthers and her husband, Texas Caruthers, entered into a mining exploration and lease agreement with E.S. Orgain of Bastrop County, Texas. Exclusive mining rights were given for prospecting, operation, excavating and mining as well as the right to build, erect, construct and maintain all buildings, houses, barns, fences, storage places and sheds, as needed. Also, the right to construct shafts, make roadways and equip them for transportation of cars and vehicles was stated. All roadways passing through or crossing fences were to have gates or be provided with ordinary cattle guards and all tenant or camp houses were to be located on the north side of the railroad spur track. The deed record provides additional stipulations and refers to the lease as having the purpose of shipping and marketing lignite or coal from the tract.¹⁷

Mining for coal was certainly not an unfamiliar enterprise for the Kenney family. John Kenney, the father of Patrick Kenney, was familiar with the coal mines in Ireland. Shortly after his arrival in Texas, he recognized the peculiar clay formation in southern Bexar County. He also observed the mining operation already in operation by T.S. Harrison and proceeded to purchase adjacent and nearby lands. In later years John Kenney purchased the land where the first coal mine was operating. By 1882, he opened his own open-pit coal mine.

The original mine had an incline shaft and was first mined by mules and ox-carts. The second mine had an elevator shaft and utilized cable cars. The mines were about 40 feet deep with veins of coal 4-7 feet thick. An estimated 7000 tons of coal per acre were mined during the mine's operation. Coal was dug out with picks and shovels or by dynamiting using long fuses at the end of the day when all workers were out of the mine. Men who worked in the mine earned about 30 cents a ton. Mule drivers and other workers above ground were paid 30 cents an hour. Coal was loaded into the carts or cars each hold about a tone. Generally able-bodied men could load each or ten cars each day.

A worker's village developed and it became known as "La Colorado" or "La Mina de la Colorado" by the Hispanic workers. A post office opened in 1883. By 1894 the community of Bexar, Texas consisted of 30-45 small houses, a doctor's office, a theater, the post office, a cotton gin, Bustamante's dance hall, a cantina, three churches, and a general store which also served as a hardware store and a drug store. The store was owned by John Conoly and Dr. James Matthews having purchased the original 1½ acres from Patrick Kenney for \$130.00. About a mile from this store was a bakery and a waterhole where individuals from the area came to get water when needed. A large portion of the land where the community of Bexar developed was originally owned by the Kenney's. In some situations, Patrick Kenney leased the land and/or the buildings to the individuals operating the stores.

After the Artesian Belt Railroad bypassed the community of Bexar for the town of Somerset, most of the population moved to Somerset. The economy shifted to oil and gas production rather than coal. The general store closed, the churches followed the people and Bexar went into decline. By 1947, peanuts were being grown over the former coal mine. 18 19 20 21

The 1940 Bexar County census indicates that the three Kenny siblings (Maggie Kenney Caruthers, Annie Kenney and James A. Kenney) were living in the same household with one another. James and Annie were both single and Maggie was a widow. Over the next 37 years, the three Kenney's sold portions of the property with 75 acres of Tract 4 of the Michael D. Chaumes being sold to William Pyron Kenney, the son of their older brother, William Franklin Kenney on 28 August 1948.²² Texas Caruthers had died on 23 February 1940 so therefore he was not a party to this sale.

On 8 May 1970, the Kenney's sold 74.06 acres of property where the Patrick Kenney House is located to J.W. James and his wife, Mary Louise James. They later sold the property to the current owner.²³ The Patrick Kenney²⁴ house is located on 1.451 acres of the Chaumes grant, Survey #136 and the Clemente Bustillo grant, Survey #348.
