WHEREAS, heretofore on to wit, June 26, 1933, in the matter of the Estate of Pat. Kenney, Sr., deceased, styled No. 18,694, Estate of Pat. Kenney, Sr., deceased, in the County Court of Bexar County, Texas, a final decree of partition and distribution was rendered on Monday, June 26, 1933 and entered in Journal 188, pages 362 to 366, probate minutes of said court. Kenney and Annie Kenney became and now are the joint owners of said three tracts of land above described, holding and owning the same in fee simple jointly and as tenants in common. And WHEREAS, Texas Caruthers, the husband of said Maggie Kenney Caruthers, has made certain cash advances and expended certain of his funds in the improvement and caring for the lands and premises above described. And WHEREAS, the said Maggie Kenney Caruthers, Texas Caruthers, her husband, James A. Kenney and Annie Kenney all reside upon, use and occupy the lands and premises above described. And WHEREAS, it is the desire and wish of the said Maggie Kenney Caruthers, her husband Texas Caruthers, James A. Kenney and Annie Kenney, jointly, to hold and own said lands and premises jointly as tenants in common during the lifetime of each, and that the survivor of said Maggie Kenney Caruthers, Texas Caruthers, James A. Kenney and Annie Kenney shall take, have, hold and own the absolute fee simple title to all of said lands and premises. Kenney and Annie Kenney all of our and each of our right, title and interest in and to the following described lands and premises, to wit: Tract No. 5, being 75.08 acres of land, part of survey No. 136, Michael de Chaumes, in Bexar county, Texas, about two miles west of Somerset. Beginning at a stake in the north line of the Benton City road, set 1350 varas east of the southwest corner of the Kenney tract. Thence east 297.10 varas, along said road, to a stake. Kenney and Annie Kenney, do each reserve unto himself and herself the right to use, occupy and enjoy said premises, together with the income and fruits thereof, jointly with the other parties hereto, for and during the natural life of each of them. It is intended by these presents to grant, give and convey, subject to the life-estate herein retained, all and singular the lands and premises hereinabove described unto that one of the grantors herein, to wit, Maggie Kenney Caruthers, Texas Caruthers, James A. Kenney and Annie Kenney, who shall, by the grace of God, be the survivor of said four persons, to the end that such final survivor shall have, take, hold and own the absolute and fee simple title to such lands and premises after the respective deaths of the other grantors herein.
