Along this blog, I will be posting about Jews in the diaspora, and how did they become a strong force worldwide after being persecuted.

Let's begin by defining diaspora, this being the movement of a population from its original homeland. So, why did Jews had to expand to other parts of the world if they were comfortable were they lived? The "reasons" behind each pogrom may be justified by the other side but what is crucial to mention is the fact that Jews were seen as a minority in Russia and this idea began to expand to other parts of Europe including Poland and Ukraine.

What was the Jewish population doing wrong besides trying to develop a Jewish heritage with the traditions they carried from their ancestors?

With all the craziness and amount of deaths that Pogroms left, Jews from all over started to realize that the definition of equality was not on the dictionary for them. What could they do? None could have pictured that the worst was yet to come; A Zionist movement calling for the necessity of a Jewish homeland was created named "He-Halutz" followed by a

As dreamers and pioneers, some young Russians decided that Palestine (Today the state of Israel) was the place to go. But it wasn't that easy. The problem in Palestine under the British regime was still very uncertain and Jews were not very welcomed to the future land of honey and milk. But that did not stop them. They created a youth Zionist movement called He-jalutz Lamerjav which its ideal was to build a land for the Jewish people in the Holy Land, no matter the cost.

Other Russians tried to spread out and begin a life in different countries but the hate increased as the emigration increased. A lot of them landed in Germany, the lucky ones got to the United States and a minority arrived at South Africa.

But life wasn't as magical as Cinderella's fairy tale. Sooner than later, the famous Adolf Hitler took control over Germany and begun to establish all type of rules against minorities, specially the Jews. It's important to clarify that Hitler had bigger ideas than the termination of Jewish "race". This included a war with Russia to gain raw materials like oil to fight against the United States in the future, as well as a easy war against Czechoslovakia followed by one with France and Britain. Let's STOP for a second to analyze how crazy a person could be to try to fight with the most powerful countries knowing how World War I ended. But that' not even the fact that shocks and amazes me the most; he was able to convince every person to become an allied for death. Most people remained silent under the terrible circumstances their neighbors where living just for the fact of having other religious beliefs. Adolf Hitler came to power in 1933 with the thought that this marked the beginning of the last Jewish existence.

The first official law focused on limiting the participation of Jews in German public life. The argument of the Nazi party was that they were "unreliable citizens". REALLY? how could this lie have a little truth in it's lines if Jews handled many powerful business that helped the economy of the country? Maybe Hitler thought Jews were a threat. If he lived today, he could see with his own eyes that rather than a threat, Jews have the power of embracing the economy of many countries and have the capacity of creating new technologies that don't do anything else than benefit the population.

In 1935 the "Laws of Nuremberg" became active which "excluded German Jews from Reich citizenship and prohibited them from marrying or having sexual relations with persons of "German or German-related blood."...Jews were disenfranchised (that is, they had no formal expectation to the tight to vote) and could not hold public office. The Nuremberg Laws did not identify a "Jew" as someone with particular religious beliefs. Instead, the first amendment to the Nuremberg Laws defined anyone who had three or four Jewish grandparents as a Jew, regardless of whether that individual recognized himself or herself as a Jew or belonged to the Jewish religious community." Endless laws and events continued to happen in the next years in Germany and Poland giving the Jewish people more

A night of Broken Glass or broken hearts? (2016-03-26 23:11)

The night of November 9th 1938 changed the history of the Jewish people. Also called "Kristallnnacht" or the Night of the Broken Glass, in this night the biggest pogrom against Jews occurred changing the game and entering a new stage of what would end up in World War II.

The name comes from all the broken glass that was left after the attack happened; many synagogues were attacked, Torahs ripped and burned, Souls of hundred Jews destroyed. The beginning of the so called "Holocaust" had officially began. The numbers of things that happened varies across historians, but what cannot be denied, is that in one single night at least 50 Jews were murdered just for the sake of being Jewish, other 30,000 were arrested and incarcerated in concentration camps lead by the Nazis.

At this point, the segregation was so marked that Jews had their own hospitals, business and places where they could live "in peace". All this "peace" came to an end and transformed in fire when the Nazis decided to attack, burn, destroy and damage every place that the Jewish people frequented...but the harm wasn't only physical; hearts of thousands broke in pieces while watching their relatives get arrested, killed, punched or all of the above.

"The Nazis managed to achieve in Kristallnacht all the theoretical targets they set for themselves: confiscation of Jewish belongings to provide finances for the military buildup to war, separation and isolation of the Jews, and most importantly the move from the antisemitic policy of discrimination to one of physical damage which began that night and continued until the end of WWII. There was no turning point now. The hate towards Jews was publicly declared and the fear only continued to grow. What was the next step? the "final solution" plan was on the table and the Jews had no where to go. Soon, it was clear who was a Jew, the yellow star sued to their clothes... or should I say their heart? Till this day, those who survived remember the alienation and hate towards them just because, just because they believed in G-d, just because they called themselves Jews, just because they were people, just because they were the same as you and me.

Post War, post trauma...Where is home? (2016-04-10 23:14)

War came and so did concentration camps, ghettos and murders. Millions of souls were left un-buried and when the American and Soviet troops ended the war, they not only faced the reality of the Nazi Ideology but also hundreds of people that didn't know were to go, lost individuals crying silently for a piece of bread that possibly (not) filled their empty heart.

Many Jews feared to go back to what they use to call "home" due to antisemitism. Consequently, a lot of them emigrated to Eastern Europe hoping to get a new beginning while others decided Europe was not for them and the best thing to do was to run somewhere else. Where to go? Many took boats without knowing their destination, or believing they were landing in the U.S; some of them did and some of them arrived at places where they didn't even know how to ask for a bathroom. The cultural shock was unbelievable and that combined with post war trauma wasn't the great combo.

A big group emigrated to Israel with the help of the "Jewish Brigade Group" (a Palestinian Jewish unit of the British army) which enabled an illegal migration, but the biggest attempt with a ship called "exodus 1947" was intercepted by British and sent back to Germany; 4500 survivors were denied the entrance to the land of Palestine.

So, how is it that the Jewish people became a prestige group within society years later if at this time they were seen as the lowest class with no rights?

Let's begin by explaining that one of the most beautiful things about Judaism is the sense of community. When survivors arrived at this foreign countries the first thing they did was either look for a Jewish community or establish one with the few people that arrived with them. "Luckily", in most of the places there were some Jews that managed to escape from the war or that arrived in the 19th and 20th century and opened their arms to the devastated ones.

At the beginning it was hard. Imagine yourself in a foreign country, with no family, not knowing a single word of their language and having to start a new life. But the Jews did not wait to apply their knowledge to every field and started little by little building connections among locals.

Throughout history, Jews have had the stereotype of being merchandisers, traders and sears. Well, not much time passed for the Jews to make sure the nickname was still on point.

Leaving Israel aside for a moment, let's focus on those Jews who were trying to organize communities in the called "diaspora" and were trying to gain the status of "power force" again. There were certain steps that Jewish people followed to establish a community, these includes:

- 1. Governmentlike institutions, whether umbrella organizations or separate institutions serving discrete functions, that play roles and provide services at all levels (countrywide, local, and, where used, intermediate) which, under other conditions, would be played, provided, or controlled, whether predominantly or exclusively, by governmental authorities (for instance, services such as external relations, defense, education, social welfare, and public, that is, communal, finance), specifically:
- a more or less comprehensive fundraising and social planning body;
- a representative body for external relations;
- a Jewish education service agency;
- a vehicle or vehicles for assisting Israel and other Jewish communities;
- various health and welfare institutions.
- 2. Local institutions and organizations that provide a means for attracting people to Jewish life on the basis of their most immediate and personal interests and needs, specifically:
- congregations organized into one or more synagogue unions, federations, or confederations;
- local cultural and recreational centers, often federated or confederated with one another.
- 3. General purpose mass-based organizations, operating countrywide at all levels, that function to: (a) articulate community values, attitudes, and policies; (b) provide the energy and motive force for crystallizing the communal consensus that grows out of those values, attitudes, and policies; and (c) maintain institutionalized channels of communication between the community's leaders and "actives" ("cosmopolitans") and the broad base of the affiliated Jewish population ("locals") for dealing with the problems facing the community, specifically:
- a Zionist federation and its constituent organizations;
- fraternal organizations.

Special interest organizations which, by serving specialized interests in the community on all planes, function to mobilize concern and support for the various programs conducted by the community and to apply pressure for their expansion, modification, and improvement.
