*It is reasonable to assume that the "new dwelling house" referrs to at least the front portion of # 56 Buf-fum St. and that it was built during the summer of 1809 by Samuel Randall and Robert Clouston either of their own accord or more probably for Ebenezer Pope. This could indeed be a good reason for his taking out of a \$ 1500. mortgage on the property for which (the land alone: 23 poles) he previously paid \$ 500. It is also interesting to question here where the back section of the present structure came. Trom since it definitely has 18th century construction styles and woodwork. From existing evidence in the cellar, the back earlier house seems to have been joined to the 1809 front half about the middle of the nineteenth century and at that time both halves altered considerably.
