John Parker of Reading yeoman, for £ 75 sells to Thomas Perkins merchant of Salem a dwellinghouse and land now in occupation of Elijah Perkins bounded: beginning on Ash St. so called, at the N.E. corner of Bracken-bridge Rose's house, running N. bounded E. on said St. 86': then running W. bounding N. on land of Daniel West 61½'; then running S. bounding W. on land of Tenry Rust 50½'; then running E. bounding S. on land late of William Childs 34'; then running S. bounding W. on said Child's land 34'; then running E. bounding S. on Brackenbridge Rose's land about 30' to beginning. With privilege of passing and repassing across the lot of land sold by said Parker to William Childs, to use the well, and reserving to heirs of William Childs a 10' road from his land to Ash St.

Milliam Chiles of Salem, Mariner, for £25 10 sh. sells to Eunice Brown spinster of Salem the E. end of a dwelling house, land and cellar under, also the E. half of the chomney (etc.) with a strip of land at the E. end of the house to extend N. and S. the breadth of the house; the N. boundary except the chimney to be the W. boundary of the E. lower room, also the use of the entry and stairs leading to her chamber, also the use of the well. Being the same Parker sold me May 9, 1787.

## Diaries of Rev. William Bentley

Could find no information pertinent to the house. One curious item below: is he referring to Elijah's wife?

### SUMMARY

This lovely Federal style brick house has provided a few problems for the researcher. Thomas Perkins (the first one) was a wealthy Topsfield resident who died in 1830. He left no wife or children. (A nephew Thomas Perkins lived in Salem.) His extremely lengthy will named a great many parcels of realestate divided among many brothers, sisters, nephews and nieces. He specified that his brother Elijah Perkins and wife were to possess the house and land in Ash St. for their lifetime only, and at their decease it was to go to Thomas Perkins son of his brother Moses. Thomas Perkins (the first) had acourred the Ash St. land and a dwelling house in 1795. His brother Elijah and family were already "in occupation of" it. Thomas Perkins in 1809 and 1824 bought the W. and E. ends of a house on the same property. I would guess he was buying the dower rights to the house he'd already purchased. Elijah appears on the tax records for the first time in 1792, paying taxes on "1 pt. house and shop" He was a chairmaker and a Revolutionary War Pensioner. Tax records are often fragmentary, but a pattern can be seen. Elijah paid varying taxes on "house and shop" until 1811 when suddenly the listing changed: "Brick house on Ash St." In the years following, Elijah was assessed for a poll tax only. Thomas Perkins appears in the non-resident tax list assessed for (among other property) "house in Ash St." He died in 1830 and the nephew Thomas Perkins (who apparently lived on Beckford St.) began paying taxes on 7 Ash St. Elijah died in 1841, and Assessors Day Books show that the house was occupied by a succession of boarders, in later years.

Now back to the origen of the house. It is a two chimney house with no sign of having been altered from a central chimney house. The deeds of 1809 and 1824 specifically describe a central chimney house. My conclusion is that Thomas Perkins bought

the land and central chimney house that his brother was living in. Then he built for his brother a <u>new brick house in 1811</u>. The older house ("house and shop") may have been either destroyed or moved off the property, after acquiring the dower rights. The deeds to the (older) house before 1795 are extremely confusing. The style of the brick house makes it unlikely that it existed earlier than its appearance in the tax records. The size of the lot remained practically the same until 1940; the house #5 (removed by the S.R.A.) having been built after 1900 and before 1940.
