INFORMATION from CITY of SALEM TAX RECORDS

From 1831 on, Benjamin B. Gardner paid taxes on "½ house" which was on the west side of North St., the old number being #65

From 1828 to 1830 he paid taxes on what was evidently another house.

I cannot find any record of William Batchelder paying taxes for the years (1827 to 1830) he owned the land, and the house he built on it.

(These old tax records are often incomplete.)

It seems likely that Batchelder sold his property not too long after he finished the house: I would guess that he built it around 1830, and the style of architecture bears out this period.
