## 65 DERBY STREET

Built in 1858 by Michael McDonald, Laborer

## 65 DERBY STREET

The house currently located at 65 Derby Street was built in 1858 by Michael McDonald, who was employed as a laborer. Since its completion, the house has consistently been occupied by people of working-class origins, no doubt reflecting the population of the neighborhood, which in the mid-19th century was populated by European immigrants.

According to the 1851 Map of Salem, the block on which the house now stands was an open lot. The lot was sandwiched between English and India Streets. The English Street extension across Derby Street no longer exists today.

The first address of the house was "rear 31 Derby Street" or "31 1/2 Derby Street". The attached 1874 Map of Salem listes McDonald (here referred to as "McDonnell") as owning not only 31 1/2 Derby Street, but the other houses on the block as well. Also listed as living at 31 1/2 from the 1860's through the early 1880's was Philip McDonnell, a shoemaker, Catherine McDonnell, a widow, Philip L. McDonald, a currier (most likely a leather worker), and John J. McDonald, a marble cutter [Salem Directories, 1861, 1864, 1866, 1874, 1881].

Records indicate that by the mid-1880's, Michael McDonald had moved to 31 Derby Street (this house no longer exists today). Mrs. William Elbers, Mrs. Ellen McDonald (widow of Philip), and John J. McDonald now occupied 31 1/2. By 1889, Mrs. Mary Carey, a widow, William Martin, Cornelius Cronan (both laborers), in addition to Ellen and John J. McDonald, lived in the house. By this time, John J. was now employed by B & M

Railroad [Salem Directories, 1884, 1886, 1888-89].

The <u>Salem Directories</u> for 1895-96 list Patrick Mackey and J.J.

Barrett as living in the house, and by 1900, John H. Barrett had joined them.

All three were employed as laborers [<u>Salem Directories</u>, 1897-1900]. At this time the house was also listed under "India Street" in the Directories.

Listed next door to the house was the Ralston Social Club and the Enterprise Social Club, 3 and 5 India Street respectively.

Between 1903 and the mid-1920's, the Mackey family were the sole occupiers of the house, now known as 65 Derby Street [Salem Directories, 1903-04, 1910, 1920, 1926]. Patrick and his wife Ellen had five children: Edward, John, Mary, Margaret, and Anna. Unfortunately for the family, Patrick died in 1923, leaving the house to Ellen. Probate records indicate the house was valued at \$1570.00 [Essex County Probate Records, No. 146878].

In the mid-twenties Ellen and Mary Welch lived in the house. The house does not appear in the Salem Directories for the years 1929, 1930, and 1931. Most likely the house was vacant at this time [Salem Directories, 1929-1931].

In 1932 Alex Eastman and James and Florence Gates resided at 65 Derby. Alex was employed as a leather worker, and James was employed as a mill worker. The next year, Stanley Eastman and John Mackey appear as residents. Stanley was employed as a leather worker in Peabody. John was employed as a laborer [Salem Directories, 1932, 1933-34].

Between 1940 and 1947 the families of Alex J. Eastman and John Mackey occupied the premises. Records indicate that John was not

married. However, Alex had 5 dependents living in the house [Salem Directories, 1940, 1945, 1947].

The Eastman family continued to live in the house througout the 1950's and 1960's. In 1950, Henry Hayes moved into the house. He was a leather worker at the Russell-Sim Tanning Co. He lived in the house after his retirement until the mid-1960's. Alex continued to work as a leather worker until his retirement in the late 1960's [Salem Directories, 1950, 1955, 1961, 1965].

In 1970, Alex Eastman is listed as living in the house with his wife Anna.\* Alex probably passed away in the early 1970's, and since then, Anna is listed as the sole occupant of the property [Salem Directories, 1970, 1975, 1980, 1986, 1988-89].


